# **Motion Filed Against City** Resolution

**Alleges City Tried to Evade Referendum**

LIVERMORE — The Alameda County Superior Court has been asked to compel the City of Livermore to undo a recent resolution on the downtown Eden Housing project.

As proposed, the project plans to build two buildings with a total of 130 affordable-housing units and an estimated 0.7-acre public community park between Railroad Avenue, Veterans Way, L Street and a planned K Street fire lane.

On June 24, the Livermore City Council accepted the certification of a voter referendum looking to repeal the approval of a 2022 agreement between the city and Eden to develop the housing project and build a public park. The referendum had gathered over 8,000 signatures in 2022 and gained

# **Pleasanton Teacher Honored**

**California History Teacher of the Year**

PLEASANTON — When Katie Orenberg learned she had been named the 2024 California History Teacher of the Year, the Pleasanton Middle School (PMS) educator was enjoying a lazy summer afternoon relaxing on the floor with her toddler surrounded by snacks, sippy cups and talk of Disney movies.

"So, here I was in full 'mom mode,' and I looked at my email and found out I had won," said Orenberg, the married mother of a young son with another on the way. "It was a very surreal moment; one of those when I had to read it twice because I wasn't sure what I was seeing."

But for the longtime

### **FCI Dublin Prison Guard Indicted Charged With Victimizing Female Prisoners Under His Watch**

DUBLIN — More than three months after federal authorities shut down their notorious women's prison in Dublin, prosecutors last week continued their efforts to hold correctional officers accountable for alleged sexual abuse of inmates.

The U.S. Attorney's office on July 26 announced that a federal grand jury issued a 15-count indictment against former guard Darrell Wayne

Smith, charging him with victimizing five female inmates under his control at Federal Correctional Institution, Dublin (FCI Dublin).

The defendant's alleged actions are some of the most disturbing charges we've seen for a former federal corrections officer," said Michael D. Nordwall, executive assistant director of the FBI's Criminal, Cyber, Response, and Services Branch. "Sexual abuse scars everyone who survives it but

can be particularly traumatiz-

ing when it's perpetrated by someone in a position of trust or authority."

Smith, 55, who now lives in Florida, originally was charged in April 2023 with sexual abuse allegations involving three women. His expanded indictment added two victims to the case, along with a charge that he violated one victim's civil rights under the color of law. The allegations occurred from 2016 to 2021. If convicted, Smith could face multiple life sentences

# **Samples from Asteroid Mission** Will Soon Be Up for Analysis

LIVERMORE — Insights into the beginnings of our solar system await study at Lawrence Livermore National Lab (LLNL) thanks to an asteroid-collection mission completed last year.

Scientists at LLNL will soon begin analyzing samples from the asteroid Bennu, collected by NA-SA's OSIRIS-REx (Origins, Spectral Interpretation, Resource Identification, Security, Regolith Explorer) mission, which returned safely to Earth on Sept. 24, 2023. Through chemical and physical analysis, they will

be able to analyze Bennu's composition. Those results, in turn, can tell us what the solar system looked like billions of years ago.

Bennu is of particular interest to researchers because of its unique qualities. Research shows that it likely broke off from a larger carbon-rich asteroid, then drifted closer to Earth over time. The frigid temperatures of space have preserved the carbon-containing molecules — also called organic molecules — inside the asteroid, which could help understand where organic molecules originated from.

But LLNL's focus is on

a different question — Bennu's age. Greg Brennecka, an LLNL scientist who works on cosmochemistry, said the chemical analysis of space samples can reveal how the galactic neighborhood was formed.

LLNL has a long history of working on this kind of analysis, which is why they — among other labs throughout the country are responsible for analyzing inorganic compounds in the asteroid samples. Brennecka said, "Our main charge is to find out where Bennu originally formed, which can help us reconstruct the early solar system." He

# **East Bay Parks Aircraft Move to Livermore Airport**

**New Location Increases Its Service**

REGIONAL — The East Bay Regional Park District (EBRPD) recently moved its air operations from Hayward to the Livermore Municipal Airport, where it is enjoying the weather and neighbors at its new home.

EBRPD Police Captain Terrence Cotcher, who manages the operations, said leaving the Hayward Executive Airport was based on several factors.

'Our move offers increased service delivery, better flying weather and increased amenities offered by Livermore (airport)," said Cotcher. "This all helps us to streamline our services. . . . It's just a better fit for us and we're very excited to be here."

Covering over 125,000 acres between Alameda and Contra Costa counties and 73 parks, the EBRPD operations division, which includes an independent police department and the air support component, serves both visitors and employees of the district, as well as the area's vast natural resources and wildlife.

"Most people don't even know we have a police department," laughed Cotcher.

The air support unit currently owns two helicopters and employs five pilots, who are also police officers. The team serves the EBRPD by patrolling the areas daily and is also a regional asset and support for local fire, police and rescue units.

# **Downtown Hotel Timeline Extended by City Council**

LIVERMORE — The city council last week granted a loan extension to a troubled hotel project in downtown Livermore.

In a 4-0 vote, with Councilmember Brittni Kiick absent, the council amended a loan agreement with the developer of a four-story, 133-unit hotel set to be built

by Davis-based Presidio Companies at the southeast corner of Railroad and South Livermore avenues.

Under the agreement first approved in February 2018, the developer was to receive a \$1.93 million loan from the city to purchase the 33,600-squarefoot property owned by a private company and pay it back with interest when

# **Chamber of Commerce Asks Area Businesses to Support Next Generation**

LIVERMORE — Last week, a panel of Tri-Valley business leaders addressed the concept of work-based learning and how local businesses and organizations can leverage the myriad career opportunities in the area to help train the next generation of workers.

Hosted by the Livermore Valley Chamber of Commerce, a large crowd of chamber members, local organizations and area politicians gathered on July 25 for the chamber's first event of its 2024 Wine Country Summer Luncheon Series, where "Business to Youth Connection" featured as the primary

Kim Hudson, engagement specialist for Earn & Learn PBC, a women-owned and -operated education intermediary that bridges the gap between campus and career, moderated the discussion.

"My hope today is that you all leave here having either a contact or an idea of how you can call your local educational institutions — whether it's a K-12 or your local community colleges or adult career centers — to engage and change somebody's life."

Hudson touched on some of the panelist's youth initiatives that are helping lead that change, such as the building up of soft skills. "How to

shake a hand," she said. "How to look somebody in the eye. How to communicate verbally and not just on your phone."

Panelists then weighed in on what work-based learning meant to them.

Alcian Lindo, program manager for the Tri-Valley Career Center, a service of the Chabot-Las Positas Community College District, kicked off the discussion. She said, to her, work-based learning means everything.

"It means providing the community with the means to achieve, to have economic freedom and security," said Lindo, adding that the idea translates into providing job assistance and training to

# **Sunol Glen Welcomes Superintendent Shay Galletti**

Shay Galletti has been on the job for just a few weeks, but the new superintendent and principal of the Sunol Glen Unified School District (SGUSD) has hit the ground running. As she prepares to welcome students back to the classroom on Aug. 7, the longtime educator and administrator is eager to start the school year.

"My total focus right now is on opening the school and getting everything running smoothly," said Galletti. "This is a new position for me and I'm ready for it and very, very excited. I am ready for the challenge."

And there are many challenges to be faced.

Galletti comes to the small community of just under 300 students on the heels of a fractious, difficult time for the district. A recent recall election resulted in the removal of two of the district's three school board members,

and the resignation of the former superintendent and principal Molly Barnes. But with the hardships seemingly behind the district and its residents, Galletti said she is optimistic the coming year will be a season of renewal for them all.

'Helping the school based on what they faced last year is very important to me," she said. "There is a community divide that I hope will heal. ... I, we, are focused on the students and their well-being and creating a positive school culture, and I think the staff has done an amazing job of buffering this from the students. Really, when you think about any school, it's about families feeling included, and I am going to ensure that happens for Sunol."

Ted Romo, the only board member who was not recalled, said he welcomes Galletti to the SGUSD.

"I am enthusiastic about Shay and I believe that she brings a wealth of

knowledge and skills to the job of superintendent/ principal," said Romo. "I have complete faith in her and expect her to do a great job. There will be a period of adjustment as she gets to know the ins and outs of the role and builds rapport with the teachers and staff and parents and larger community, but in the end, I think she will do well."


Galletti brings to her new position a history of experience and expertise. The daughter of Pleasanton Unified School District (PUSD) Trustee Steve Maher, she has been with PUSD for the past nine years, serving as the principal of Fairlands Elementary School from 2015 to 2019 before being appointed as the district's director of elementary education. Earlier in her career, Galletti taught at two PUSD elementary schools and later became the Tri-Valley Regional Occupational Program coordinator in 2004. She has also taught classes at Livermore, Granada, Foothill and Amador Valley high schools. Galletti holds a bachelor's degree in liberal studies from California State University, East Bay, and a master's degree in early education from Saint Mary's College of California. She is currently working on her doctorate.

"Honestly, when I thought about Sunol, I realized it really combines what I have done in my career and I felt it was a perfect fit with my skills and where I saw myself in my career," said Galletti. "I look forward to getting to know the staff better and the community and supporting all of them as best I can.'

As she prepares for the first day of school, the Pleasanton resident, married mother of four and grandmother of four, eagerly anticipates returning to the school campus and engaging with students, families and the wider community

"It's been five years

since I've been on a campus, so I am really looking forward to the students' arrival," said Galletti. "There is just a special energy that being with the students brings. And because we are such a small district, I will get to know all the students and their families. I am very excited to be here."

# **Interim SGUSD Board Members Appointed**

The Alameda County Board of Education (AC-BOE) has appointed two interim trustees to fill the vacancies following the recall of Sunol Glen Unified School District (SGUSD) Board President Ryan Jergensen and Trustee Linda Hurley. The recall was certified on July 19.

ACBOE President Cheryl Cook-Kallio appointed herself and ACBOE Trustee Aisha Knowles as interim SGUSD board members. Cook-Kallio will serve until the Nov. 5 general election when Hurley's term would have expired. The winner of the November race will be sworn in on Dec. 10.

Knowles will sit on the

board until a replacement is appointed for Jergensen's seat. According to staff, the position will be appointed by the SGUSD board on Aug. 14. Applications for the position are currently being accepted. Jergensen's seat expires in November 2026.

The Cook-Kallio and Knowles appointments, mandated by law, are crucial for ensuring SGUSD maintains a full three-person board to conduct business. The remaining board member, Ted Romo, was unanimously approved as the new board president during the July 24 special board

Cook-Kallio and Knowles were introduced during the same meeting.

"I am honored to be working with Superintendent Galletti and Trustee Romo to better serve the students of Sunol," said Cook-Kallio, whose grown children attended the K-12 school. "I did elect myself (and Knowles) and not lightly. You are the people I take care of as part of my responsibility on the County Board of Education. ... We all want what's best for the students, and we will turn this back over to the Sunol community as quickly as we

possibly can." Knowles agreed that getting the school board back on track was the top priority.

"I am thankful for the opportunity to serve in the role at this period in time, and I look forward to doing

whatever is necessary in support of students here so they can begin the new school year in a positive

manner," she said. Jergensen and Hurley were recalled earlier this month following a series of contentious board meetings. During these meetings, Jergensen and Hurley voted to prohibit flying the LGBTQ+ pride flag and other non-U.S. or non-California flags on campus. Supporters of removing Jergensen and Hurley also cited poor governance and not allowing community members to speak during public comment periods at school board meetings as contributing




Dallas' project consisted of removing two inches of dirt and installing bender boards for a path leading to the site of a future museum.



# **Bridge Removed From Planned Arroyo Vista Project**

The Livermore Planning Commission agreed last month to remove a pedestrian bridge requirement from the city's planned Arroyo Vista residential project, a move that is expected to save the city an estimated \$73,000 per year while adding two pocket parks.

The commission unanimously greenlit the modifications at its July 17 meeting. The changes also include increasing the height of homes from two to three stories and a financial contribution from the developer.

The project, originally approved in 2017 for 435 homes developed by Summerhill LLC, has been taken over by Trumark Homes, LLC. The new modifications raise the height of single-family homes and replace the pedestrian bridge over the Arroyo Seco Channel with pocket parks and a \$2 million financial contribution from Trumark. 'The modifications were

made to address liability issues and enhance community benefits," according to the staff report.

The 29-acre site, located southeast of Arroyo Vista and Las Positas Road, will now feature three-story single-family homes and the pocket parks in place of the bridge landings. The approved changes do not affect the overall layout or the number of residential units.

The financial contribution from Trumark will be split between the Community Benefit Fund and the Social Opportunity Endowment Fund.

In 2007, the city council established the basic development framework for the Arroyo Vista Neighborhood Plan, which guided the residential land use, circulation, open space, and architecture for the project site. The latest amendments reflect the city's evolving approach to

balancing development with community needs and safety concerns.

The removal of the bridge aspect of the plan was hailed as a significant cost savings for the city, as it relieves the city of the responsibility of upkeep for an essentially private community.

"I don't want to see us waste \$73,000, in the long term, that could go towards other bike infrastructure," said Commission Chairman Jacob Anderson.

Trumark said the pocket parks were a positive replacement for the bridge and one that made the most

"We agree with staff that it's kind of a challenging public/private component to the project and believe that this is an excellent alternative that benefits both parties," said Michael Keeney, director of forward planning for Trumark Homes.

# **Gaidos Launches Bid for Pleasanton**

Veteran Alameda County prosecutor Matt Gaidos has launched a bid for the District 4 seat on the Pleasanton City Council.

District 4 covers portions of downtown Pleasanton, the Vintage Hills and Ruby Hill neighborhoods, Jensen Tract, and Amador Estates.

Gaidos, a lifelong Pleasanton resident, has been an Alameda County deputy district attorney for 16 years.

He is also on the Pleasanton Planning Commission and is a former member of the city's Housing Commission.

In announcing his campaign, Gaidos promised to provide the council with an "expert level understanding" of public safety

"I will leverage my experience to reinforce a bridge between Pleasan-

ton's police and prosecuting agencies so that criminals are held accountable," Gaidos said.

"Pleasanton is a safe community, (but) it will require a comprehensive effort by law enforcement, the courts, and residents to

keep it that way," Gaidos added.

Gaidos also said he is a proponent of "measured development and open hillside space."

As chair of the Pleasanton Housing Commission, Gaidos supported grants to Sunflower Hill, a nonprofit that develops housing for adults with intellectual and developmental disabilities.

He also supported programs for senior and low-income family housing and said he supports efforts to make housing more affordable for teachers and public safety employees.

During his tenure on the Planning Commission, he has supported high-density housing projects with easy access to freeways and public transit options.

Gaidos also said he has been closely watching issues affecting the city's

water supply and would make that a top priority going forward, while taking a fiscally conservative approach to municipal spending.

"Like many Bay Area cities, Pleasanton is facing a daunting budget shortfall that will require pragmatic and creative ways to secure fiscal health," Gaidos said. "I'm prepared to join that conversation and be a part of a solution that Pleasanton residents will support."

Gaidos has a bachelor's degree in philosophy from the University of California, Santa Cruz, and a law degree from Golden Gate University.

He and his wife have four children enrolled in the Pleasanton Unified School District.

His campaign website, vote4gaidos.com, lists endorsements from former Alameda County District Attorneys Tom Orloff and Nancy O'Malley, Pleasanton Mayor Karla Brown, and City Councilmembers Jeff Nibert and Julie Testa.

# Classify the Upcoming Tesla Park as a State Reserve

Some 3,100 acres of open space in the Diablo Range east of Livermore are currently undergoing a classification process to become a state park. The process, expected to be completed this year, will decide between designations — such as state reserve or state recreation area — that will define the allowed uses in the park.

Known as the Alameda-Tesla property, the area lies along the boundary between the Native American people of the Northern Valley Yokuts and the Ohlone. Evidence of Native American settlement has been found both within and near the prospective park.

The property is also located within the climatic convergence zone between the hot, dry San Joaquin Plain and the cool, moist Pacific Coast. The result is one of the highest levels of biodiversity in the state. Fifty-three special-status species, including the Alameda whipsnake and the California redlegged frog, have been identified in or near Tesla, of which 32 are listed as "species of greatest conservation need" in the California State Wildlife Action Plan.

This confluence of cultural and biological significance in a large, scenic, contiguous space should be preserved as a State Reserve. Such a classification would put cultural and ecosystem values first, while still allowing for low-intensity public recreation.

More intensive recreation, increased human traffic and facilities risk fragmenting the Tesla habitats as they are today, driving some species away and damaging ecosystems.

Other parks in the state parks system, such as the neighboring Carnegie State Vehicular Recreation Area, already offer a wide array of options for these more intensive recreational activities. Preserve Tesla Park for the fragile natural and cultural resources it uniquely offers.

As you may have heard, Livermore Airport LVK) is now offering UL 94. This is a small step towards eliminating the impacts of leaded aviation pollution on several residential developments, schools, and preschools close to the airport. Unfortunately, UL 94 cannot be used in all piston en-

gine aircraft. Clearly, the most important next step is for Five Rivers Aviation FBO Pete Sandhu to start selling GAMI G100UL — an unleaded aviation fuel that can be used and/or mixed with fuel in any plane or tank

GAMI G100UL is FAA approved, insurable, and can be purchased from a distributor in Fresno by the end of 2024. Mr. Sandhu says he will offer GAMI G100UL by the end of 2025. Why DE-LAY for a year?

We need to reduce the impacts of leaded aviation fuel on our community as soon as possible.

The Livermore City Council has the authority to direct the FBO to offer GAMI G100UL. At the July 22nd council meeting, the Mayor stated that other airports sell leaded aviation fuel. This comment is both DISTURBING and disappointing. When residents asked the City Council to ban the sale of vaping products and

flavored tobacco products, the Council worked swiftly to make these sales illegal in Livermore and followed up with an ordinance to allow enforcement.

The sale of leaded aviation fuel also poses a significant health risk to minors living and/ or participating in outdoor activities near the airport. The Livermore City Council needs to respond as urgently and forcefully to this health threat as they did to the sale of vaping products. Vaping was a free choice decision teenagers made. In contrast; children living near the airport are marginalized because breathing leaded aviation fuel is not a free choice.

Flying at speeds of 120 miles an hour, EBRPD's helicopters can cover one corner of the district to the other — roughly the size of Rhode Island — in seven to eight minutes.

"We take pride in the job we do and serving as an ambassador for any fire or police agency or first responder in need," said Cotcher. "The air support unit is critical to us. We would need 400 officers to cover that area on foot." The park district's police department currently has 76 sworn officers.

The EBRPD is leasing its hangar at the airport from Five Rivers Aviation. Five Rivers owner Pete Sandhu said he is delighted to have the units housed in Livermore.

"We are thrilled to have them here; it just makes sense," said Sandhu. "These are the kinds of things we want to bring to the Livermore Airport. We don't want Boeings; we want to fill the airport with aviation uses and activities that are compatible with the community."

Five Rivers also rents space to the Alameda County Sheriff's Office Air Support Unit. The new location of the parks district police department, according to Fred Greer, EBRPD police sergeant and chief pilot, allows for better communication and collaboration between the

"Being at our current location gives us daily networking with the Alameda County Sheriff's Office Air Support Unit, which is right next door," said Greer, adding that it's also allowed for better resource coordination, cross-communication and tactics.

Since arriving in Livermore, the EBRPD team has been busy.

Three days after the unit's move, even before becoming operational, said Greer, a lost hiker with medical conditions was reported in the nearby Sunol area. The team was called in on a day off and initiated a two-day search operation in coordination with local emergency personnel. The hiker was found, and the helicopter was used for evacuations.

"The ability to take off from the Livermore Airport and be on scene in less than five minutes was a huge advantage," Greer added.

Then, just three weeks later, a series of fires broke out in the Altamont Pass area. Due to the location, the team was first on the scene at a small fire and coordinated with Cal Fire resources. A week later, the team engaged in water drops in the Altamont with Cal Fire air resources on another fire.

county registrar certification in June following a two-year court battle on the referendum's validity.

Although the city council, in response to a court ruling in March, agreed to rescind its 2022 approval at its June 24 meeting, it also readopted the administrative parts of the 2022 agreement — as opposed to the legislative parts — that were not related to the park. City Attorney Jason Alcala advised the council that such a separation would allow the other aspects of the approval to move forward.

Legislative actions establish policies, while administrative actions execute them. Administrative actions cannot be referended, only legislative actions.

In rescinding the approval, the city council decided against putting the issue to a public vote.

The council voted 4-1, with Councilmember Ben Barrientos against, for the readoption.

Move Eden Housing (MEH), the community group behind the referendum, filed a motion on July 29 claiming that such a readoption was not allowed under state law. The motion now asks the court to order the city to rescind the June 24 resolution.

"The city council's actions on June 24 clearly violated rules in the Elections Code requiring that cities wait one year before reapproving an ordinance or resolution that has been subject to referendum,' said MEH attorney Winston Stromberg. "An ordinance or resolution cannot be passed in less than a year if it is 'essentially the same' as the original proposal, as is the case here.'

The city, however, maintained that the readoption of the administrative portions was allowed.

"The new question posed to the courts by MEH is whether a petition against the legislative acts has the legal effect of preventing the city council from pursuing the administrative acts the appellate court determined were not subject to referendum," City Manager Marianna Marysheva told The Independent. "The law is clear that administrative acts are not subject to referendum, so the city is confident the courts will answer that question in the city's favor and reject MEH's argument.

"The city looks forward to the day when MEH no longer engages in public deception about the legal effect of its referendum," she continued.

Linda Mandolini, CEO of Eden Housing, also lamented the delays of MEH's new legal action.

"It is unfortunate that Move Eden Housing continues to seek ways to delay the development of affordable housing for families with limited means. Despite these challenges, Eden remains dedicated to providing housing opportunities for the crucial members of our communities, including our teachers, firefighters, school staff, and restaurant, vineyard and other essential workers. Without these baseless lawsuits, 130 families would now have a place to call home and enjoy a beautiful park that cannot be developed at this time due to Move Eden Housing's actions."

The hearing is scheduled for Aug. 22.

### **Project History**

According to Richard Ryon, the original proponent for the referendum, the Livermore community favored a larger, creative community park on the site that the council had chosen for Eden. Ryon stated that community members wanted to relocate the housing units across Railroad Avenue to the north and accommodate even more units.

The referendum, however, ran into issues when

MEH submitted the petition to the city in July 2022. On the advice of Alcala, Livermore City Clerk Marie Weber declined to verify the signatures when they were submitted, reasoning that the city council's approval was administrative and not legislative.

While the Alameda County Superior Court sided with Alcala's interpretation in August 2022, the California 1st District Court of Appeal earlier this year overruled that decision, reasoning that the city clerk lacked the legal authority to make the determination she did. The appellate court also concluded that a \$5.5 million payment from the city for the park rendered the entire 2022 resolution as legislative and therefore subject to referendum.

Following MEH's motion this week, Marysheva said that "the question the court previously answered was whether the city clerk was required to process MEH's petition as a refer-

"That question evaluated whether the resolution contained a legislative act," she continued. "That is important here because the petition signed by the voters said, 'We request the legislative acts contained in said resolution be entirely repealed.""

Last week, Alameda Superior Court Judge Michael Markman, in response to the appellate court's ruling, reversed his earlier decision and ordered the city to process the referendum.

According to Stromberg, the city's readoption of portions of the 2022 resolution represents an attempt to evade the referendum."

"We regret having to demonstrate again that the city has not complied with the law," he continued.

Ryon added, "We are so frustrated that the city continues to ignore the voices of the voters in Livermore, who clearly supported this Referendum."

compared the work that he and his colleagues will be performing as something of a forensics exercise: trying to understand when and how something happened.

Brennecka emphasized just how important these samples are to understanding the history of our solar system. "This is a rock that captures our origins. The sun is formed from the same stuff that this asteroid is formed from. Our planets are too. But those other rocks have melted and formed cores, whereas Bennu has spent over 4.5 billion years in a deep freezer instead." And Bennu differs from rocks on Earth because its composition was formed far before the ones on Earth. For example, many space samples contain more iron than those found on Earth because they haven't melted to form the core of a planet.

Not only that, but Bennu, unlike meteorites that have been studied in the past, has stayed free from the influence that burning through our atmosphere and crashing onto the surface can have.

Targeting pristine asteroids, the way that OSIRIS-REx and Hayabusa-2 (another asteroid-sample return mission) have done, gives us a chance to analyze the samples that haven't been changed by interacting with terrestrial systems, which is really valuable," said Brennecka.

One process cosmochemists use to understand a sample is to take a rock, dissolve it in an acid, then perform chemical separations that help observe isotopes, which are like the fingerprints of different elements. These chemical signatures are distinct enough that scientists can tell when a compound was formed or how far away it was from the sun at its origin point. But it can be tricky when the samples are limited. The NASA mission collected about 120 grams of Bennu samples; LLNL received 0.5 grams.

"You can't easily go back and get more samples," said Brennecka. "Some situations, when you start an analysis, you get one shot. And that's it."

But 0.5 grams is more than enough — especially because cosmochemistry is a rapidly evolving field. "It's a golden period of cosmochemistry right now. We're

getting to a point where we can collect these materials, bring them back from space and analyze them in a lab on Earth," said Brennecka. "The material that NASA collected is designed to represent something like 50 to 100 years of study, because as the field keeps changing and technology gets better, we'll want to study it with that better, cutting-edge research."

In the future, cosmochemistry and other analyses of space material can help us understand more about our neighboring planets and those beyond our galaxy.

"It's important to preserve these materials so we can keep furthering our understanding. The Space Age before really inspired so many people to go into STEM (science, technology, engineering and mathematics), to do these hard things that no one's done before that help us learn more about the world," said Brennecka. "And it's important to do hard things. Not just for learning, but it's important for humanity to keep striving to understand what's out there."

> prisons across the country. The special master, Wendy Still, completed a report on the institution, but it has not been released.

Last month, inspired largely by the treatment of inmates at FCI Dublin, the U.S. Senate passed a prison oversight act that legislators hope will prevent the toxic conditions that resulted in the institution's shutdown from happening anywhere else.

The bipartisan Federal Prison Oversight Act, which previously passed the House of Representatives, was sent to President Joe Biden for his signature.

The act will require the Department of Justice's Inspector General to conduct comprehensive inspections of the BOP's 122 correctional facilities, provide recommendations to fix problems, and assign each facility a risk score. Higher-risk facilities will be required to be inspected more often.

history teacher with deep roots in Pleasanton and the Tri-Valley, the recognition was the honor of a lifetime.

"Honestly, I was so shocked, I didn't even know I was up for it (the nomination)," she said. "It felt wonderful to be recognized not only for my efforts but also while serving this wonderful community. It was amazing."

The honors come from the Gilder Lehrman Institute of American History, a nonprofit organization focused on American history education for students from elementary through high school. Based in New York, the institute was established in 2004 and annually recognizes history teachers from kindergarten to high school across the country with an

award for their contributions to American history education.

Orenberg is one of 53 national winners. She was awarded \$1,000 in prize money in addition to a selection of American history books and educational materials curated by the Gilder Lehrman Institute. She will also be recognized in a local, public ceremony sometime during the school year. As one of the state winners, Orenberg is automatically placed into a pool of all the state winners from which a national winner will be chosen later this year. The national winner will be honored in an awards ceremony in New York City and receive \$10,000.

"In times like these, history teachers play a critical role in shaping students' understanding of the past and inspiring hope for the future," said James G. Basker, president of the Gilder

Lehrman Institute, in a press release. "Their unwavering dedication to educating our youth is commendable, and we take great pride in honoring the most exceptional educators across the country."

Orenberg grew up in Pleasanton and attended PMS and Foothill High School. Today she lives in Dublin with her family, and while her love of history has always been intact, she said the support she received from the teaching community as she followed her path toward teaching was key to her success.

When she was in high school, Orenberg's father became ill. While he later recovered, Orenberg worked on securing as many college scholarships as possible as she was dealing with her family's situation and financial considerations. As the offers of financial support came in, she says most of

her awards came from the Pleasanton community.

"I wasn't necessarily the strongest student, but I was committed," said Orenberg. "And I kept saying to them (the scholarship panels) that when I come back, I'm going to teach in Pleasanton, and they believed me, and they believed IN me. ... I owe so much to this community. It's been a real full-circle moment."

And it is her contagious enthusiasm that continues to drive her. As a U.S. history teacher, Orenberg said it is not unusual for her to arrive to class in a period costume to engage her students on a particular historical topic or to create educational games to make the learning fun.

"Maybe they (the students) don't go on to be history teachers or historians, but the theme of government and civics, and that they are going to be able to participate in that process someday is so important," she said. "History and how it happens doesn't change, but our perception of it does, and if you can blow the dust off of it for students to see how it changes for them ... that's worth everything."

For now, as Orenberg enjoys the last days of summer, she remains grateful for the recognition and to those who helped her get there.

"It's been really lovely," she said. "I feel so lucky. I think the best part of it has been all the former families who have heard about it and shown their support. It's been really, really special and I am so appreciative."

the hotel opened in 2020. Delays, including two referenda and an initiative, postponed the project. In 2022, the city council authorized a new agreement with Presidio to pay back the loan with 3.5% interest when the hotel opened on the expected date of May 2024.

According to a city staff report, however, the project continued to face problems. The hotel has yet to be built.

"The COVID-19 pandemic had a damaging effect on tourism and business travel, which has resulted in reduced demand for new hotel development," the report said. "Following the pandemic, a prolonged period of economic inflation has resulted in increased costs for materials, labor, and capital, which has further challenged the developer's ability to deliver the hotel, and the related payments, in accordance with the original Schedule of Performance."

The amended agreement sets the new date as Dec. 31, 2027, and terminates the agreement with Presidio for the hotel if that date is not met. The developer must also pay for a market feasibility study and confer with the city to help it identify alternative projects if the study suggests the project is no longer feasible.

During public comments, resident Donna Cabanne questioned why the city would extend the timeline.

"The loan agreement has already been extended numerous times," she said. "The developer gets a loan taken out of the general fund at the expense of the taxpayers. This gift has gone on long enough. It's time to end the gift. Please require the developer to start construction by the end of the year or to get their own loan."

Resident Jean King encouraged the council not to vote to extend the agreement for a different reason.

"We need more information about this to say what is happening with the hotel," King said. "What is going to help us bring our hotel to Livermore?"

When the Tri-Valley Career Center was first founded in 2016, it operated under the Workforce Innovation and Opportunity Act (WIOA). The WIOA program was originally awarded to help people aged 18 and over by supplementing wages for adults to have experiential internships of short-term placements with employers. But Lindo's previous work in the youth space led her to push the Tri-Valley Career Center to open up to youth as well as their adult students.

### Regional Occupational Program

The career center recently partnered with the Tri-Valley Regional Occupational Program (TVROP) to expand a high school Certified Nursing Assistant (CNA) program. The pilot program started this past spring with five students, three of whom are now employed.

Not only are we providing them with this opportunity to support their families and support themselves," said Lindo, "but we're helping the Tri-Valley community that has expressed a need for more CNAs."

And students are feeling stressed, she shared. They think at age 15, they need to know exactly what they want

"And so, we alleviate those fears by allowing them to really explore, to get their feet wet and also gain certifications and make a nice chunk of change as a high school student," she said.

Julie Duncan, TVROP superintendent, said, "My job is to make sure we give students in the Tri-Valley the opportunity to have a career by choice and not by chance.'

ROPs are all over the state of California and have been for over 50 years. Their original intent was to help Vietnam Veterans gain access to training programs after their service. Their mission has evolved and so has some of the terminology Duncan helped redefine.

"You've heard of vocational ed," said Duncan. "That's an archaic term because it was, you know, these kids go here and these (other) kids go to college."

It's not like that anymore, she explained. Instead, TV-ROP empowers students to gain the skills and certifications in a variety of career pathways to choose what they like to do. Whether that's to earn a livable wage so they can afford college or move directly from high school into a well-paying job.

Panelist Monya Lane, CEO of Quest Science Center and a retiree of the Lawrence Livermore National Laboratory, said work-based learning gives youth the awareness of the possibilities for a future they might not otherwise have known about. For Quest that means bringing hands-on learning through fun, interactive activities and events to local learners who are interested in all things science, technology, engineering and

Lane shared an anecdote that speaks to Quest's purpose: A young boy was overheard saying, as he was leaving an exhibitor booth at their annual Tri-Valley Innovation Fair, "They told me I could work there someday."

The only traditional employer on the panel, Megan Craig, rail services coordinator for the San Joaquin Regional Rail Commission, leads a workforce development program called The Rail Academy of Central California. The program was developed in direct response to an aging workforce and evolving industry. In partnership with Sacramento City College, which acquired a federal grant from the U.S. Department of Education, graduates of the academy, currently in its pilot stage, would be able to enter an industry in just seven months.

'So this is huge, because high school students, by the time they graduate, are automatically able to enter into a career."

Craig added in closing, "I think that it's important to take care of our youth and provide these opportunities for competitive salaries and allow them to really grow within the community they grew up in, without (necessarily) going the traditional four-year university route."

# **Dublin Seeks Artist Proposals** For Basketball Court Murals

Dublin is soliciting proposals for temporary murals to be painted on outdoor basketball courts at four neighborhood parks.

The goal, according to the city, is to make the courts "more inviting and more fun" and "draw people to the parks."

Murals will be painted in the "keys," or free-throw lanes, at each end of the courts at Alamo Creek Park, Dolan Park, Schaefer Ranch Park, and Ted Fairfield Park.

The city will provide artists chosen for the project with paint and a sealant for outdoor basketball courts.

Murals must be created by professional artists or students

Jan's celebration of life will be held at New Beginnings Church, 170 Lindbergh Ave., Livermore, on August 3, 2024, at 4 p.m.


### CELEBRATION OF LIFE James Lee Steinhaeur

# **LLNL Physicist Discusses the Future of Fusion**

Tammy Ma, a physicist at the Lawrence Livermore National Laboratory (LLNL), posed a question during a TED Conference talk this spring in Vancouver, Canada: "What would you do with the largest laser in the world?'

Ma's answer was to make non-polluting laser-based fusion energy available to the world, which she said is now feasible after LLNL demonstrated fusion ignition for the first time in late 2022.

"Our team at LLNL demonstrated fusion ignition for the very first time in human history," Ma said. "We generated a controlled thermonuclear reaction in the laboratory that generated more fusion energy than the laser energy needed to spark it."

Ma is now spearheading efforts to establish commercial fusion energy based on LLNL's approach.

By harnessing what's known as inertial fusion energy (IFE), Ma said a new kind of power plant could create usable energy from lasers firing onto hydrogen fueled targets at a rapid rate.

When those targets ignite, Ma said, they would give off more clean fusion energy than was used to create the reaction, and unlike nuclear fission power plants, fusion ignition does not result in long-term waste.

"When we make fusion energy a reality, energy will become so plentiful that it will no longer be a limited resource," Ma said in her talk. This will change the world as we know it.'

She said LLNL has repeated the successful 2022 experiment four times.

However, she added, fusion is incredibly complex and difficult, and significant scientific and engineering hurdles remain.

Following LLNL's successful demonstration two years ago, governments across the world have ramped up their efforts and newly formed private fusion companies have joined the pursuit, according to Ma.

'The depth and breadth of this challenge will require sustained investment from government and private industry and all of us working together," she said. "I don't know how exactly long this will all take, but I do know that we can do it.'

# **Livermore Ranch Receives Audubon Society Bird-Friendly Designation**

The 3 Calhoun Sisters Ranch in Livermore is now a National Audubon Society-certified bird-friendly habitat.

Managed by sisters Nancy Calhoun Mueller, Susie Calhoun, and Merry Carter, the ranch is enrolled in the society's voluntary Conservation Ranching program, which announced the bird-friendly designation this week.

The Calhoun family has been ranching on Mines Road in the Livermore Valley since the early 1900s.

The sisters can now use the Audubon bird-friend seal to market their grass-fed Circle H Beef

'The biodiversity of our ranch, the open grassland, the oak woodlands, and the riparian areas create an environment where birds and cattle can thrive," said Mueller, who lives on the property with her husband and oversees the cattle operation. "We are privileged to be in partnership with the Audubon Conservation Ranching program."

Since assuming management of the family ranch in 2018, the Calhoun sisters have dedicated themselves to improving the habitat value on the property, according to the Audubon Society. That has included upgrading the ranch's infrastructure to improve livestock rotation, restoring native plants, and supporting research initiatives.

Grace Ferguson, a range ecologist with Audubon California, guided the Calhoun sisters through the bird-friendly certification process.

"The grazing strategy includes medium- to high-intensity grazing in smaller pastures to allow for extended rest periods," Ferguson said. "Under this grazing strategy, the Calhoun sisters are able to maintain a mix of short and tall stature grasses for species like Western meadowlarks and lark sparrows, patches of shrubs for the California quail and spotted towhee, oak savannah for Western bluebirds and acorn woodpeckers, and healthy riparian vegetation for ash-throated flycatchers and black-headed grosbeak."

Owen Sowerwine and Farley Connolly, with the Alameda County Resource Conservation District, also created a habitat management plan for the ranch property.



# **Proposed Dublin Place Designs Criticized, Put on Hold**

By Ruth Roberts

The Dublin Planning Commission has hit the pause button on the Dublin Place Shopping Center project over concerns about its layout and architectural design.

In a unanimous vote during its regular meeting on July 23, Commission Chair Stephen Wright cited the project's outdated parking design, lack of overall attractiveness, and unanswered commitments from some of its anchor stores as reasons for not approving the applicant's request for a site development review permit.

The permit is required for the demolition of two commercial buildings at the southwest corner of Amador Valley Boulevard and Amador Plaza Road, and the subsequent construction of a new multi-tenant building. The relocation of tenants and reconfiguration of the existing site are the

first steps involved in the treatment, removal of the revitalization of the city's downtown plan.

"I don't know what to tell you except that I think you need to go back and figure out a way to hammer away at this or come up with a different design, because I don't sense any excitement about this,' said Wright.

The applicant, Hines, a real estate development company, wants to tear down the existing buildings, which total 28,800 square feet, and build a new 33,125 square-foot multi-tenant building at the shopping center.

The new building would continue to host the center's current tenants, including PetSmart, Panera, Chipotle, BMO Bank and Yafa. According to the applicant, Target has recently signed onto the plan.

The project also includes site upgrades such as an updated parking area with stormwater

northern driveway to Amador Plaza Road, shifting of the southern driveway on Amador Plaza Road to align with the new drive aisle, and improvements to the drive aisle leading to the intersection of Amador Valley Boulevard and Donohue Drive. The project site is in the Downtown Dublin Specific Plan and has a General Plan land-use designation of Downtown Dublin-Retail District, which allows for a range of residential and

For the project to proceed, the current tenants must agree to be relocated. Josh Brodsky, portfolio advisor for American Realty Advisors, the landlords of the project, said Target has agreed to move and several other retailers are still in negotiations. But PetSmart, whose lease runs out in 2036, is proving the most challenging currently, with a laundry list of requirements to

commercial uses.

move including visibility from the street and proximity to Target.

"PetSmart doesn't want to move, so they need incentives," said Brodsky. "And we, as landlords, have to pay for this. ... They can stay until 2036; they don't have to agree to move."

The retail district's architectural vision, per the staff report, and as set out in the Downtown Dublin Specific Plan, emphasizes that new buildings should harmonize with existing ones, ensuring compatibility with adjacent structures and the district overall. The structures are expected to use high-quality materials and feature creative, unique designs.

Commissioner Wahida Rashid said the project's design as presented was outdated and unappealing.

"We are really trying to make Dublin and Amador boulevards a pedestrian- and bicycle-friendly city," said Rashid. "But this whole idea about a giant paved parking lot in front of stores is so 70s, so it just doesn't seem

very progressive thinking in terms of design. People are very excited about this downtown. ... I think we can do better."

Commissioner Renata Tyler agreed.

"This is supposed to be a town square and we are getting a strip mall," she said.

The applicant can appeal the commission's decision or return with a new design.

Brodsky said the team would regroup and reach back out to the commis-
