# County Road 5 roundabout comes in under estimates

Isanti City Engineer Jason Cook's gamble of calling for bids for the County Road 5/East Dual Blvd roundabout project "late" in the year paid off big-time as all six returned bids came in under the engineer's estimate.

Normally, government entities call for road construction bids in late winter or early spring, with bids being awarded so construction can begin during the spring in order to

fully utilize as much of construction season as possible. After talking with a few contractors, Cook predicted the city could receive favorable bids in June, with construction not beginning until late July but still concluding before the first snowfall.

Asphalt Surface Technologies proved to be the low bidder, coming in at \$1,103,947.75. That amount is just over \$400,000 lower than the engineer's estimate.

To make the news even better, that

# **South Main Street** reconstruction starts soon

Despite a delay in awarding a contracting bid, the Cambridge South Main Street reconstruction project, which includes adding a roundabout, will still be performed this summer.

According to City Engineer Greg Anderson, preliminary work on the project will hopefully begin before the end of June. He added the portion of the project that directly impacts traffic in the area will most likely begin towards the end of July. Reconstruction will start closest to the Highway 65 intersection and work its way north since that first section, which includes the roundabout at the intersections of

Kwik Trip's entrance/ exit and 40th Ave SW, will most impact traffic.

Besides the roundabout, the major component of the project will be decreasing the number of lanes from two in each direction to one, plus a center left turn only lane. There will also be a walking/biking path constructed on the western side of the road from 40th Ave SW to 24th Ave SW.

Originally scheduled to be opened and awarded at the beginning of May, the winning bid for the project was just awarded by the Cambridge City Council during its June 16 meeting. Douglas-Kerr Underground LLC, out of Mora, had the lowest bid, at \$6,079,234.41. This amount is nearly \$900,000

under the engineer's estimated cost. Additionally, Douglas-Kerr had the lowest bids for two alternate projects, which, at the council's discretion, would be completed at the same time as the main project.

Those two alternate bids were for constructing Garland Street and a parking lot for the pickleball courts in Heritage Greens, plus the construction of a parking lot off Central Drive for people using the Cambridge-Isanti walking/ biking path.

When adding up the three bids, the total cost of the project -\$6,845,727.62, it still comes in under the engineer's estimate for only the main project.



# Cambridge approves purchase agreement with New Pathways

The city of Cambridge has officially agreed to sell a piece of land to New Pathways for one dollar, paving the way for the non-profit organization that provides services to homeless families to construct a nice, new home of its own.

Previously, the council tentatively agreed to sell the city-owned land located in the southwest corner of Heritage Greens under the condition the organization acquired enough funding to begin construction in the near future.

Recently, New Pathways announced it was three-quarters of the way towards raising the \$3.5 million needed to construct a building that would house twice as many families as it currently does. Plus, the new building would offer a location for those families to stay 24/7, rather than spending nights in various churches and being transported to the organization's current location on Ashland Street in Cambridge during

the day.

A second condition of the purchase agreement is New Pathways would pay for the leveling of the ground in the entire area, plus putting in a larger holding pond. The city will maintain ownership of the land directly to the north and south of New Pathways. The land to the north will be turned into a parking lot for the pickleball courts and Heritage Greens playground. Construction of the parking lot is now included in the South Main Street reconstruction project (see article on page 1).

The land to the south will continue to be offered for sale by the city.

The purchase agreement with New Pathways, subject to final approval by the city administrator and city attorney, was approved 4-1, with Council member Molly Christian casting the lone nay vote.

# Cambridge Farmers Market to make short move

The Cambridge Farmers Market will follow in the footsteps of Isanti's Neighborhood Market by making a short change in locations. However, this move isn't by choice.

According to City Administrator Evan Vogel, the farmers market is being forced out of its current location by the new owners of City Center Market. Not wanting to move too far away from the location where it has been held for many years, organizers of the farmers market asked if the weekly Saturday event could be held in the staff parking lot in front of City Hall.

Vogel admitted a request such as this to use the City Hall parking lot has not been made before. Therefore, there is no precedence as far as willingness by the council or fees/conditions that would be imposed.

Cambridge Farmers Market Treasurer Anthony Smith said they

currently don't pay a fee to use the parking lot in front of City Center Market, however, they understand that since they have to move, it might mean they will start being assessed a fee wherever they wind up moving to. He added the new owner wants them to move "as soon as possible."

Currently, the farmers market does use the hallways of City Center Mall for markets during the wintertime. According to Vogel, non-profits are not charged a fee for that, however, a damage deposit is required.

After a brief discussion, the council unanimously agreed to start letting the farmers market use the parking lot immediately as long as it can provide proof of insurance. An additional condition is neither vendors nor customers will park blocking the Fire Department's emergency lane. The council also authorized city staff to draw up a formal contract for both parties to sign.

# Planned Unit Development approved for Cambridge Shores

The housing portion of the Cambridge Shores project, located on the former Munkberg farm property adjacent to Lake Fannie, is one step closer to becoming a reality after the Cambridge Council approved a Planned Unit Development and Conditional Use Permit request from the developer.

According to Community and Economic Development Director Marcia Westover, Centra Homes is proposing constructing a total of 311 single-family homes in a mixture of three different styles in its 121.5-acre portion of the property. That number of houses means each property would be smaller than what zoning would normally allow, thus requiring the PUD and CUP.

"All the developers want to have smaller parcels," Westover said. "It's not just Cambridge that is facing this. It is happening everywhere. The cost to build and infrastructure is too expensive so they're shrinking the lot size to make them more affordable."

At the same time, Westover acknowledged these proposed lot sizes aren't that far off from other housing developments in Cambridge.

"We have had a history of planned developments with smaller lots," she said. "We can find them in the Parkwood on the Lakes area, Bridgewater, Heritage Greens, Maple Ridge Townhomes, Joe's Lake Townhomes, and most recently Cambridge Cove."

She said during the recent public hearing during the Planning Commission meeting, they had a "robust" discussion between the commissioners and residents and non-residents in attendance before ultimately unanimously recommending to approve the

PUD and CUP.

Besides the smaller lot sizes, the biggest area of concern was the increased traffic the housing development and the proposed lakeshore park would bring to the area.

"We will have to build something (to handle the increased traffic)," Westover said. "But we are just trying to figure out the timing of all of that."

She added a street improvement project is planned for a couple of the streets leading into the area in 2027, so that would be the time to address those traffic concerns.

Ultimately, the council approved the requested PUD and CUP on a 4-1 vote, with Council member Molly Christian casting the lone nay vote.

# CONDUIT BONDING APPROVED FOR APARTMENT COMPLEX

In other housing-related action, the council gave formal approval for the possible issuance of conduit bond financing to Reuter Walton for the construction of a two-building, 180-unit apartment complex just north of the former Perkins Restaurant property.

Conduit bonds provide lower interest rates as a city acts as a "middleman" for the loan. The city bears no financial responsibility for the repayment of ne Ioan.

According to Westover, the project is now slated to be constructed in two phases, with each phase having one 90-unit building constructed.

The next steps are for Reuter Walton to apply to the Minnesota Management and Budget office for final approval of the conduit bonds. After that is approved, the city must annex the land into the city limits. Finally, Garfield St. North would need to be extended, plus the extension of city utilities. Those would be done at the developer's expense. Because of that, the developer would also ask for Tax Increment Financing to cover those extra costs.

The approval of issuing of conduit bonds was also approved 4-1, with Christian again casting the lone nay vote.

# Tips for maintaining a low maintenance lawn

- Set your mower at 2.5 inches or higher to promote deeper roots.
- Water only when it is necessary.
- If watering is required, it is best to water between 4 a.m. and 8 a.m. to reduce water loss due to evaporation or wind.
- Water deeply and infrequently.
- Depending on soil type and air temperature, lawns need only a quarter inch to one inch of water (minus any rainfall) per week.
- Sandy soils may need to be watered 2-3 times per week but with less volume each time.
- Clay soils need to be watered only 1 time per week.
- Install a rain sensor, a soil moisture sensor or a smart irrigation controller as

# Developer gets go-ahead for single family homes in North Branch

Single-family homes are now an option for high-density residential areas in North Branch, with the city council unanimously passing an update to allow them in areas previously reserved for multi-family buildings only.

The issue was raised by developer Kris Caroll, who plans to develop the vacant land just west of Interstate 35, across Falcon Avenue from the Wildridge communities, and south of the Ecumen facilities and furniture stores.

The planned Cedar Ridge Community meets the density requirements of six units per acre for R3 zoning with a mix of apartments and single-family homes.

The preliminary plat for the develop-

ment was also approved.

Community Development Director Nathan Sondrol and his staff analyzed nearby communities' zoning for reference: Isanti, for example, does not allow single-family homes in their equivalent to an R3 district, while Cambridge does. Council member Patrick Meacham pointed out the lot sizes for twin homes in the Schoolside Village development are the same size as the ones proposed for single-family homes in Cedar Ridge. Twin homes were already allowed in R3 before the change.

"If we only have a minimum density to hit, what does it matter what type of home it is?" Meacham said.

Carroll plans to divide the 62-acre parcel into 75 small single-family home sites, three apartment buildings containing a total of 167 units, and seven additional outlots "which will be for future commercial development or stormwater ponding depending upon the location of the parcel," according to the staff report.

Caroll told council she would like to start the project in July, and she now has the needed approvals to do so.

Caroll initially thought single-family homes were permitted on the site due to a prior conflict in city code. While the zoning code did not officially permit

building of single-family homes in an R3 district, the section dedicated to design standards for all types of districts includes standards for single-family homes located in an R3 district.

The council considered the issue after some confusion over plans for the project, and after the developer updated plans in order to meet landscaping and other requirements. In the process, residents of the Wildridge developments expressed disdain for building housing on the site, especially apartments.

Multiple council members and the mayor pointed out the land, while long vacant, is already zoned for apartments and has been for quite some time, meaning the owner has the right to develop it as such.

"If residents wanted to stop it," council member Jeff Goulet said, "they could have bought the land."

Mayor Kevin Scheiber also referenced some Wildridge residents proposing a physical barrier between the new development and their community, which he said would have to be the responsibility of the people wanting to separate their properties from new development and not, as some residents suggested, the builders.

"I don't know how the city can expect a developer to put up some type of a barrier when they have a legal right to build," Schieber said.

The new housing will directly abut vacant commercial land that will remain spacious enough for several "big box" stores, according to council.

Building standards will remain subject to change as the city updates its comprehensive plan for the first time since 2018, with Schieber suggesting increased lot setbacks to allow for more green space between new buildings.

The council discussed increasing the setback from six to 10 feet, a move that would require a public hearing and possibly a supermajority vote, before agreeing to keep it under consideration alongside conversations about updating the strategic plan.

Initially A.I. will create new jobs in the design, manufacture, and installation process, but long term it will eliminate jobs in all sectors of our economy.

We must bring back manufacturing jobs to the U.S. and hopefully the tariffs will do just that. We need to kickstart trade schools to attract more students, especially in electronics. Create incentives for manufacturers to kickstart start-up process. Create incentives to research and patent A.I. technologies. Open up mining in the areas of land permits and mining of minerals for the manufacture of chips and other electronic technologies.

# Caretaker peace of mind

uestion: I thought I heard something about a new law in regards to caretaker information included on driver's license or identification card record. Do you have any information on this?

Answer: You can now use your Driver and Vehicle Services (DVS) records to let law enforcement know if you're the caretaker for someone else. That way, if you are

involved in a crash, law enforcement officers will know that there is someone at home who depends on you. They can quickly respond and ensure that the people you care for are not left alone. The new law gives you reassurance that your loved ones will be taken care of if something happens, reducing your anxiety and stress about leaving them alone.

# Propagating perennial plants

I can't think of any gardener that doesn't want more plants. I think the majority of us want them as cheaply as possible. This is where knowing plant propagation methods is useful.



Propagation is generally done following one of the following methods:

1. Growing plants from seed. Saving seeds from existing plants is easy and free. Research the germination requirements for each plant variety. Many natives require a vernalization (chill period). Unfortunately, if the plant is a hybrid variety the seed will revert back to one of the original parents rather than the hybrid. I harvested seeds from yellow petunias and planted them. I ended up with 4 flats of beautiful

purple petunias. Not one was yellow! Some plants can take years to grow from seed to the point of flower. Plants like American wisteria and peonies can take up to 7 years from seed germination to flower. You can also create your own hybrid by cross pollinating plants by hand. I have benefitted greatly from my sister's hand pollination of daylily varieties.

2. Plant division is also a common method for obtaining new plants. This requires digging the plant and dividing the root system. Most perennials require division to every few years (3-5) to remain strong, healthy plants. The following site has excellent instructions that break down the process based on the type of root system. https://hgic.clemson.edu/factsheet/dividing-perennials/ A downside of this method is the possible transportation/spread of invasive species like jumping worms or Japanese beetles (eggs are in the soil). Extra effort must be made to remove all existing soil before transporting the division to another location. Also beware of "hitchhiker" plants that may have their own root system intertwined with the plant being divided. Some plants like goatsbeard (aruncus dioicus) or Alchemilla mollis (ladies mantle) can have such a dense root ball that it can require a hatchet to split it! Division of perennials is best done in early spring or fall.

3. Soft tissue propagation is an alternative option for hybrid varieties or plants that take a significant number of years from seed to flower. Early summer is the perfect time to take cuttings and start the process of rooting new plants. The internet has a lot of videos and sites on how to do this. Search for information on the specific plant. This is easier than digging the plant up and dividing the root mass. Don't expect all the cuttings to root Dipping the base of the cutting into a rooting compound can improve the results. Be patient. check the cuttings frequently to ensure they're not too moist or too dry. Like Goldilocks, they want the environment to be "just right".

I have found that it's easier to ask someone for seeds or soft tissue cuttings than asking them to divide the plant. After attempting to propagate plants, I've gained a better appreciation for nurseries and the amount of time and effort expended to bring a plant to the onequart pot size.

# Cambridge Farmers Market receives grant to boost nutrition access

The Cambridge Farmers Market will receive a \$2,170 grant from the Minnesota Department of Agriculture (MDA) to strengthen its nutrition assistance programs during the 2025 season.

The funding, part of a onetime \$146,669 appropriation from the state, is designed to help farmers markets across Minnesota expand access to fresh, locally grown food for residents who rely on programs like SNAP and WIC.

"Farmers' markets help bridge the gap between producers and families seeking healthy, affordable food," Minnesota Agriculture Commissioner Thom Petersen said in a statement.

The grant may be used to cover costs such as staffing, outreach materials, EBT to-



kens, or transportation assistance—tools that support the smooth operation of nutrition assistance at the market.

Cambridge is one of 29 markets statewide selected through a competitive review process. Markets were required to be located in Minnesota and participate in at least one nutrition assistance program to qualify for funding. More information about the

# Talking active kids with the University of Minnesota

Katie Schuver, a lecturer in the School of Kinesiology, discusses why it's important for children to stay active over the summer.

Q: Why is physical activity important for kids? Schuver: While it might just seem like a way to burn off energy, regular movement plays a powerful role in child development and has the potential to impact everything from physical health to emotional well-being and academic success. Regular physical activity helps build strong muscles and bones, supports a healthy weight and improves cardiovascular health. Additionally, studies show active children tend to perform better in school, as it improves concentration, memory and behav-

Perhaps most importantly, encouraging kids to be regularly physically active at a young age lays the foundation for a lifetime of healthy habits and may reduce the risk of chronic diseases later in

Q: Are there mental health benefits associated with physical activity?

Schuver: Research suggests regular physical activity for kids can boost mood and reduce anxiety while improving sleep. Socially, physical activity offers opportunities for connection and growth. Whether it's a game of tag, an organized team sport or a dance class, these interactions help children develop communication skills, teamwork and confidence, which can impact mental health

Q: What tips do you have for encouraging kids to be active during the summer?

Schuver: When it comes to keeping kids active, variety, fun and age-appropriate activities are key. According to the Physical Activity Guidelines for Americans, children and teens ages 6 to 17 should get at least 60 minutes of moderate-to-vigorous physical activity daily. For preschoolers aged 3 to 5, the goal is to stay active throughout the day with plenty of movement woven into play. Here's the good news: staying active doesn't have to mean structured workouts or rigid routines. Research shows kids are far more likely to stay engaged when physical activity feels like play.

Think water balloon battles, backyard obstacle courses or nature scavenger hunts — these aren't just fun, they're powerful tools for boosting physical health and sparking creativity. For younger children, simple activities like hopping, climbing, dancing and imaginative games can provide all

the movement they need. To keep energy levels high and boredom at bay, break activities into short, manageable bursts of 15 to 20 minutes and prioritize outdoor play whenever possible. Limiting screen time and giving kids a say in what they do also helps build lasting motivation.

Q: How can families support staying active? Schuver: Parents and guardians are powerful role models when it comes to shaping children's attitudes toward physical activity, and the most effective way to inspire movement is to join in. Being active together doesn't just benefit physical health, it also strengthens emotional bonds and has the potential to create lasting memories. Whether it is a morning walk around the block, a weekend bike ride or a spontaneous living room dance party, these shared moments turn exercise into something joyful and deeply connected.

When kids see their caregivers participating enthusiastically, regardless of age or ability, it sends a powerful message that movement is for everyone. It's not about perfection or performance, it's about showing up, having fun and making activity a natural part of daily life.

Creating a home environment that encourages movement is important and easier than you might think. Keep jump ropes, balls and other play gear within easy reach. Replace some sedentary screen time with fun, movement-based activities that your child enjoys. Set aside time each day for active play and give children a say in what activities they do. Encourage outdoor play whenever possible.

Q: How does your work focus on kids' physical

Schuver: My teaching in the University of Minnesota's School of Kinesiology concentrates on the development of evidence-based strategies and programs to promote active lifestyles and healthy habits across the lifespan. My areas of interest include health promotion, physical activity, exercise and mental health, mindfulness-based strategies for health promotion, and physical activity interventions for mental health promotion and co-occurring disorders.

# New boat operator education requirements begin July 1

Beginning July 1, 2025, more people who operate motorboats or personal watercrafts on Minnesota waters must obtain a valid watercraft operator's permit. The updated requirements, passed into law during 2023, are intended to make boating safer by ensuring people operating motorized watercraft know the rules and are properly trained.

Initially, the law applies

•People who were born after June 30, 2004, and are aged 12 or older.

·Anyone who wishes to serve as an "accompanying operator" for people without a valid watercraft operator's permit, or for people under the age of 12 and not eligible to obtain a permit.

Individuals who wish to rent/operate motorized rental watercraft.

 People who already possess a valid watercraft operator's permit from Minnesota or another state do not need to obtain a new permit to meet these requirements. The requirements will incrementally include more people over time. When the law is fully implemented on July 1, 2028, all motorized watercraft operators born after June 30, 1987, will be required to have a valid watercraft operator's permit. Boaters born before July 1, 1987, generally are not required to obtain a watercraft operator's permit.

Instances in which people born before July 1, 1987, need a watercraft operator's permit include: If they're an "accompa-

nying operator" and allow youth or person without a watercraft operator's permit to operate a motorboat. Accompanying operators must be 21 years of age or older; in the boat or on the personal watercraft; within immediate reach of the motor controls; and possess a valid operator's permit or be an "exempt operator" (possess a valid U.S. Coast Guard license for maritime personnel, for example).

If they're renting a motorized watercraft. Renters must be 18 years of age or older and possess a valid watercraft operator's permit.

"Minnesota has a long and proud tradition of safe outdoor recreation, and a key part of that is safety education," said Capt. Adam Block, DNR boating law administrator. "While this new law won't initially apply to many boat operators, we still encourage all boaters - regardless of their age - to obtain their watercraft operator's permit."



bid means that all of the direct construction costs will be covered by the \$1.5 million local road improvement project grant. The remainder of the costs, such as engineering, design, land acquisition, etc. will be split between the city and the county, with Isanti County picking up two-thirds of the cost and the city of Isanti picking up one-third of the costs.

According to Cook, the city's new estimated "out of pocket" cost for the entire project will be \$170,000.



"We had originally budgeted for \$500,000," Cook said. "That's just great numbers all-around, plus getting it finished this year.'

While Isanti County Highway Engineer Justin Bergerson wasn't willing to publicly state what the county's costs will be, based on Cook's estimate, it should be around \$340,000. The county will be using ARPA savings to fund its portion of the project.

Since this is a joint project between the city of Isanti and Isanti County, both government entities needed to approve the same bid. Both unanimously did so on Tuesday, June 17.

# Cambridge man faces charges for kidnapping Pine City group home resident

A Cambridge man, Dean Michael Simonson, 58, is facing felony kidnapping and first degree burglary charges in connection to an incident occurring at a Pine City group home.

According to the criminal complaint, Pine County Sheriff's Office deputies responded to a report that Simonson came to the group home on June 10 around 6 a.m., where he worked but was on medical leave.

According to the report, Simonson came into the group home, woke a resident up and left with the resident in Simonson's truck at a high rate of speed, without gaining permission to take the resident from the home. The resident was reported to needing round-the-clock supervision and is a vulnerable adult.

Law enforcement learned that Simonson was at a nearby car dealership, and cleaning staff reported that Simonson was banging on the door while arguing with the group home resident.

Before officers arrived, Simonson left with the resident in his truck. Law enforcement located the truck driving at a high rate of speed. A deputy positioned his squad car behind the truck and initiated lights and sirens. Simonson did not immediately stop and turned onto another road before stopping abruptly in the middle of the road.

According to the complaint, Simonson got out of the truck yelling that he was going home, adding that he owned the road while refusing to follow commands from law enforcement. Simonson also yelled that he was the resident's father but is not his father.

The resident was shaking and visibly frightened. The resident told law enforcement that Simonson woke him up and told him to go with him because he had something to show him, assuming Simonson had permission to take him.

The resident reported that Simonson intended to try to switch cars at the dealership but the dealership was closed. The resident reported that the group home manager repeatedly tried to call Simonson, but Simonson refused to take the call and threw the cell phone out the truck window.

The resident observed the squad car lights and told Simonson to stop, but Simonson refused and insisted he owned the road, according to the report.

Officers arrested Simonson, and it took several officers to assist him into the squad car due to resistance. Law enforcement later located Simonson's broken cell phone on the side of the

A group home employee reported that someone had called earlier in the morning claiming to be the resident's father, "ranting and raving" about wanting his son. Shortly after the call, Simonson "busted" into the house and took the resident posing as his father.

According to the complaint, Simonson dropped a notebook when taking the resident that contained statements another resident had said. Another employee reported that Simonson had been sending them erratic text messages with conspiracy theories related to other employees. Simonson's family had requested a welfare check on him as well based on nonsensical communication throughout the night.

The messages included a video of Simonson telling a relative to follow instructions or "someone will die." In the background of the video was a list of group homes and names. The messages included Simonson praising the kidnapped resident.

The felony kidnapping (for ransom, reward or as a shield) charge comes with a maximum prison sentence of 40 years and/or a \$50,000 fine. The felony first degree burglary charge comes with a maximum prison sentence of 20 years and/or a \$35,000 fine. Simonson is also being charged with fleeing a peace officer in a motor vehicle which comes with a maximum jail sentence of three years and one day and/or a \$5,000

Simonson's past criminal record includes a disorderly conduct conviction from 2003, along with minor traffic violation convictions.
