On an early Friday morning, the Cambridge Library basement fills with the sweet

aroma of cinnamon rolls. Thirty volunteers are bustling about setting up breakfast for the soon-to-arrive high school students. As the 150 students from Cambridge-Isanti High School start streaming in around 7 a.m., they are greeted by volunteers offering hugs to everyone coming through the door, which are happily reciprocated. The volunteers at the C-I Breakfast Club are there to serve their youth, showing them the importance

of community and how they are

through Jake and Christy Venada of St. Michael, who formed the first one in the basement of their home in 2014. According to their website, their goal was to create a space for high school students to enjoy a full breakfast and hear a teaching from the Bible. Since their first Breakfast Club, the Venadas have helped many groups start up throughout Minnesota and in other states. One of those such groups was started by Aminta

Geisler in Spring Lake Park six years ago.

"We took their formula and implemented it, and since then, with my nonprofit, I've been able to help start 10, so it's really been fun," stated Geisler

A series of unfortunate situations with high school kids where depression took over was what moved Geisler and her friend to form their first Breakfast Club in Spring Lake Park. They decided to help combat these issues by creating a space where students can experience how much they are cared about in their community.

"We need to do something so the kids know that people care about them, so there's hope. You know, they're supposed to be the most connected generation because they have those phones. Still, the phones are actually isolating, so to be in person...and we're really intentional about giving hugs and

giving high fives, looking them in the eye and telling them we're glad they're here. So, by the time they leave, they know it matters to be in person and actually together, not just over a phone...and food just brings everybody together, right?" Geisler stated.

# Veterans Administration eying Cambridge for new clinic

While nothing has been formally put to paper yet, positive signs have been sent that Cambridge might become the location of a new Veterans Administra-

According to Cambridge City Administrator Evan Vogel, the VA has been looking at a number of properties within the city limits that might meet its needs for a VA clinic. Vogel said the property chosen would have to be large enough for a 20,000 to 30,000 square feet single-story building, plus at least 155 parking spaces. He explained the prop-

erty would be purchased by a private developer who would also construct the building for the VA to lease on a longterm basis.

"This is encouraging and very exciting," Vogel said of the prospects of a VA clinic opening. "Cambridge is in a little bit of a desert as you don't see another VA until you get up to St. Cloud, down to the metro area, or north to Duluth. This is a real opportunity to enhanced service opportunities for veterans in the area."

While no specific timeline has been established, Vogel said the VA has set

# Illuminate Isanti's future dimming

The Isanti City Council is on the verge of pulling the plug on Illuminate Isanti, the city's three-year-old Christmas lighting event, due to increasing costs and decreasing revenue.

According to Isanti Community Development Director Stephanie Hillesheim, 2024's event, which for the first time was open the entire month of December and featured no admission fee, only garnered \$9,798.74, with \$9,000 of that coming from business sponsors and the remainder coming from donations from attendees.

At the same time, Hillesheim said the total expenses to put on the event this year came to approximately \$60,000, meaning the city lost approximately \$50,000 putting on the event this year. Of those expenses, a majority of the cost (approximately \$39,000) came from paying Public Works staff overtime and hiring a couple of seasonal staff members

exclusively for putting on the event.

Hillesheim added the staff time turned out to be higher than anticipated due to the increased amount of maintenance needed to keep the displays working properly for the entire month, plus adverse weather conditions that damaged some of the displays.

"Leaving the stuff out there for a long time just added to our hours,"

# **BREAKFAST CLUB:** Participation caused meeting to move to larger location

### STARTING C-I BREAKFAST CLUB

Having moved to the Cambridge community this past summer after her husband Ben took a position as the head football coach and science teacher at the Cambridge-Isanti High School, they felt it was essential to get involved in the community they lived in. With the help of many volunteers, Geisler launched the C-I Breakfast Club in October of this past year.

"So many people reached out and were like, 'Are you going to start a breakfast club up here?', and only if I could get a team together...because it really is a team effort, it's not just one person, it's a village," said Geisler.

The breakfast club is 100% volunteer-funded, and all the donations go directly to purchasing food. The club relies on contributions from local businesses and community members to make this happen twice a month.

"We've had over 40 businesses and individuals donate to the breakfast club already, which is unbelievable and says a lot about the Cambridge community. I think they are caring and believe in their young people, so that's been amazing," said Geisler. It costs about \$7 to \$8 per student to provide food, which is quite an investment, with roughly 160 to 180 students attending each break-

The C-I Breakfast Club quickly outgrew its first meeting space at the Party Room in downtown Cambridge back

in October, forcing them to find a new meeting location, which turned out to be the Cambridge Library.

'The very first time, we blew the capacity of that, so we met there one more time, and you couldn't even walk through the room because it was so full," stated Geisler. "It has had tremendous growth. Breakfast Clubs typically grow slower, so for us to start and be at this point already, it has taken most breakfast clubs four to five years to get to this point, so it has been super fun that in three months we got to this point."

Students can expect a full-course breakfast complete with Breakfast Club's signature food, Monkey Bread. They offer a variety of other food, including cheesy potatoes, sausage, bacon, fresh fruits, donuts, yogurt parfaits, and an assortment of drinks. It's all free due to the community's support, and students can take as much as they want and come back for seconds. After eating, they get a short, inspiring message to give them hope, letting them know how valuable they are and that people care about them and God cares

"I think it just shows kids are just looking to belong," Giesler said when talking about their attendance numbers, "They want somewhere to belong, and everyone belongs at Breakfast Club. That's the phrase we talk about a lot. It doesn't matter what's going on in your life, whether it's going well or bad.

If you're doing well in school or doing poorly, making good or bad decisions, you belong here. We love you. Please come. I think that message is, 'We're glad you're here; it's OK to be you, and we'll love you as you are.' The Venadas, who started it, their tagline is, 'Feeding Bellies and feeding souls,' and that's what we do," Geisler said.

### **COUNCIL DECLINES ORDINANCE CHANGE**

The Cambridge City Council is holding firm on its regulations for the maximum weight of vehicles able to park in driveways within the city limits.

it will start in cold weather, plus it makes it difficult

for him to wash it on weekends. According to Community Development Director

Marcia Westover, the Planning Commission recommended denying the ordinance amendment request, or at most making anyone wishing to park larger commercial vehicles on their property obtain an Interim Use Permit from the city.

During discussion, the council's primary concern was what kind of damage these heavier vehicles would inflict on city streets. Additionally, Councilmember Aaron Berg was concerned about neighbors being subject to having to hear the louder engines running especially when warming them up in the winter.

Ultimately, the council voted 4-1, with Mark Ziebarth casting the lone nay vote, to reject amending the ordinance and to take no further action in terms of allowing for an IUP request.

# Environmental Assessment Worksheet available for proposed Cambridge park, housing development

The City of Cambridge is proposing a City park and a new single-family residential development. The property is approximately 119 acres.

The park will comprise approximately 35 acres and the residential development 84 acres. The park is planned to incorporate a swimming beach, playground, event center, parking lot, and open space with a trail system.

The residential development is proposed to have 336 housing units. Of these, approximately 78 units will be allev loaded homes and 258 traditional front-loaded homes. The residential development proposes city streets, open space, and stormwater requirements.

As part of the project development process, an Environmental Assessment Worksheet (EAW) has been prepared and will be available for public and agency review and comment beginning January 28, 2025.

The EAW identifies the project purpose and need and identifies potential social, economic, and environmental effects. The EAW is available for review at the following locations:

# **Get to work before** everyone loses

n this ongoing battle between the Minnesota House of Representative Democrats and Republicans, each party has now posted a legal victory. First, it was the Republicans who prevailed in their claim that Governor Walz jumped the gun in declaring a special election

for the vacant District 40B seat. Walz declared the special election would be held on Jan. 28, however, the court ruled it couldn't take place until at least 22 days after the legislative session begins, which most likely pushes it back until March at the earliest.

Several days later, the Democrats scored their own legal victory when a different court ruled the number establishing a quorum was based on the total number of seats in the House and not on the number of seats currently filled. What this ruling did was wipe out every action the House Republicans had taken while the Democrats were boycotting.

Here's the crazy thing about all of this: I think both court rulings were correct, yet they were also the worst rulings in terms of

negative impact on Minnesotans in general. Walz did jump the gun, probably to regain a 50/50 split in the House. Just look at recent history. When Republican Kurt Daudt announced his resignation on January 10, 2024, Walz declared a special election would be held on March 19. In the case of District 40B's vacancy, the vacancy was declared on Dec. 27. So, based on nothing else but the precedence set with Daudt's resignation, this special election should take place in March as well. What this means, though, is the residents of District 40B won't have a voice in the House for nearly two more


The juxtaposition is even more severe for the second ruling. Yes, the number for a quorum should be stagnant and not flexible depending on vacant seats. It is that way for city councils, and county and school boards. Take a look at Isanti City Council, which has had several vacancies lately. If the number for a quorum was flexible, there would have been times when just two council members would have made a quorum. Even though it would take a major calamity to create more than a couple of open seats in the House, the definition of what constitutes a quorum should be consistent throughout all forms of

However, this ruling also gives Democrats the ammunition they need to continue their boycott, even to the point of holding the State Legislature hostage until that special election is held.

And that, right there, is the last thing the Democrats should do. Instead, they should get their rear-ends to the State Capital immediately, even if there isn't some sort of 'power-sharing" agreement in place. At the very least, there is a ton of behind-the-scenes work that wouldn't be dependent on which party holds the majority. Ideally, there should also be a good number of non-partisan bills

that could be passed. To not do that would mean it doesn't matter who "won" the legal battles, because ultimately, the entire state of Minnesota would lose.



Hillesheim said, "because we were out there repairing and fixing stuff. We saw the windstorm that came through. If that had happened every week, we would have spent even more days out there."

"I don't think it is sustainable," said interim Mayor Luke Merrill. "We tried this year, and I really hoped everyone would come in and see a QR code and think 'maybe I should donate a few dollars to keep this going,' but it didn't happen. I don't know how we can spend that much staff time and money on it.'

"I knew this thing would become a money pit," added Councilmember George Hemen. "I was hoping we would be able to find a way for it not to become one, but you can't argue with these numbers.'

Painting an even grimmer picture of the event's prospects, City Administrator Josi Wood noted that rough attendance calculations indicated about 5,000 people attended it throughout the entire month. She noted that since it wasn't paid admission like in previous years, they couldn't get exact attendance numbers. Despite that, even the rough estimates of 5,000 were larger than the attendance figures from either of the first two years.

Doing very basic number crunching, Merrill noted that in order for the event to break even, it would have required every attendee to voluntarily donate \$10. By way of comparison, admission tickets for the two previous years were \$12 for anyone 13 years old and up, and \$5 for seven to 12 year

The council stopped short of taking formal action on the event's future, opting to wait until Councilmember Steve Lundeen, who has been the biggest advocate for it on the council, could voice his opinion on the topic. Lundeen was absent from the Jan. 21 meeting due to an emergency job he had to perform at work.

Additionally, the council instructed staff to come up with possible alternatives for running the event. Some of those alternatives could be putting on a greatly scaled-back event that wouldn't require as much staff time, offering to let an outside organization take over running it, or not holding the event at all and trying to sell the purchased displays to another lighting event. Another suggestion was to modify the displays and put them out along Main Street and other downtown streets.

### **CONTRIBUTIONS TO NON-PROFITS**

The catalyst for this discussion was Hillesheim's request for the council to consider how much of the donated money would go to the non-profits that volunteered to engage with attendees at the event. Originally, the council was willing to split 40% of the on-site donations between the six non-profits. However, given only receiving just short of \$800 that would have meant each organization would have only received \$53.25.

Ultimately, after a discussion that centered around the idea that "volunteers" shouldn't expect money in return, the council approved splitting the full \$800 between the six organi-

# University of Minnesota leads effort to track bird flu's threat to Minnesota wildlife

With \$1.267 million in funding approved by Governor Tim Walz on Jan. 3, researchers from the University of Minnesota's College of Veterinary Medicine will lead a collaborative effort to address highly pathogenic avian influenza and its emerging threat to Minnesota wildlife.

For two years, highly pathogenic avian influenza, also known as "bird flu" or HPAI, has made headlines for its devastating impact on free-ranging birds, free-ranging mammals and the poultry industry. More information is emerging about its spread to cows and humans, yet little is known about its impact on wild animals.

Through the Emerging Issues Account, the Legislative-Citizen Commission on Minnesota Resources (LCCMR) recommended expedited funds for more research into HPAI's impact on Minnesota wildlife. The account supports efforts to address unexpected and urgent needs, especially those where a delay could threaten natural resources or human health. This timing is critical to prepare for a potential resurgence of HPAI this spring.

"The College of Veterinary Medicine is uniquely equipped to advance Minnesota's health and well-being through cutting-edge research, workforce development, and exceptional diagnostic and clinical services," said Laura Molgaard, dean of the College of Veterinary Medicine. "Our interdisciplinary approach is a key asset in addressing the connections between human and animal health and finding solutions to this critical issue for Minnesota."

College of Veterinary Medicine professors Arno Wuenschmann and Declan Schroeder aim at establishing a Minnesota wildlife virus surveillance program, collaborating with state, federal and tribal biologists; wildlife rehabilitation centers; zoos; the Humane Society's wildlife unit and others.

The team will:

Establish a wildlife health network of rehabilitators and tribal biologists that will be trained to safely collect and submit samples to the University of Minnesota's Veterinary Diagnostic

Collect and test 9,000 samples from free-ranging birds and mammals across the state for HPAI virus.

Run a newly established assay, developed in the College of Veterinary Medicine's Schroeder Lab, that quickly confirms the presence of live HPAI virus in samples. Results will be reported to submitters in real time.

The current HPAI outbreak is a ticking time bomb for animal and human health — it is two years in and the virus continues to spread in unforeseen patterns beyond birds to wild and domestic mammals, including humans." said Wuenschmann.

Having greater understanding of the virus and which species its impacting will help experts develop better mitigation strategies and warnings for the public, and agricultural and health sectors. As part of the program, anonymized results will be reported in weekly updates on a publicly accessible University of Minnesota web page.

The team hopes this program can serve as a new resource for future virus outbreaks in Minnesota involving free-ranging animals.



# Arts funding available for Youth, Professional Artists, and Arts Organizations

The East Central Regional Arts Council (ECRAC) is accepting applications for the March 1st grant deadline. Funding is available to artists, k-12 students, and eligible arts organizations located in Chisago, Isanti, Kanabec, Mille Lacs and Pine Counties. Available grants include:

K-12 Student Art Scholarship: this \$599 arts scholarship funding is for special arts learning projects or programs for youth. The program provides at least one student award annually, based upon a competitive review of submitted applications. Applications must be for a specific art project that will advance the skills of the student in their art form. The Arts Council is interested in funding projects such as training with a mentor or summer art programs such as music or visual art camps. All young artists in kindergarten through 12th grade, who strive to improve their artistic abilities, can apply.

Essential Artist Award: this \$9,000 Essential Artist Award program is designed to recognize, reward, and encourage outstanding professional artists. The Council will fund artists at various stages in their professional careers. The Essential Artist Award will allow artists to set aside time to work, purchase supplies and materials, undertake advanced study (not related to a degree) or to pursue other artistic

Essential Support Grant: This program provides general operating support to high quality, established arts organizations that produce, present, or exhibit works of art; to organizations that provide a broad range of services to artists; and to community arts groups that make arts learning available to regional individuals of all ages and abilities. The Essential Support grant program offers \$3,000 to \$10,000 of funding to qualified organizations to maintain their ongoing organizational operating needs. This program recognizes that organizations with an established record of programmatic service and administrative stability should have access to funds to support their organizational goals and objectives, and to maintain their ongoing programs, services, and facilities without any emphasis on new initiatives or programs

as justification for funding.

In addition to the above grants the April 1st grant deadline will be here soon. Applications will be open mid-February for the April 1st deadline. These grants for artists include Resiliency Grant – up to \$600; Arts and Cultural Heritage Fund Grant – up to \$2,000; and the Mid-Career Artist Grant - up to \$3,600. Grants for organizations include Resiliency Grants - up to \$600; Art in Our Schools Grant – up to \$5,000; Small/Arts Project Grant -\$500 to \$5.000; and the Arts and Cultural Heritage Fund Grant - \$5,000 to
