# Staffing shortages plague NBW&L

North Branch Water & Light General Manager Scott Hautala has suddenly found himself to be the captain of crew-less ship. Over the last several weeks, a series of resignations of office staff have taken place, culminating with the resignation of Finance Director Brenda Jepsen last Friday, May 7.

Jepsen's resignation prompted an emergency meeting of the NBW&L Commission, which was held on Tuesday, May 10, with a subsequent emergency meeting being called the following morning. The primary reason for these meetings was to formally approve the resignation and to discuss NBW&L's immediate needs in completing Jepsen's duties, which most importantly included processing payroll considering it was a pay-week.

Commissioner Peter Schaps began the discussion by outlining the history of when Jepsen was hired. He said in the process of contracting Jepsen to perform an audit of NBW&L's financial history, Jepsen uncovered discrepancies dating back to 2012.

"There was a plethora of items that were not correct in the accounting," Schaps said. "And basically every day she found something."

"I have no problem with her work," said Commission Chair Terry Smith. "But she has put in her resignation and that's what we need to address at this point."

Committee Member James Baxter stated that in subsequent conversations with Jepsen as the head of the personnel subcommittee, Jepsen indicated she would be willing to continue working, but not under the leadership of Hautala.

"She would be willing to come back, providing that we reorganize the management, and that she's no longer interested in working with Scott any longer," Baxter said.

"It was an interesting dynamic

## Highway 95 to be under construction west of Cambridge

Motorist traveling on Highway 95 west of Cambridge will experience a significant detour as the Minnesota Department of Transportation begins the first phase of several meant to improve the commute between Cambridge and Princeton.

Beginning just after the Fourth of July, a 12-mile stretch between County Road 70/Polk Street NE and approximately County Road 15 will be reconstructed via a full depth surface reclaim. Additionally, a roundabout will be constructed at the intersection of Highway 95 and County Road 47 (EC's Corner/Pine Brook Inn). The roundabout will consist of a center island that will include low-maintenance shrubs and overhead lighting for safety. It will be built to accommodate larger semi-trailers or recreational vehicles, along with pedestrian crossing.

There will also be a left turn lane installed at County Road 10/Palm Street. Finally, 17 underground pipes/culverts will be installed, along with an upgrade to roadside guardrails, and the installation of mumble and rumble strips.

A detour that utilizes County Road 15, County Road 6, Highway 47, and back onto County Road 6 to Highway 65 north of Cambridge will be in place for the duration of the project. According to MnDOT, this project will help "provide a smooth, long-life road surface,

reduce overall maintenance cost and upkeep, improve motorist and pedestrian safety, improve drainage, and improve traffic flow and access." The \$8.8 million project is expected to be completed sometime in October, 2021.

## **Exploring the early cabins of Isanti County**

If there is one thing synonymous with frontier life, it's log cabins, but actually, some of

the first Eu-

ropean settler

structures in

an enclosed structure. Crude by today's standards, old cabins were an upgrade from the dirt walls and floors that so many settlers had to endure. The fledgling villages of Old Isanti, Cambridge, and Spencer Brook did contain clusters of log-type structures during the early set-

tlement period of the 1860s as well. One area of the county of particular interest is the early Athens settlement just north of St.Francis. Records indicate an early settlement occupied the banks of the Rum River as early as 1855. Although no information is available on the type of structures, it's entirely reasonable to assume they were a combination of earthen homes along the river banks as well as cabins.

The emergence of the cabin as a primary home hit its stride in the late 1860s into the early-1880s. Not only were early homes constructed of logs, but many area country schools and barns were too. As the 19th century drew to a close, cabin-style home construction was mostly abandoned in favor of more common and less labor-intensive use of dimensional building materials. Cabins in Isanti County were generally constructed of tamarack or oak and of course, were handbuilt. The most important tool

to achieve such a feat was the felling ax. One could say that just like the six-shooter won the old west, the presence of the ax in Isanti County had a pivotal role in developing the county as we know it today. Many settlers found their plot of chosen land was a mix of timber and prairie openings; oak, maple, and tamarack were abundant. Tamarack was favored for its workability, relative weight, and rot resistance. Once the trees were cut with a felling ax, logs were further shaped by either a broad ax or an adze. Other tools including, a drawknife, mallet, and froe were required for any cabin builder

People settling in Isanti County carried with them not only some of these precious tools but their knowledge of home construction. The cabins were generally one-room structures with a centrally placed stove for heat and cooking. There was a steep staircase or ladder that led up to a loft. The main floor was open; usually with one bedroom. The floors in the cabin were covered with rough-hewn boards, grass, or dirt. If logs making up the walls weren't evenly "planked" top and bottom, the gaps were generally filled with grass, moss, dirt, and later, mortar type chinking. Windows in the cabins were minimal for two reasons: glass was considered a luxury and the more windows a cabin had, the draftier it was.

It's hard to say how many cabins were built in Isanti County, but it is evident that many still stand, cloaked in somewhat modern materials As families grew larger and time went on, the cabin was often transformed to suit the needs of the family. Early conveniences such as lath, plaster, and floor treatments began to

cover up the past. Upgrades to the exterior walls were usually in the form of rough planked siding. Eventually, if retained as a primary residence, the cabin was adorned in traditional farmhouse lap siding. Other amenities such as a porch and a second woodstove rounded out the list of creature comforts. When indoor plumbing became available, that once prominent porch was partially enclosed and usually delegated to bathroom duty.

As farms became more established, self-sustaining, and profitable, many cabins were replaced by an entirely new farmhouse. Those abandoned cabins were used as other structures on the farm; as nothing ever went to waste. Commonly, the family cabin was perfectly suited for hired help or even a large summer kitchen. Additionally, many cabins that no longer served as homes were used for housing livestock, feed, or converted into a blacksmith shop. Today, farms dotting the landscape throughout Isanti County often appear on the outside to be, "just another old house." In many cases, hiding beneath the facade of siding, wallpaper, lath, sheetrock, and decades of additions sits an old cabin.

With Ritz, I had publicly stated to one of my bosses that I wanted to be a "lifer" with the company. I had quickly risen to store manager and was working in the area of photography. Plus, I was still able to maintain my freelance picture

taking and towards the end was a key component in at least the Minnesota stores attempting to preak into event photography, which mostly consisted of taking photos at hockey tournaments.

Sure, there were some downsides. It was still retail, with all the pressures that go along with a national corporation. And as long as I insisted on living here in Cambridge, I would always have some sort of extended commute. But all of that was certainly outweighed by doing something I enjoyed doing.

Then the recession hit and even worse, the camera sales business started drying up after years of being one of the hottest commodities out there. Ritz Camera went into bankruptcy and wound up closing all but three or four of their Minnesota stores. I, like many others, were the odd people out and after a crazy liquidation period (which could be an article unto itself), I was out of work.

Working for OfficeMax was quite the opposite. After an extended unemployment period, taking that job was a bit more of a "beggers can't be choosers" scenario. They offered me a full-time position that was semi-management, so the pay was okay, especially if I was able to score some SPIFFs (sales incentives). I did like a majority of my coworkers and my boss still somewhat let me set my own schedule in order to continue with some photography. But selling computers and office supplies isn't as fun as selling cameras, so the same national corporation pressures weighed much heavier on me.

Then came this job. With it came new challenges, a little bit of risk, and a new set of pressures. But at the same time, I love what I'm doing, enjoy ny coworkers, and have minimal commute time to boot. It didn't take me long to openly declare

his as my new "lifer" position. Now, I don't anyone to feel nervous. I have absoutely no desire to continue that five-year trend. Plus, in the interest of full disclosure, I worked for One Hour Roseville Photo (a photo finishing store) for around seven years before they had to let me go in a cost-cutting effort (they wound up closing a half-year later).

And while this past year-plus has had its own evel of uncertainty for the future of the newspaper industry, I am happy to say that with a lot of hard work and a few sacrifices, the future is again ooking much brighter. People brought in their personal documents to be shredded by the Shredright-4good Company. The project helped to reduce CO2 emissions by eliminating 455 trash bags of waste instead of going to a landfill, 26,891 miles driven by a passenger vehicle: .07 acres of U.S. forest preserved

## Become a certified invasive species detector

Lake lovers of any education level are encouraged to participate in the Aquatic Invasive Species (AIS) Detectors Program's namesake course that is open for registration and fully online for the first time this year.

The AIS Detectors certification is an introduction to aquatic invasive species science, identification, and surveillance. Participants learn how to report invasive species to government officials, best practices for preventing the spread of AIS, relevant rules and regulations, and how to search for AIS on their own.

In the course, participants learn how to correctly distinguish between invasive species and their native Minnesota counterparts. The course covers invasive plants including Eurasian watermilfoil, hvdrilla, and starry stonewort; invasive invertebrates including spiny water fleas, rusty crayfish, red swamp crayfish, zebra mussels, and quagga mussels; and invasive fish including bighead carp, silver carp, round goby, and ruffe.

To become a certified AIS Detector, participants must first complete a selfpaced online course that introduces them to species

identification, the steps to take when reporting a new AIS infestation, and more. The online course can be completed on any schedule and from any location with internet access. The course is estimated to take a total of 6-8 hours, but breaks can be taken at any point. After the self-paced coursework, participants attend two 3-hour virtual workshop sessions led by program staff and AIS experts. Though online, the workshops are highly interactive sessions that allow for discussions, questions, and networking.

The online coursework must be completed before participants attend the workshops, as such we recommend registering at least a week prior to your workshop dates. Virtual workshops begin as early as May 19, 2021 and the last workshops begin June 9, 2021. The AIS Detectors Program at the University of Minnesota is jointly sup ported by the Minnesota Aquatic Invasive Species Research Center and University of Minnesota Extension.

The program was created with initial funding from the Environment and Natural Resources Trust Fund, ongoing support from the state of Minnesota, and guidance from the Minnesota Department of Natural Resources.

The program aims to help protect Minnesota's life at the lake by empowering community members through its volunteer programs, events, workshops, and other educational offerings.

## Slowing aquatic invasive species spread requires everyone to take part

Minnesota's walleye, bass, northern pike, and lake trout fishing opener is next weekend, and aquatic invasive species (AIS) will be on many people's minds.

2021 not only brought us a new way of life with guidelines surrounding COVID-19, but the Minnesota Aquatic Invasive Species Research Center at the University of Minnesota has also created us a new resource — an online dashboard called AIS Explorer— that predicts the introduction risk of aquatic invasive species and identifies the optimal placement of watercraft inspection locations introduction, they can negatively affect natural resources, human health and the economy.

Unfortunately, Minnesota's waterways are threatened by a number of AIS. Some more notable species include zebra mussels, Asian and common carp, and plants such as starry stonewort, curly-leaf pondweed, and Eurasian watermilfoil.

Decorative moss balls infested with zebra mussels are a new concern in Minnesota. These small 2-to-5-inch balls of green algae are sold at pet stores for aquarium decorations. This means that some aquarium owners may be inadvertently harboring zebra and boating equipment.

One last point worth highlighting this year is the importance of properly disposing of baitfish. Since baitfish can harbor pathogens that can cause disease in native fish, it is important to never release unused bait and bait water into the waterways, but instead dispose of bait in a trash can on land and dump your bait water on land far from the shore.

### Q: What does your latest work show on AIS?

My recent efforts have focused on outlining a statewide surveillance and early detection system for AIS in Minnesota in response to a request by the state legislature. The program was described in detail in a report which outlined critical components of an effective program along with any necessary policy and funding changes. The report was submitted to the legislature in January 2021. Within the report, we discussed the challenges of surveillance and early detection. We also discussed the history and benefits of decision support tools and we introduced our new decision-support tool called AIS Explorer. This user-friendly, online platform helps AIS managers make efficient decisions about surveillance activities and watercraft inspections.

### existing gap does it help fill in Minnesota?

Although many AIS currentlv inhabit our lakes and waterways, only about 8% of water bodies are currently infested, which is an important point because we have the opportunity to protect the remaining 92%. AIS Explorer is a free, publicly-accessible online tool that can support us in those efforts considering that there is a limited amount of money, people, and time available to do so. The AIS Explorer dashboard has two main functions: it helps 1) AIS managers visualize risk of new infestations to plan where to conduct surveillance activities, and 2) AIS managers plan their watercraft inspec-

in order to base decisions on. That is similar to AIS, where infested waterbodies may not be identified early in the infestation. However, by conducting surveillance and having information of the location of AIS infestations, managers can make better decisions about how to respond and communicate that response plan more clearly. In both cases, slowing the spread of COVID-19 and AIS, we can all do our part by participating in the recommended prevention activities.

### Q: What is the No. 1 thing people can do to help in the fight against AIS, especially this year?

One of the most important things that people can do is to clean, drain, and dry. By being familiar with and following state laws that help prevent the spread of AIS, including cleaning aquatic plants and any debris from boats, draining all water from your boat, removing drain plugs, wiping out residual water in live wells and bait buckets, and properly disposing of baitfish, we can all play a role in protecting our waterways from AIS.

Amy Kinsley, an assistant professor in the College of Veterinary Medicine at the University of Minnesota, answers questions on what the latest research on AIS shows, what boaters and anglers alike can do to stop the spread of AIS, as well as the new AIS Explorer dashboard.

### Q: What aquatic invasive species are in Minnesota, and are there any new ones of great concern?

Aquatic invasive species (AIS) are non-native aquatic animals, pathogens or plants that have been introduced to a new environment, beyond where they are typically found. Depending on their characteristics and the extent of their mussels in their tanks at home.

The U.S. Fish and Wildlife Service is asking people who have recently purchased them to dispose of them by freezing them or putting them in hot water, salt or bleach, then placing them in a bag and in the trash. They also recommend disinfecting the tank and accessories after disposing of the moss balls.

Although not necessarily a new AIS, one worth mentioning given the upcoming fishing opener is spiny water flea, a small freshwater zooplankton. Spiny water fleas are important because they can impact populations of native zooplankton, leading to lower food availability for fish. Spiny water fleas can spread to uninfested lakes through fishing

### Q: Why is the AIS Explorer dashboard necessary and what

tion programs by identifying the optimal locations for inspection stations. The tool is a result of the collaborative efforts of researchers from a variety of backgrounds and I urge anyone interested in AIS to check it out.

### Q: In the age of COVID-19, what can you say about the parallels between COVID-19 transmission and AIS spread?

"There is a lot of overlap when considering how COVID-19 and AIS are spread. COVID-19 showed us how important it is to identify infected individuals, even if they are not showing symptoms. By contact tracing and testing public health officials were able to use data to gain a clearer picture of the situation

to manage," Hautala told the commissioners, noting how a majority of the office staff were new at their positions and relatively untrained, with several staff needing to perform duties beyond the scope of their employment.

"Sometimes people don't get along in the office," summarized Smith, bringing the commission back to the task at hand.

Hautala was asked to explain what duties were most urgently needed to be performed in light of Jepsen's resignation. He indicated payroll was the biggest concern considering it was due in two days. He said he came up with two options for getting that accomplished. One was to reach out to city staff to give them a hand. The second was to reach out to one of the auditor finalists to contract with them to perform duties on an hourly fee basis. However, he said one of the two would have a conflict of interest in paying any bills since they are also the city's auditor. The other finalist had not responded with any formal proposal outside of saying they were interested. He added it would be very difficult for them to get payroll done in time.

Hautala also said sending out bills to customers was coming up in the next two weeks, and since the billing clerk had recently resigned, he and Jepsen, "but mainly Brenda," were looking into outsourcing those duties, and that he should have the results of that search in the next day or so. Finally, he said he was already in the process of hiring

some temporary employees to at least handle receiving payments, taking phone calls, and other lighter-weight duties.

"I've been training furiously on many administrative items to keep the wheels on the bus," he concluded.

### A HAIL MARY FALLS INCOMPLETE

After City Administrator Renae Fry told the committee that the city did not have the staffing available to perform the payroll service at this time, the commission ultimately decided to make one last-ditch effort to have Jepsen at least do payroll for this week, even if it meant her doing it remotely, with Hautala supporting her with any tasks such as loading pay stubs into the printer.

Ultimately, the commission approved on a 4-1 vote to "reject Jepsen's resignation," and instructing Baxter to talk with her about temporarily staying on the job. Later on in the evening, however, Baxter called for the second emergency meeting, indicating Jepsen was unwilling to work with Hautala in any way, shape or form.

During the second emergency meet-

ing, Jepsen's resignation was formally approved by the committee, and a motion was made to write up a formal contract with the city to perform financial services for W&L, subject to council approval.

### CITY FINDS TEMPORARY SOLUTION

After a whirlwind day on Tuesday of writing up memorandums of agreement (MOA), the council approved on a 4-1 vote, with Council Member Kathy Blomquist voting nay, a contract between the city and W&L to perform all of the finance director's duties beginning immediately, with a sunset of Dec. 31, 2021. Additionally, either party can terminate the contract with 30 days notice.

In the process of constructing this MOA, Fry said she was successful in also reaching an agreement with Jepsen for her to perform a majority of those tasks as an outside contractor to the city, meaning Jepsen would not be directly working with NBW&L, and, by extension, Hautala.

"Joe (Starks, City Finance Director) and I had multiple meetings today and both of us see this as really a positive opportunity to begin laying the foundation for the sharing of services to taking on a more collaborative approach to finance management," said Fry.

"We do, however, want to make sure there is good risk management, and so, in looking at what this process would look like, and how the city would want to ensure our good financial practices being employed in this, we did reach out to Ms. Jepsen to see if as an independent contractor for the city if she would be willing to take on this responsibility and she said yes."

Under the terms of the two MOAs, Jepsen will charge the city \$75 an hour. She can either work remotely or at City Hall. In turn, the city will charge W&L \$75 an hour for the work Jepsen performs, plus \$60 an hour for any work performed by current city staff, with the exception of Starks or Fry. If they perform any work, it will be billed at \$90 an hour.

"We did consult with Miranda at CliftonLarsonAllen (the city's auditor), and she indicated their fees would start at \$75 an hour and go up to \$150 an hour," Fry said.

"We are in a tough spot, so we appreciate the city stepping forward and helping us through this," said W&L Commission Chair Terry Smith.

Blomquist questioned why the MOA included all of the duties of a finance director when it was her impression that W&L's primary concern was this week's payroll.

"What they were looking to do was fill the role of finance director," Fry said. "And let me be real clear, if they don't bill, the city doesn't get paid (for things like sewer, stormwater and the franchise fees). So this was a very, very incredible gap in services. Payroll was driving the urgency, the finance functions in general, everything their previous finance director was doing was a gap or a void, and it would take months to fill that void."

## NBW&L to look into contracting other services with city

A strange secondary item on the North Branch Water & Light's emergency meeting agenda wound up creating an extended debate in front of a larger-than-normal audience, and ultimately took the first steps towards a closer working relationship with the city that is hoped will result in lowering utility bills.

The agenda item was originally labeled as "Resolution enacting Minnesota Statute 412.321 Subd. 4. Municipal Utilitys (sic) Lease, Sale, or Abandonment of North Branch Water and Light." The wording of that agenda item was changed several times over the course of the day on Monday, May 10, however not before a screenshot of the initial agenda was shared on social media, prompting a number of people, including some of the committee members, to believe the commission was going to discuss the possibility of completely disbanding North Branch Water & Light and turning its services over to the city.

"The whole reason we also called this meeting was to have a discussion, which was on the agenda and which is why all these people are here...we as a commission are not doing this (what Water & Light was created for), nor is Water and Light as a whole," said Commission Member James Baxter. "Another solution needs to be created, and turned over to the city to be discussed what to do with it." "I think what is being brought to light here tonight is band-aid fixes at best, to what is a larger problem," added Commission Member Nathan Keech. "I was also informed that we would be having this meeting to discuss the disbanding of Water and Light, and for it to be absorbed by the city. I would like to get the input from other commissioners, but I was under the impression we were going to take votes and take action on what would be seemingly a more positive direction for Water and Light itself."

As it turns out, the commission doesn't have the authority to, as was stated by Commission Member Thomas Hals "dump it in the laps" of the city council. According to City Administrator Renae Fry, action to formally abolish the commission would require a referendum vote, similar to the one held during the 2016 election. A referendum vote can be called for by the council or via a successful petition campaign by residents.

In an email to the *Star*, Fry explained "the commission has the opportunity to sell, lease or discontinue certain aspects of their operations, but it takes formal council approval to implement. In theory, they could parse out their entire operation with only a council vote if there is no discontinuance of services to residents."

After further discussion, Commission Member Baxter made a motion that "we explore the opportunity to contract services with the City of North Branch." He explained that this would help eliminate redundancy in certain jobs both the city's public works department and Water and Light already perform, which should reduce expenses and create savings that could be passed on to customers.

For their part, Public Works Director Shawn Williams was all for this motion. "This is a positive thing, it is not negative at all," Williams said. "We're ready to do it, I'm ready to do it, my team is ready to do it. The tax savings could be huge. We could start locating water tomorrow if that is the need of you guys. Our footprint is the same. (City and Water and Light) trucks are passing each other. We're not here to take anyone's job. I'm not here to take over. We're here to do what's right for everybody as a whole."

Baxter's motion, which was seconded by Commission Chair Terry Smith, passed unanimously. Additionally, a subcommittee comprised of Williams, Fry, Water and Light General Manager Scott Hautala, Nathan Keech, and James Baxter to explore those possibilities, was unanimously approved.

### THE MORE THE MERRIER

During the Tuesday, May 11 city council meeting, a motion was made to include two council members on that subcommittee as well. Mayor Jim Swenson made a motion to appoint Council Members Patrick Meacham and Kelly Neider, which passed unanimously.

## DNR reminds anglers to be aware of northern pike zone regulations

The Minnesota Department of Natural Resources reminds anglers who might want to keep northern pike when the season opens on May 15 to familiarize themselves with the regulations and be prepared to measure the fish.

"Sometimes anglers who catch northern pike are fishing for other types of fish and aren't sure what to do with that toothy pike on the line," said Bethany Bethke, DNR fisheries research scientist. "We want these anglers to be equipped with the knowledge they need to keep a pike if that's their desire." Minnesota has three northern pike zones that apply to inland waters and reflect the differing characteristics of pike populations across the state:

•North-central: Limit of 10 northern pike, but not more than two pike longer than 26 inches; all fish 22 to 26 inches must be released.

•Northeast: Two northern pike; anglers must release all fish 30 to 40 inches, with only one fish over 40 inches allowed in possession.

•South: Two northern pike; minimum size 24 inches.

The DNR implemented the zone

regulations in 2018 following extensive public input and comments. In the north-central zone, the northern pike regulations address angler concerns about the over-abundance of small, or hammer-handle, northern pike.

In the southern zone, where reproduction is limited, the regulation is designed to increase pike abundance while also increasing the size of fish harvested. In the northeastern zone, the regulations aim to protect large pike.

"Northern pike can be delicious table fare. We encourage anglers to know the regulations and give a meal of pike a try," Bethke said. "Northern pike require a little more work while filleting, and anglers can check the DNR website and other online sources for how-to videos on cleaning northern pike."

Throughout the state, special regulations that cover individual lakes, rivers and streams remain in effect and take precedence over the zone regulations. The northern pike zone regulations do not apply to border waters.

### **GIRLS GOLF**



## **Despite county's efforts, COVID vaccinations lagging**

While Isanti County Public Health has administered nearly 10,000 COVID-19 vaccines since they became available, frustrations were aired at the May 5 Isanti County Community Health Board meeting regarding the low percentage of the county's population that has been vaccinated.

A member of the audience shared that the New York Times shows only 20% of the total population of Isanti County has been vaccinated. However, Marylynn Dahlquist, Isanti County Public Health Nurse and lead injector and coordinator for the COVID-19 response reported that about 72% of the 65 and older population in Isanti County has been vaccinated, and about 37% of the total population.

"Here's another piece of information that I think is also important is the number of cases per 100,000 people. Isanti County has 43 per 100,000, Kanabec County has 27. We're with Sherburne County, which is 43. And then St. Louis County only has 20," the audience member stated. "The reason I'm here is I don't want to be fighting this for 20 more years. I'm really motivated to see more of our county get vaccinated."

The lack of people vaccinated in Isanti County is not due to lack of effort by the public health team, which has used an influenza grant it obtained last fall to enhance its vaccination efforts, according to Joan Schleicher, Isanti County Public Health Nurse and immunization coordinator. She noted that public health typically administers 100 to 300 vaccines to under- and uninsured residents yearly, so approaching 10,000 COVID-19 vaccinations is outstanding.

"Really the success of our COVID-19 efforts and being able to provide that is a direct result of getting the influenza project grant underway and beginning that work last fall," she said.

Grant money was used to outfit the emergency management trailer and a cargo van for mobile vaccination clinics, Schleicher said. Targeted postcard mailings and letters sent to area residents allowed for successful mobile vaccination clinics at Long Lake Lutheran Church, St. John's Lutheran Church-Weber, Pine Village, Rich Park, Ashland Place, and Braham Event Center.

"The mobile clinics have been great, because they require less manpower, less ushers and stuff like that, so we really enjoy the drive-throughs,' Dahlguist said.

Public health has also organized vaccination clinics at Cambridge-Isanti and Braham high schools using the Pfizer vaccine after it was authorized for use in those 16 and older.

Once the Johnson and Johnson vaccine was re-authorized for use, public health used it to vaccinate jail staff and inmates. as well as a clinic at Anoka-Ramsey Community College. Efforts are being made to reach out to manufacturers and places that hire migrant workers to offer the Johnson and Johnson vaccine, as well. "Some things that we have struggled with is filling our large pod clinics," Dahlquist said. "We were really good in the beginning, and now the large pod clinics, not so much. So that's why I think we are going to speed more towards reaching outwards in the community with our mobile stuff."

want the vaccine, so all we can do is continue to educate."

Isanti County Commissioner Susan Morris mentioned that the Minnesota Gerontological Society recently had a conference and at which epidemiologist Dr. Micheal Osterholm was the keynote speaker, and his advice was to meet people where they are at, because the story is not the same for all people who are choosing not to get the vaccine. She encouraged the public health team to push the educational efforts and reach out to other counties to learn from them what has been working.

Isanti County Administrator Julia Lines offered her view about the efforts of public health and vaccine hesitancy. "Our public health team has actually done way more than many other counties. We're a small team, so to have vaccinated almost 10,000 people is amazing," Lines said. "I think that the difference, we'll take Chisago County, their Fairview system has pushed this vaccine from day one, and there are many people out there that are more comfortable with their provider and their own doctor, and they are waiting for that to get their vaccines. I certainly don't want to point fingers, but I think that's why Chisago County has been so successful - is that Fairview has really taken on the effort whole-heartedly and has also partnered up with public health."

Noting that the state has been pushing Allina to get more proactive, she continued, "I think they are listening and I hope that starts happening, but to reach out to their own patients will give some of those people, hopefully, that are a little more uncertain that comfort level so that they can receive it from their own clinic. Our rates are no way reflective of what public health has done, so I just really want to make sure that's known.'

Morris shared that her cousin, who works in retail and is in her 60s, contacted Allina to get her vaccine, and she had to travel to Woodbury to get her shot. "That is so ridiculous," she said. "I think our community partner probably has not stepped up to the plate in the way they should have and I've been really disappointed."

Amongst all the efforts to get the county's population vaccinated, the public health team continues to update county residents on Minnesota Department of Health protocols, has acquired oximeters to assess county residents who may be struggling with COVID-19, and also has the ability to administer oxygen to county residents that may need it. Public health is also creating training videos about the vaccinations, use of oximeters and oxygen, and other public health needs.

"Overall, the teamwork amongst all the staff and volunteers working at the clinics has been phenomenal,' Dahlquist said. "We're just continuing to improve on things that haven't worked well, and we just continue to build on our strengths to accomplish our goals."

## Closed meeting yields staffing changes at Isanti Liquor Store

A last-minute closed session was added to the agenda for Isanti City Council at its May 4 meeting to consider allegations against an employee.

Before closing the council meeting, Isanti Mayor Jeff Johnson read a statement, and the city's civil legal services attorney Tim Sullivan of Ratwick, Roszik, and Maloney clarified why the meeting was being closed.

"Persistent to Minnesota State statute 13D.05 subdivision 2B, the authorities that authorize a city to close a meeting for preliminary consideration of allegations or charges against an individual subject to its authority," Johnson stated. "There are allegations against an employee requiring consideration by the city council, Minnesota statute 13D.05 subdivision 3B authorizes the city council to close this meeting for purpose of attorney/client privileges."

"Well, just to clarify, Mr. Mayor. The city council needs to meet with its attorney in a confidential setting to obtain advice regarding potential imminent legal action related to the city's allegations and defenses in a potential employment matter, so that's the basis of closing it on the attorney/ client privilege," Sullivan said. "So, there's two basis to close this meeting today, first for preliminary consideration of charges or allegations against an employee and the second, independent basis is for attorney/ client privilege. Just wanted to make sure we had a clear record on that." After returning from the closed session, the council unanimously approved two motions, labeled as 2021-100 and 2021-101. The first motion states that an attached letter setting forth the discipline of an employee was approved by

the council, the city administrator is authorized to sign the letter on behalf of the city, and the letter and resolution will be delivered to the employee and copies placed in the employee's personnel file.

The second motion moved assistant liquor store manager Keith Lusk to interim liquor store manager at Step 1 of the liquor store manager wage scale, and moved liquor store clerk Gregory Fauskee to interim assistant liquor store manager at Step 1 of assistant liquor store manager wage scale.

The motion also stated that the increased compensation for Lusk and Fauskee would be retroactive to March 3, 2021, and the temporary wage adjustment would terminate when a liquor store manager begins employment with the city.

### **ODDS AND ENDS**

In other action, the council: Adopted an ordinance amendment regarding the keeping of certain animals to allow the keeping of bees within the city limits.

•Approved a resolution awarding the bid for the 2021 storm system maintenance project to the low-bidder of Dirtworks Company for approximately \$112,545. The city engineer's estimate for the project was \$113,000.

 Approved a resolution allowing for and setting forth parameters for the Isanti Fire District to use city water at no charge when participating in training exercises within city limits. Approved the issuance of conduit debt to Arts and Science Academy for the purchase of the buildings they are currently leasing within city limits. Conduit debt is essentially the city co-signing for a loan, however the city is not liable for payments not made by ASA.



The commission shall review such facts and documents and conduct such appeal hearing and, in such manner, as it shall determine to be appropriate to decide the appeal. The decision of the commission is final.

No appeal to district court may be taken as to the amount of an assessment unless a written objection signed by the affected property owner is filed with the General Manager prior to the assessment hearing or presented to the presiding officer at the hearing. The commission may consider such an objection at an adjourned meeting upon such further notice to the affected property owners as it deems advisable.

Under Minn. Stat. §§ 435.193 to 435.195 the commission may, in its discretion, defer the payment of this special assessment for any homestead property owned by a person 65 years of age or older, one retired by virtue of a permanent and total disability, or a member of the National Guard or other reserves ordered to active military service for whom it would be a hardship to make the payments. When deferment of the special assessment has been granted and is terminated for any reason provided in that law, all amounts accumulated plus applicable interest become due. Any assessed property owner meeting the requirements of this law may, within 30 days of the confirmation of the assessment, apply to the General Manager for the prescribed form for such deferral of payment of this special assessment on his/her property.

### Plants that can keep bugs away from outdoor living spaces
