# Rise of the sky walkers

### Bluejacket pole vaulters look to exceed recent successes

In the long, storied history of Cambridge-Isanti Bluejacket track and field, one event has consistently excelled over any other as of late: pole vault.

Since 2011, there has been only one season (excluding the COVID-canceled 2020 season) where the Bluejackets didn't have at least one athlete competing in the event at the State Meet. More impressively, in that same span, a total of 20 Bluejackets — 13 boys and seven girls — have qualified for state. To qualify for state, an athlete must finish first or second at the section meet, or they must beat a qualifying standard at the section meet. In the case of pole vault, that means clearing a predetermined minimum height.

As successful as the Bluejacket pole vaulters have been in the recent past, this year's group is on the verge of being the most successful ever. Based on previous results throughout this season, all six section competitors (each school is allowed up to three athletes per event at sections) have a reasonable chance of qualifying for state.

#### **BOYS LOOK TO REPEAT THE FEAT**

If all three boys pole vaulters advance to state, it will be the second season in a row for C-I, and the third time in school history. All three have already eclipsed this season's qualifying standard of 13 feet, 2 inches by at least eight inches, meaning at sections they could fall short of their personal best by half a foot and still advance to

Given that, the trio has collectively set their sights on the even more impressive result of all three medaling at state by finishing in the top

Leading the boys is junior Calvin Piescher, who finished third at state last season. Not only does Calvin have his sights set on taking first at state, but doing so by breaking the state record of 16 feet, 2 inches. Calvin's official personal best is currently 15 feet, 8 inches.

"Calvin started out being a good athlete but not a great pole vaulter," Bluejacket boys track and field head coach Kent Viesselman said. "But once he figured out the basics of vaulting, he excelled. He is one of the hardest workers and most dedicated track athletes we have ever had at Cambridge-Isanti. "He will go down as one of the greatest pole

vaulters in the history of Minnesota by the time his high school career is over," Viesselman prophesized. Senior Lucas Frank also competed at state last

season, coming in 17th place. Lucas has already topped his height of 13 feet, 6 inches at last year's state, twice clearing 14 feet, even.

# Cambridge bans downtown cannabis stores

Anyone wishing a marijuana sales store would open up in a certain downtown Cambridge space and keep the previous business' name will now be disappointed.

On a unanimous vote and with minimal discussion, the Cambridge City Council has approved an amendment to the city's cannabis sales ordinance that removes the downtown business district and downtown fringe business district from the zones where a cannabis sales business may open.

According to Cambridge City Administrator Evan Vogel, over the last few months, city staff have been approached by prospective cannabis business owners inquiring about two vacant buildings in downtown Cambridge: the former North Metro Auto Sales site and the former Herman's Bakery site. Before getting too far into the process, Vogel said staff wanted to get a final, definitive answer to whether the council wished to allow such a business to open downtown.

"Given the focus of previous strategic planning efforts, I did not want to presume the council would be supportive of a new and semi-controversial business class in that business district the council has deemed the cultural hub of the city," Vogel

According to Community and Economic Development Director Marcia Westover, the amendment would still allow for the sale of low-potency hemp edibles downtown, such as if one of the downtown restaurants decided to start selling THC-infused drinks that have become popular. Additionally, the change would still allow a cannabis sales business to open along the Highway 95 business corridor to the east of the railroad tracks, or in the industrial

"There's ample opportunities in our city to open such a business, westover said. "The callers have asked about the two businesses downtown, but there are other vacant buildings in the city they are also interested in."

# **VAULTERS:** Jackets hope to send six to state for first time in school history

"Lucas has been an excellent leader," Viesselman said. "He has always been willing to compete in any event that could help the team."

Junior Wesley Kennedy would be the state meet "rookie" among the three. Like Lucas, he has cleared 14 feet, even in multiple meets this

"Wesley has made himself a great pole vaulter through hard work both in and out of the season," Viesselman said. "Wesley has passion for life and pole vaulting. He gets excited for not only himself but his teammates and his passion is infectious."

"I think we are as good as we are because everyone is pushing each other to get better," Wesley said. "That's really helpful to have that competition throughout even our team."

#### **GIRLS LOOK TO MATCH BOYS**

Unlike the boys, if the Bluejacket girls pull off the state meet trifecta, it would be the first time in school history. In fact, C-I has never had two pole vaulters share the same state meet runway before. Also unlike the boys, for the three girls to advance, two of them would have to beat their personal best height.

Abby Kryzer has the best chance of earning a state meet berth. The senior is currently tied for first in Section 7AAA, previously clearing 11 feet, even — the same height she cleared for eighth place at state last season.

"Abby has trained relentlessly, pursuing her goal of higher heights with a vengeance throughout her career," said Bluejacket girls track and field head coach Michael Galligan. "She is an amazing role model and leader to the vault squad."

Junior Aubrey Wilson is currently a mere three inches away from the state-qualifying height of 10 feet, 10 inches.

"Aubrey is meticulous in her form and uses finesse to continue to soar higher and higher in her vaulting,' Galligan said. "She is the future leader of the squad."

Not to put additional pressure on her, but accomplishing the girl's trifecta may very well rest on the shoulders of eighth-grader Annabelle O'Brien. While competing on the varsity team the entire season, Annabelle went from clearing 9 feet in several meets to clearing 10 feet, 6 inches twice in the last three meets. This puts her within four inches of the state-qualifying height.

Her rapid ascension among the ranks has also caused Annabelle to modify her personal goals for the

"I do want to make it to state really bad," Annabelle admitted. "But I think I really made my goal of tensix."

"Annabelle is a mashup of raw speed and force combined with great determination to make her mark on the team," Galligan said, "which is an incredible feat at her age."

The Bluejackets will make their run at history during the Section 7AAA Meet at Forest Lake. The boy's pole vault will be held on Wednesday, May 28, with the girl's pole vault being held on Friday, May 30. The Class AAA State Meet will be held at St. Michael-Albertville on Tuesday, June 10, and Thursday, June 12.

# UMN Extension to offer Tractor and Farm Safety Training for youth

University of Minnesota Extension will be offering Youth Tractor and

Farm Satety Training this summer. The youth tractor and farm safety certification program provides youth 14 years and older the opportunity to learn about safe equipment operation and general farm safety. Students who complete the program are eligible to receive a U.S. Department of Labor certificate of training. This certificate is required for 14- and 15-year-olds who

wish to work on farms as employees. This training is also a great opportunity for youth planning to work on their family's farm.

This hybrid training includes an online course on the National Safe Tractor and Machinery Operation Program learning objectives and two days of in-person training that include tractor operation instruction in a safe learning environment. The online course takes 8 to 10 hours to complete and can be done at the participant's own pace. After completing the online course,

participants attend a two-day in-person training with hands-on instruction. All sections of the online course must be completed prior to attending an in-person session.

# Cambridge needs to increase number of election precincts

In light of the recent Isanti County Commissioners' decision to not purchase election epollbooks for every precinct in the county, which in turn forces the city of Cambridge precincts to revert back to paper

roster books, I am asking that you immediately begin the process of increasing the city's number of precincts.

If my memory is correct, this has actually been somewhat considered before, which only makes sense. The two precincts' polling locations — one in the Fire Hall and one in the Council Chambers, are experiencing space constraints as the number of voters increases. However, the time for consideration is over and the time to take action is now.

I am convinced the only reason the city has been able to delay adding one or maybe even two precincts is because of the epollbooks. It is undeniable their use is the reason lines are shorter and

the time it takes from parking your car to pulling back out is considerably shorter. When asked, Cambridge City Administrator Evan Vogel estimated the epollbooks were two or three times faster at checking in voters than the paper roster books. In my opinion, that estimate is conservative for voters whose last name begins with a more common letter of the alphabet.

Without epollbooks, I am seriously considering resorting to early in-person voting. However, based on new early in-person voting laws, that too will take longer than before thanks to not having the epollbooks.

The second reason for adding precincts is for after the polls close and the votes are tabulated. Even when utilizing the epollbooks, Cambridge's two precincts were notorious for being the last two having its results posted. Again, that makes sense based on how many more voters there are than any other precinct in the county. Now, without the epollbooks and with just the two precincts, voters might as well forget about finding out the city's election results until at the earliest the next day.

The obvious question would be where the additional precinct(s) would be? The most obvious answer is the Cambridge Library. But since the largest open space is below the ground level in the Great Northern Room, although it appears to be ADA compliant, it isn't an ideal location. Other possibilities include the Catholic Church's Parish Hall, Anoka-Ramsey Community College, or least ideally due to the distance from the parking lot to the building itself, the Armed Forces Reserve

Now, I know adding precincts will cost the city more money for additional poll workers, election judges, ballot counter machines, plus other expenses. However, I feel that the city can justify the added expenses in the name of election efficiency and accuracy.

Or better yet, get Isanti County to pick up the tab. After all, it now has over \$90,000 it isn't using for any other common-sense election improvements like the epollbooks.

I sat at the table and was the first person to greet the clients. Some came in excited to know it would be done in just a little time. Others came in very stressed, some crying, about what they heard on the news about Social Security and Medicare going away, not entitlements. One man was so upset, he was supposed to take care of his wife, both in their 90s, he had promised her father he would and now won't be able to do so.

I don't believe it will happen. But the stress is making them sick and with the threat of taking Medicaid away is making it worse. To all of you that voted for the person in the White House. Please open your doors to people that may be looking for a place to sleep.

When I moved up here about 4 1/2 years ago, I was so pleased with the respect that the community showed for the military. Having a son, brother, cousins, uncles and an uncle that died in WWII made me feel like people really cared about them. So, I was so surprised when this same community supported a man that called the military suckers and losers.

# Memorial Hospital Foundation commits \$500,000 to New Pathways

A \$500,000 gift from the Memorial Hospital Foundation is propelling New Pathways, Inc., closer to breaking ground on a permanent family shelter in Cambridge.

The Memorial Hospital Foundation's donation to the "Hope Lives Here" capital campaign represents a significant boost to the nonprofit's efforts to raise \$3.5 million for a new 12,000-square-foot facility that will offer year-round shelter and wraparound services to families experiencing homelessness. The city of Cambridge is playing a crucial role and is poised to sell a parcel of land to New Pathways for \$1.

With about 75 percent of funds now raised, construction on the new site—located adjacent to downtown Cambridge—could begin this summer if the remaining balance is secured.

"This [Memorial Hospital Foundation] gift is truly a game-changer," said Mary Westlund, executive director at New Pathways. The organization has been moving toward its centralized shelter vision since 2020 when the pandemic exposed gaps in its church-based shelter model. A \$60,000 grant from the Initiative Foundation in June 2022, supported by the Otto Bremer Trust, helped the organization explore the feasibility of the project, create plans and build its

capital campaign.

"To see the community step
up in such a meaningful way is
incredibly moving," Westlund
said. "Now it's no longer 'if' we get
this done—it's 'when' we get this
done."

New Pathways has served families across a five-county area for 25 years, helping them transition out of homelessness and into stable housing. The new shelter will double its current capacity, allowing the organization to serve up to 10 families at a time. Families will stay in private upper-floor efficiency apartments and will be supported by on-site programming, case management and recovery services. Most families stabilize

up to six months.
"I think it's really going to be life changing," Westlund said. "I can't

imagine what it's going to mean for families to get out of fight or flight more quickly and settle into rest and digest" so they can think and problem-solve and work toward finding permanent housing.

Lowell Becker, chair of the Memorial Hospital Foundation and a longtime physician in the community, said the decision to support the campaign was immediate and unanimous. Becker and another Memorial Hospital board member are part of the "Hope Lives Here" capital campaign and abstained from voting on the shelter project.

"When it was presented to our board, there wasn't even a question," Becker said. "This was exactly the kind of project we were looking for. Everybody was totally in favor of it. We wanted to help [New Pathways] get over that fundraising threshold to take it public. That's why we jumped in with a pretty sizable amount of money."

Becker added, "Just to feel the energy around this project—it's rewarding enough. We have a board that's focused and deeply committed to using our resources for something that truly matters in this community."

The Memorial Hospital Foundation was established after the sale of Cambridge's Memorial Hospital to Allina Health. Seeded with funds from the transaction, the Foundation has maintained a strong focus on supporting health-related initiatives in Isanti County. It operates as a Partner Fund of the Initiative Foundation, which provides professional fund management and ensures long-term impact in the region.



# Think twice before cutting it close with big rigs

uestion: I drive truck for a living.

us off? These big riggs can't stop on a
dime. It's frustrating because when
they do that it can cause a wreck.

Answer: Changing lanes and cutting

takes to stop.

• Stopping Distance: An average passenger car traveling at 55 mph can stop within 130 to 140 feet. A fully loaded tractor-trailer may need more than 400 feet to stop completely.

• Safe Following Distance: Following a

commercial vehicle too closely reduces your ability to see the road ahead. Maintain a safe following distance and position your vehicle so the driver can see you in their side mirrors. This will also give you time to react if the commercial vehicle stops suddenly.

• Headlights at Night: Commercial vehicles have large side mirrors that can reflect light. When following a commercial vehicle at night, always dim your headlights to avoid blinding the driver.

 Merging: When a commercial vehicle merges into traffic, it needs more time than a car to accelerate and reach normal speed. Be prepared to slow down or change lanes to allow the truck to merge safely.

• Stopping on an Upgrade: If you stop behind a commercial vehicle on an upgrade, allow space for the truck to roll back slightly when it starts to move. Position your vehicle on the left side of your lane so the driver can see you in the side mirror.

# Isanti County drone purchase grounded

The fear of the fiscal unknown is causing the Isanti County Sheriff's Office to drop a request to purchase a tethered drone.

Previously, Emergency Management Director Clinton Maxson had asked the Isanti County Commissioners to approve the purchase of a tethered drone, primarily using money that was awarded to the county through the Urban Area Security Initiative. While presenting to the board, Maxson acknowledged that program was being scrutinized by the U.S. Department of Government Efficiency, meaning there was a possibility the grant money could be withdrawn before the county was able to collect it from the state. Given that, the County Commissioners opted to table the request until either it was more certain if the grant money would still be available or the Sheriff's Office was able to figure out an alternative way to pay for the drone should the grant be withdrawn.

During the May 20 Isanti County Commissioner meeting, Maxson gave an update on the request.

"Last week, (County Administrator) Amanda Usher, Sheriff Sieberlich, and I met to discuss the grant," Maxson told the board. "We discussed possible temporary funding sources while awaiting reimbursement, the potential risk for non-reim-

bursement, and the overall wants versus needs. We came to the consensus that the uncertain landscape for federal reimbursement post-purchase exposes the county to too much financial risk."

With that, Maxson informed the board the Sheriff's Office would be declining the grant at this time.

'It's tough to not accept free money," said Chair Alan Duff, "but in this case, it may not come."

#### **AFFECTS OF TARIFFS**

In other county commissioner actions caused by recent federal government actions, the commissioners scheduled a special, single-topic Committee of the Whole meeting for 9 a.m. Tuesday, May 27. According to County Administrator Amanda Usher the county is starting to see additional costs on previously approved purchases due to recently enacted tariffs. She said some of those additional costs might push the purchase price above the "not to exceed" amount approved by the commissioners.

Usher wants the board to discuss what staff should do in such an instance. She said the commissioners could have leaders bring the purchase request back before the board, or it could continue the approval process with the "up to" amount including any im-

Whatever the board decides at the COW meeting will have to be formally voted on at a future regular meeting.

# North Branch Council considers zoning changes

Developers will get another chance to try to convince North Branch officials to allow single-family homes in areas zoned for multi-family housing.

Kris Carroll is hoping to develop a mix of single-family homes and apartments on vacant land just west of Interstate 35, across Falcon Avenue from the Wildridge communities, and south of the Ecumen facilities and furniture stores. The development would be called Cedar Ridge Community.

The parcel in question is 62 acres, and Carroll is seeking approval of plans to divide it into 75 small single-family home sites, three apartment buildings containing a total of 167 units, and seven additional outlots "which will be for future commercial development or stormwater ponding depending upon the location of the parcel," according to the staff report.

The area is currently zoned R3, high-density residential, which requires a density of six units per acre and does not technically allow for the construction of single-family homes.

Carroll is hoping to change that by meeting density requirements through apartment buildings.

Developers initially thought single-family homes were permitted on the site due to a conflict in city code. While the zoning code does not officially permit building of single-family homes in an R3 district, the section dedicated to design standards for all types of districts includes standards for single-family homes located in an R3 district.

According to Community Development Director Nathan Sondrol, the resolution to the conflict is also in the code: the city is required to side with the more restrictive rules in case of conflict, which in this case would mean no single-family homes in R3 districts.

Thus, for Cedar Ridge to proceed, the

city would need to amend its zoning code to allow for single-family homes to be built in high-density residential areas, provided the density requirement is met.

This would change the code in all R3 districts across the city, which constitute more than 200 acres of vacant land, said Mayor Kevin Schieber.

The request comes as North Branch begins the process of updating its comprehensive plan, which could mean changes to zoning and other laws that affect development in the city.

At the May 6 Planning Commission meeting, several residents from the nearby Wildridge developments spoke against allowing apartments on the parcel, citing traffic and safety con-

Commissioner Gary Schaefer countered that to attract the type of commercial activity residents said they also wanted, more housing was a necessity.

"To get businesses, we need rooftops,"

Schaefer said at the planning commission meeting.

At the May 13 council meeting, Schieber pointed out that the land is presently zoned to only allow apartments regardless of what nearby residents want or don't want to be built there. It's the proposed single-family homes that would require a change of policy.

Carroll updated the plan's phasing between the Planning Commission and the city council meeting to get all the apartments built within the first two phases, quelling the city's fears of a potential zoning change that would allow a development that would ultimately not meet density requirements.

The council tabled consideration of the zoning change to its June 10 meeting. Carroll said that if the change goes her way, she is hoping to start the project in July.
