A list of real property in Isanti County on which delinquent property taxes and penalties are due has been filed with the District Court Administrator of Isanti County. This list is published to inform all persons that the listed property is subject to forfeiture because of delinquent taxes.					
The property owner, taxpayer or other interested person must either pay the tax and penalty, plus interest and costs, or file a written objection with the District Court Administrator. The objection must be filed by April 31, 2025, stating the reason why the tax or penalty is not due on the property. If no objection is filed, a court judgment will be entered against the property for the unpaid tax, penalty, interest and costs.					
For property under court judgment, the period of redemption begins on May 12, 2025, and ends three years later. The period of redemption means the time within which taxes must be paid to avoid losing the property through forfeiture.					
To avoid forfeiture, taxes on the property must be paid by May 8, 2028.

Head-on crash hospitalizes seven

A head-on collision between two vehicles on Rush Lake Trail in Nessel Township on Friday, March 14 resulted in seven people — including five minors, being sent to the hospital with various degrees of injury.  
According to a press release from the Chisago County Sheriff's Office, at approximately 6:18 p.m., a 911 call was received reporting a head-on collision on Rush Lake Trail, south of Belle Isle Drive. Upon arrival, emergency personnel provided aid to seven victims involved in the crash.  
Based on initial investigation, it appears a Chevrolet Cruz, driven by

36 year-old Ashlee R. Klapperick was traveling northbound when it crossed over the center line and struck a Chrysler Pacifica that was traveling southbound. At the time of the crash, Klapperick's two young children were passengers in the vehicle.  
The name of the driver of the Pacifica, along with three youth passengers, has not been released as of yet. All four were transported to a metro area hospital by ambulance with non life-threatening injuries.  
Klapperick and her two children were flown via helicopter to metro area hospitals. One of the children, who is described as a 4 year-old male, remains in critical condition with life

threatening injuries. The other child, a 3 year-old, has already been released from the hospital.  
Klapperick, who was ready to be released from the hospital on Wednesday, March 19, has been taken into custody as impairment does appear to be a factor. Formal toxicology results are still pending. A criminal complaint is anticipated to be released by the Chisago County Attorney's Office in the coming days.  
The Chisago County Sheriff's Office was assisted by Lakes Region EMS, North Memorial Air Care, Life Link III, the Minnesota State Patrol Crash Recon, Rush City Fire Department, and Allina Health EMS.
