Large portion of North Branch industrial park set for purchase

North Branch is on the verge of turning its luck around for its sparsely occupied industrial park.

Louisiana-Pacific Corporation, a global siding manufacturer, has developed a \$5,250,000 purchase agreement with the North Branch Economic Development Authority for 120 acres of the park to build a 250,000 square foot manufacturing facility.

This project would occupy nearly half of the vacant space in the long-largely-vacant park, and could create roughly 100 jobs with a \$157 million dollar investment — numbers that are strictly preliminary and subject to change,

City Development Director Nathan Sondrol emphasized.

The land, consisting of parts of five parcels, sits at "the southwest corner of 410th Street and County Road 30."

"The manufacturing at this facility will include LP's Expert finish facility which special izes in pre-finishing engineered wood siding trim with durable, factory applied paint in var ious colors, reducing the installation time and labor for builders by eliminating field painting and caulking needs," the staff report reads. "The site will require the outdoor storage of materials on the site."

NORTH BRANCH: Siding manufacturer set to purchase 120 acres in industrial park

City staff submitted a proposal for the project in May and has completed several site visits with LP, which considered multiple local and national sites before proceeding with North Branch, according staff reports.

This would be LP's second manufacturing facility in Minnesota, with the other in Two Harbors, and several more in Wisconsin and Michigan, according to its website. It is headquartered in Nashville, Tennessee, with all other administrative offices located across

Central and South America. The city has applied for and received grant funding to improve and expand

Isanti County whittles down levy increase to 1.99%

What started out last June as a double-digit levy increase for Isanti County residents has been chunked and chipped away to a sub-four percent increase as presented at the recent Truth in Taxation meeting, and ultimately down even further to just under a 2% increase.

Following one last committee of the whole meeting where the board gave its last-ditch offerings for how to shrink the levy increase even further, the commissioners were presented with three final options: keep it at the 3.63% increase as presented at the Truth in Taxation meeting, decrease it to 2.85%, or drop it even further to an increase of 1.99%.

In order to achieve those percentages, the county would use up to \$1.1 million from the general fund balance and/or the newly created capital improvement fund. Earlier in the meeting, the board approved moving \$2.5 million from the general fund balance to this capital improvement fund. That money would be earmarked for future capital improvement projects. This would decrease the general fund, which acts as a financial cushion in case of a financial crisis, to approximately 45% of the general fund.

During discussions at the final regular meeting of 2025, Commissioners Steve Westerberg and Bill Berg indicated they would be comfortable going with the "middle ground" number of 2.85%, citing concerns over the uncertainty of next year's budget. According to some financial experts, local governments may be looking at huge increases in expenses. The top two factors in this dire

forecast are an expected increase in employee insurance rates, plus a decrease in state funding due to the predicted state budget shortfall.

"I would rather have a small increase this year rather than face a large increase in 2027," Westerberg

Commissioner Todd Christiensen countered that based on this board's recent history of minimal to no levy increases, he is confident they can repeat that next year.

"If we continue to be very frugal and look at places we can cut, I don't think it will be as bad as we think,' Christiensen said.

County Administrator Amanda Usher cautioned the board against continually dipping into the fund balance simply to reduce the levy. She noted the fund balance had become very healthy thanks to ARPA funds, however those funds are all but dried up.

"That's been really helpful in being able to do some of these projects," Usher said, referring to the County Road 5 roundabout and county jail improvements. "What I really would hate to see is for us to continue to use fund balance to get these lower levies. Two point eight five is a low levy, it is a great amount. To use more to get that lower won't have a significant impact on taxpayers. I think it's about \$10 per year for the average

Initially, a motion to go with a 2.85% levy increase failed on a 2-3 vote, with Westerberg and Berg vot-

A subsequent motion to go with a 1.99% levy increase passed by a 3-2 vote, again with Westerberg and Berg voting in the minority.

Prune oaks now to avoid oak wilt

Now through February is the safest time to prune or cut oaks without risking oak wilt, an invasive fungal disease deadly to Minnesota's oaks, according to the DNR. The disease spreads when sap-feeding beetles carry spores from infected trees to fresh wounds.

"Oak wilt is costly to treat, but prevention is often free and effective," said Brian Schwingle, DNR Forest Health Program consultant. Winter pruning avoids the beetles' active spring and summer season, reducing infection risk.

What should your keep in your car for winter survival?

uestion: I know you were talking about winter safety tips in your last article. Can you go over the items a person should have in their vehicle when traveling in the winter?

Answer: When assembling a winter travel survival kit, it's best to include a variety of items that prepare you for cold, isolation, and unexpected delays. Even if you keep the kit in your vehicle year-round, review it regularly to make sure everything is in good condition and still in its proper place. A winter travel survival kit

should focus on warmth, traction, communication, and basic supplies.

WINTER TRAVEL SURVIVAL KIT ESSENTIALS

Warmth

- Extra blankets or a sleeping bag
- Warm hats, gloves, socks, and scarves
- Hand and foot warmers
- Emergency thermal (space) blanket

Traction & Vehicle Safety

- Ice scraper and snow brush
- Small shovel
- Sand, cat litter, or traction mats
- Tire chains (if appropriate for your area)

Jumper cables

Communication & Visibility

- Fully charged power bank and charging cables
- Flashlight or headlamp with extra batteries
- Reflective vest or roadside flares
- Whistle for signaling
- Paper and pencil(s) to leave note/message

Basic Supplies Non-perishable food and snacks

- Bottled water (rotate to prevent freezing or expiration)
 - First aid kit
 - Multi-tool or basic tool kit
 - Matches or lighter (stored safely)
 - Paper towels, tissues, and wet wipes

Additional Helpful Items

- Map of the area (in case GPS fails)
- Emergency contact information
- Duct tape and zip ties
- Tow strap

Keeping these essentials on hand can make a critical difference if you're stranded or delayed during winter travel. Regular checks ensure your kit is always ready when you need it most.

Minnesota state parks celebrate new year with first-day hikes

On Thursday, Jan. 1, the Minnesota Department of Natural Resources is hosting First Day Hike events at 12 state parks in support of a nationwide effort to connect people to the outdoors. As part of the First Day Hikes initiative led by America's State Parks, a national organization, hikers in all 50 states will welcome the new year with an outdoor hike, exercising and connecting with nature.

The DNR's First Day Hikes will be held at: •Blue Mounds State Park, Luverne

- •Forestville/Mystery Cave State •Fort Snelling State Park, St. Paul
- Jay Cooke State Park, Carlton
- •Lake Bemidii State Park, Bemidii •Lake Vermilion-Soudan Underground Mine State Park, Soudan

- Maplewood State Park, Pelican Rapids
- •Minneopa State Park, Mankato
- •Nerstrand Big Woods State Park,
 - •Tettegouche State Park, Silver Bay •Whitewater State Park, Altura
- •William O'Brien State Park, Marine on St. Croix

Participants may snowshoe if the ground has enough snow cover. They can bring their own snowshoes or borrow a set from the state park (if available) at no charge.

There is no participation fee for First Day Hikes, but visitors need a vehicle permit (\$7 per day or \$35 for a year) to enter Minnesota state parks and recreation areas. Visitors can save time and purchase permits in advance on the DNR's permit webpage (mndnr.gov/permit) or buy a permit in person during open hours at a state park ranger station.

Dispose of holiday greens, Christmas trees correctly

Holiday greenery and Christmas trees bring joy throughout the season, but they can also hide dangerous pests. Diseases and invasive species can make their way into our landscapes on trees and boughs brought into Minnesota from other states.

To protect our environment, the Minnesota Department of Agriculture is asking residents to take these steps to properly dispose of greenery and trees after the holiday season:

The best option is to use a curbside tree collection or bring trees to a designated drop-off site. Check with your waste hauler, city, or county to see what services are offered in your area. The Minnesota Pollution Control Agency has a map of yard waste compost locations; contact locations directly to see if they accept trees and greenery.

Don't toss trees and greenery into your backyard woods or residential compost pile, which can spread the invasive species or disease.

Wreaths and other decorative greens

can be disposed of in trash cans.

If your city or county does not have an organized pick-up or drop-oil, the last resort is to burn the greens. Always check fire danger conditions and burning restrictions before burning and follow local ordinances.

Pests of concern include elongate hemlock scale, a small insect established in the eastern United States where many Fraser firs are grown. Damage caused by this invasive insect can cause the needles of hemlocks, firs, and spruces to yellow and prematurely drop. Also, boxwood blight, a fungal disease, and round leaf bittersweet, an invasive noxious weed, are sometimes found on wreaths and centerpieces and can endanger native trees.

Isanti City Council pulls off flat levy

The Isanti City Council metaphorically pulled a rabbit out of its hat, delivering a flat levy amount for 2026. The next several years, however, will reveal if its actions turn out to be just an illusion.

As late as the annual Truth in Taxation meeting, held on Dec. 2, it looked like the city was looking at a levy increase of 5.05%. While this amount would still equate to lower taxes for some residents based on the continued increase in the city's tax base and subsequent decrease in the tax rate, the council instructed finance director Nicholas Solberg to continue looking for ways to trim the budget even further.

During the Dec. 16 meeting, Solberg presented two options for the council to consider: the original levy amount, or a 0% increase (flat) levy amount. Solberg said the only difference between the two options was the city council would be taking an additional \$182,460 out of the fund balance. He said the first

option uses \$212,860 from the fund balance, leaving the fund balance at 50.87% of unrestricted balance. The second option takes \$395,320 from the fund balance, leaving a projected 47.20% of unrestricted fund balance.

Solberg said the downside to going with a flat levy this year is it sets up a potential double-digit levy increase percentage for next year.

"With the second option (the flat levy for 2026), just to get our tax levy back to where we're not pulling any amount from the fund balance in 2027, we would have a projected levy increase of 10.93%," Solberg said, "compared to the first option, we would only need to increase our total tax levy by 5.06% to make up that \$212,000 in fund balance used for 2026."

He also mentioned capital improvement projects slated for 2027 would increase the projected levy to 12.74% in 2027.

"Using those reserves is good to steady out the levy," Solberg said. "We just don't want to get to the point so that we are running the fund balance so low that now

we are not only trying to catch up to get to zero, but also needing to make up some of the fund balance."

Mayor Luke Merrill pointed out those numbers were assuming no growth, no sales of city owned property, and no budget cuts.

"Yep, but those numbers also don't include any increases to wages or steps or potential insurance wages," Solberg added.

Merrill also pointed out city policy called for a fund balance between 30% and 70%, "so even at 47% we would be right in the middle."

Merrill also noted the EDA is expected to sell some land worth approximately \$182,000, which would offset some of the projected levy increase under option two. He added the city anticipates on being debt-free starting in 2029, which will eliminate \$200,000 from each year's budget going forward.

Ultimately, the council approved going with a flat levy for 2026 by a 4-0 vote. Council member Steve Lundeen was absent from the meeting.








