# Isanti staff to be allowed to carry weapons

Isanti city staff will most likely soon be able to carry a properly registered and licensed firearm while on the job at City Hall or other city owned buildings.

As an offshoot of the discussion regarding police presence at Parks and Recreation Committee meetings, the Isanti City Council is taking a look at altering its staff personnel policy from forbidding staff from carrying weapons in city owned buildings to allowing those with conceal and carry permits to carry them. Currently, such weapons must be at least kept in their

While all five council members agreed that based on the Second Amendment, city staff should be allowed to have a weapon on their person if they feel the need, the council was split on if there should be additional conditions to the policy. Council member Steve Lundeen felt it should be under the condition the weapon is kept concealed at all times, barring a need to use it.

"As long as they aren't allowed to brandish it, I don't have a problem with (changing the policy)," Lundeen said. "Texas, the easiest going state on firearms, you cannot have open carry."

Lundeen said he was also concerned about the public's perception if they see a city employee carrying a weapon.

Mayor Luke Merrill and Council members Nick Pedersen and George Hemen, however, didn't feel that condition should be included.

"If you have a firearm on your hip and your shirt comes up over it, it's not concealed," Merrill said. "So what if you are sitting at your desk and it's no longer concealed and another employee wants retribution on them, they could call on them about not being concealed."

After further discussion, the

# What happens next?

## School District projects future based on yes, no vote

Editor's note: This is the ninth and final

article in our series regarding the upcoming Cambridge-Isanti Schools referendum

No matter what the results of the Cambridge-Isanti Schools' bond referendum may be, the district is already looking towards what the next steps they will take will be.

According to Superintendent Dr. Nate Rudolph, there are two things that will definitely happen, regardless of whether the final outcome is passing or failing the question(s). The first is that the district will take a couple of days to take a step back, take a deep breath, and thank

"When you go through this as a community, it is fatiguing and appreciative," Rudolph said. "and whatever next steps we need to establish based on the results, we will do. We would pause and acknowledge the community, the community task force, the people who were informed, the dialogue, and everything we did over the last year to get to the point of (November) 5."

The second is that the district will continue to look for community input.

Beyond that, it will solely depend on if one or both questions pass or fail.

### **QUESTION 1 PASSES**

According to Finance Director Chris Kampa, there are several procedural actions that need to take place for larger projects. This includes consulting with engineers, coming up with the scope and specific details of each project, calling

for bids, awarding projects, and finally starting construction. He added most of the projects would not begin until school was out for the summer to minimize the inconvenience on students and staff.

Before all of that, however, Kampa, Rudolph, and Community Development Director Christina Thayer Anderson agree the district will have to prioritize all of the projects, determining which projects would be the first to get started. That step is where gathering further input from the staff and community would be essential, according to Rudolph.

Once the "first phase" of projects has been established, Kampa said prioritizing the remaining projects very well could be very fluid, especially considering completing all the projects will take four or five years.

Another major factor to the prioritizing of projects would be how the bids for the previous projects come in. If bids start consistently coming in over the anticipated cost, Kampa stated the district will have to make some tough decisions.

Legally, the district cannot collect from taxpayers more than \$87.1 million if question 1 passes or \$123,575,000 if question 2 also passes. Therefore, if costs are consistently higher, the district would have to find other funding sources or cut lower-priority projects.

Kampa, however, feels optimistic bids will for the most part come in under expectations. He notes how the parking lot projects last summer each came in under budget, along with the Cambridge Primary and Intermediate Schools boiler system replacement.

council approved on a 4-1 vote, with Pedersen casting the lone nay vote, to ask the city attorney to come up with the appropriate rewording of the policy. According to City Administrator Josi Wood, the city attorney's recommended language should be available in time for the next council meeting.

### NO POLICE PRESENCE NEEDED

As a follow-up to the council discussion on police presence at Parks and Recreation meetings, Hemen, who sits on that committee, said the committee discussed the matter at its last meeting and determined the whole situation was a misunderstanding between staff members and then between staff and the council. Hemen asserted police

presence would not be needed at future meetings.

#### **SECOND MARIJUANA STORE**

A second cannabis store will be opening up within city limits. This store will be located at 703 East Dual Blvd NE. After the council approved the registration, Council member Hemen asked the council to revisit the city's

ordinance pertaining to the number of cannabis businesses allowed within city limits. The council currently allows an unlimited number, however that decision was made under the assumption the city would somewhat financially benefit from each business. During the last legislative session, however, those benefits to local governments were removed.

# C-I Schools referendum early voting begins Sept. 19

Any residents within the Cambridge-Isanti School District's boundaries wishing to cast their vote on the proposed bond referendum before the general election on Nov. 4 can do so beginning Friday, Sept. 19.

There are two ways to vote early: by mail or in person. To cast your vote via mail, a person must complete the absentee voter application and either email it to mallen@c-ischools.org or send it in via regular mail to Attn: Elections, 625 Main Street N. Cambridge, MN, 55008. If voting by mail, the school district strongly encourages people to submit their applications prior to Oct. 20. Additionally, completed ballots should be mailed back as soon as possible, or no later than Oct. 31, to ensure they arrive before Nov. 4. Any ballots received after election day will not

For those wishing to vote early in person, there are two locations they can do so from Sept. 19 through Nov. 3. The first is the school district's offices located in the Education Services Center at 625 Main Street North in Cambridge. The district offices are open for early voting Monday through Friday from 7:30 a.m. to

The second location is at the Cambridge-Isanti High School, located at 430 8th Ave NW, Cambridge. Early voting is open from 7:30 a.m. to 4 p.m. Monday through Friday, but only when classes are in session. On Thursdays, there will be extended voting hours to

8 p.m. — also only on days when school is in session.

In Minnesota, people can register to vote on the same day they wish to vote. Unregistered voters should bring a photo ID, such as a driver's license or another acceptable identification for voter registration. First responders located the pilot and determined he was deceased. The identity of the pilot is being withheld pending the notification of the family.



# Minnesota DNR shares what to expect for the 2025 fall color

The Minnesota Department of Natural Resources has released its 2025 fall color forecast, with peak colors expected from late September through mid-October. The change begins in the northwest and north-central regions before moving southeast, typically lasting about a week in each area.

The timing and brilliance of colors depend on sunlight, temperature, precipitation and tree species. Sunny days, cool nights and steady rainfall during the growing season create the most vibrant displays. This year's relatively dry May followed by steady summer rains has set the stage for strong fall colors, barring any early hard freezes.

"Brilliant fall color occurs when early fall days are sunny, nights are chilly and there is adequate rainfall," said Brian Schwingle, DNR forest health



consultant. "Regardless of conditions, there should be plenty of beautiful foliage to enjoy.

The DNR's Fall Color Finder at mndnr.gov/fallcolor provides weekly updates, maps and photos to help Minnesotans track peak viewing times.~MN

# Get out and make an informed vote

his week's edition features the ninth and final article regarding the Cambridge-Isanti School District's upcoming bond referendum. When I first saw the massive number of proposed projects involved with this vote, I knew I couldn't simply condense all the information

down to an article or two, or even three.

My main goal for this series is to enable as many informed votes as possible — no matter how each person decides to vote. And believe it or not, so does the school

Some claim the district scheduled this vote during an off-election year solely to make it easier to pass. That does seem to be the suggested course of action by the experts. However, it also doesn't necessarily guarantee passage. How many referendums did it take North Branch and Mora to finally get one passed? Pine City is still trying to get one passed. Most, if not all, those elections were held outside the general election day.

Again, believe it or not, but districts prefer a large voter turnout, as long as those voters are making an informed decision. When a referendum is included in a general election, there are many more uninformed votes cast. Many people are focused on a different major election, say the governor or the president. Some probably even go to their polling location completely unaware there is a referendum question on their ballot. As soon as they see someone is asking for more money, their knee-jerk reaction is to say "no," even if they might have voted yes if they had known some little snippets about the

### PAID LETTERS POLICY

On the subject of the bond referendum, there has been some confusion about our paid letter to the editor policy. As we've mentioned before, in an effort to minimize organized letter campaigns flooding the newspaper's opinion pages, we have instituted a paid letter policy that says any letter endorsing for or against a candidate or other ballot question will be assessed a small publishing fee, whether the endorsement is direct or indirect.

While that might seem pretty cut and dried, the confusion comes in with the "indirect" endorsements, especially regarding bond referendums. With a candidate, a letter writer could get around our policy by focusing on a topic instead of a person. For example, if there are city council seats up for election and someone wants to complain about something like the upcoming levy, they can do that and not be assessed a fee. All they would have to do is avoid referencing candidates, political parties, or the election.

That's not that easy for a referendum vote. For example, several residents have voiced their opposition to artificial turf. If that subject wasn't part of the referendum and say the school district simply announced they have found a way to pay for artificial turf without a vote, then there would be no fee imposed by us. But since it is one of the prominent projects on this referendum, by saying you oppose artificial turf, you are indirectly promoting a no vote.



Remember, parents, you need to be aware of what your children are watching on social media and to seek friends who have faith and morals.



Our strong partnership with the North Branch Police Department plays a vital role in school safety. With a full-time School Resource Officer on campus, we benefit from both enhanced safety and the positive relationships the officer builds with students, staff, and families. Trained crossing guards provide additional protection during arrival and dismissal times, helping students safely navigate busy roads.

Clarity of expectations is one of the most effective tools we have for creating a safe and respectful environment. The Student-Parent Handbook serves as a key resource for outlining these expectations, and our Welcome Days give students a personalized and structured start to the school vear. Staff members reinforce safety through student orientations, direct instruction on school policies and procedures, and bus safety training that helps students understand how to ride safely and responsibly. Clarity is kind, and when expectations are clear, students feel more secure and supported.

We also follow the Standard Re-

sponse Protocols developed by the I Love U Guys Foundation, which provide a common language and clear procedures for responding to a range of emergencies. These include Hold, which keeps hallways clear while classes continue as normal, and Secure, which brings everyone inside while the school remains locked due to an external concern. The protocols also cover more serious responses such as Lockdown, Evacuate, and Shelter. These procedures are well established and practiced by all staff and students, ensuring a strong foundation for emergency response.

Safety goes beyond physical well-being. It includes emotional and relational awareness as well. Trained social workers and individual therapy services are available at every school in our district, providing essential mental health support to students who

need it.

One of the most powerful tools we have is communication. People noticing and speaking up is essential. If something feels off, say something. Whether it is a student sharing a concern with a teacher or a parent reaching out to staff, every voice matters. It is often these small acts of awareness and courage that prevent harm and keep our schools safe.

Our vigilance in ensuring that schools are safe and that students feel safe is ongoing work. It is not a box we check at the start of the year, but a daily responsibility we share as educators, families, students, and community members.

By maintaining strong partnerships, clear expectations, and open lines of communication, we create an environment where every student can thrive. ## Drivers reminded to stop 20 feet from school buses

uestion: With school back in session, can you talk about school bus safety and what motorists need to know?

Answer: School buses have yellow and red lights that flash alternately to warn drivers they

are stopping to load or unload students. Bus drivers will ac-

Ask A **Trooper** Jesse Grabow tivate flashing yellow lights at least 100 feet before a school bus stops in a speed zone of 35 mph or less. They will activate the lights at least 300 feet before it stops in a speed zone of more than 35 mph. It

is against the law to pass on the right side of a school bus while it is displaying red or yellow

flashing lights.

Flashing red lights warn drivers that the school bus is loading or unloading students. When you see a school bus that is stopped with its red lights flashing and its stop arm extended, you must stop your vehicle at least 20 feet from the bus.

Regardless of whether you are facing the front or back of the bus, you must remain stopped until the stop arm is retracted, and the red lights stop flashing. If you don't, you can be charged with a misdemeanor. If convicted, you must pay a fine of at least \$500 and lose your driving privileges.

Rudolph also pointed to the 2021 successful operating levy referendum, noting the final impact on taxpayers was lower than what the district had been quoting heading into that vote.

"There are a lot of assumptions built into the project costs and they are very conservative," Kampa said.

Does that mean if projects continue to come in under estimated costs, the district would come up with additional projects? Kampa acknowledged legally, the district could do that. However, it would not happen until after all the bids were received, in case projects started going over budget. And it wouldn't happen without additional community input.

"We've structured this to be maximum flexibility to be as beneficial to the community," Kampa said. "We also have the capability to lessen the tax impact."

"That's part of being fiscally conservative," Rudolph added. "We manage the money so we do what we say and we say what we do. Chris is always tasked with

### **QUESTION 1 FAILS**

It should come as no surprise to anyone, if question 1 fails, there will most likely be another referendum vote. What that referendum would look like, or when it would be put up for a public vote, however, is unknown even by the district.

"We would go back to the community," Rudolph said. "We would go to our community and say 'we still have these needs.' We would ask our community task force 'how are we going to do this?' Because the

needs won't go away. We have the responsibility of taking care of our community assets. If the community said no to this, what would be the next iteration and we will likely come back (with another referendum) because there is not another way to fix this level of

Based on state statute, a second referendum vote asking for the same amount of bond money cannot be held until at least 180 days after the first election. Based on that, the earliest a second bond referendum election could be held would be the second Tuesday

in May, 2026.

According to Kampa, one thing that won't happen should question 1 fails is property owners seeing an immediate decrease in their taxes. While there is debt that will be coming off the books from previous bonds, the amount varies from year-to-year, with the next two years seeing minimal decreases.

Kampa said the district is not bonding the entire amount all at once. Rather, they will bond in phases that mirror the varied amounts of the old bonds. After the initial increase the first year (\$5 per month for question 1 or \$16 per month for both questions on a \$300,000 home), the total amount of money homeowners will pay for the school district's debt will be the same each year — assuming there is no change in their property value.

"The projects will get more expensive," Kampa said. "And we're going to get further behind on deferred maintenance.'

"Additionally, our students and community members will continue to lose out on opportunities," Thayer Anderson said. "We will have to continue to make really hard decisions on what programs will not continue."

### QUESTION 1 PASSES, QUESTION 2 FAILS

But what if question 2, which deals with the construction of a fieldhouse, plus other projects directly related to it, fails while question 1 passes?

According to Rudolph, it is possible another referendum may be called exclusively to consider the same or a scaled-down version. Again, though, that would be entirely up to the discretion of the Facilities Committee and other community members.

"We are doing the community's work right now," Rudolph said. "If the community gives us different feedback through the referendum, we would continue to re-engage them and ask them to give us more guidance and we will do that work for them. It all comes down to what the community wants us to do and we execute that."

# Braham Mayor seeks Republican endorsement for state auditor

Braham Mayor Nate George will seek the Republican endorsement for the position of state auditor.

George will vie for the position currently held by State Auditor Julie Blaha, who will not be running for reelection in 2026.

"If I am lucky enough to have the opportunity to become the Republican endorsed candidate, then it is an all-out statewide campaign and race to the November 2026 ballot box," George said. "The current incumbent ... has announced she will not run for re-election, so it is an open seat up for grabs.

"Unless another Republican challenger stays in the race, then it would go to a primary next August, and the Republican candidate with the most votes would go on to the November election from there. I already have grassroots bipartisan support and am confident my values and views on the responsibilities of this office will resonate with most Minnesotans. Ground work has already begun leading up to the caucuses and endorsing conventions next spring."

Minnesota State Rep. Dan Wolgamott, DFL-St. Cloud, announced his intention to run for auditor shortly after Blaha's announcement. Wolgamott pleaded guilty in October 2023 to a misdemeanor charge of driving while intoxicated

during an incident on July 7, 2023, in Kanabec County.

Republican Rep. Elliott Engen of White Bear Township is reportedly considering a run for auditor as well, according to Axios.

### **COMMON SENSE**

George, who was elected mayor of Braham in November 2022, said his choice to throw his hat into the auditor's ring was similar to how he got into local politics: He was asked.

"People tell me they like my leadership and common-sense approach to government and admire the financial turnaround we were able to make here with the city of Braham's finances," George said. "Our state representatives have also encouraged me to run for state office, and this would be a good fit given my experience with local finances and budgeting, auditing, state government, running government agencies, and compliance (and) regulation experience."

George noted the primary focus of the state auditor is to audit and monitor compliance of local units of government, such as townships, cities, counties and school boards.

"They also audit and monitor compliance for state agencies that receive federal funding," he said. "My experience relates directly to this role in many ways, from managing and overseeing the city budget and audit requirements,

to leading government agencies like the city of Braham and as the director of licensing and investigations with the Mille Lacs Band of Ojibwe - Office of Gaming Regulation & Compliance.

"I also have executive-level experience in the private sector, as well as in the military serving on a headquarters staff," he added. "I worked for the state at the Capitol for almost six years, have over a decade of experience in my current role and previous roles with interpreting and enforcing government regulation and compliance, as well as conducting and leading criminal and administrative investigations stemming from complaints or audit findings.

George has university degrees in business management, law enforcement and criminal justice, and he is working on a Master of Law and paralegal certification at Hamline University, which he expects to obtain in May 2026.

'With so much fraud happening at the state level, Minnesotans want someone who can bring accountability and integrity back to the state auditor's office," he said. "Not only do I have a ton of experience rooting out fraud, criminal activity and inefficiencies in government, my character aligns with the values I mentioned that taxpayers

George is married and the father of five. In addition to his position as mayor and his job with the Mille Lacs Band of Ojibwe, he is preparing to retire after 20 years with the U.S. Air Force Reserve; his military service includes three combat deployments, one non-combat deployment and 19 decorations.

### **NO AMBITION**

George contends that his success in politics can be attributed to his lack of political ambition.

"I am not a polished politician looking for a career," he said. "I am a bluejean-wearing, every-day family guy and veteran, who pays taxes and (is) raising a family while being tired of rampant corruption, fraud and incompetence in government.

"I am involved in politics because I simply answered the call to service when asked, knowing it was the right thing to do. My interest in taking on the next challenge is simply to do the right thing, and instill trust and accountabil ity in state government and local government. My motivation is always what is best and what is legal, for the People, and are their tax dollars being spent honestly, for the right reasons. We need to do a better job as citizens electing people into office with these values, regardless of what party they belong to in the end, because complacency is what breeds fraud."

# Cedergren family nurtures soil and conservation ethic

Rick Cedergren grew up on a dairy farm in southern Chisago County but never planned to make farming his career. He holds three degrees but jokes that he has never used any of them.

After high school, Cedergren studied music at the University of Wisconsin-Eau Claire. He earned a master's degree in New Testament studies from Luther Seminary and a two-year degree in Food Science and Technology from Dunwoody College. He worked at General Mills and lived in north Minneapolis but became disillusioned with the food industry. His wife, Sarah, suggested they find a farm.

In 2016, the Cedergrens purchased 37 acres in North Branch, naming it Chain Lake Pastures. They began converting row crops to pasture and pollinator habitat while planting a windbreak to prevent runoff and erosion. Today, pigs graze 3.5 acres of old growth oaks, and a mobile chicken enclosure supports 70 to 100 laying hens. The couple also raises a small herd of Randall Lineback cattle, a colonial breed from the 1700s and 1800s that is now considered critically

Rick Cedergren practices regenerative agriculture,

a holistic approach aimed at improving soil, water, and ecosystem health. The method cycles grazing, nutrient deposition, and resting to restore balanced microbiota and promote plant growth and moisture

His conservation work led him to join the Chisago Soil and Water Conservation District board in 2023. He was elected last fall to serve a full four-year term. The SWCD provides education and technical support to help landowners implement conservation practices.

The Cedergrens' connection to the SWCD runs deep. When the organization was established in 1950, Cedergren's great uncle, John Cedergren, was one of the first three board supervisors and later worked for the Blue Earth SWCD in Mankato.

Rick Cedergren said he is encouraged by the diversity of experience on the board and the growing number of local farmers using conservation practices, including cover crops and no-till farming. He said many new farmers and homesteaders are willing to take action to improve their soil and water even outside of government programs.

This fall, the Chisago SWCD celebrates its 75th

anniversary, and Cedergren is proud to continue a family tradition of growing healthy food and soil in northern Chisago County.

Trees and shrubs

### Pests and diseases

Composting in home gardens is a great way to keep valuable nutrients and soil-building materials in your garden, and potentially save you money if you typically buy compost for your garden.

However, do not add diseased plant material to your home compost pile at the end of the growing season. Your home compost pile likely does not heat up high or long enough to kill most pathogens. Diseased plant material should be placed in a yard waste bin that is taken to a

drought-like conditions going into winter.

Dry soil cools down faster than moist soil, and plant roots need to slowly acclimate to colder temperatures to avoid

Take the time to learn about proper watering techniques for trees and shrubs. Watering deeply and infrequently, such as once a week, is better than watering shallowly and more frequently.

You may not know that watering established trees and shrubs differs from watering newly planted trees and shrubs.

### Flowers and other garden plants

Order spring-flowering bulbs and garlic this month. Wait to plant the bulbs until the end of this month if you live further north, and until midway through next month if you live further south. Bulbs need to establish their roots before the ground freezes to grow well the following spring.

### Lawn

As we transition from the summer heat to September, our lawns are primed for making the biggest possible improvements. September is the most critical month of the year for our lawns.

According to the Lawn Care Calendar, this is the very best time to fertilize, aerate, control broadleaf weeds, and establish or renovate a new lawn using seed.

The best defense against weeds and other pests is a dense and healthy turf. The best way of getting a dense and healthy turf is by promoting it with the best management practices in the early fall.

### Other tasks

Stop watering your amaryllis, bring it inside, and place it in a dark, cool place for a few months if you want it to bloom during the holidays. This "resting" period signals to the bulb to send up a flowering stalk when it is watered and put in a sunny location in a few months.

# DNR, conservation groups purchase Fiedler property for hunting, recreation

A parcel of land just north of the city of Braham in Grass Lake Township is now part of the Rice Creek Wildlife Management Area.

That land, sold to the Minnesota Department of Natural Resources by Don and Kathy Fiedler and their son Shaun, will be available to the public for hunting and other recreational activities.

The sale was made possible through funding partnerships between the DNR and several local conservation groups.

Tim Marion, DNR area wildlife manager serving Isanti, Chisago, Mille Lacs and Kanabec Counties, said the parcel is just over 220 acres. The acquisition was five years in the making.

Landowner Shaun Fiedler got the process going when he reached out through a mutual friend of Marion's. "That's how 80% of our land acquisitions start is that the landowner contacts us," Marion said.

For the state of Minnesota to acquire a property, Marion said, "It takes a long time." In general, it can take approximately 18 months to ensure all state laws and county ordinances are followed and the title of the land is clear.

"But first of all, we need to have a willing seller, and we have to have a very patient seller," Marion said. "The Fiedler family was extremely patient."

Shaun Fiedler first approached the Kanabec County Board of Commis-

sioners in November 2020. County commissioners then expressed concern over the DNR's takeover of land in the county and questioned the loss of taxes on the land.

The main concern for all county boards, Marion said, is how the property taxes will be paid. Because the DNR works with a state program called Payment in Lieu of Taxes, the state compensates a county for the loss of tax base from state ownership of land. The DNR calculates the payments based on a legislatively set formula. Kanabec County receives PILT money annually from more than 20,000 acres of stateowned, natural resource lands.

#### **PARTNERS**

When the DNR acquires land from a farm family or other landowner, it often pays for it through a partnership with other organizations interested in wildlife and land conservation. In this case, the DNR received funding from the Kanabec and Isanti County chapters of Pheasants Forever; the East Central Spurs chapter of Pheasants Forever out of Pine County; the Snake River Chapter of the Minnesota Deer Hunters Association; The Minnesota Deer Hunters Association State Habitat Committee; and Reinvest in Minnesota. The Isanti County Sportsmen's Club donated a log bollard to prevent visitors from driving into the new sign.

On Saturday morning, Sept. 6, the Fiedler family and representatives

from the DNR and the various conservation groups met at the acreage to dedicate the Don and Kathy Fiedler Addition to the Rice Creek Wildlife Management Area.

"Today, we're here to celebrate two things," said Will Clayton, regional representative for Pheasants Forever. "226 brand new acres open to public hunting and the public's enjoyment, and the partners that put it here."

Clayton noted the four tenets of Pheasants Forever: create wildlife habitat, create public access, fight for sound conservation policy, and increase the number of people who want to enjoy the culture of hunting and wildlife enjoyment.

"Thanks to the support of our partners, we are able to celebrate the accomplishment of all four of those strategic priorities," Clayton said. "To achieve anything meaningful in conservation, it takes people. Pheasants Forever, at its core, is a grassroots volunteer conservation organization, and we would be nothing without the dedication of our volunteers.

"This tract is another great example of what can happen when the conservation community comes together."

### KUDOS

Marion told those assembled that he was impressed with the acreage when he first saw it, noting, "226 acres is a lot of acres without any development on it. Nothing. And it worked out really

well, and without willing sellers, these projects would never happen."

He offered praise to the various conservation and sportsmen groups who were involved in the process.

"They make my job a lot easier, and without them, this wouldn't have happened," Marion said.

Alex Gerhardson, president of the Isanti County Chapter of Pheasants Forever, told the group that even though the property is not in Isanti County, it was necessary for his chapter to assist with funding the purchase as the acreage will serve people throughout the state of Minnesota. He pointed to his daughter, who was in attendance, and said, "That's why we do it, right

there. It's for generations to come."

He also praised Marion for his planting of prairie grasses and immature trees on the land, and he thanked the Kanabec County Board for approving the land sale.

Shaun Fiedler spoke on behalf of his family, thanking all of the partners. He was touched that his parents' names would forever be associated with the land once farmed by his grandfather.

"(They were) able to put their names on this park ... so that my kids and my grandchildren will be able to come and see that," he said. "We took a little piece of this beautiful county and saved it for everyone."

# Minnesota DNR asks upland bird hunters to voluntarily log hunting activities

The Minnesota Department of Natural Resources is inviting upland bird hunters to voluntarily log details about their hunts for grouse, woodcock, pheasants,

prairie chickens and partridge.

"We're working with bird hunters to improve our understanding of what they see in the field," said Nate Huck, migratory gamebird consultant. "Their information will complement our existing monitoring efforts. We deeply appreciate hunters who take the time to share their observations."

Once the hunting seasons begin, bird hunters can use an upland bird hunting diary to share their observations. The diary is available in electronic form using web browser or app versions on the DNR website (mndnr.gov/wildlife/sightings/upland-field-log.html). Hunters can also print off a paper version of the diary and enter their hunts online at a later point.

Participating hunters will be asked to report information specific to each hunt including: date, species

pursued, if the hunter was using a dog, total hours hunted, number of birds flushed, number of birds harvested, and ages of any pheasants harvested.

Hunters are also asked to report the location of their hunt including: the county and if the hunt was on a wildlife management area, a hunter walking trail or a Walk-In Access program area.

This citizen science effort complements the DNR's once-a-year small game harvest survey to monitor upland game bird harvest. The harvest survey is available on the DNR website (mndnr.gov/wildlife/research/wildlife-research-publications.html#reports). While annual survey information is useful to estimate the total hunter effort and harvest of upland game birds, it does not provide specific, localized or season-long insights.



# Talking extracurricular activities with University of Minnesota

Families are juggling classes and activities as school resumes. Kate Walker, youth development state specialist at University of Minnesota Extension, explains how after-school programs support learning and growth.

Q: Why are extracurriculars important for kids?

Walker: After school programs provide young people with safe and engaging opportunities to develop skills they need to thrive in work and life. They can explore interests, build skills beyond the school day and contribute to their communities. These development programs are unique spaces where young people engage in real-world projects, work in teams, take on meaningful challenges and experience the accompanying emotional ups and downs. This makes them a natural space for young people to learn, practice and reinforce a range of skills such as self-control, empathy, teamwork, problem-solving and perseverance.

Q: How can families find an activity

Walker: Start with your child's spark or passion. Are they interested in exploring coding, digging into gardening or serving on a youth leadership council? What causes give them purpose or direction? What people or places bring them energy or joy? Do they need homework help, outdoor time, opportunities for self-expression or connection to peers or caring adults? There is a program or project to fit all their needs and interests. 4-H clubs and opportunities in every Minnesota county and some tribal nations are a great place to start. Kids and families can learn more at extension.umn.edu/minnesota-4-h/ about-4-H. They can also check with schools, community centers, libraries or youth-serving organizations like the YMCA or the Boys & Girls Club.

Q: What challenges do rural families face with after school activities?

Walker: Transportation is typically the biggest barrier, as rural areas often have sparse populations spread across

large geographic areas. Funding and staffing shortages can also be issues. While rural kids often participate in sports and music at comparable rates to their urban and suburban peers, the gap widens for special interest opportunities, such as those related to Science, Technology, Engineering, and Math (STEM), due to limited access to resources and expertise. 4-H offers distance learning programs to explore, discover and make a difference right from your own home. And 4-H leadership events connect youth across the region, state or country. Q: What impact does 4-H in MN?

Walker: University of Minnesota Extension has a long history of youth development leadership. We are best known for running Minnesota 4-H for more than 100 years. Minnesota 4-H is the largest youth development program in the state, offering hands-on learning for youth in kindergarten through one year post-high school. Last year Minnesota 4-H served 48,751 youth, and they

averaged seven years in our programs, more than twice the national average. Ninety-seven percent of Minnesota 4-H'ers believe they can make a difference in their communities, and 92% reported gaining confidence in their leadership through Minnesota 4-H.

Q: How does your work support quality youth programming across MN?

Walker: My work supports youth-serving organizations through research-based training and resources for adults who work with and on behalf of Minnesota's young people. Last year we facilitated 41 trainings for nearly 1,600 youth workers with strategies and skills to support positive youth development across the state and beyond. Our youth development curriculum library is a great resource for lessons and curricula on topics such as gardening and agriculture, social and emotional skills, healthy living, college readiness and STEM.
