County Commissioners approve new 911 computers

The Isanti County Commissioners had to hold their collective noses and swallow the bitter pill of having to shell out close to a quarter-million dollars on replacing computer equipment that is less than ten-years-old.

During the Oct. 4 County Commissioner meeting, Isanti County Sheriff Chris Caulk presented the board with three budget requests, which were aimed to ensure better communication in the event of an emergency, along with public safety in the government center.

The heftier of the three purchases was for a new computer system for the 911 dispatch center. Caulk told the board the current computer equipment, which was installed around 2016 to 2017, has outlived its lifespan and needs replacing before the system crashes, which would leave anyone calling 911 in a lurch.

"As you know, those computers run 24/7," Caulk said, "they've exceeded their expected life and are in dire need

of an upgrade to ensure all 911 calls keep coming in.

"We realize on a short-term basis if ever a piece of equipment does fail, we have redundancies, but obviously Chisago County doesn't want to take our 911 calls for months."

Caulk said the cost of the equipment, which can only come from one source due to compatibility issues with other existing equipment, was \$241,753. Caulk said that is over \$23,000 lower than the original cost estimate.

"I don't know why, other than the guy said he was just trying to be nice," Caulk said of the unexpected discount.

Caulk said he would work with Isanti County Auditor-Treasurer Chad Struss to figure out where in the budget this purchase would come from.

"We would work with Chad's office to see what money we could pull from our E911 fund because that is an allowed expense," Caulk said, "but we don't want to bury that fund and take everything out of there because that does pay for other service contracts

Cambridge narrows focus for downtown revitalization

Throughout the summer, Cambridge staff and councilmembers have engaged in an investigation into what residents and businesses envision for how to restore and revitalize the downtown business district. That investigation has included meeting with residents during the "Third Thursday" events, having organized meetings with downtown business owners, plus looking back at the recommendations of the Minnesota Design Team from their visit in 2015. Some of those findings and a request for further direction from the council were presented by Deputy City Administrator Alex Smith during the Oct. 3 council meeting.

Smith said that both the public and business owners shared several similar ideas for improving downtown. Included in those ideas were to find a way to fill the vacant buildings, find a way to be

more pedestrian (and dog) friendly, and create a cleaner, "unified" look, possibly with the addition of artwork.

One of the ideas that the two differed greatly on, however, dealt with parking. Smith said of the people who filled out surveys during Third Thursdays, 86% said they would support the removal of on-street parking in front of businesses on select blocks to support outdoor dining and better pedestrian accommodations. A majority of the business owners said the exact opposite, according to Smith. She said many indicated they have older clients who prefer to park immediately in front of their destination. They indicated the removal of parking spots would hurt downtown business and that there should be more parking made available.

On parking, Smith said studies completed by staff and the Minnesota Design

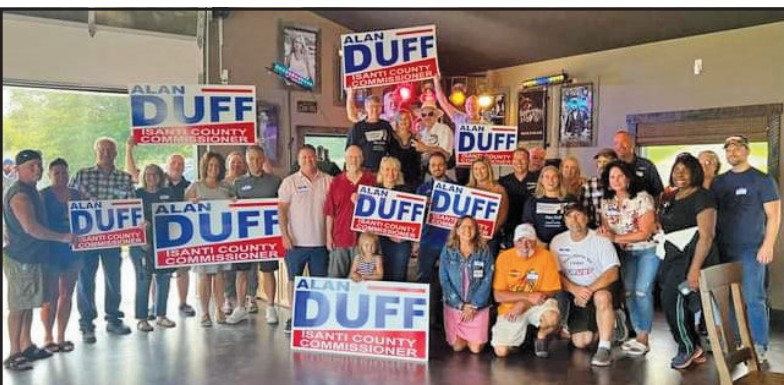

Underground Art Fair comes to The Leader

On Oct. 15 in the Foundation Room of the Leader, the public will have a chance to explore and purchase the work of local artists at the Fourth Annual Leader Underground Art Fair.

One of the artists featured this year will be Sue Redfield of Cambridge — a wood fire potter who will be bringing her unique, hand-crafted pottery to the show.

The wood-fired pottery Redfield creates is unique because the glaze for each piece is created from the wood and ash from her Manabigama, a wood-burning kiln designed by John Theis. The firing of the pottery can take anywhere from 12 to 15 hours at over 2,300 degrees.

Five other artists will be featured. Local oil painting artist Nathan Hager has completed over 100 paintings this past year. A selection of these paintings

will be on display.

There will be two glass artists displayed. Robinson Scott from Anoka is a glass blower who creates vases, bowls, and other art pieces. Charles and Rene Grisham are an artist couple who create jewelry and home décor from fused glass.

The Leader Underground Art Fair was started four years ago by Marilyn Cuellar, a fine artist who was voted Best Fine Artist in the *Isanti-Chisago*

County Star 2022 Reader's Choice issue for her pencil drawings.

"It's good for the community to have a place to display local artists," Redfield said.

The art show is open to the public from noon to 7 p.m. on Oct. 15, with a wine and hors d'oeuvres reception from 3 to 5 p.m. The art show runs through Wednesday, Oct. 19 in The Leader's Foundation Room, 135 Main St. S., Cambridge, MN.

THE FLORIDA SOUTHWEST coast was hit Wednesday, September 5 by a Category 4 hurricane. Hurricane Ian was devastating.

The slow moving, wide storm sustained winds over 100 miles per hour and did extensive damage to Fort Myers Beach, Sanibel and Captiva Islands, the City of Fort Myers. Adjoining areas were affected as well, before it crossed the state to hit Orlando and move north into the Atlantic and back inland.

Resorts, marinas, homes and area businesses were destroyed. The value is estimated at 50 billion dollars. Thousands of people were made homeless, lives were lost and pets missing.

Our motor yacht, our winter home for 19 years, was badly damaged when a 12 foot surge of water hit Legacy Harbour Marina at Fort Myers. Pilings and piers broke and boats ended up hitting each other. More than 20 boats in the marina sank.

The hurricane which took more than 100 lives is considered the most powerful to hit Florida.

This storm will take a long time to recover from. The causeways to Sanibel Island, Captiva Island and Pine Island blew out.

Our boat, Front Page, was on several television networks after the storm. As a result, many family and friends from across the country are sending comforting messages.

Do what you can to help those who lost homes and property. Recovery will be long.

This has been and will continue to be another lesson in God's creation - power and wind.

EMPLOYERS ALL OVER Minnesota, Wisconsin and elsewhere are finding it difficult to fill job openings. Some people blame it on the fact that people don't want to work. Various kinds of unemployment government assistance may discourage job seeking. I'm not sure that's the only cause.

I think we have undervalued our vocational schools. Another observation I have made is a lack of people skills. Many of those we interview have a very difficult time making eye contact or talking comfortably in conversation. Maybe they have had their face in the computer and television screens too long and lost people skills.

If you have a desire to work and can interact with people, chances are you can learn the skill requirement for the job available.

Sometimes technology moves us forward, but also slows us down.

It's important to understand the background of why this workshop was brought here. Every three years the Isanti County Public Health Department does a survey to see what the top health needs are in the county. Allina hospital system does something similar. Are license plate frames legal in Minnesota?

Question: My granddaughter had a project where she was trying to locate the license plates from all the states. While helping her we noticed license plates with frames

around them that obscure the state and only the numbers and letters are visible. Also we saw license plates that have a shade over it. If police are provided a license number of a hit-and-run car but the person doesn't see what the state the car is from,

are they still able to identify the car? Is it legal to have something masking or obscuring part of the license plate information?

Answer: Minnesota law states that the license plates cannot be obstructed and lays out how license plate registration is to be displayed. You can have a license plate frame but it cannot obstruct the needed information.

License plates cannot be displayed in the front windshield or the rear window, they must be displayed on the front and rear of the vehicle. All plates must be securely fastened so as to prevent them from swinging, displayed horizontally with the identifying numbers and letters facing outward from the vehicle, and mounted in the upright position. The person driving the motor vehicle shall keep the plate legible and unobstructed and free from grease, dust, or other blurring material (dirt, mud, snow, etc.) so that the lettering is plainly visible at all times. It is unlawful to cover any assigned letters and numbers or the name of the state of origin of a license plate with any material whatever, including any clear or colorless material that affects the plate's visibility or reflectivity. This also includes obstructing license plate brackets that block the state of issuance and tabs.

License plates issued to vehicles must display the month of expiration in the lower left corner of each plate and the year of expiration in the lower right corner of each plate.

To answer your question: We can identify a vehicle using the license plate number without knowing what state it is from, but it makes it more difficult and can take up significant time. It is not uncommon for those involved in criminal activity to obstruct license plates.

Witch Grass – It's Everywhere

Well, it's that time of year again when those spikey little tumbleweed-like weeds start blowing into my garage the minute we open the garage door. They gather, or should I say stick, to whatever they end up against and are very hard to remove as they are so super thin and super light. I usually end up using a broom in a very light "sweeping motion" to gather and dispose of them in my large refuse container. I've also used a shop vac which works well to. I dread windy days when as soon I we open the garage door, in they come by the thousands.

Those spikey little tumbleweeds are

called Witch Grass or "Panicum capillare". It's a native here in Minnesota as well as many other states and prefers to grow in dry soil (and we've had plenty of that this year) and full sun. It likes to grow in ditches, empty lots and roadsides too. I find plenty of it near my home in an open and unused field. The plant height can be anywhere from 6"-40" but what I see is mostly in the 6" to 10" range with the spikes being about 12" tall. The plant is hairy throughout and the leaves leaf out from the base of the plant. Those base nodes are typically green to purple in color and that really stands out in the fall. Also, the plant grows in a distinct clump at least 12" across or more.

The plant develops a "spikelet" which

turns the color of straw later in the season. The entire cluster breaks off at maturity blowing to new locations in tumbleweed fashion. The "spikelets" carry a grain like egg shaped seed that eventually falls off. And from what I see in my neck of the prairie, they seed themselves quite well. Watching them blow across the road is actually kind of beautiful as they are light as a feather and move gracefully. These type of grasses are referred to as "Tumbleweed Grasses" and include similar species in Minnesota such as Fall Witch Grass (*Digitaria cognata*) and Purple Love Grass (*Eragrostis spectabilis*). Both are perennials grasses whereas the Witch Grass is an annual.

Isanti resident accepted into statewide advocacy skills and leadership training program

Selected from a pool of statewide applicants, Isanti resident, Robin Fiene has been accepted into the eight-month Minnesota Partners in Policymaking® leadership training, which starts this fall.



Participants include adults with disabilities and parents raising children with developmental disabilities. Fiene's son has autism and sensory differences that require one-on-one assistance for daily living activity and safety and is minimally verbal and difficult to understand. He has gone through Applied Behavior Analysis (ABA), a therapy that rewards positive behaviors, and has speech therapy to improve communication.

Fiene works at the Department of Revenue and skilled in the areas of policy, legislation, and human relations. Prior to having children with extreme

mental health issues, she was unaware of how this population is so underfunded and underserved. She wants to apply her skills to help those who might not have the skills or time to advocate for themselves or their children to live their fullest lives.

The program was created by the Minnesota Governor's Council on Developmental Disabilities. "The goal is to develop leaders statewide to partner with school systems, medical and business communities so all individuals with disabilities are supported as they become self-confident, independent and contributing citizens across the state," said Dr. Colleen Wieck, Executive Director of the Governor's Council.

This highly acclaimed and finely tuned leadership training taps into national experts and utilizes group participation. Described by many as life-changing, in its 35-year history, over 1,100 Minnesotans have been trained to become leaders in their own communities. Participants become effective advocates for themselves, their children, and others with disabilities.

and training and other things.”

He said he guessed maybe \$40,000 to \$50,000 would come from E911, with the rest coming from ARPA funds.

“That is expensive equipment,” said Commissioner Susan Morris. “Some day we’ve got to talk about regionalizing 911 call centers. With issues of getting staffing and maintaining all this expensive equipment, it’s just wow.”

Commission chair Terry Turnquist asked Caulk what the expected lifespan of this computer equipment is.

“Five years,” Caulk said. “I can tell you when the election’s over and the sheriff-elect comes to my office, he or she is going to have a conversation about this and let them know between this and the ARMER radios, this is an expense that is always going to be there.”

Caulk did say the situation is a little less dire than before if it went down.

“When we used to have two stations, and one went down, then you lost 50% of your call-taking ability,” he explained. “Now, if one goes down, you only lose 25%.”

NEW BAGGAGE SCANNER

Along the same lines of equipment reaching the end of its lifespan, the middle expense was for the purchase of a new bag scanner for the Government Center’s front door security.

Caulk said the current bag scanner is outdated primarily due to the operating software it uses.

“If this company comes to fix it, it’s

usually between three and six thousand dollars to come and fix it,” Caulk said.

The cost of the scanner is \$26,690.

PAGER RELAY STATION

The least expensive request was for just over \$14,000 to be used to purchase pager repeater equipment that would be installed on the city of Isanti’s water tower. According to Caulk, the southern portion of the county continues to be a bit of a communication dead zone for some emergency personnel. He said with the expanded service area of Isanti Fire District, in particular, the need for more reliable page messages has increased.

“At one point in time, we used to have Stacy Fire and other fire departments that would cover some of the fringes of the county,” Caulk said. “Isanti Fire District has grown to take over that, which means the base for where they’re grabbing their folks from live further out and their pagers don’t work as well.”

He added his department’s Safety and Rescue would also benefit from the extended pager range.

Caulk said he proactively approached the city of Isanti for a conditional use permit to place the repeater on their water tower, which was already approved by the council. He also paid money to make sure the repeater signal wouldn’t interfere with any other signals in the area. He said that based on current computer equipment supply issues, the equipment probably wouldn’t arrive until around next spring.

DOWNTOWN: Council considers expanding business grant program

Team indicated there is plenty of parking available in the downtown district, albeit maybe not quite as close to businesses as some people would like. She said there are currently 1,235 parking spaces within a ring around the downtown district. Surveys indicate that 971 spaces are the minimum needed for that area.

Despite that, she said the staff’s recommendation would be to not eliminate any parking to widen sidewalks and/or accommodate outdoor dining. As a compromise, she mentioned there are temporary “parklets” that would accommodate outdoor dining in select locations during the warm weather months and be removed during the cold weather months. She said these parklets are less expensive than doing permanent alterations, with the only problem being where to store them when not in use.

Additional, less expensive ideas for making downtown more inviting included the addition of directional signage, possibly utilizing QR codes linked to the city’s website; additional bike racks; paying local artists for murals, statues, or sculptures; along with the addition of electric vehicle charging stations.

During the discussion, the council indicated they agreed with not permanently removing parking. However, none of the other ideas were met with a unanimous thumbs up.

FILLING THE EMPTY

Previously, the city established a Redevelopment Fund of \$2.4 million with the goal of using it to spur business growth not only downtown but throughout the city. That money was first used to purchase the old Community College land on the west end of the city from the state to resell the land to Kwik Trip. City Administrator Evan Vogel said the sale to Kwik Trip should be finalized soon, meaning the

city will have the full amount at its disposal again soon.

During her presentation, Smith mentioned using a portion of the money to expand the city’s current grant/low-interest loan program for businesses. That expansion could include allowing businesses to apply for more money and for more than aesthetic improvements to the outside or non-optimal improvements to the inside. This expansion could even be used to aid in the purchase of businesses or the remodeling of the building. She mentioned the city could go as far as purchasing buildings and “flipping” them, however, the council didn’t seem too enthusiastic about that.

Additional money at the city’s disposal is \$700,000 in the Water Fund, which Smith suggested might be used to help businesses with the installation of sprinkler systems — something that is very costly and probably was a major deterrent for potential businesses moving in. That idea was very agreeable with the council, with them mentioning how it would prevent a block-long catastrophe like what could have happened when the old Arlington Hotel building caught fire.

The council indicated they were in favor of using a portion of the \$2.4 million for expanding the grant/low-interest loan program, but they weren’t sure exactly how much money they would like to use. They agreed they didn’t want to ignore the rest of the city and solely use the money downtown.

Smith said the council does have some time to consider what was presented. She said the current timeline is to spend the fall and winter coming up with more concrete ideas, with the implementation of their decisions beginning in the spring of 2023. She also said the public and business owners are invited to continue offering suggestions and feedback throughout the entire process.

Jackets tame Wildcats for Homecoming victory

FOOTBALL

As is usually the case between Cambridge-Isanti and Chisago Lakes football, last Friday's game came down to the final minutes before the winner could be determined. Unlike several of their most recent clashes, however, this game turned out to be a low-scoring affair featuring a final score of 13-7.

C-I got on the board first with a six-yard run from Levi Maurer five minutes into the second quarter. Chisago Lakes tied it up with a two-yard TD run with just 28 seconds remaining until halftime. The very next play, Jacket quarterback Braylon Davis hooked up with Brayden Coplan down the far sidelines for an 83-yard touchdown.

Both teams threatened to score in the second half, with the Wildcats reaching C-I's nine-yard-line with just under two minutes remaining in the game. But the Jacket defense stiffened up and stopped Chisago Lakes cold on a fourth and goal to secure the win.

North Branch had a much easier time with their game, topping Duluth Denfeld 40-8. The Vikings jumped out to a 24-0 lead before yielding the Hunters' only score of the game in the third quarter. NB would then tack on another two touchdowns to seal the deal.

BOYS AND GIRLS SOCCER

The section playoff seedings have been set, and as expected, all four local teams had to hit the road for the quarterfinal round, with all of them falling to the higher seed and thus ending their season.

The North Branch girls earned the highest seed, getting placed at #5 where they went up against #4 seed Hermantown. The Vikings would lose to the Hawks for the second time this season, with both games having a 1-0 final score. Earlier in the week, NB faced off against defending state champion Mahtomedi, getting shut out by the Zephyrs 6-0.

The Cambridge-Isanti girl's team received the #6 seed, where they went up against Centennial, losing to the Cougars 7-0.

The North Branch boys were handed the #7 seed and traveled to Duluth Denfeld, losing to the Hunters 3-0. Before that, NB completed their regular season with a 2-1 win over Zimmerman and a 4-2 loss to Duluth Marshall.

Apparently, the other section coaches weren't all that impressed with C-I's six-game winning streak to end the

season as the Jacket boys were dropped down to the #8 seed. This demotion resulted in the Jackets facing #1 seed Andover, who they lost to 9-0.

VOLLEYBALL

C-I had a very satisfying week, going 1-1 in regular matches and also winning the Esko Tournament. The one loss for the Jackets was a 3-0 defeat from Centennial. The win was a 3-0 win over Princeton.

In the Esko tournament, the Jackets nearly swept through the competition, beating Hibbing, Greenway, and Pine City 2-0. The only set loss came in the third match, where Duluth East forced a decisive third set before C-I came out on top 2-1.

North Branch had two matches last week, featuring an easy win over Chisago Lakes 3-0 on scores of 25-16, 25-11, 25-13. Their loss came via a 3-1 defeat from Monticello by scores of 20-25, 19-25, 25-22, 10-25.

CROSS COUNTRY

C-I and North Branch faced off against each other, along with nine other schools, at the Hinckley-Finlayson Invite last week.

In the boy's race, C-I came in second and North Branch came in fifth. C-I's Hunter Jacobson was the top finisher for either team, coming in fourth. North Branch's Jordan Stum was only seven seconds behind, coming in sixth. C-I's Jonas Kennedy was five seconds behind Stum, in seventh. C-I's Noah McGovern also cracked the top ten, coming in tenth.

In the girl's race, C-I also took second, with North Branch coming in eighth. Jackets Kenna Sjoberg and Kendyl Izzo cracked the top five, coming in third and fifth, respectively. Seventh-grader Ava Witkowski was North Branch's top finisher, coming in 28th.

GIRLS SWIMMING AND DIVING

The Jackets competed in one dual meet last week and hosted their annual invite. In the dual meet, C-I came up short against Becker, with a final team score of 94-82. The Bulldogs took first place in all of the events until they swam as exhibition only beginning with the 200 freestyle relay.

At the annual Scott Sholund Invite, C-I took third out of five teams. Cincy Gibbs was the top finisher for the Jackets, coming in second in the 100 breaststroke. Olivia Hansen and Jovie Ebertowski also cracked the top three, coming in third in the 100 butterfly and diving, respectively.

Staying safe on cold water

The Minnesota Department of Natural Resources reminds anyone whose autumn plans include spending time on or around the water to keep safety in mind. While more boating-related accidents happen during the summer, boating fatalities are higher during the cold-water season.

As water temperatures drop, water-based activities become riskier. A fall into a cold lake, pond or river can result in even a strong swimmer becoming incapacitated quickly. Further, cries for help can go unheard and rescues can take longer than in the warm-weather months when more people are on or near the water.

"Nobody expects to encounter a life-or-death situation when they're out on the water, but the people who survive such experiences tend to be the ones who are best

prepared," said Lt. Adam Block, DNR boating law administrator.

The easiest and most effective way to stay safe and survive a fall into the water is to wear a life jacket. Having a life jacket "nearby" will not help in an accidental fall. Foam life jackets are the best option when the water is cold because inflatable life jackets may not fully inflate.

While boating or paddling, people can reduce the likelihood of a fall overboard by distributing weight evenly and abiding by the manufacturer's weight limits. Changes in weather that result in shifting winds and storms can also lead to a treacherous situation, so it's vital for anglers, hunters and others recreating on or near the water to keep an eye to the sky.

Fall Home IMPROVEMENT

Wood floor installation dos and don'ts

Jaw-dropping features can sell a home in a heartbeat. A penthouse apartment with floor-to-ceiling windows and a panoramic view of a city skyline likely won't prove a hard sell, nor will a home with an infinity pool overlooking a landscape of rolling hills. As awe-inspiring as such features can be, some more subtle components, such as authentic hardwood floors, also can do much to make a home more appealing to prospective buyers.

Hardwood flooring is a sought-after commodity. Data from the National Association of Realtors indicates that 54 percent of home buyers are willing to pay more for hardwood floors. In fact, NAR figures indicate that 28 percent of buyers between the ages of 35 and 54 consider hardwood floors "very important" when looking for a home. Homeowners who are considering selling their homes, or those who simply want to upgrade their existing flooring, may want to consider installing hardwood flooring. Though it's a project best left to professionals, hardwood flooring can be installed by skilled DIYers. In such instances, homeowners may want to keep these dos and don'ts in mind.

DO hire a professional if you have limited or no DIY flooring experience. Hardwood flooring installation is not generally a project for novice DIYers. Hardwood flooring projects may present some common challenges, but no two homes are the same. So unless they have prior experience installing floors in multiple rooms or homes, homeowners may save themselves time, trouble and a significant amount of money hiring a professional to do the job.

DON'T ignore the subfloor. New hardwoods won't erase the problem of subfloors in poor condition. According to the home renovation experts at BobVila.com, squeaky floors could be an indication that the subfloor has begun to warp or twist. Sinking floors are another indicator of deteriorating subfloors. Subfloors should be somewhat level before new hardwoods are installed, so DIYers should inspect and address subfloor issues before installing new flooring.

DO expose wood flooring to the elements in your home prior to installation. The home improvement resource BuildDirect recommends acclimating hardwoods to the space where they will be installed. Skipping this important step could result in gaps during the winter and cupping over the

summer. To acclimate hardwoods, open the boxes and spread them out for about a week while running the air conditioner or heater at normal levels. When storing hardwoods prior to installation, avoid keeping them in potentially moist areas like a basement.

DON'T skimp on tools. A DIY hardwood flooring installation might be less expensive than hiring a professional, but homeowners should resist any temptation to increase those savings further by purchasing less costly tools or fewer tools than is necessary to complete the job. BuildDirect notes that DIYers will need at least a miter saw, table saw, cleat-nailer or stapler, finish nailer, compressor, jamb saw, chalk line, nail set, and tape measurer when installing hardwood floors. Purchase all necessary tools and read product reviews to ensure each tool is up to the task.

Wood floors can be awe-inspiring. Some homeowners can install such flooring on their own, and the project can be much easier if they learn as much about installation as possible prior to beginning the project.
