A little bit of this and that from Fall

Autumn seems to be a bit off this year and much of that is a result of the last few years of inadequate moisture and a changing climate. Some of my noticeable changes are the abundance of Maple tree seeds. Also called "helicopters, whirlers or whirligigs, my Norway maple is producing them on steroids ! Usually that tree changes to a bright yellow and it's striking when the ground is covered in that yellow blanket resembling sunshine. But as I write this, the leaves have gone from green to a kind of brown green then a dull yellow followed by piles of those "helicopters." It's most likely the tree's reaction to back to back years of a lack of

adequate moisture and the tree is producing copious amounts of seed to make more trees. I've had the tree on my property for at least 25 years and I've never seen it do what it's doing this year. And because the ground has been so dry (despite our attempts at giving the area adequate waterings) the grass has thinned out and I'm seeing some possible root girdling around the base of the tree. I'll be contacting a tree service soon about that.

The mole and gophers are having an Olympic year on my sandy soil property ! Nothing we've tried has deterred them one bit and with the impending winter afoot, they are especially active right now. This is not a new problem for us but it's worse than anything we've

seen in decades. We are 1 mole dead so far and I'm pretty sure his demise didn't make a dent in the population. I'm not sure there's any science in this theory but there must be a banquet of grubs down there that they have staked a claim on my property. I wonder now if next year will be more of a problem with Japanese Beetles and Rose Chafers because I hardly had any this year.

The Red Oaks on the property are still hanging on to their autumn leaves and right now they are a striking bronze color. During winter they will shed some leaves but they hang on to quite a lot all winter. The new growth in the Spring will push them off. But my White Oak is now leafless and that wonderful gnarly look gives

the tree that "haunted woods" look. Our property is surrounded by lowland with birches, oaks, and mostly poplar at the edges and when we have a cloudless day and when the sun is setting, those yellows and oranges literally flame with color. And many areas in the lowland and along the back roads have native grasses that take on a bronze/purple/beige color in autumn. Yup, there's a lot of eye candy out there if you just take the time to look.

If you have a newly planted tree or shrub, please don't turn your outside water off until the ground freezes as those plants need all the moisture they can get to insure winter survival. And also keep in mind that you can plant trees and shrubs until the ground freezes giving

you a great chance to take advantage of those half off sales at the garden center.

And regarding those Box Elder, Lady bugs and Stink bugs.....WOW, what a population they're enjoying this year! I've been spraying them on the outside of my house with a solution of water and Dawn dish soap but in no time, I'll start finding them inside my house. I've already found a half dozen Stink bugs which I've never had in my house before this year. Going on the injury-reserve list

Just as I was entering the homestretch of recovering from my bruises created by “the hit,” I found myself having to be concerned about another injury. No, I didn’t cross paths with a cross-country runner or get spiked by a volleyball player. This isn’t even an injury I sustained. Rather, this injury was to the family dog, Mollie Mae.

You see, during the incredibly warm weather over MEA weekend, my mom was obliging Ms. Mollie with her favorite outdoor activity — chasing her ball. During one of the throws, which are intentionally shorter tosses, Mollie wound up having her back legs go out from under her, at which time she immediately started limping and refusing to put any weight on one of her back legs.

Now, this isn’t the first time this has happened, but the previous times resulted in her limping around for a short period of time, but a day or two later going back to her normal gait. This time, though, was obviously more severe. And given her advancing age and history, we decided to get her an appointment with the vet, which was completely booked up until last Tuesday morning, meaning we had several days to contemplate the nature of her condition.

Normally, this might not seem to be anything too worry-some, but in the back of our minds was the memory of our last dog, Tia. Just like Mollie, she was an extremely energetic canine who never acted her age. That is, until that fateful day when we were blindsided with a diagnosis that Tia had a large, inoperable tumor growing inside her that forced us to make the difficult decision to not prolong Tia’s suffering. That incident caused us to now hope for the best with Mollie, but to also mentally prepare our minds for the worst.

I will spare you the anxiety of having to read any further for the results. It turned out Mollie suffered a very common injury not only among athletes but dogs as well — a torn ACL. Upon hearing the x-ray results, it did all make sense. The vet said she could very easily have partially torn it before that didn’t heal completely yet so now this time it was completely torn.

Additionally, while surgery is a possibility, based on her age, the vet recommended we just go with rest and canine-appropriate pain medications. For the most part, that shouldn’t be too difficult. Mollie has so far been fine with taking her pills wrapped in a little cheese. Plus, during the week when it is just her and my dad at home, her activity level is relatively minimal, to begin with. The hard part will be when I, being her best buddy and preferred playing partner, come over on Sundays.

But even in that, dogs have an amazing ability to adapt to their circumstances. Mollie has already gotten good at hopping around on three legs when going out to do her business. And they also seem to have a lot more common sense than humans in knowing their limitations. Plus, once it gets colder, and especially once the snow starts flying, her play sessions get relegated to indoors anyway.


The tough part will be next spring when we will be discontinuing those outdoor chases to prevent any re-injury. But much like an athlete, while she might not like the idea of “retirement” from playing ball, it is far better than any of the other alternatives.

Consider donating hides

To the editor,

This Saturday marks the beginning of the 2022 firearm deer hunting season. Along with all the anticipation of harvesting a nice deer and filling the freezer with venison, the Isanti County Chapter of the Minnesota Deer Hunters Association (MDHA) is encouraging area hunters to also consider donating their deer hides to the MDHA Hides for Habitat Program. By making the donation to the MDHA, hunters are actually helping the deer of the future.

MDHA’s Hides for Habitat program is a flagship program of MDHA, and since its inception in 1985 has generated nearly \$5.7 million dollars and over one million hides to help fund statewide habitat projects. This program works because of hunters who donate their hides to the orange MDHA logo collection boxes around the state and because of dedicated chapters.

Our chapter uses the funds to purchase trees, food plot seed, (corn, soybeans, sunflowers and a variety of Frigid Forage) for our members to plant for habitat, helping a variety of wildlife. Some of the funds are used for

scholarships to send local kids to Forkhorn Camps and we also sponsor two scholarships for “Dollar for Scholars”. We have used funding from this program to help purchase land that is then turned into Wildlife Management Area, which is then open to the public for hunting.

The Isanti County MDHA boxes are quite easy to identify - as they will all have a sign indicating they are our boxes. Most of the boxes are bright orange, recently painted by Jackson Koukol as his Eagle Scout project. Thank you Jackson.

To donate a deer hide this season, simply look for the MDHA Hides for Habitat orange signs located at Hides Drop Point Stations. To locate an official MDHA Hides Drop Station,

log onto www.mndeerhunters.com or call MDHA’s State Office at 800-450-3337.

INFLATION IS AFFECTING every one of us with higher costs, primarily gasoline and heating fuel. But the grocery store prices are also shocking. We need more cooperation with Congress, the president and the feds. The way we are going is a viscous circle and we have a huge problem in controlling this inflation.

SOME WISDOM FROM Steven Covey. “Every human has four endowments—self-awareness, conscience, independent will, and creative imagination. These give us the ultimate human freedom ... the power to choose, to respond, to change.”

I THINK IT is dangerous in America when the far left and the far right try to reset our country with our economy and our way of life.

I receive information from Hillsdale College and an article by Michael Rectenwald in an issue of their Imprimis described the economy goals of the great reset as “capitalism with Chinese characteristics—a two-tiered economy with profitable monopoly and the state on top and socialism for the majority below.”

Delusions and Hallucinations

In an effort to raise awareness, reduce the stigma of Alzheimer's disease, educate our community and assist families who have been touched by Alzheimer's



disease; this month's article highlights a symptom of Alzheimer's Disease and related forms of dementia, Delusions and Hallucinations. Not everyone experiences delusions and hallucinations, however it can be common. A delusion is a fixed false belief. For example, the person may hold the false belief of being under the threat of harm from the care

partner. To the person with dementia the delusion is very real and causes fear and may result in distressing self-protective behaviors. If the person is experiencing a hallucination, he/she might see or hear things that are not there; for instance, figures at the foot of the bed, or people

talking in the room.

Here are some suggestions that may help:

- Do not argue with the person about the validity of what was seen or heard.
- When the person is frightened try to give comfort. Your calm voice and gently holding a hand can be comforting.
- Distract the person by drawing attention to something real in the room.
- Check with your doctor about medications that are being used as these may contribute to the problem.

testing the Omniballots (including inserting write-in votes). That ballot is then printed out and compared to the original sample ballot to make sure the Omniballots are properly filling out the paper ballot, including making sure the ovals are filled out properly enough for the counting machines to read.

That ballot is then added to other prefilled test ballots to be fed into the counters. According to Fowler, the number of test ballots fed into the machine is predetermined.

“Every candidate on that precinct’s ballot must have at least one vote, and each candidate must have a different vote total,” explained Fowler. She said some tests only require about 20 ballots, while others could be 50 or more. She said Cambridge’s 39 ballot test this year is one of the larger ones she’s had to perform, primarily due to the large number of candidates for Cambridge-Isanti School Board.

Additionally, each batch of test ballots includes anomalies such as too many votes being cast in a race or even a completely blank ballot. These are done to make sure the counting machines will detect these anomalies and provide the appropriate response. In the case of too many

votes being cast, the machine is supposed to alert the election judge and give the option of still casting the ballot (which would nullify some or all of the votes) or rejecting the ballot and having the voter fill out a new one.

Other things that can be tested include extra markings or smudges on the ballot, folds or creases in the ballot, or even if two ballots are inserted at the same time.

Once the predetermined number of ballots are inserted, the general ballot count is checked. If that matches, a printout of the votes cast is generated. This printout is the same as what is printed out at the end of the day on election day and lists all candidates, how many votes each of them received, plus lists how many “other” (write-in) votes were cast. Those numbers are then compared to a master list of how many votes the machines should have recorded for each candidate. If all of the numbers match up, the machines are deemed to be accurately counting votes.

All of the test ballots and readouts are initialed by the election officials conducting the test and kept as proof that the machines were tested. Finally, the machines are zeroed out, powered down, placed back in their carrying cases, and locked away in a secure location until election day.

upon,” Harrington told the council.

Thus, the city’s options for delaying the proposed project are to instruct staff to draft a “resolution authorizing a study of uses within the CBD” and also draft “an interim ordinance including a regulation, restriction, or prohibition on such uses within the CBD” for a year from the effective date of the ordinance.

Any interim ordinance cannot single out a specific project, Harrington pointed out, prompting City Administrator Renae Fry to point out the possibility of this action affecting other proposed or in-progress developments in the city.

“You’ve got a citizen group trying to shut down a use by calling for a study, but you have a lot of activity going on in your community right now that you’re going to shut the door on,” Fry said.

Fry said developers are currently working with staff on building new and expanding existing housing development, so staff will have to work carefully and extensively with the city’s attorneys to ensure the study does not hinder those developments.

“You could be shutting the door to millions of dollars of investment in your community,” Fry said.

Mayor Jim Swenson told the assembly North Branch is already behind in apartment capacity and losing potential residents to nearby municipalities, according to an earlier meeting of the Chisago County Housing and Redevelopment Authority – Economic Development Authority. New developments are filling up before the apartments are even built, he added.

The council voted 4-1 to instruct staff to write the resolution and ordinance, with council member Kathy Blomquist casting the lone “nay” vote. According to Harrington, if approved, these will act as a “stop-clock” on the development for one year.

After the meeting, Fry confirmed she and her staff’s next step will be to craft the resolution and ordinance in such a way that it does not affect other in-progress or proposed developments.

Winter parking restrictions began Nov. 1

With the mild weather Minnesotans are experiencing it’s easy to forget that snow and all the havoc it causes is on it’s way. Nov. 1 is the date that cities in the area start their winter parking restrictions. Below are the specific times and conditions when no parking will be enforced for each city in the area.

Isanti - No parking on any city street between 1 to 8 a.m. from Nov. 1 through March 31. Parking is permitted from 6 to 8 a.m. if there is no snow or it has been removed. The city removes snow within the city limits on public sidewalks and trails for every two-inch or more snow event.

Cambridge - Winter parking restrictions are enforced from Nov. 1 through March 31. During this time there is no parking on any city street from 10 p.m. to 7 a. m. If a vehicle is moved prior to 2 a.m., any parking tickets issued that night will be waived. Vehicles may also be towed, especially if a “snow emergency” is declared via the Everbridge Alert app.

Braham - No parking is permitted on any city street, city owned parking lot, or public right of way from Nov. 1 to April 1 between the hours of 2 a.m. to 7 a.m.

North Branch - It is unlawful for anyone to park a vehicle on a public alley, street, or highway within the city limits between the hours of 1 a.m. and 7 a.m. from Nov. 1 until April 1, inclusive, or after any snowstorm until the snow has been removed or during snow removal time. It is unlawful for anyone to park a vehicle in a city-owned parking lot, except by city permit, between the hours of 2 a.m. and 5 a.m. from Nov. 1 until April 1, inclusive, or after any snowstorm until the snow has been removed or during snow removal time.

Rush City - No parking on any city street from 2-6 a.m. from Nov. 1 through April 15. No parking on streets any time snowfall exceeds three inches until streets are cleared.

Harris - No Parking on any Street 1 a.m. to 7 p.m. No Parking anytime when snow exceeds three inches until streets are cleared. Violators will be towed.

Hunting safety begins with personal responsibility

With many hunting seasons underway, and about 400,000 hunters set to converge on the state’s fields and woods for the Nov. 5 firearms deer opener, the Minnesota Department of Natural Resources reminds hunters there’s no such thing as a successful hunt if it isn’t safe.

Done right, hunting is an exceptionally safe activity that brings families and friends together to create life-long memories, and it’s up to every hunter to ensure that trend continues. Three of the main ways to ensure a safe hunt are to:

- Practice climbing into and out of tree stands before the season starts.
- Brush up on the key tenets of safe firearms handling before hitting the field.
- Wear blaze clothing to ensure visibility to other hunters.

“There’s a lot at stake every time hunters head into the field,” said Col. Rodmen Smith, director of the DNR Enforcement Division. “Safe hunts don’t just

happen by chance — they happen when hunters make keeping themselves and others safe the top priority.”

Accidents involving tree stands are the leading cause of injury among hunters. According to national data, as many as one in three hunters who hunt from an elevated stand will fall and sustain a serious injury. The number of hunting-related firearms fatalities has dropped significantly over the past 60 years — largely due to safety training requirements for young and new hunters — but even one fatality is too many.

These additional safety tips can also help ensure a safe hunting season for everyone:

- Inspect tree stand safety harnesses thoroughly and use them when in the stand and when climbing in and out.
- Maintain three points of contact with the steps or ladder at all times.
- Treat every firearm as if it’s loaded.
- Always control the muzzle.
- Be sure of the target and what’s beyond it.
- Only put your finger on the trigger when ready to shoot.

Make a plan for deer hunting season

As deer hunters enjoy current hunting seasons and 400,000 hunters prepare for the opening of firearms deer season on Saturday, Nov. 5, the Minnesota Department of Natural Resources reminds them to plan ahead for a safe and enjoyable hunt.

The DNR’s online make a plan tool (mndnr.gov/DeerHunt) provides a comprehensive step-by-step list of information hunters need to consider before heading to deer camp. The tool covers topics including hunting regulations, deer processing, chronic wasting disease sampling, safety and how to make the most out of a hunt. To use the online tool, hunters need their deer permit area number, which they can find on an interactive deer map.

In Minnesota, archery deer season began Sept. 17 and continues through Saturday, Dec. 31; firearms deer season begins Saturday, Nov. 5, with various closing dates depending on a hunter’s DPA; and muzzleloader season is Saturday, Nov. 26, through Sunday, Dec. 11.

Deer hunters invited to share wildlife observations

Minnesota deer hunters can use an online questionnaire (mndnr.gov/Mammals/Deer/Management/Hunter-Field-Log.html) to report wildlife they see while hunting. Data from the observation logs help the DNR estimate

population level trends for deer and track wildlife distribution for other species across the state.

Using a mobile device or desktop computer, hunters can enter information on the DNR website (mndnr.gov/Mammals/Deer/Management/Hunter-Field-Log.html) about wildlife they see each day of hunting, including deer, turkeys, bears, fishers and other species. They’ll also be able to report specific information about any deer they harvest. Hunters are encouraged to fill out a report after each hunt, even if they don’t see any deer that day. The online questionnaire will be available until Jan. 15, 2023.

Know the difference between white-tailed deer and elk

Individual elk sightings are beginning to be reported in a wider geographic area outside of far northwestern Minnesota. Hunters need to make sure they know the difference in the field. The DNR website (mndnr.gov/Hunting/Deer-Elk-ID.html) has drawings and traits listed to help distinguish elk from white-tailed deer. Additionally, people are encouraged to report elk sightings using the DNR’s online elk sighting reporting tool (mndnr.gov/Elk/Elk-Sightings.html).

Hunters: Register your deer

Hunters are required to register every deer they harvest before processing, before antlers are removed and

within 48 hours after taking the animal. Hunters can register deer online, via phone or in person. Information from deer registration is essential for the DNR to track and manage deer populations. Detailed registration instructions for all methods are available on the DNR website (mndnr.gov/Hunting/Deer/HarvestReg.html).

Deer carcass movement restrictions in place in

Deer carcass movement restrictions are in place for 14 deer permit areas located in southeastern and north-central Minnesota and the south metro area.

DPA’s 604, 605, 643, 645, 646, 647, 648, 649, 655, 661 and 679 together form the Chronic Wasting Disease management zone. Hunters are not allowed to bring whole deer carcasses outside of the management zone until a “not detected” test result is received. DPA’s 255, 343 and 344 form a control zone and whole deer carcasses cannot be moved out of a control zone or the adjacent management zone until a “not-detected” test result is received. Hunters are allowed to move whole deer carcasses in between contiguous management zone DPA’s or from a control zone DPA into the management zone.

If hunters do not submit their deer for sampling or want to transport a deer outside of these zones before getting a test result, they must debone or quarter their deer, properly disposing of

the head and spinal column inside the zones. The DNR provides dumpsters for hunters to use for this purpose.

These restrictions are part of a comprehensive strategy to keep Minnesota’s deer, elk and moose healthy by limiting the spread of disease. Hunters can find details for the DPA in which they hunt by visiting the DNR’s CWD page (mndnr.gov/CWD) and using the “find your requirements for your DPA” tool.

Deer harvest numbers available online

Hunters, media and anyone interested in deer harvest data can find current deer harvest figures and harvest reports for past years on the DNR deer reports and statistics page (mndnr.gov/Mammals/Deer/Management/Statistics.html). The page also features an interactive map and graph that visualizes the data.

DNR webinars cover preserving your harvest

The first webinar is at noon Wednesday, Nov. 2. Kraig Kiger, DNR shooting sports specialist, will discuss what to do with a harvest after a successful hunting or fishing trip. The webinar will cover ways to preserve your harvest and provide tips for preparing it. The webinars are free but registration is required. More information is available on the DNR website (mndnr.gov/Discover).

Temporary off-highway vehicle trail closures for deer season begin Nov. 5

Recreational use of off-highway vehicles will be restricted on some state forest trails and access routes during the upcoming firearms deer hunting season, according to the Minnesota Department of Natural Resources. Vehicles affected by the restrictions include all-terrain vehicles, off-highway motorcycles and registered off-road vehicles, such as four-wheel drive trucks. At certain times of day (listed below), these restrictions do not apply to vehicles being used by a licensed deer hunter in conjunction with deer hunting.

The effective dates of the recreational riding restrictions are:

- Nov. 5-20 for the northeastern Minnesota 100 Series deer season.
- Nov. 5-13 for the Minnesota 200 Series deer season.

Visit the deer hunting page of the DNR website (mndnr.gov/Hunting/Deer) for more information about deer hunting seasons in Minnesota.

Recreational OHV trails located in southeastern Minnesota close by Nov. 1 each year, so no additional OHV riding restrictions are necessary during deer season in that part of the state.

The restrictions, which do not apply to state forest roads, aim to protect recreational riders from potentially unsafe riding conditions and to minimize the potential for conflicts between deer hunters and recreational riders.

Licensed deer hunters may still use restricted routes in conjunction with their hunting activity during the following time periods:

- Before legal shooting time,
- From 11 a.m. to 2 p.m., and
- After legal shooting hours.

“It’s important to always put safety first,” said Joe Unger, OHV program consultant for the DNR. “We thank everyone, in advance, for their safety vigilance and for sharing space in Minnesota state forests.”

Vikings clip Hawks' wings, advance to section finals

After years of sub .500 seasons, the North Branch football team is beginning to get into the habit of contending for a section championship and state tournament berth. Now, all that's needed to be accomplished is breaching that last obstacle and claiming the school's first-ever football section championship. North Branch will be making their second-straight appearance in the Section 7AAAA tournament following their 28-20 victory over Hermantown on Saturday, Oct. 29. This will be the third-straight year where the Vikings will be hoisting at least the runner-up

trophy. Last season, North Branch entered the section championship game undefeated but was upended by Grand Rapids in a thrilling game. The year before, North Branch "won" the section runner-up trophy after COVID caused an abbreviated postseason that resulted in the #1 seed being handed the section championship while the #2 and #3 seeds battled it out on the gridiron for second place. In the semifinal game against the Hawks, after allowing a first-quarter touchdown, the Viking defense clamped down on Hermantown's passing attack, not yielding a completed pass until the fourth quarter. Meanwhile, North Branch's ground game got roll-

ing, scoring twice in the first half for a 14-13 lead. NB doubled their score with a pair of long, time-consuming drives in the second half, building up a 28-13 lead early in the fourth quarter. Hermantown tried to rally, scoring their second passing touchdown to make the score 28-20, but with precious little time left in the game, a failed onside kick and a single first down chewed up the remaining time and gave the Vikings the win. The Vikings are also doubly fortunate based on the results of the other section semifinal, which pitted Cloquet traveling to #1 seed Grand Rapids, who entered the game undefeated and QRF ranked #2 in all of Class AAAA. Cloquet, however, dominated the Thunderhawks 42-15, which results in a rematch between the Vikings and Lumberjacks, who just faced each other two weeks ago, with NB coming out on top 40-27. The game will also be a rematch of the 2017 section championship game, which was the first time in 30 years North Branch had advanced to the championship game. And thanks to a scheduling change from a neutral site championship game in Duluth, the higher-seeded Vikings will play host to Cloquet. Kickoff is scheduled for 7 p.m. on Friday, Nov. 4. If North Branch again defeats Cloquet and earns that precious first-ever state tournament berth, they won't have to travel too far for their state quarterfinal game and they could be facing a fellow Mississippi 8 school. Based on MSHSL bracketing, the section 7 champion faces the section 8 champion, which will either be Rocori or Becker. That game will be played on Nov. 10 at

Blaine High School.

STUM HEADED TO STATE
Sophomore Jordan Stum made the most out of his section cross-country race, coming in eighth at the Section 7AA meet, which was good enough to advance to the state meet. Stum's time of 17:27.20 was the fourth fastest time among runners who aren't on teams who earned a berth in the state meet. The state meet will be held in Northfield on Saturday, Nov. 5. As a team, the NB boys came in ninth out of 11 teams. For the North Branch girls, their top finisher was Ava Witkowski, who finished 59th. In Section 7AAA, the Cambridge-Isanti boys finished seventh out of eight teams, with the girls finishing fifth. Kenna Sjoberg came in 12th in the girls race, just missing out on a state meet berth. The first

six individuals who are not on the first or second-place teams advance. Sjoberg finished in seventh place. Hunter Jacobson was the top C-I boys finisher, coming in 16th.

VIKING VOLLEYBALL ADVANCES TO SEMIFINALS
North Branch had an easy time in their section quarterfinal match, defeating Princeton 3-0 in just over an hour. The final scores were 25-17, 25-11, and 25-15. The Vikings faced section #1 seed Grand Rapids on Wednesday, Nov. 2, after this edition went to press. If they were able to upset the Thunderhawks, they would advance to the section championship on Saturday, Nov. 5 at a neutral site to be determined.

North Branch Veterans Memorial redesign, location officially approved

The North Branch Veterans Memorial finally has a home, having received enthusiastic and unanimous approval from the city council. The council approved the ap- proximate location in Central Park between the existing pavilion and Christmas tree in front of a packed house of dozens of people Tuesday evening, Oct. 25, many of whom were veterans and family members there to support the project. Joe Scaramelli and Randy Koivisto of the Veterans Memorial Committee Association, the organizing and driv- ing force behind the memorial, spoke to the assembly about the project and "I want to honor those guys I served with, some of them didn't go home." Koivisto, a member of the local Amer- ican Legion, told the council before Scaramelli took the floor. Scaramelli emphasized the impor- tance of having the memorial in a central, visible location, unlike the memorial in Cambridge — which he was quick to compliment, calling it "beautiful" and expressing his pride in his counterparts' work. Despite many veterans wanting the memorial in Central Park from the start of the planning process, accord- ing to Scaramelli, there was opposition to that plan, resulting in an attempted location change that was ultimately fruitless. "The veterans do not want to be pushed aside anymore," he said. Scaramelli said the planned memo- rial will take up just 4% of the park. For those concerned about taking up spaces from the Fall Harvest Fest, Scaramelli suggested closing down the block of Elm St. between Branch Ave. and 6th Ave. temporarily for special events. He said when he brought the idea to Peterson's North Branch Mill, the business immediately adjacent to that stretch of road, the response was an

Can you pass a schoolbus with no stop arm extended?

Question: I see school busses that do not use their flashing lights or extend the stop arm as they're picking up kids. Cars are passing them from behind and from the front. What are the requirements for bus drivers to use their safety lights? Thank you for your time.

Answer: Minnesota law allows for certain exceptions for school buses not to use the flashing lights and stop arm system. These situations require approval from the school board in writing. If the flashing red lights and stop arm are not being used other vehicles are not required to stop. However, I would recommend using caution and common sense.

Some other examples of when School bus drivers shall not activate

the prewarning flashing amber signals or flashing red signals and shall not use the stop arm signal:

- (1) in special school bus loading areas where the bus is entirely off the traveled portion of the roadway and where no other motor vehicle traffic is moving or is likely to be moving within 20 feet of the bus;
- (2) when directed not to do so, in writing, by the local school board;
- (3) when a school bus is being used on a street or highway for purposes other than the actual transportation of school children to or from school or a school-approved activity, except as provided in subdivision 8;
- (4) at railroad grade crossings;
- (5) when operating the bus under special event school bus use
- (6) when loading and unloading people at designated school bus stops where people are not required to cross the street or highway, while the bus is com-

pletely off the traveled portion of a roadway that has adequate shoulders. The driver shall drive the bus completely off the traveled portion of this roadway before loading or unloading people. A school bus stop is designated under this clause if the transportation director of the school district in which the bus stop is located, in consultation with the road authority, certifies the integrity of the shoulder and the safety of the location for loading and unloading people. Each designated school bus stop must be documented and approved by the school board.

Who benefits if LaRowe is elected?

Recently, I had two encounters with Scott LaRowe, husband of a candidate for county commissioner, Kristi LaRowe.

The first time was at a public event. Scott talked mostly about how we need to clean the county ditches. Scott shared that he farmed thousands of acres and if the ditches were reopened he could farm more. I mostly listened but wondered what such a project might cost.

Five days later, a truck pulled up and Scott got out. He was door-knocking for his wife's candidacy. He didn't remember me until I reminded him that we had had a conversation a few days earlier. Given that my family had farmed in Oxford Township from the 1890s to the 1970s, we started by talking about farming. It did not take long to hear again about the county ditch system and why it needed to be cleaned up.

Since our first child I had done some investigating about Isanti County ditches. These are not roadside ditches but ditches that were excavated back in the late 1800s and early 1900s to create more farmland. Now in the 21st century, the bulk of the 24 official county ditches resemble natural creeks. These ditches have become a natural resource and important habitat for ducks, mink, deer, frogs and many more species.

I told Scott that I had learned there have been two ditches evaluated in Isanti County last year and the average cost per ditch is \$2,500,000. I commented that he and his wife would certainly benefit from such a costly public funded effort, but when I asked "How would my wife and I and other Isanti County residents benefit from such an exorbitant cost?" he had nothing to say.

It seems the LaRowe family would benefit if they can get the county residents to pay for expensive ditching projects so they can farm more acres.

I'm going to vote to re-elect Susan Morris. She knows the value of smart county spending.
