### ORDINANCE NO. 2025-02 SUMMARY OF ADOPTION OF AMENDMENTS TO THE ZONING ORDINANCE

THE CITY COUNCIL OF THE CITY OF HARRIS, CHISAGO COUNTY, MINNESOTA ORDAINS:

Section 1. That the following Chapter 154 entitled Zoning is hereby adopted to add section 154.34 Accessory Dwelling Units

Section 2. That the city council finds that the cost of publication of the full ordinance is prohibitive and a summary of the ordinance would clearly inform the public of the intent and effect of the ordinance.

Section 3. That this is a summary of the adopted ordinance and the full text of the ordinance is available for public inspection at city hall or by standard or electronic mail upon request.

Section 4. That this ordinance shall become effective immediately upon its passage and publication of the approved summary, whichever is later.

The Township of Fish Lake will be accepting sealed quotes until **March 10, 2025 at 6:00 PM** at which time all quotes will be opened and read aloud.

Mark on the outside of the envelope **"Gravel Quote"**. Certificate of insurance must accompany quote.

Quote is for the service contract of **crushing and hauling** approximately 8,000 c.y. of **modified class 1** base aggregate under MN-DOT specification #3138, except that the #200 sieve shall be modified to 9%-13% binder.

Contractor will supply the Township with material sample test results before product is delivered. Township must be notified when crushing begins to perform sample gradations. Township may request that contracted equipment be scaled for capacity periodically at the township's expense.

Contractor must also provide loader and dedicated loader operator at the pit site and attend a prestart meeting with the township. Fish Lake Township will require six belly dump trucks at one time for delivering this gravel when project is started.

Township requires a separate pile that will be measured and tested at township's expense.

All yardage is to be delivered by **September 1, 2025**.
