## What is your reason for running?

Last year, I had no intention of running for Commissioner. I was preparing for the arrival of my sixth baby and working as a corporate litigator. But God convicted me to say no to medical mandates, and I was fired for non-compliance in November 2021. Since then, I have become more familiar with the nuances of local government. Unfortunately, I have found things are awry in Isanti County.

Commissioners have a substantial job. They wield both legislative and executive powers. Commissioners are responsible for contract negotiations, passing ordinances, and managing taxpayer money. Commissioners are responsible for setting local taxes and charged with using those taxes effectively.

Isanti County citizens need Commissioners that recognize the government's true purpose: securing the blessings of liberty and protecting individuals' rights. Isanti County citizens need servant-leaders who recognize that government should work for them, government should be limited, and government must be transparent. I would be honored to serve Isanti County.

## What is your top priority and how do you plan on addressing it if elected?

My top priority is to give Isanti County citizens the trust they deserve--the trust to keep more of their money; the trust to give them the right to vote for county management positions; the trust to inform them and encourage input; and the trust to let them lead their lives according to their conscience.

As Commissioner, I will be dedicated to removing and reducing every unnecessary tax and fee, working to give the right to vote back to the people, advocating for more accessible meeting times, and following the principles laid out by our founders.

## What are the biggest challenges facing your constit-

From speaking with my constituents, the first question almost universally asked is: "what does a county commissioner do?" For many years, local government has operated with little transparency and accountability. My campaign is focused on educating citizens on the county commissioners' role. Once the citizens of Isanti County understand this role, citizens can begin to hold commissioners accountable for their actions.

Many constituents also express frustration with taxes and fees, internet accessibility, and government spending. I will use my skill as a corporate litigator to uncover and remove unnecessary taxes and fees and ensure every option for internet is assessed. I will also diligently follow this principle: the more government spends, the more freedom is lost.

## What is your reason for running?

I was compelled to run in this election, by my love and respect for the people of Isanti County. ## What is your top priority and how do you plan on addressing it if elected?

## What is your reason for running?

## What is your top priority and how do you plan on addressing it if elected?

My top priority is ensuring no more tax increases during this economic uncertainty. I will do this just like I did in my six years of previous elected office, by respecting the limited resources of the citizens we represent more than increasing taxes for new programs like the orange frog experiment.

## What are the biggest challenges facing your constituents?

In addition to out-of-control taxation, citizens feel like they are losing their rights and sense of community belonging due to a lack of transparency and an over-reaching government that took away their right to vote for County Auditor and Recorder. Citizens want a say in their government. When politicians take away this treasured right to vote, we lose a sense of identity in our community and grow frustrated over being ruled rather than served by politicians. Many citizens who voiced concerns over their voting rights being taken away, another 7%+ tax increase, and initiating an orange frog program to "make people happy" are frustrated that their concerns were not considered in the voting process.

Citizens are frustrated, and it is encouraging to see nine new candidates run for four Commissioner positions to make the changes necessary to regain the public's trust. This new board can regain the public trust through genuine transparency, listening to public input, and making public decisions that recognize the financial uncertainties of our time



## **GARY LANTZ**

## What is your reason for running?

Over the past year I have attended nearly all the County Commissioner board meetings and have come to realize that there are several things that need changing in our current governance operation, implementation, agenda, and attitude. ## What is your top priority and how do you plan on addressing it if elected?

In this post-pandemic time, we are just beginning to realize the deep emotional and spiritual impact of the isolation thrust upon us... sometimes necessarily and sometimes needlessly. As a result, the rates of depression, drug use, death by drug overdose, and suicide have skyrocketed. We must begin to use available funds to provide more individual counselling and mentoring programs that have a historically true success rate rather than things like the pie-in-the-sky, self-talk program the Orange Frog/Happiness Advantage, that is hyped up and highly promoted for huge financial gains.

Then there is the area of fiscal responsibility. Isanti County's property taxes are higher than 82% of Minnesota counties. Although we have a lot to be grateful for in this county, I cannot but believe that a good hard look at our spending practices would reveal possible cost-cutting measures which could lead to lower taxes.

We need commonsense leadership in these uncommon times.

## **LISA LOVERING**

## What is your reason for running?

I have been employed with the Isanti County Sheriff's Office for over 30 years. Starting as a part-time dispatcher, and being promoted through the ranks to include serving as a deputy sheriff, investigator, and patrol sergeant. As a respected member of the staff, in 2015 Sheriff Caulk appointed me as the Chief Deputy. As second in command, I run the day-today operations and oversee patrol, investigations, dispatch, jail and volunteers. I also serve as the deputy emergency management director as well as acting sheriff in his absence. I assist in managing the budget as well as all grants and fundraising. We have implemented many programs including Triad, assigning personnel to rural areas to patrol and assigning deputies to townships to be more visible in our community. I want to continue to work with our residents and partner on projects important to them that make our community safer.

## What is your top priority and how do you plan on addressing it if elected?

My first priority would be to work on mental health programs. So many of our residents have been affected by those suffering with mental health. People suffering cannot get the help they need or in a timely fashion. We respond to many calls for help each day and we do not have the resources to help everyone. We need to be creative in ways to help those in crisis. There are untapped resources including our faith community, social services and veteran resources as well as mental health professionals that we should explore partnering with.

In 2021, I started a mental health program for our staff. We need to take care of our first responders as well so that they can also help and understand those that rely on us for help.

## What are the biggest challenges facing your constitu-

It is that of the perception of what a law enforcement officer is and does. I am thankful for all the support our community continues to give us. However, we need to continue to show our professionalism, transparency and partnerships in order to continue our positive relationships. We also need to work to come up with creative recruiting ideas so that we can continue to hire qualified candidates.. I will continue to partner with all elected officials including those at the state level to make sure that our voices are heard and that we continue to provide a high level of law enforcement service to our residents.

I want Isanti County to continue to be a safe place to work and live.



## **WAYNE SEIBERLICH**

## What is your top priority and how do you plan on addressing it if elected?

Top priorities include proactive policing as we target our theft and drug concerns in Isanti County. This will be addressed with expanded undercover theft and narcotics investigations, systematic patrol in our rural areas, and more thorough updates and direct follow up with the public. Our senior citizens are still targets in financial fraud and scams, and we have lost our connection with youth and preventative education. I will continue to evaluate and improve these efforts as the community and Sheriff's Office work together in our common goal of Public Safety.

## What are the biggest challenges facing your constitu-

One of the biggest challenges I have seen is the community's faith in our ability to serve them. As an investigator, I have heard directly from many members of the community who admit that they have experienced crimes that went unreported. This has been due to a belief that reporting the crime won't matter. Please take a moment and ask yourself if you or someone you know has had a crime happen that went unreported and then ask yourself why it wasn't reported. The most common response I've heard would be something to effect of "well, it wouldn't matter anyways" or "you can't do anything about it anyway." When we lose the trust of the community, we've failed the community. If we continue to sit back and not acknowledge our shortcomings, nothing will change and we will continue to fail you. If elected, I will acknowledge our faults and immediately begin efforts to restore public trust and cooperation.

I would like to see an advisory board created which will include a representative from each township who will be liaisons between that township and the Sheriff's Office. The Sheriff's Office needs to be seen as a member of the community and our relationship with the community needs to be stronger if we want to see improved Public

Reports of crimes help us to investigate and proactively respond. Though it's true we will unfortunately not catch every suspect or solve every crime, we need the information and data of what's being done, where it's being done, what time of day and how it's being done to prevent the crimes from continuing. One person's loss can help in preventing the next person's loss, but without trust in the sheriff's office, we cannot work together to make that difference.

## What is your reason for running?


