Isanti County Fair wraps up busy event month

This year, the Isanti County Fair will be running the "anchor leg" of a month-long summertime event "relay." Taking place Wednesday through Sunday, July 16 - 20, the fair is loaded with appealing features

Gates officially open at 3 p.m. on Wednesday, July 16. The day is designated as "Veterans Day," the kickoff features the official raising of the flag ceremony at 6 p.m. The live music on the opening day is by Kenny Krona & Rick Stener, who will be performing at 6 p.m. The grandstand entertainment will be motocross at 7 p.m.

Thursday, July 17 is designated as Seniors Day, with a special program running from 1 to 4 p.m. The live music will be from The Varsity Rejects, who will be performing starting at 8 p.m. The grandstand entertainment is the popular "Night of Destruction.

Friday is Kids Day, with special features for the youngsters from 8:30 a.m. to 1 p.m. during that time, there will be games, a drawing for a new bike,

Balloon Art, the Kindsci Pedal Pull, plus more including free ice cream. A new addition to the events is the Isanti County Historical Society's annual

Heritage Day, which will be held from 10 a.m. to 2 p.m. The live music Friday night will be from the band Ragtown at 8 p.m. The grandstand entertainment will be a tractor, diesel, pickup, and semi pull.

Saturday is 4-H Day. There will also be several contests throughout the day including

the Blue Ribbon Beard Contest, a Lego building contest, hot dish contest, and dessert bar contest. A new addition to Saturday's lineup is professional wrestling matches at the grandstand at noon. The live music at 8 p.m. will be from the Red Letter Band. The main grandstand entertainment will be "Night of Chaos'

The fair wraps up on Sunday, with the traditional church service, car show, and free corn feed.

Carnival rides will be running throughout the entire duration of the fair. On Wednesday, all rides are \$2. Friday and Sunday feature unlimited ride wristbands for \$25.

Other attractions throughout all five days include "Grand Illusions by the Blooms," a family of master magicians and illusionists; "Captain Jack Sparrow;" and "Roarie," the baby dinosaur from The Dinosaur Xperience.

Cambridge to use recruitment program for hiring officer

As the recruitment of qualified police officer candidates continues to be increasingly difficult, the Cambridge Police Department is turning to a state initiative that supports non-traditional pathways into law enforcement.

According to Cambridge Police Chief Shawn Machin, the Minnesota Innovative Community Policing Officer Education and Training Program is administered by the Minnesota Department of Public Safety's Office of

Justice Programs. It allows law enforcement agencies to hire individuals who are not yet Peace Officer Standards and Training licensed but meet eligibility criteria. Agencies sponsor an individual through training and certification, with state grant funding covering most of the associated costs.

According to Machin, the program includes 20 to 22 weeks of accelerated academic and skills-based peace officer training, train ing at Alexandria Technical & Community College or

Additional work to be done on County Road 5

Taking advantage of the lower-than-estimated bids for the County Road 5/East Dual Blvd roundabout project, Isanti County is now planning on doing more extensive reconstruction between Highway 65 and the railroad tracks.

According to Isanti County Highway Engineer Justin Bergerson, part of the original discussions for the project included resurfacing that stretch of County Road 5. However, in the interest of minimizing costs, it was taken out of the final project plans. After discovering the project would leave roughly \$400,000 in local road improvement project grant money unused, Bergerson and Isanti City Engineer Jason Cook got together to figure out how they could use that leftover money.

Bergerson said they put in a change order with the winning bidder for the roundabout project, asking how much adding in the resurfacing would cost. He said they came back with an amount of \$496,859.

"The base bid, plus this change order would put us right back at where we were with the engineer's estimate of the project," Bergerson said.

Bergerson also said the amount of money the county would have to pay "out-of-pocket" for the project, including the additional work, would be approximately \$450,000, which is the maximum amount the commissioners had dedicated from ARPA savings for the project.

"From a financial standpoint, there is no change for the county," Bergerson said. "(And) we would be getting the full scope of what we wanted to get a better end product."

Podcast series featuring Pine County cult leader debuts

Many Minnesotans remember learning of River Road Fellowship cult leader Victor Barnard and the abuses that occurred in rural Finlayson through the testimonies of his victims during his 2018 trial. Now, this story will be told for the world to hear through a new podcast series.

The 10-part weekly podcast will be featuring Barnard's case, prosecution, subsequent fleeing, capture and finally imprisonment of Barnard.

The podcast is titled "The Turning - River Road" and produced by Rococo Punch. It can be found on iHeart True Crime +, Apple podcasts, Spotify, or wherever you get your

podcasts.

Bernard's story will be featured in season three of the award-winning podcast. It features testimonial from Lindsay Tornambe, a key witness in the trial, and Pine County Attorney Reese Frederickson.

When Tornambe was 13 years old, she was chosen by the leader of her family's commune for a "special role." She became one of the youngest maidens of the River Road Fellowship. At the time, she didn't know what that really meant for her. After a ritualistic ceremony that married her and other girls in the group to their adult leader, she endured more than a decade of mental and physical abuse hidden from outsiders.

When Tornambe and a

friend decided to escape, they became the whistle-blowers that prompted an international manhunt in 2014 that would bring the entire cult crumbling to the ground and an eventual capture of Barnard overseas.

However, when Barnard pled guilty to sexual assault in 2016, Tornambe and her fellow maidens' stories were not heard by the public. Nearly a decade later, Tornambe — now herself a mother — will tell the story on her own terms through the podcast series.

Elin Lantz Lesser, host and producer at Rococo Punch, took an interest in this case because as a team they have been creating audio documentaries on communities with dangerous power dynamics or where some kind of lofty goal was pushed on a group of people in unusual extremes. The two previous seasons had been on similar topics.

"When we stumbled across this story in the media and realized something like this happened so close to where we lived and where we grew up as sisters in Minnesota, we felt like we had to explore it further," said Lantz Lesser. "Once we started talking to Lindsay and heard her mind-blowing story, we decided to do an entire season on River Road and Lindsay's experience. Once we went deeper, we uncovered so many interesting layers."

Lantz Lesser added they've observed the dynamics of personal relationships mixed with community hierarchies leading to some shocking results.

"We explore questions of who was to blame," she said. "Lindsay's story in particular was fascinating because she was one of the two people to spark an international manhunt and take the whole thing down. We feel this is an important story that is worth telling, and we're hoping people will listen."

Senior producer Erika Lantz feels it's important to examine how leaders can use religion and people's belief systems to get them to do more and more extreme things and convince them of almost anything and how a community can revere and harbor that leader/abuser.


"I hope people who hear the podcast can reflect not only what happened in this cult, but also on their own lives or the communities they're a part

of, and think about how they can keep an eye out for abusive situations and provide support and compassion to victims who need it," said Lantz.

Pine County Attorney Reese Frederickson, who was the prosecutor in the Barnard case, said he is looking forward to the series himself.

"I believe Lindsay's story is important to hear," he said.
"This podcast will shine a new and thought-provoking light on that story. Elin and Erika are two of the most impressive people I've met in media, so I have no doubt that this will be an amazing series."

Referendum's price tag is large, but justified

egular readers of this column won't be surprised to find out I am in favor of a "yes" vote for the upcoming Cambridge-Isanti Schools referendum questions. Multiple times in this space, I have bemoaned the need for updated facilities, particularly at the high school. Specifically, I've brought up the poor conditions

of the football/soccer field, the high school gymnasiums — especially in terms of the space for gymnastics, plus

I will openly admit when I first saw the extensive list of projects proposed and the corresponding nearly \$123.6 million price tag, I experienced more than a little sticker shock.

But then I started looking at each school buildings' itemized lists. A vast majority of what is being recommended in question #1 is not only needs but long-overdue needs. I attended kindergarten at Cambridge Elementary (now Primary) School 50 years ago. In the Cambridge Primary, Intermediate, and High Schools, there is much that has

gone unchanged in those 50 years. And while I don't have as extensive of a history with Isanti Primary and Middle Schools, I've been told the story is the same there.

For question #1, there really isn't one single large project that accounts for a significant percentage of the \$87 million price tag. The most expensive project is an addition to the Isanti Primary School that would include a new cafeteria, kitchen, main entrance, etc. at a cost of \$7.4 million. And while there are a few other projects over \$1 million, I would give a rough estimate at least 70% of the projects coming in under \$1 million.


Comparing this referendum to North Branch's 2017 referendum that was approved, C-I's question #1 is only about \$10 million more than North Branch's total referendum cost. This fact is more impressive considering North Branch has only four buildings, compared to Cambridge-Isanti's 11, all of which have at least a couple of projects tied to them.

To me, that says there is very little "fat" that could be trimmed should question #1 fail in November, forcing the district to attempt a second referendum vote some-

In terms of question #2, I will be very honest. If the fieldhouse/community fitness center were the only project, I would probably stay neutral on it. There is no doubt there has been a vocal section of the community who have been advocating for this very thing for the past 10 to 15 years. This is their opportunity to prove their position is in line with the majority of the community.

However, question #2 also includes a new practice and competition space for the gymnastics program. It is no secret I have close ties to the gymnastics program. However, I think even an outsider can see how unsafe the program's space is for both practices and meets. That in itself moves my needle to endorsing a yes vote on ques-



What is lane splitting?

Question: I heard some talk about a new law of July 1st that allows motorcycles to drive through traffic. Can you explain this as a lot of my friends are talking but I can't get the same answer from

Answer: Motorcycle lane splitting and filtering

are legal on Minnesota roads as of July 1. The new law, passed by the Legislature in 2024, allows motorcycles to share lanes with cars for the first time in the state, and where lane sharing can be performed.

they are not obligated to accom-



modate them.

with notable restrictions on speed

It is the responsibility of motorcyclists to perform these actions safely and legally. Motorists need to be aware of motorcycles that are splitting and filtering and cannot get in their way, however

 Lane splitting allows a motorcycle to share a lane with and pass a vehicle in slow-moving traffic at no more than 25 mph, and no more than 15 mph over the speed of traffic. Once traffic gets back up to 25 mph, the motorcycle must go back into their own lane of traffic.

 Lane filtering allows motorcycles to move through traffic that is stopped, such as at a stoplight or in a traffic jam. The motorcyclist cannot go more than 15 mph as they filter toward the front of the line of traffic.

 Splitting and filtering are prohibited in roundabouts, school zones, freeway on-ramps and work zones where traffic has been funneled down to a



Hennepin Technical College, a conditional job offer from the agency before training begins, a full salary for the cadet during the training process and tuition, materials, uniforms and some housing costs, which are covered by the state.

Machin said the city would have to apply for the grant, which would be for up to \$50,000 per candidate. He said most agencies have been able to be fully reimbursed for mandatory expenses, depending on the wage assigned to the cadet position. He added if the department was awarded the grant, but then decided to decline participation, there would be no financial penalty. "I would just contact them and they would take it back."

Machin added the department currently has one opening, and he knows of someone locally who is not only eligible to go through this program but who has expressed an interest in doing

During the discussion, Council member Aaron Berg noted his son had recently gone through this very program with the Waseca County Sheriff's Office, resulting in him going through the training academy debt-free.

The council unanimously approved applying for the grant.



Isanti Council requires proposed apartment complex to pay for full street improvements

The Isanti City Council is going against previously established policy, requiring the developers of a proposed 28-unit, market-rate apartment complex to pay the entire amount of improvements to the street adjacent to the property.

According to Community Development Director Stephanie Hillesheim, staff has been working with the developer to construct the apartment complex on vacant land along Centennial Drive SW, just to the south of the Isanti Middle School. She said Centennial Drive is already in poor condition, doesn't include a cul-de-sac, and due to the vacant lots, is low-prioritv when it comes to snow removal.

However, if the complex were built, the city's policy advises the road be upgraded to current standards due to the anticipated increased traffic. Hillesheim said the assessment policy also states the cost of the street improvements would be split between the city and the developer, with in this case the city paying approximately \$144,000 and the developer being assessed approximately \$125,000.

She added the city could treat this as if it was like a new road being constructed, in which case the developer would be responsible for the entire amount. However, if the council went with that option. it "could prevent the project from going forward."

A third option would be to just allow the project to move forward without any street improvements being made at this time. However, Isanti City Engineer Jason Cook stated the street would already be assessed as being "failing." Plus, the absence of a cul-de-sac makes snow removal much more difficult.

After a brief discussion, the council was unanimous in insisting on the developer paying for the entire cost of the street improvement.

"Even if it prevents the project from going forward?" asked Hillesheim, adding that multi-family housing was the city's best way to grow its tax base.

"Yes," Interim Mayor Luke Merrill bluntly responded. "When you're subsidizing a housing development, it has a long-term cost to taxpayers."

Both Hillesheim and Cook emphasized to the council that the street is already part of the city's short-term capital improvement

"We're going to have to upgrade the street anyway," Hillesheim said. "So actually, this (project) helps us save money."

"The road is already filled," Cook added. "We've seal-coated it just to try and make it last longer. But if we are about to do the (improvement) project and this (housing) project doesn't happen, well, then we are running the whole show."

He concluded by saying he came up with the \$125,000 figure based on how that property would have been assessed like any other street improvement assessment.

The council, however, went unswaved and unanimously approved mandating the developer pay for all of the street improvement costs if the housing project goes forward.

Minnesota DNR expands library pass program to provide more access to state parks, recreation areas

In partnership with over 200 libraries and bookmobiles across the state, the Minnesota Department of Natural Resources is expanding the popular library park pass program, which provides access to state parks and recreation areas at no cost to library

Piloted in 2018 and launched statewide in 2021, the program offers seven-day state park passes that can be checked out from participating public libraries. In an exciting expansion of this successful program, effective July 1, the number of participating libraries and the number of park passes available to check out

has more than doubled.

'State parks and recreation areas in Minnesota are for everyone, and this program is an important way we're expanding access," explained Ann Pierce, director of the DNR's Parks and Trails Division. "There are so many benefits to spending time outdoors, from health and wellness benefits to education and making memories with loved ones. This program helps us bring meaningful experiences in state parks and recreation areas to more Minnesotans."

The program has expanded from about 100 participating libraries to more than 200 libraries and bookmobiles. All 87 counties in Minnesota have at least one participating library. The number of available passes has also grown from 175 to 450. Usage of the library passes increased almost two-fold in the first three years of the program, with 1,960 pass checkouts in the first year (July 2021-June 2022) to 3,812 checkouts in the third year of the program (July 2023-June

The cost of the passes available through this program is covered by the Parks and Trails Legacy Fund, while partnering libraries facilitate the checkout process. To see a list of participating libraries, visit mndnr.gov/librarypass.

A 2024 survey of people using library park passes found that most respondents checked out a pass to save money, and the cost of a vehicle permit was a barrier. Some survey respondents noted they were not frequent state park visitors and were looking to



try a state park before they buy a permit.

"Data from the past several years tells us that the average household income of people using the library pass program is lower than the average household income of all state park visitors, indicating the program is reaching households that may otherwise have more of an economic barrier to visiting a state park," said Arielle Courtney, partnership development consultant and program manager. "We are grateful for the many partner libraries across the state that support DNR's efforts to expand access to

Minnesota state parks and recreation areas."

People interested in checking out a pass should contact their library directly, as checkout policies vary among participating locations. All passes through this program are valid for seven days.

Library park passes only cover the vehicle entrance fee. If participants would like to camp, they will need to make and pay for camping reservations, either online at mndnr.gov/reservations or by phone at 866-857-2757. ~ MNDNR

Suspect arrested after statue theft in Chisago County

On 07/05/2025, at approximately 6:50 a.m., Chisago County Emergency Communications received a call from the business owner at Rush Point Store, in Nessel Township, reporting that they had a statue stolen and damage to their property from an overnight incident. The lifesize replica, Vietnam statue had been stolen from their front step area around 3 a.m. The statue was valued at \$3500.00.

Staff advised that video surveillance captured the theft, including the three suspects and their vehicle. Deputies were able to obtain the vehicle license plate from the video. While deputies were continuing their investigation, staff posted a clip of the surveillance video on social media.

Information was obtained by Rush Point Store staff and the Sheriff's Office that the suspects may attempt to return the statue after video was circulating online.

With deputies in the area, the statue arrived back on the property at approximately 11:20 a.m. Deputies arrived within seconds and confirmed one suspect was present from the early morning theft, along with the stolen statue. Deputies physically assisted the suspect with returning the statue to its original place.

Suspect #1, identified as Ryan Thomas Warling, 18, of Maplewood, MN, was arrested and transported to the Chisago County Jail where he was booked in for Theft – (Felony).

The Sheriff's Office is confident we have identified the additional two adult male suspects, (18 – Staples, MN) and (19 – St Croix Falls, WI).

Talking running and health with University of Minnesota

Taking advantage of Minnesota's summer weather, runners are lacing up their shoes and heading out to their favorite trails and paths. Whether you are a seasoned marathoner or giving running a try for the first time, the activity provides numerous benefits beyond burning calories.

David Supik, DO, with the University of Minnesota Medical School and M Health Fairview talks about the health benefits of running, common injuries and advice for new runners.

Q: How does running benefit our health and overall wellbeing?


Dr. Supik: There is an exhaustive list of benefits that running affords our health and well-being. Studies show that individuals who regularly engage in physical activities, such as running, have an average life expectancy that is about seven years longer than inactive individuals. Running can decrease the risk factors for some of the most common diseases and conditions we might face, including hypertension, obesity, elevated cholesterol, diabetes and osteoporosis. Running can even shrink risks for some cancers. From a mental health perspective, running can improve blood flow to the brain and help to combat our daily stresses of work or school. It can also improve cognition, fight depression and anxiety and decrease our risk for Alzheimer's disease later in life.

From a personal standpoint, running improves my daily mental focus, decreases my stress, energizes me for the remainder of my day and allows me to sleep more soundly at night.

Q: What are some of the most common injuries runners experience? What tips do you have for avoiding injury?

Dr. Supik: Most commonly, we see overuse injuries related to overtraining — either by ramping up a new running program too quickly or not taking adequate rest or cross-training between runs. Each time we run, it places small stresses on ligaments, tendons, bones and muscles. If these structures don't have time to repair themselves between bouts of exercise, stresses can compound, and it can lead to injury. These injuries most commonly include tendonitis, shin splints, runner's knee, IT band syndrome and

Stretching and strengthening can help to avoid injury. Start slow when adopting a new running plan. Allow your body to rest and recover between runs. It can also be helpful to cross-train with a lower impact activity, such as biking or resistance exercise. Running "equipment," such as supportive running shoes, also plays an important role in running safely.



Be sure to adhere to a 300-400 mile lifespan for your training shoes. If you are unsure about which shoes are best for you, seek help at a local running store. They do a great job of recommending brands for your particular foot shape and running form.

Q: Are there any negative long-term impacts of running? Dr. Supik: Like many of our favorite things in life, too much of a good thing can sometimes end badly. In the most extreme endurance athletes training for ultramarathons — races which are 30 to 100 miles some studies have shown an increased risk for developing scarring and thickening in the muscular walls of the heart over time. However, for the vast majority of recreational or typical runners, the benefits wildly outweigh the associated risks. Some of the most prevalent negative beliefs about running have been

disproven in recent years. We used to believe runners increased their risks for knee or hip arthritis. However, recent studies have debunked this. We have also learned an adaptation to cartilage in runners' joints can make them more resilient and less prone to developing arthritis.

Q: What advice do you have for beginners interested in running?

Dr. Supik: First, you should always get off on the right foot with the proper running gear. Fortunately, unlike other sports like hockey, you won't break the bank. New running shoes and moisture wicking clothing are the basic essentials. If you will be running on busier streets or paths, consider opting for bright colors and reflective clothing for safety. A fitness tracker app or watch is not essential, but it can be a fun way to track your progress with different metrics like heart rate, calories burned, pace and total time running.

Getting out the door with your new shoes is the hardest part for many beginners, so set attainable goals for yourself, keep a regular schedule and try your best to follow it. If you miss a day, don't sweat it and get back to your groove. It is important to start slow, and you may want to consider a run-walk program to get yourself started. There is no shame in walking! After a run, you can also always reward yourself in some way.

Q: How does your work at the University of Minnesota advance health in Minnesota?

As a sports medicine physician at the University of Minnesota, I strive to advance health by using my platform to educate patients about their ailments and emphasize injury prevention when able. I promote the philosophy "exercise is medicine" and work with my patient population to achieve these goals in a very individualized way. As a professor, I have the privilege to teach medical students and resident doctors about the tenets of sports and exercise medicine with the hope that my beliefs can be adopted by a new generation of healthcare providers to benefit their future patients.

USPS delivering July price increase

The United State Post office has announced that mail costs are going up again July 13. Stamps for regular letters move from 73 to 78 cents, a 6.4% bump. Marketing or bulk mail is going up 7.3%. Postcards increase from 56 to 32 cents. In-county Periodical mail increases 9.3%. Large volume packages known as Parcel Select go up 7.6%, while standard Ground Advantage packages have a 9.8% increase.

The USPS lost \$9.5 billion in 2024 and lost \$6.5 billion in 2023 while raising postage prices in both January and July both years. USPS expects to lose \$6.9 billion in 2025, due to declining mail volume and rising costs.

More frequent price increases have been part Postmaster General Louis DeJoy's 10-year plan for financial stability. DeJoy stepped down in March. The U.S. Postal Service Board of Governors appointed David Steiner, who has worked for Waste Management and FedEx, to be the new Postmaster General. The U.S. Postal Service Board of Governors expects Steiner to begin work at USPS in July after ethics and security checks.

The U.S. Government Accountability Office, or GAO, reports "(USPS) expenses are growing faster than its revenues, in part due to continuing declines in volume of First-Class mail – its most profitable product." "Punitive rate increases have been counter-productive, only serving to destroy mail volume," National Newspaper Association chair Martha Diaz Aszkenazy, publisher of The San Fernando (California) Valley Sun, said.

Volume of first-class mail, the USPS' most profitable mail type, fell 4.8% in 2024, and

"NNA offers it congratulations, and we look forward to working with PMG Steiner to help change course and restore the confidence of oublishers in the USPS," Diaz Aszkenazy said. 'The last five years have been a disastrous

... the pattern of service failures and twicea-year punitive rate increases has driven publishers out of the mail. It has been no more beneficial for the USPS, which has experienced skyrocketing costs and financial losses. USPS cannot survive continued pursuit of higher rates and poorer service.'

With the July 13 increase, periodical mail used by newspapers and magazines increased 56% since the start of USPS' financial stability plan in 2021, making subscription prices rise across U.S. periodicals. USPS postage increases had inflation-based price caps before its 2021 plan launched. The 10-year plan allows it to raise rates faster than inflation. The plan also slows its delivery standards, allowing USPS six days to deliver versus three days previously required.

SUBSCRIPTION INCREASES

While being a free-distribution newspaper, the price for a subscription of the Isanti-Chis ago County Star outside its distribution area via First Class mail will increase to \$139 for a

The Star's sister publications will also increase subscription prices, beginning Aug. 1. The Kanabec County Times is increasing home-delivery subscription prices from \$61 to \$64 per year for in-county subscriptions and from \$71 to \$74 for out-of-county subscriptions.

The Pine City Pioneer, North Pine County News, and Moose Lake Star Gazette will increase to \$59 per year for in-county and \$70 for out-of-county subscriptions. The Braham Journal, which is also a free-distribution newspaper, will increase to \$44 per year for First Class Mail delivery. In addition, all the above-mentioned newspapers will discontinue offering multi-year subscriptions.

Publisher Jeff Andres said, "Home delivery of the newspaper is still a value with the new rates. Home delivery subscribers get unlimited access to the paper's website including the

e-edition of the paper."

DNR cautions lake, river property owners about improper hydraulic jet use

The Minnesota Department of Natural Resources frequently receives questions about devices that generate water current to blast muck and aquatic plants away. They have various trade names, but the DNR refers to these devices generically as hydraulic jets. Even though they can be purchased in Minnesota, they cannot be used in any way that disturbs the bottom of a waterbody or destroys plants.

A person may legally operate a hydraulic jet if it is placed at the surface of the water in such a way that it does not disturb the bottom or destroy rooted aquatic plants. It should be directed slightly upward toward the water's surface. This can prevent dead vegetation and duckweed from collecting around docks and boat lifts.

"We want people to know why it's important to protect aquatic plants," said Shane McBride, DNR aquatic plant management consultant. "Plants are important to lakes and rivers because they help maintain water clarity, prevent erosion, stabilize the bottom of the waterbody, and provide habitat for fish and wildlife. Aquatic plants are

protected under state law." Specific regulations govern aquatic plant removal and prescribe the situations that require permits from the DNR. Regulations and a guide to aquatic plants can be found on the Minnesota DNR website (mndnr.gov/shorelandmgmt/ apg/regulations.html). To apply for an aquatic plant management permit, visit the Minnesota DNR's permitting and reporting system (mndnr.gov/ mpars).

All hail the hardy Hosta

Hosta plants come in such a variety that the choices are only limited by your pocketbook. The size, foliage color and leaf shape offer so many opportunities to

fill out the garden and improve the overall look of the bed.

As a northern gardener hostas are a staple in my gardens. I know they will reliably come back year after year. I love adding a new variety each year.

Hostas can be categorized as:

- Fragrant plants will have a sweet scent to their flowers, which make great cutting flowers for bouquets.

They tend to perform better in part to full sun. Examples are Stained Glass, Cathedral Windows and Fragrant Blue.

- Blue-Hued plants are a great way to add depth and mood to the landscape. The genetics allow them to make a crystalline wax layer that shows off the blue color. Plant these hostas in the shade. Sunlight can damage the wax layer.

Examples are Blue Mouse Ears, Abiqua Drinking Gourd and Blue Hawaii.

Slug-Resistant plants are available. Slugs are the number one enemy of hostas. These varieties are naturally slug resistant due to their thick leaves. Examples are Empress Wu, Liberty and Brother Stefan.

- Sun-Tolerant plants can flourish in many light settings. These hostas can handle more sun than most if they are grown in good soil and given adequate moisture. Examples are Curly Fries, Sum & Substance and Rainforest Sunrise.

- Ground-Cover plants are ideal for rock gardens, borders or that hard to grow spot in the yard. Examples are Silly String, Hush Puppie and Golden

- Red Petioles plants have red stems, flower scapes and even flowers. There are anthocyanins in the genus Hosta. The type of anthocyanin and the amount of it is what determines the strength of color. Examples are Fire Island Cherry Berry and Marilyn Monroe.

- Rippled Foliage plants seem to dance in the garden with the waves and ruffles in their leaf structure. Examples are

Silly String, School Mouse and Wiggles and Squiggles.

- Deer Resistant varieties don't really exist; however, deer seem to prefer eating non-variegated/fully green varieties and those with fragrant flowers. If growing hostas, plan on utilizing some type of control method. (I tend to spray mine with a deer repellant and string fishline at knee height around my plants), several websites suggest planting the hostas among deer resistant plants. Rutgers University provides a list; https://njaes. rutgers.edu/deer-resistant-plants/

Nhhostas.com is a great place to see a large variety of available hostas and the site provides good information about each variety and how best to grow them. I use this site to create a list of hostas which I use when prowling my local garden centers. By doing a bit of research beforehand, I'm less likely to impulse

meeting to order at 6:00 pm and led the assembly in the Pledge of Allegiance. Isanti County Deputy County Administrator Heather Sward gave the oath of office to the members of the Board of Appeal and Equalization. Chairperson Duff informed the attendees of the ground rules for this meeting.

County Assessor Long began by introducing the appraisers. She then described what the purpose of this meeting is and the duties of the board. She presented a detailed PowerPoint explaining the valuation process that is required by the State of Minnesota to assess properties The 2025 estimated market value increased 8.22% compared to 2024

Duevel, James parcel 16.151.0130, appeared before the board to appeal the 2025 assessment of his property located in the City of Isanti. He purchased the slab on grade property in 2024 for \$292,000. The original 2025 assessed value was \$315,200. After a reinspection of the property, the value was reduced to \$309,600. Assessor Long stated this property is valued consistent with other comparable sales. Motion by Christensen, seconded by LaRowe to decrease the estimated market value to \$304,340. Motion carried unanimously.

Thompson 09.024.1100, appeared the board to appeal the 2025 assessment of his property located in Spencer Brook Township. He recently met with Appraiser Cook, which resulted in a reduction of value from \$681,700 to \$673,500. The 2024 estimated market value was \$494,300. The property includes a residence, a secondary residence, a detached garage, and a commercial pole building. Thompson provided an appraisal with an opinion of value of \$500,000. Assessor Long said it was difficult to find comparable properties due to the extra buildings on this property. Motion by Christensen, seconded by LaRowe to decrease the estimated market value to \$550,000. Motion carried unanimously.

Donald Davies, 12.006.0303, located in Stanford Township on Blue Lake, appeared before the board to discuss the increase of value from \$1,300 to \$119,800. He stated the vacant lot should not be valued based on lake frontage because the lake would need to be dredged for a boat to access the lake. Assessor Long stated the property was already being appraised at a lower price per foot then other properties on the lake. Appraiser Cook reviewed the property and determined the property is appropriately assessed in line with comparable lake lots. Motion by Christensen, seconded by LaRowe to decrease the estimated market value to \$64,000. Motion failed. Opposed: Westerberg, Berg, Duff, Larson. A second motion was made by Berg, seconded by Westerberg to decrease the estimated market value to \$95,000. Motion carried. In Favor: Berg, Westerberg, Duff, Christensen, Larson. Opposed: LaRowe.

Davies, 12.140.0501. located in Stanford Township, appeared before the board to discuss the increase of value on his vacant lot from \$15,500 to \$68,300. The property owner does not believe the acreage being used for the assessment is correct. Appraiser Cook displayed the recorded plat on the screen and verified the acreage used was calculated correctly. Motion by Christensen, seconded by LaRowe to decrease the estimated market value to \$62,500. Motion carried unanimously.

Zachary Adams, 12.009.0404 did not have an appointment however, had questions about the increase in estimated market value from \$497,900 in 2024 to \$829,400 in 2025. Assessor Long explained to the taxpayer that because the new construction on January 2, 2024, it was assessed at 50% of the estimated market value. Because the home was completed on January 2, 2025, it is assessed at the full 100% estimated market value. The taxpayer understood and withdrew the appeal.

Flannigan, parcel 03.116.0020, initially attended the Cambridge Township Local Board of Appeals meeting to dispute the increase of estimated market value on his property for 2025 His request was denied by the local board of appeals. The next step in the appeal process, is to appear at the Isanti County Board of Appeals meeting. He stated the property value went from \$445,200 in 2024 to \$451,600 in 2025. He provided a market analysis with the opinion that this property was being overvalued. Assessor Long indicated the property was recently reviewed there was no discrepancies in the assessment. Motion by Berg, seconded by Christensen decrease the estimated market value to \$439,000. Motion Carried. Westerberg, Christensen, LaRowe. Opposed: Duff, Larson.

SPEC1975 13.062.0070, appeared in front of the board to discuss the valuation of her seasonal property located on Spectacle Lake. The cabin, which cannot be used in the winter, improvements have been made, the properties being constructed around her property are raising her values. Her 2025 estimated market value is \$364,700. Assessor Long said the property has 77 feet of shoreline on a highly sought out lake. The raise in assessment is in line with comparable sales on other county lakes. Motion by Berg, seconded by Christensen to decrease the estimated market value to \$340,000. Motion carried unanimously.

Paul Landberg, parcel 02.001.1401, located in Bradford Township, withdrew his appeal.

Sheldon Beedle, parcel 08.008.0600, located in Oxford Township, appeared before the board regarding the estimated market value on his new construction property. The estimated market value for 2025 is \$1,079,100. The property owner provided insurance statements indicating the home is insured for \$850,000. Assessor Long explained that the property is rare due to size and is difficult to compare with other area property values and Motion by Westerberg, seconded by Berg to decrease the estimated market value to \$1,000,000. Motion carried. In Favor: Westerberg, Berg, Duff, Larson. Opposed: Christensen,

T. Hosch, 08.017.0803, contacted Assessor office County by mail requesting to appeal the 2025 estimated market valuation Originally, the value was \$670,500 however, after a recent review by Assessor Wahl, the value was decreased to \$612,300. The property owner believes the value should be adjusted to \$588,000 after applying an estimated sales ratio of 98%. Assessor Long indicated to the board members that she is confident in the current assessment on this property. Motion by Duff, seconded by Christensen to make no change to the assessment. Motion carried unanimously

The open book adjustments were distributed and reviewed. Motion by Christensen, seconded by Westerberg to approve the open book adjustments. Motion carried unanimously.

There being no further matters brought before the Board of Appeal and Equalization, motion was made by Westerberg and seconded by Larson to adjourn. The motion carried and the meeting was adjourned at 9:42 pm.
