# C-I Schools operating referendum, one NB school board seat up for election

Unlike most odd-numbered years, voters in the Cambridge-Isanti and North Branch Area School Districts will have a reason to get out and vote on Nov. 2.

#### **C-I SCHOOLS OPERATING REFERENDUM**

For the second-straight year, the C-I School District is asking residents to approve an operating referendum in order to increase their revenue. According to the district, C-I Schools continues to lag behind a vast majority of the districts in the state when it comes to per-student revenue and spending. According to the most recent statistics, the district is in the bottom 7% in the state in those two categories. As a result, the district has cut \$8.5 million from their budget over the last three years, which is approximately one-seventh of the district's \$60 million budget.

Unlike last year's referendum, this year's is broken up into two questions. The first question is labeled as "Authorization to Hire/Retain High-Quality Teachers and Support Students." If approved, this question will increase the district's revenue by \$565 per pupil, and would be applicable for ten years.

The second question is labeled "Additional Authorization to Support Vocational Technology and College Readiness." If approved, it will increase the district's revenue by \$121 per pupil, and would also be applicable for ten years. Question 2 can only pass if question 1 passes.

According to the district, the impact on a home valued at \$200,000 would be an increase in its property taxes by \$12 per month. Passing of the referendum would also trigger approximately \$500,000 in additional revenue from the state.

#### WHAT IF IT DOESN'T PASS?

Until recently, the primary focus of the district's information centered around how passing the referendum would be for "student support, hiring/retaining high-quality teachers, reducing class sizes, and enhancing career readiness." Last week, howev-

er, the district started emphasizing what would happen if it again failed.

"Without new revenue, we can expect another \$1 - 1.7 million in reductions," said Superintendent Dr. Nate Rudolph in an email to students' parents, which he also read at the Oct. 14 School Board meeting. "We can't trim around the edges. We need to look at significant restructuring and changes for the future."

While not being able to go into specifics on what those changes will be, some of the possible most impactful cuts would be the reduction of elective courses offered at the high school. "With the additional cuts, fewer classes would be available to students and more electives would be cut, up to 75%."

Rudolph explained 52 credits are required to graduate, with 36 of those credits being required classes, leaving 16 credits for electives. Calculated out, the cuts would eliminate four to 12 elective credits.

"Cuts would impact career-technical education, family and consumer science, personal finance, business, world languages, art, band, choir, physical education, and electives in English, math, science and social

# North Branch finds new way to fund street sweeper

The North Branch City Council had to get a little creative in finding a way to purchase a new street sweeper.

Previously, during the April 13 council meeting, the council had authorized staff to pursue the purchase of a new street sweeper, with part of the funding coming from grant funds. Unfortunately, according to Finance Director Joseph Starks, the city wasn't awarded any such grants, meaning 100% of the money would have to come from the

#### ity.

In light of that, Starks proposed a method of paying for the sweeper that while being a unique method to the city, it could ultimately increase the city's buying power for future expenses, such as the planned purchase of a new snow plow/grader. The method Starks presented is an interfund loan - essentially the city is loaning itself

# Gruden's sadly more like his nickname

have always been a Jon Gruden fan. As a coach, he was fiery and represented good old, hard-nosed football. Add to that a fun nickname ("Chucky" based on when he scowled it looked just like the main character in

the "Child's Play" horror movies), and it was hard not to like him. I was even more a fan of him as an announcer. His enthusiasm for the game, good-natured commentary and knowledge made him appear to be the next-coming of John Madden.

When the news first broke about a single email sent by Gruden that was very derogatory towards NFL Players Association Executive Director DeMaurice Smith, I was disappointed, but probably more so at how quickly people were willing to drag someone's name through the mud over one email ten years ago. After all, everyone has done something in their history they could potentially be persecuted for in today's hyper-sensitive

society. Those feelings were only magnified when Gruden's former announcing partner Mike Tirico repeatedly proclaimed Gruden's overall positive character, stating "I probably know Jon better than anybody in the league on a personal level."

Then came Monday's revelation that it wasn't just a single email ten years ago, but a multitude of emails over years. Those emails not only were laced with racism, but bigotry towards gays, women, and of all things, attempts to make the game of football safer for players.

As it turns out, Gruden was exactly like his nickname - innocent and playful looking on the outside, but sinister on the inside. The only difference between Gruden and Chucky was that Gruden's preferred method of killing was with words.

I have read a few commentary pieces stating this is the exact M.O. for people like Gruden, which is also the reason why it is so hard to expose them. They only unleash their true nature when your back is turned or they feel comfortable that the people surrounding them are of like minds. But these people also seem to wind up getting sloppy, or too comfortable.

It's ironic, but yet not totally surprising that Gruden's true nature was exposed during an investigation not directly against him, but of another person who appears to share the same sentiments. And the thing is, if these sentiments had merely been spoken over the phone or in person, nobody would be any the wiser. But they were sent via email, which is essentially permanent. Sure you can delete them from your own computer, but as any techie will tell you, they are never completely gone. As Judge Marilyn Milian of "The People's Court frequently says, "Say it, forget it. Write it, regret it.'

But what comes out of all of this? Some commentators have half-seriously stated this will actually help the causes of minorities, gays and women in football, stating how the Raiders will in essence fall all over themselves to distance themselves from Gruden's line of thinking. However there are still plenty of "old school" football thinkers out there. While there isn't always a direct connection between them and bigotry, it certainly seems like they follow a similar path.

There has already been others who are doing damage control for allegedly similar lines of communication. Hopefully that is all it is - damage control to prevent guilt by association. ## Classes have been invaluable for people with Parkinson's disease

#### To the editor.

My husband, Nick, was diagnosed with Parkinson's disease over 14 years ago. Our motto throughout these many years has been "We are a team and we WILL fight this together."

# What's at stake for Cambridge-Isanti Schools?

ast week I answered a few questions related to the upcoming school district referendum. This week, I'd like to address the three biggest questions:

1. If the referendum passes, how will the money be spent?

**C-I School News** Dr. Nate Rudolph 2. Who will make sure the referendum funds will be used for student learning?

3. What happens if the referendum does not pass?

#### How will the money be spent?

Since January, a Community Task Force has been studying our finances and their impact on students. They were very clear and direct in our need for additional funding, and urged the district to keep things simple. The legal language for the referendum is very direct and binds the district to a legal contract with voters.

On the ballot, Question 1 states "Authorization to Hire/Retain High-Quality Teachers and Support Students." If question 1 is approved, we will be obligated legally to hire and retain teachers, reduce class sizes and support student learning. That means we will purchase more classroom supplies, books and learning materials to support students in the new teachers' classrooms, and we will provide additional support for students.

Question 2 states "Authorization to Support Vocational Technology and College Readiness." We will be legally obligated to maintain (avoid cutting) and expand vocational and career technical classes, and we will increase opportunities to earn college credits while in high school. We will add apprenticeships and provide training and mentoring to prepare graduates for success in careers and college.

Question 2 can only pass if Question 1 passes because as much as the Task Force values vocational-technical classes, they could not justify adding programs at the high school when the basics of how many students are in a classroom are unacceptably high.

#### Who will make sure the spending is on learning?

Last January, we expanded the School Board's Finance Committee to become a Citizens Financial Advisory Council. Community business leaders joined to increase transparency, oversight and accountability. The Board commits to maintaining the Citizens Financial Advisory Council over the duration of the approved referendum authorization.

In addition, the official resolution calling for the referendum specifically stated the funds will be used for student learning, hiring and keeping high-quality teachers, reducing class sizes, and enhancing career and college readiness. This language is in the title of the ballot question. This is a legally binding commitment by the School Board and is subject to independent financial audits.

# What will happen if the additional funding is not approved?

After cutting \$8.5 million over the last three years, we have cut all the fat and are down to the bone. We already know state funding (approved last June for the next two years) will not keep pace with inflation. Without new revenue, we can expect another \$1-\$1.7 million in reductions. This will be the fourth year of budget cuts; we can't trim around the edges. The Community Task Force prioritized the following cost-cutting measures:

•Schedule changes at the high school and elimination of more electives

Students currently register for 60 possible credits over 4 years with 52 credits required to graduate —16 are elective credits. With additional budget cuts, electives would be cut up to 75%. Cuts would impact career-technical education, family and consumer science, personal finance, business, world languages, art, band, choir, physical education, and electives in English, math, science and social studies. Such a change will likely impact K-8 options and schedules as well.

•Reduce academic support programs, those that provide a lifeline to students who are below grade level. Many of these federal or grant funded programs require matching funds from the district, and if district funds are eliminated grant funds will be gone the next year. This includes targeted reading supports, smaller group interventions and supports.

•Increased facility use fees to cover utilities and custodial services for groups who rent or use our buildings. Youth sports fees will increase, community education class fees will go up, scouts and other nonprofits who use our buildings will have to pay more.

•Eliminate more middle school activities and increase activity fees.

Some middle school activities have already been cut and combined with high school teams. More could be eliminated completely or fees would need to increase. This year First Bank and Trust of Cambridge donated \$10,000 to avoid activity fee increases for students, and we appreciate their generosity.

•Eliminate specialty choice programs and reconfigure school grade levels.

Over the last two year, we eliminated the middle school year-round school (MN Center) and the year round schedule for School For All Seasons, but kept the students together with a focus on science and the environment. Without additional funding, this program can no longer be sustained. We'd also start to plan for reconfiguring grade levels and shifting some boundaries for increased efficiencies in administration, district supports, and transportation.

•Reduce Transportation with a Two-Mile Walk Zone State funding is intended to pay for transportations for students who live two miles or more from school. This will likely increase traffic congestion around each of our schools.

Over the last three years, the district has reduced expenses by \$8.5 million (on a \$60 million budget). Budget reductions have resulted in larger class sizes, less individual attention for students, higher student fees, fewer teachers and staff, and reductions in critical support for students who struggle.

For the North Branch taxpayer, this has reduced the need for two new public works employees which is a taxpayer savings. This provided the water employees with a better work life balance. Before they were on-call every other week. now every 12 weeks. •The Water Policy Plan is being updated. Water as we all know is a very precious resource that we need to manage well for our future. The Water Policy Plan covers important areas including: wellhead protection, water treatment and capacity, trend analysis, plans for emergencies, and future water planning. # Cambridge adjusts revolving business loan fund

In an attempt to improve the city's business retention and expansion efforts, the Cambridge City Council has modified their Revolving Loan Fund to differentiate between the manufacturing and the downtown revolving loan funds.

According to Assistant City Administrator Athanasia Lewis, there have been inquiries about sites in Cambridge, and their willingness to purchase participation in a loan to the potential business as an incentive for that business to move to Cambridge. However, since the current guidelines were limited, the city was not able to extend such an offer.

The city's revolving loan fund was made possible based on a grant the city received and subsequently loaned out for the sale of Cambridge Metal and Plastics back in 2007. The interest on that grant loan, which totaled \$114,315, was retained by the city to use at their discretion for other business incentives. The city still has approximately \$66,000 remaining of that money.

According to City Administrator Evan Vogel, the proposed modifications would be additional benefit to the city since direct participation in loans would enable the city to be in a better financial position should the loan get defaulted on.

"In the event of a default, where we would usually take a significantly subordinate position (meaning the city would be a lower priority for recouping money), we're taking a position that puts us on a prorated basis with the other, larger notes," explained Vogel. "So if we're \$50,000 of a \$200,000 note, we're 25% of that. Should something default, we would get a quarter of that amount that was collected through the default process."

#### LIBRARY AIR CONDITIONING IMPROVED

Play Inc Arts, who rents a section within the new Cambridge Library, is getting hot reviews, but not in a good way. "We were notified by Play Inc Arts that they were having heating issues this summer, and the cooling in the space was inadequate," Vogel said.

was inadequate," Vogel said. According to Vogel, the current configuration doesn't allow for the temperature to be controlled within their space, and since that space has several windows facing east, the space heated up in the morning much quicker than the rest of the library. Vogel said in talking with Air Conditioning Associates, Inc, who originally installed the air conditioning in the library, they could add a new AC system for this space that would provide the tenant control over the temperature of the unit.

"Looking at the lease agreement with Play Inc, I think it is absolutely our responsibility to take care of this issue," Vogel told the council.

According to Finance Director Caroline Moe, the money for this fix, which comes to \$9,957, would come from the \$100,000 fund established by the city for needed repairs to the library.

"That was one of the reasons why we advocated for setting up that fund," said Moe. "Because invariably, when we do a building project, there's something not quite right and we have to come back and do some fixing. This is a perfect example of why we should be doing that."

Moe added that the city adds \$5,000 a year to the fund to keep a large enough balance for future fixes.

As a side question, Council Member Mark Ziebarth asked why that fund wasn't used to pay for the new handicapped parking spot and reserved parking signage in the east parking lot?

Moe explained that the city's policy is that capital expenditures must be over \$5,000. "Since the those library signage issues were less than that, it's not appropriate to take it out of a capital fund."

studies."

Rudolph added which classes would remain would depend on which classes see the largest student enrollment.

According to Rudolph, besides those cuts, there would also be a reduction in academic support programs, an increase in facility use fees, further elimination of middle school activities and/or an increase in activity fees, the possible complete elimination of the School for all Seasons program (which had previously seen its schedule changed from a year-round calendar to a traditional calendar, plus their number of grade levels), plus increasing the distance where students are able to take the buses from one mile to two miles away. (For a more detailed explanation of the possible cuts, see Dr. Rudolph's column on page 5 or go to c-ischools.org for full details of the referendum).

#### WHERE TO VOTE

Currently, early voting is available at two locations. The first is the C-I Schools District Office, located at 625A Main Street North, Cambridge. Voting hours are 7:30 a.m. - 4:30 p.m. on weekdays, and 7:30 a.m. - 5 p.m. on Nov. 1. The second location is Cambridge-Isanti High School at 430 8th Ave NW, Cambridge, using the main entrance. Voting hours are weekdays, 7:30 a.m. - 4 p.m., except for Thursdays when voting hours are extended to 8 p.m. There will also be voting available from 9 a.m. - 3 p.m. on Saturday, Oct. 30. On Monday, Nov. 1 it will also be extended to 5 p.m.

On election day, since it is only the two ballot questions, not all of the typical polling locations will be open. Voters within the Cambridge-Isanti School District will either go to the Cambridge Fire Hall or Isanti Community Center (see sidebar on page 1).

#### NORTH BRANCH SCHOOL BOARD

For residents in the North Branch Area Public School District, there is one seat on the school board up for election, which will fill the remaining term of Kirby Ekstrom, who resigned after moving out of the district last January. The board appointed Jesse LaValla to fill that seat until a special election could be called on Nov. 2. Lavalla is the only person to officially file for election, and nobody has openly declared a write-in campaign.

For those wishing to vote, the only polling place will be located at Main Street Church, located at 6500 Main Street, North Branch.

"The sewer fund is in healthier shape as it relates to cash/net position," Starks said. "The loan resolution contains a reimbursement bond clause to preserve the right to pay ourselves back with tax-exempt bonds. The benefit is that the city would not do a small debt issuance, unless we decide not to pursue a larger issuance in early 2022."

Starks said this method would save roughly \$15,000 on bond issuance costs right now. It would also increase the city's marketability for the future, larger bond, which would also potentially lead to lower interest rates on the potential future bond.

"This funding arrangement allows us flexibility to purchase the street sweeper now while preserving the right

to save on bond issuance and interest costs should there be a larger debt issuance next year," Starks concluded.

The term of the loan would be one year "or very likely less than that," according to Starks. "It would not impact our ability to potentially provide relief to sewer rates."

Starks said interfund loans generally have to have an interest rate attached to them, and based on calculations he assigned a rate of 1%. "The interfund actually acts as an investment for the sewer fund, and that's looked upon favorably when you're doing these interest rate," he added.

The total cost of the sweeper is \$319,006.50.

"This is very creative," said Council Member Kathy Blomquist. "I don't think we've ever done something like this before."

"I've talked to Shawn (Williams, the city's Public Works Director), and there should be a small town that might be interested in that street sweeper, because there's still life in it and they don't have 107 miles of roads to go on, or 90 miles of tar," said Mayor Jim Swenson. "If we can something for it, that would be great, otherwise you guys when you street sweep, you should have no excuses with two of them."

# Types of home insulation and where to install them

When thinking about renovating their homes, homeowners may imagine changing wall colors, expanding room sizes or upgrading appliances and fixtures. However, unless people take inventory of the less glamourous components of the home, such as structure, plumbing, heating and cooling, and insulation, other improvements may be for naught.

A home insulation project certainly doesn't offer the wow factor of a kitchen remodel, but insulation serves a vital function in the house that helps keep people comfortable and reduces energy consumption. Insulation is typically placed in areas where air escapes, such as between the stud cavities inside the walls and in the attic, and serves to slow and reduce heat transfer.

The U.S. Department of Energy says between 50 and 70 percent of the energy used in homes is for heating and cooling. By improving home insulation, homeowners can make their homes more comfortable, consistent and efficient. In fact, the ENERGY STAR program overseen by the U.S. Environmental Protection Agency says homeowners stand to save an average of 15 percent on heating and cooling costs by adding proper insulation. To do so, homeowners can take a crash course in home insulation and find the products that fit their needs.

#### Blanket batts and rolls

Blanket batts and rolls typically are constructed with fiberglass, so proper safety gear, such as a mask and gloves, is needed when handling them. Installing this type of insulation is relatively easy since the materials are designed to fit the standard width between studs, rafters and floor joists.

#### Loose fill

Loose fill is usually made of fiberglass or cellulose (recycled paper fiber). It is blown or sprayed into place with pneumatic equipment, according to home improvement stores. Loose fill can be ideal for hardto-reach areas in attics or inside wall cavities. It's good for adding insulation to irregularly shaped areas. Since it requires special equipment, this is a job best left to professionals.

#### Sprayed foam

Sprayed foam is just as the name implies, a foam made from polyurethane, polyisocyanurate, cementitious, or other materials that are applied by a spray container. DIYers who need only small applications can use canned products . Large quantities are pressuresprayed by professionals.

#### Foam board/rigid foam panels

Ideal for unfinished walls, such as basement or foundation walls, floors and ceilings, these are boards of polyurethane or polystyrene. Foam boards tend to reduce energy consumption more effectively than other types of insulation.

Homeowners considering upgrading their insulation or amending existing insulation should do their homework on the type of insulation that will be most effective for their homes.







# Viking girls soccer falls in section finals

The young, but talented North Branch Viking girls soccer team had fought hard throughout the season to achieve their best results since their state tournament runs in 2016 and 2017. Despite their best efforts, however, the team fell just one game short of making the school's third-ever state appearance with a 3-0 loss to Cloquet in the Section 7AA championship game played in Duluth on Tuesday, Oct. 19.

The Lumberjacks, who were the two-time defending Section 7A champions, stopped the Vikings cold on a lukewarm fall evening in Duluth. Cloquet's stingy defense and excellent execution of passing prevented the Vikings from putting on any sort of consistent pressure on the Lumberjack goalie, who spent a majority of the game as another spectator of the action being played in front of her.

What also didn't help was the Vikings came into the game at less than full strength, as was evidenced by the large knee brace being worn by senior Lilly Johnson, which was obviously hindering the speedy forward from breaking away for attacks on the goal.

Cloquet would get the only goal they would need nine minutes into the game. The Lumberjacks would add two more goals in the last 20 minutes of the game to secure their third-straight section championship.

#### SECTION QUARTERFINALS

The Vikings came into the section tournament as

the #3 seed, hosting Hibbing in the opening round at home. And it didn't take long to establish their dominance over the Bluejackets, building a 2-1 lead at halftime on a pair of goals by sophomore Eva Gerten.

North Branch put the game away in the second half, scoring three unanswered goals to secure a 5-1 win. Gerten would score two of those three goals for a four-goal game, with Johnson adding the final score.

#### SECTION SEMIFINALS

The Vikings could have very easily placed a claim for being named the #2 seed in the tournament, as they had played Grand Rapids, who was awarded the second seed, to a scoreless tie earlier in the season. As it was, the only difference was North Branch having to travel up north to prove their point, rather than having one last home game.

This "tie-breaking" game was equally tight, featuring a number of yellow cards as the referee tried to limit the physical play. In the end, Gerten's goal in the first half proved to be the only scoring either team would be able to achieve for a hard-fought 1-0 win over the Thunderhawks, and thus setting up the previously mentioned championship game.

While the Vikings graduate five key seniors from this team, the core group of players, including eighth-grade goalie Sharis Garcia Velazquez, who recorded seven shutouts this season, will be around for another two years or more as the team has only one junior on the roster.

# Late-season boaters encouraged to play it safe

Minnesota's waterways were unusually deadly this year, with 17 people losing their lives in boating-related drownings and crashes—the highest number since 2005. And with weeks of open water left this year, there's a chance that total could climb higher.

"Any life lost on the water is one too many, and we hope we've seen the last of these terrible tragedies," said Lisa Dugan, DNR recreation safety outreach coordinator. "Too many families have had their lives immeasurably altered while their loved ones were taking part in what should be a fun and memorable activity."

Of the 17 people who died, 16 were not known to be wearing life jackets when they went into the water. Some of them fell unexpectedly into the water, while others jumped in and experienced some sort of trouble that prevented them from getting back to their boat. The DNR recommends people always wear a life jacket when they're on the water, but it's especially important during the cold-water season, when expected falls in can incapacitate even the strongest swimmers in a matter of minutes.

While air temperatures have been above normal for much of the fall, the water temperature has dropped below 70 degrees, which is the threshold for classifying water as cold. Each year, about 30 percent of boating-related fatalities happen during the cold-water periods of spring and fall.

Anglers and hunters tend to be the primary people on the water at this time of year, but paddlers and others also venture onto the water to enjoy the relative solitude of the water after the summer crowds have parked their boats.

Following are other safety reminders as people head out onto cold water:


•Wear a life jacket (foam life jackets are more effective than inflatable life


jackets during the cold-water season). •Distribute weight in the boat evenly and abide by manufacturer's weight limits to reduce the likelihood of falling overboard.

•Have a means of communication. Boaters also should let other people know where they're going and when they plan to return.

- •Watch the weather to avoid shifting winds or storms.
- •Wear an engine cut-off device if the boat is equipped with one.



("MDH") have determined that the COVID-19 pandemic is currently ongoing and may remain ongoing for an unknown

WHEREAS, the Minnesota Department of Education ("MDE") has issued and may continue to issue written guidance for Minnesota schools on educational issues related to COVID-19; and

WHEREAS, the MDH has issued and may continue to issue written guidance for Minnesota schools on public health issues related to COVID-19; and

WHEREAS, the School Districts has established a consultative process to inform decision making; and

WHEREAS, the School District has a Safe Learning Continuum that shows five levels of mitigation; and

WHEREAS, the Superintendent and the administration of the School District have conferred with the School Board regarding COVID-19 health and safety measures, the current CDC, MDE, and MDH recommendations for each, and
