## Back to square one

### Isanti County Commissioners reopen administrator search, name Struss interim administrator

After a week of personal deliberation over whether to choose one of the two finalists for the soon-to-be vacant county administrator position or to start the hiring process up all over again, the county commissioners decided to essentially split the difference — offering current County Auditor/Treasurer (and one of the two finalists) Chad Struss the position of interim county administrator and at the same time restarting the search for a permanent administrator, a process which may include the hiring of a search firm.

“Hiring the right administrator is a very important decision for us,” said Commission Vice Chair Alan Duff. “I believe it warrants us to take our time to fully assess this decision.”

“I believe Camille Hepula could offer us very strong communication skills, while Chad Struss offers us 16 years of dependable, loyal service to Isanti County,” Duff added. “Personally, I was disappointed one of our finalists pulled out of consideration before our interviews. I believe we owe it to our constituents to further explore additional candidates.”

As such, Duff made the motion to offer the interim position to Struss, and to “direct our assistant administrator to begin identifying viable HR recruiting firms who can bring in additional candidates for our consideration.”

Chair Mike Warring indicated he wasn't in favor of extending the search, especially via a hired firm. “I felt we spent a lot of time going over all of the information on the candidates,” he said. “And when we got down to our last two, they were by far the best. If we decide to hire a firm, we are going to be spending close to \$20,000 with no guarantees.”

Warring added he felt Struss' 16 years of experience working for the county made him the best person for the job.

Commissioner Bill Berg went through a litany of pluses and minuses for both finalists, ultimately concluding Struss was also his choice for the position.

“I think it would be good for Chad to try the interim (position) and we can work closely with him,” Commissioner Kristi LaRowe said. “In the meantime, I think we really should take the opportunity to see if there's someone out there that we could consider as well.”

“What more do you need to see in a candidate beyond Chad?” asked Berg. “What is that big thing that maybe we need to find and hope people have all the other things that he brings?”

“You gave a very strong overview of both candidates,” Duff replied. “I would like to see a combination of them (the two finalists). The intent of my motion to place Chad in an interim basis, I think he gives us options going forward to look at other candidates. It doesn't mean Mr. Struss would be disqualified from getting the permanent position at some point in time. I just don't think it

## County Commissioners abolish anti-proclamation policy

The Isanti County Board of Commissioners has opened a door for themselves to once again make official proclamations and symbolic resolutions, abolishing a policy the previous commissioners established less than two years ago.

Vice Chair Alan Duff brought this item to the attention of the board with a very specific motivation in mind — the Second Amendment of the US Constitution.

“I brought this policy forward because I would like Isanti County to pursue becoming a Second Amendment dedicated county,” Duff said. “I already have this resolution drafted based on a lot of good input from a lot of people that care about that issue.”

“I believe we need to abolish this symbolic resolution policy from the past because I think it limits our ability to do that.”

The policy, as it read, allowed for the issuance of proclamations for public awareness, arts and

cultural celebrations, and special honors. However, it stated, “The Isanti County Board of Commissioners will not consider or issue resolutions and proclamations for the following: matters of political or ideological controversy; matters generally identified and known as supported by one political party and/or opposed by a political party; topics with no explicit and unambiguous relationship to the county of Isanti's programs, services, policies, or budgets; or campaigns or events contrary to policies of the county of Isanti.”

Commissioner Bill Berg asked County Administrator Julia Lines if she could explain the reasoning the previous board adopted this policy.

“The reason is the county board has limited authority as far as constitutional laws and other laws of that nature,” Lines explained. “So the worry, I think, was if you start venturing down this path, there's a potential request for other

would hurt for us to continue to explore our options.” Berg asked if there was money in the budget to hire a search firm. Warring indicated there wasn’t. Duff added that since Struss would be getting promoted, even with the mandatory minimum increase in his salary of at least 4%, there would be a temporary vacancy somewhere along the line of county employees that could make up for the cost of the search firm.

“I’m not happy spending more money,” said Warring, “I think we have the right candidate.”

Ultimately, the commission voted 3-2 to Duff’s motion, with Warring and Berg voting nay. As of press time, it had not been announced if Struss had accepted or rejected the offer of being named interim administrator.

kinds of decisions on matters that may be political in nature. And the previous board just didn’t want to open that door.”

“Because they felt the board needed to stay in their non-partisan position, as county board members, we are non-partisan,” added Berg questionably. “And is that part of the reasoning?”

“Yes,” responded Lines.

“I don’t look at the Constitution as a partisan thing,” said Commissioner Steve Westerberg.

“I believe it is over 60% of the counties in America are sanctuary counties,” Duff said. “So we’re not the first ones in the rodeo with this.” He added both Kanabec and Chisago Counties have something similar in place.

The motion to abolish the policy was unanimously approved. However since it was in place at the time of setting the agenda, Duff will have to wait until at least the next meeting before introducing his Second Amendment proclamation.

# North Branch council delays self-determination

The North Branch city council is having a bit of an identity crisis, and they need more time to figure out who they are.

City Attorney Alissa M. Harrington of Flaherty & Hood, P.A. presented a memo to the council at its Feb. 28 meeting asking the council to decide whether the mayor, city council members, and commission members should be classified as “personnel” or not under city law.

The memo was submitted to the council members the day of the meeting, although city administrator Renae Fry said she and her staff had alerted council members it was coming.

“The data practices act has this gray area for people who are city council members, so people who are elected or appointed to their positions,” Harrington said, clarifying that the process for complaints about them “can go either way” unless the city makes a ruling.

Councilmember Kelly Neider questioned why this was being presented to the council at this time.

Harrington said there were no active complaints before the city attorney that would be affected by this potential change, making this the best time to make a decision.

Most of the council expressed a preference for classifying these officials as non-personnel since a personnel classification would make complaints private data and necessitate discussion in closed session, unless the subject of the complaint requested the meeting be opened to the public.

After strongly advocating for complaints about herself, as an elected official, to be public, Neider asked that the decision be brought up in a work session rather than decided that night. Schaps made a motion to that effect after commenting on how late the item was added to the agenda. His motion passed unanimously. The next work session, which is a non-voting meeting of the city council, will be March 21.

## PLANNING COMMISSION SEAT REMAINS OPEN

The council declined to fill an open seat on the planning commission, despite receiving two applications for two open seats.

Lorraine Moeller, who has previously served as chair of the Economic Development Authority, will not serve on the Planning Commission.

Moeller applied and was interviewed along with Sarah Bishop; the latter was appointed to

the commission upon the recommendation of council member Travis Miles. Miles and City Development Director Jason Ziemer interviewed both candidates. The vote on Bishop’s appointment passed 3-2, with Schaps and Neider voting nay.

Prior to the votes, Neider again expressed extreme disapproval of the interview process, claiming all commission interviewees have gone before the council before appointment in the past, a point disputed by Fry and Schieber.

Fry reminded the council that during the Jan. 10 meeting, the council unanimously approved going forward with a council member and Ziemer conducting interviews rather than the entire council. Additionally, she said it was the practice “for the past three years” for then-mayor Jim Swenson and then-Community Development Director Carla Vita to interview EDA and Planning Commission applicants and bring their recommendations before the council.

“Unfortunately, I didn’t hear that part, because I would have disagreed,” Neider said. “This is wrong on so many levels. This is not transparent, and I feel like I should have had the opportunity to hear from both of these candidates.”

When asked by Schaps and Neider why he did not recommend Moeller be appointed, Miles referenced a commissioner’s obligation to make certain decisions based on city code and laws and only incorporate public input where appropriate — or subject the city to legal liability.

“We’re a small community,” Schaps said. “You’ve got families that have lived in this community their whole lives. We have to remember that when we’re making these decisions.”

Neider asserted the decision to reject Moeller was “personal” and implored listeners to “peel back the layers.”

Schieber said despite Moeller’s extensive resume of serving the city in multiple capacities, he was concerned about her style at times.

“I do have a concern when she expresses strong opposition, often she has been callous with her words against others when she disagrees,” Schieber said, adding that after a conversation with her, she explained the COVID years “got the better of her. I’m going to take her word on that.”

Moeller was ultimately rejected on a 2-2 margin, with Schieber and Schaps voting in favor of her appointment, Miles and Canada voting against it, and Neider abstaining despite the fact Schieber had previously told her she didn’t have a justifiable reason to abstain.

# Talking spring break safety with U of M

Spring break trips are a time for sun, fun and memories, but it's important to keep health and safety in mind.

James Miner, MD, with the University of Minnesota Medical School talks about how to stay safe while enjoying spring break.

**Q:** How can families stay safe while playing at a pool or beach?

**Dr. Miner:** The best way to stay safe around the water is to learn to swim. Wear a life jacket if you don't know how to swim or you're not a strong swimmer.

It's also important to remember that children require close supervision. Whoever is watching them should always keep them in their direct line of sight whenever they are in or around the water.

Swimming in the ocean is trickier than a lake or pool because of waves, currents and tides. Waves and currents can knock you down or pull you into the water. If you are caught in a current, swim parallel to the shore, rather than toward it until the water stops

pulling you.

Know your limits, so if you start feeling tired, get out of the water and rest.

**Q:** How can people protect their skin and stay safe in the sun?

**Dr. Miner:** You can stay protected from the sun by staying in the shade, like under an umbrella, or keeping your skin covered with lightweight clothes. Remember to always put on plenty of sunscreen before you go outside and wear sunglasses with UV protection and a wide brimmed hat to protect your skin from the sun's harmful rays. I would recommend using broad spectrum sunscreen of at least SPF 30 and reapply at least every two hours. Don't forget — you can still get sunburned on a cloudy day, so it's important to always wear sunscreen.

**Q:** What should people know about safe drinking during spring break?

**Dr. Miner:** If people drink more than they are used to, they may lose track of how impaired they are. Be sure to track how much you are drinking and stay aware of your surroundings.

Other tips to keep in mind:

Know what you're drinking.

Don't accept drinks from people you

don't know or trust.

Don't leave a drink unattended. You may also want to consider using a product to detect whether something has been added to your beverage.

Know your limits and when to say no. **Q:** If you find yourself in need of medical care while on your vacation, what should you do?

**Dr. Miner:** Most of the time, this means finding an urgent care or emergency department.

If you're traveling abroad, getting medical care can be a little more complicated. Some countries have government funded hospitals that offer services similar to what we are used to in the U.S. Others, like the Dominican Republic, Jamaica and Barbados have good private health services that can handle anything you would need as a tourist with an unanticipated medical problem. In countries with less developed medical systems, you may want to look into the best place for you to go.

Some resources that can help you find the best place to go include:

The International Society of Travel Medicine has listings of recommended doctors and travel clinics.

Joint Commission International (JCI) for medical centers and hospitals that meet the standards for the JCI Gold Seal of Approval.

International Association for Medical Assistance to Travelers for English-speaking doctors in your destination

**Q:** In general, what can people do to ensure a safe and healthy spring break?

**Dr. Miner:** If you are in an unfamiliar place, pay extra attention to your safety and stay in groups. Know where you're going, what you're doing and have a plan to get around. Stay hydrated. Warmer weather, alcohol consumption and time in hot tubs all have the potential to dehydrate you quickly, so be sure to drink plenty of water.

Lastly, don't use drugs. This is often what precedes some of the worst things that happen to people on vacation and lands them in the emergency department.

## All government meetings should be live streamed

There is a growing trend among local government bodies — the video recording and/or live streaming of meetings.

Just this morning (Tuesday, March 7), Isanti County rolled out its first-ever live streaming of the Board of Commissioners meeting. Two weeks ago, the city of Isanti did the same thing. I have heard the city of Braham is looking into live streaming its monthly meetings as well.

The city of North Branch was way ahead of the curve in this area, as they have been live streaming their meetings since before I became editor. And recently, they upgraded their video equipment.

With the exception of North Branch, this is a trend that started during the pandemic out of necessity as people couldn't physically be in the same room. But now, even though the pandemic

and COVID-related protocols are over, I think it is something the remaining government bodies should seriously consider instituting.

For me personally, this feature has become a god-send. Just as one example, the very first meeting the city of Isanti live streamed happened to fall on one of those days when two government meetings had the potential to overlap. Additionally, it was the night of the "first wave" of the predicted mega snowstorm.

Conversely, it would have been really helpful if some of the other meetings I cover had been live streamed as I had to choose between covering the meeting or covering something else such as a key high school game.

I know my asking the remaining local governments (the city of Cambridge and both Cambridge-Isanti and North Branch Area Schools) might sound more than just a little self-serving. But when you look at it, I am the perfect example of why they should be doing it. Since it is my job to cover these meetings, I sometimes have to make concessions or special arrangements to attend these meetings. The average citizen, however, usually doesn't have such extreme motivations to make the trek to them.

"Transparency" has been a buzzword in local politics for a long time now. Well, government officials can be as transparent as they want during these meetings, but if nobody is there to hear them, how transparent are they really being? It's like the old adage: "If a tree falls in the woods and no one is around to hear it, does it make a sound?"

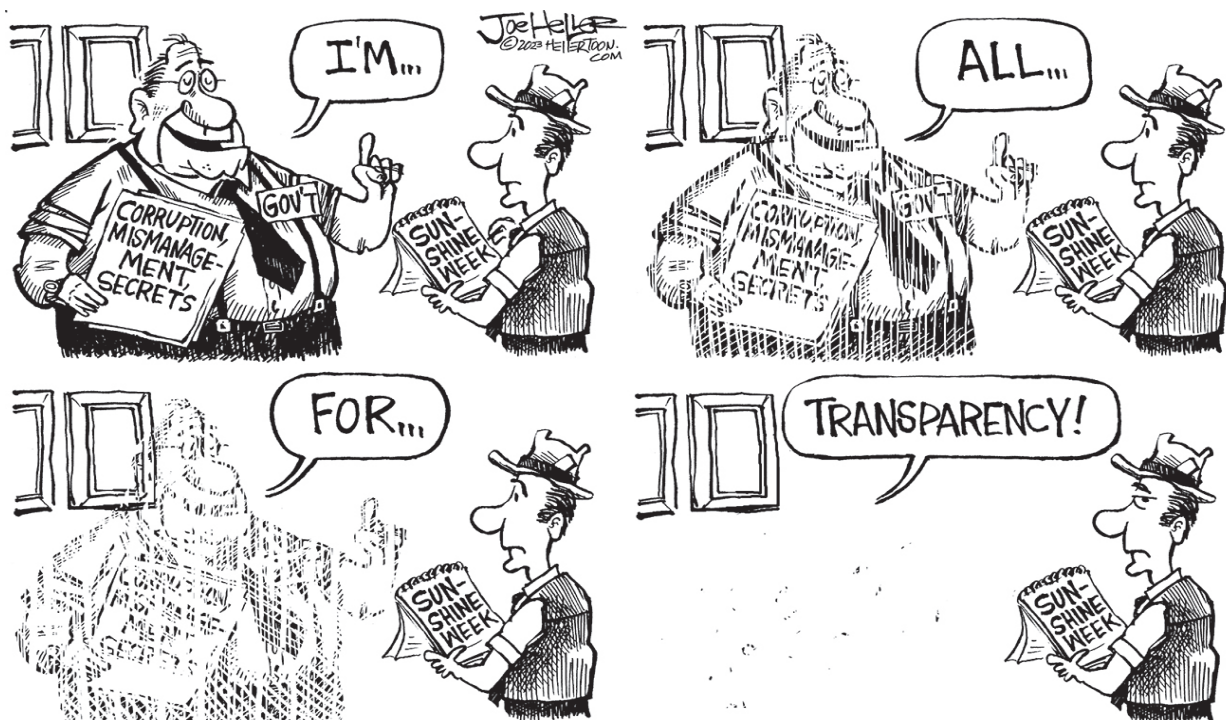
Obviously, it doesn't take much to do this. These videos don't have to be Hollywood movie quality. During the pandemic, I helped the Bluejacket gymnastics team live stream their home meets on YouTube Live using just a video camera and laptop computer.

To paraphrase the opening to "The Six Million Dollar Man," we can broadcast them. We have the technology. We have the capability to bring meetings to the masses, better than they were before. And it won't come anywhere close to six million dollars to do it either.

When bonds are issued, as NBAPS did in 2017, external investment groups provide ratings to bond investors. A positive or improved bond rating signals to investors that their money is safely

invested. Last week, Moody's Investment Services informed NBAPS that the school district's bond rating has improved from Baa1 to A3. Moody's noted the district's fiscal responsibility and enrollment growth as reasons for the upgrade. This is the second increase in our bond rating from Moody's in the past three years.

Fiscal responsibility is critical to the success of our school district. The upgraded rating of A3 reflects the district's continued growth in reserves through careful management of our funds and improved enrollment trends.

Previously, our school district operated with a fund balance policy of maintaining 5-10% in reserves. School districts with a low fund balance frequently need to cash-flow borrow because the timing of the expenses of a school district are not aligned with the revenue received from the state. Over the past three years, our School Board made the decision to revise our fund balance policy to shift from the previous range of 5-10% in reserves to 10-15% reserves in our unassigned general fund. We are currently operating within the board approved range of 10-15%. This has allowed us to stay away from cash-flow borrowing, and the associated fees and expenses, better committing our resources to district priorities.

Committing resources to district priorities was evident in our response to COVID-19. We carefully allocated our one-time federal funding for COVID related expenses to keep students in school while the majority of the country defaulted to distance learning as the only option for students and families. According to the Association of School Business Officials, having school in person during the pandemic had an estimated additional annual cost of 1.3 million annually for a school district our size. That estimate proved to be very accurate in our case. Our commitment

to provide both in-person and distance learning options for families provided predictability and quality learning options as we navigated through challenging times. As this one-time COVID relief federal funding comes to an end, we are working carefully to provide an off ramp to these funds to avoid a spending cliff that some other districts are facing at this time.

We embrace choice, and our commitment to being at the forefront of educational excellence is drawing families to choose North Branch Area Public Schools. Our current enrollment growth is coming from families choosing to be part of our school district after previously opting for a different school option. We have well maintained buildings with expanded community use. As our community grows, we are beginning to see families moving into our area and we are proud to share what it means to be a Viking.

The improvement to our bond rating is an important indicator that we are moving in the right direction. Continuing to commit resources to district priorities is critical to our success and it is a privilege to move forward together at the forefront of educational excellence.

# From Spencer Brook to the State Capitol – The David Clough Story

For some, the last name Clough (pronounced “cluff”) may not ring a bell, but for others, it may immediately evoke an image of a bearded gentleman with ties to timber and politics. David Marstan Clough was born in Lyme, New Hampshire on Dec. 27, 1846.

Like many East Coast families during the initial settlement period of Minnesota in the 1850s and 60s, bigger and broader plans were on the horizon as they pulled up stakes and headed west for new opportunities. Examining Isanti County in the 1850s reveals a mostly uncharted territory. Much like today,

geographically speaking, pre-statehood Isanti County included upland forests, prairie openings, lakes, and rivers. At the time of the Clough’s arrival, small scattered settlements and pioneers would’ve dotted the rural landscape. Some of the first European-Americans to arrive en masse and settle were from the Eastern States. Some early villages like Cambridge and Spencer Brook had a notable population of New Englanders. Striking out into the wild and mostly uncharted territory certainly would’ve been a formidable endeavor, even for the most seasoned traveler. But the promise of unlimited resources, cheap land, and opportunity is what brought many settlers including the Cloughs, to Isanti County.

Arriving in the Spencer Brook area in 1857, the Clough family carved out their existence along the Rum River between what is now Princeton and Cambridge. As early as 1854, Spencer Brook had just a handful of residents looking to capitalize on the natural

resources that the area offered, namely timber. Upon the Clough’s arrival, the area around Spencer Brook was home to Native Americans and very few settlers. Other than land prospectors, fur traders, or logging outfits, early European contact with Native Americans in and around Spencer Brook was most likely minimal. As the Cloughs settled in and word spread, more people from East Coast states began to populate the area. In fact, Spencer Brook became known as the largest settlement of native-born Americans in the state outside of Minneapolis and St. Paul. As more families arrived, small farms continued to spring up, schools started; stores and post offices became established. Finally, in 1869 Spencer Brook became an officially recognized township within Isanti County. By this time other ethnic groups (primarily Swedish) began to settle around Spencer Brook.

Part of what put Spencer Brook on the map was its timber resource and perfect transportation system for harvested logs by way of the Rum River. Those valuable natural resources certainly wouldn’t have gone unnoticed by the Clough family, especially David Clough’s father, who was a timber cutter and lumberman back East. Growing up having to harvest trees out of necessity like many families, the hard work, benefits, and perhaps more importantly the experience, eventually helped David secure work. At age 20, he traveled to St. Anthony Falls in Minneapolis to work in the sawmills where he drove a team of horses and worked as a sawyer. David stayed in Minneapolis until 1870 at which point he returned to Spencer Brook with his newly acquired skills. Upon his return, he and his brother Gilbert started a small logging and sawmill operation at Spencer Brook. At the time, much of the area’s coveted old-growth white pine was long gone in the sense most of the premium stands were harvested. There was, of course, still abundant pine awaiting the saw, but gone were the giants of the past.

What remained was a mix of merchantable pine and hardwood timber like oak, ash, maple, and elm. Having realized the expansive and almost limitless resources within the Spencer Brook area and beyond, the enterprising Clough Brothers moved their firm to Minneapolis in 1872. The duo erected a sawmill at St. Anthony Falls in Minneapolis where they processed millions of board feet of timber from areas around Spencer Brook and beyond.

Working in the logging and timber industry during the Gilded Age, especially a lucrative one would’ve offered the chance to rub elbows with other like-minded businessmen of the era. Railroad tycoons, real estate developers, and politicians would’ve been a select few. Along with making connections and expanding his logging and sawmill business, David Clough became active in politics. David, starting at the ground level as a Min-

neapolis City Council member in 1883, continued to excel through the ranks of politics and business, and in 1886, made a successful run for state senate. As he continued his lumbering enterprises, there was a brief change in joint ownership after the untimely death of his brother Gilbert in 1888. At the time of his death, the Clough Brothers were operating a million-dollar company that was processing 15,000,000 board feet of lumber annually and was recognized as one of the more substantial firms of the Falls.

As David took over sole ownership of the company, he continued to serve in the senate until he was elected Lieutenant Governor to Knute Nelson in 1892. Clough continued to work in both politics and the logging industry through his eventual assignment as Governor in 1895 after Nelson’s resignation. After a brief term, Clough campaigned and won on his merit and was formally elected as Minnesota’s 13th Governor on Nov. 3, 1896. For the next three years, Governor Clough navigated his way through several noteworthy points in history that included the board of pardons being created; the advancement of child labor laws; the Red Lake Chippewa Indian Reservation opening up to settlement; and Minnesota’s involvement in the Spanish-American War. Upon his final term as Governor, David Clough did not seek re-election. Instead, with the encouragement of local railroad tycoon James J Hill, David Clough headed out west to Washington State. The trip wasn’t for political reasons, but rather to explore the timber resource once again. David Clough became a local advocate of the timber and mill industry near Everett, Washington. Some of the firms he consulted with were said to have the nicest mills and timber products in the world. He remained in the Everett area with his wife Addie until his passing on Aug. 27, 1924.

## Follow these safety tips when pulling a trailer

**Question:** Is it illegal for a vehicle pulling a trailer to have a ladder or ramp hanging from the side of the trailer?

**Answer:** You are able to have ladders or ramps secured to the side of an enclosed trailer as long as you do not exceed the width of 8 feet 6 inches. This is the maximum dimension that may be operated on Minnesota roadways without a special permit. The maximum height is 13 feet 6 inches. If you exceed the height or width, then you would have to apply

for an oversize permit.

A few trailer safety tips:

- Make sure the pulling unit of the trailer has the towing capacity to pull the trailer safely.
- Check the trailer tires for proper tire pressure and the conditions of the tires. If the trailer has not been used recently, check the tread and for any cracking on the side walls.
- Make sure you have the proper ball size required for the trailer.
- Be sure the safety chains are connected and all the lights are working properly.
- Adjust your mirrors so you can see behind the trailer when towing it.

• Adjust your trailer brakes according to the load. For example, if you’re towing a heavy boat you would need to increase the brake press compared to pulling an empty boat trailer.

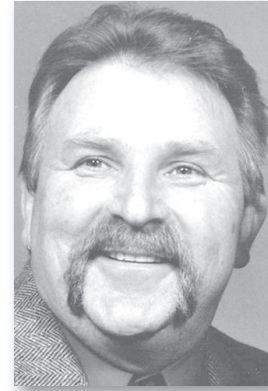

## Rotary Club Sends Medical Supplies to Ukraine

The Cambridge-Isanti Rotary club has taken on an ambitious project of raising \$25,000 to cover the cost of sending two containers of medical supplies to Cherkasy, Ukraine. The first container was sent on February 28 and the next is planned for May, 2023.

The medical supplies have been donated by Matter, a non-profit humanitarian aid agency located in St. Louis Park, MN. The supplies have been received from area and regional hospitals, warehouses and manufacturers located around Minnesota and

surrounding states.

The supplies are delivered to Hand in Hand Logistics, a non-profit located in rural Isanti. At this location, volunteers from Isanti and surrounding counties gather on Monday mornings to sort the supplies into 15 categories. The supplies are then packaged and readied for shipment.

The connection with the Cherkasy club was made last summer when Julia Pais from the Cherkasy Club was visiting the Cambridge area. As a result of this initial connection, further contact was made by Lee Scheumann of the Cambridge-Isanti club with Denys Andrushchenk, president of the Cherkasy

Club.

“We are in critical need of hospital equipment and supplies in the city of Cherkasy,” stated Andrushchenk. “Prior to the war, Cherkasy was a city of 225,000. Since that time, we have had to host over 50,000 refugees. We also are receiving large numbers of soldiers who have been wounded in the war, all requiring medical supplies and equipment.”

“According to Bohdan Borukhovskiy, Deputy Minister of Health in Ukraine, over 927 health care facilities have been damaged or destroyed,” stated Scheumann. “The need is acute, both for the civilian and military population.”

Efforts are underway to also procure used hospital equipment of all varieties – beds, diagnostic equipment, laboratory and surgical – to replace or upgrade what has been damaged.

The containers are routed through Gdansk, Poland, then sent to Cherkasy Rotary Club where in turn they will be divided between local hospitals.

## Senlycki handily claims state championship

It could almost be argued that Kami Senlycki's claiming of the state girls wrestling championship at 185 pounds was a bit anti-climactic. Before the public address announcers even had a chance to rattle off the senior Bluejacket's impressive bio, Senlycki had already muscled her overmatched championship opponent to her back and the referee slapped the mat indicating a pin in a mere 14 seconds.

The smile on Senlycki's face as she signaled a "W" sign with her hands to her fans signifying "winning" and as she was congratulated by head coach Neil Jennissen, however, told a different story.

Similar to her run through the section tournament two weeks prior, Senlycki's state tournament experience was relatively smooth. In the quarterfinals, she pinned St. Michael-Albertville's Maggie Steele at the 1:17 mark of the first period.

Her semifinal match proved to be her trickiest.

While Senlycki was in control of Apple Valley's Gloriann Vigniavo the entire match, she couldn't quite roll her over for a pin, instead settling for a 9-2 decision.

Then came the finals, and the 14-second victory over St. Paul Harding's Chae Nay Htoo, making Senlycki Cambridge-Isanti's first Minnesota State High School League sanctioned girls wrestling state champion.

### EDBLAD FINISHES SECOND

C-I's Leo Edblad also advanced to the championship round of the boys state tournament at 113 pounds,

however the junior was stopped just short of joining his teammate at the top of the podium by the defending state champion.

Edblad's tournament began with a pinfall over Centennial's Logan Fu 1:33 into the first period. Next came Edblad meeting an Apple Valley opponent, where he earned a 5-3 victory over Austin Laudenbach in the quarterfinals.

His semifinal match, against Wayzata's Luke Koenen, turned into a battle as the two were tied at five points at the end of regulation and forcing overtime. In the first, one-minute extra stanza, he managed to sneak in a two-point takedown, which appeared to even be a surprise to Edblad.

In the finals, Edblad would fall to Hastings' Blake Beissel, who was the #1-ranked wrestler at that weight and who was sporting a 52-1 season record. Despite Edblad's best efforts, all he could muster was a single point coming from three false starts by Beissel. The final score was 5-1.

### BYERS FINISHES FOURTH

At 170 pounds, C-I's Treytin Byers would finish in fourth place, one place higher than his state ranking. Byers' first match was an easy technical fall over Irondale's Calvin Brinkman. That was followed by a 10-6 decision over Willmar's Braeden Erickson in the quarterfinals.

Byers would lose his semifinal match against Wayzata's Adam Cheme 11-2, sending the Bluejacket senior to the consolation round. Byers advanced to the third place match with a 5-1 win over Apple Valley's

Marcell Booth.

In that third-place match, it was a case of running out of time as Byers was mere seconds away from earning a one-point escape that would have tied the score at 6-6. But he couldn't quite beat the buzzer, suffering a 6-5 defeat and relegating him to the fourth-place medal.

Cambridge-Isanti's other state entrant, Shawn Henderson, wound up being a "one-and-done" as he lost his opening-round match via pinfall in the first period to Brainerd's Shane Carlson. And because Carlson would lose his quarterfinal match, that meant he took Henderson's place in the consolation round.

### SHOCKMAN EARNS THIRD PLACE

Rush City/Braham's Isabelle Shockman made RC/B history in earning its first-ever girls medal, picking up third place at 107 pounds. Shockman scored a 13-2 major decision over Owatonna's Isabelle Townley in the quarterfinals. She then suffered a pinfall to eventual champion Charli Raymond of Simley in the semifinals.

Shockman would rebound from that loss by earning her own pin in the third-place match over Maggie Olson of Albert Lea Area midway through the second period.

Rush City/Braham's other two state entrants — Tucker Gould at 106 pounds and Landon Umbreit at 138 pounds, each were "one-and-done" after losing their opening-round matches and having their opponents lose their quarterfinal match.

## Vikings, Jackets host boys basketball playoff game

Both the Cambridge-Isanti Bluejacket and North Branch Viking boys basketball teams were rewarded for their strong regular seasons with a higher seed in their respective section tournaments, affording them one last opportunity to play in front of their home crowds.

In Section 7AAA, North Branch was given the #2 seed. Since there are only six teams in the section, that seeding also gives the Vikings a quarterfinal bye, sending them directly to the semifinals. There, they will face the winner of #3 Duluth Denfeld versus #6 Hibbing at home on Friday, March 10. During the regular season, the Vikings defeated both of those teams, edging out an 80-75 win over Denfeld in the second game of the season and easily topping Hibbing 74-31.

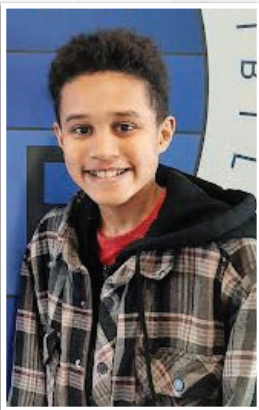

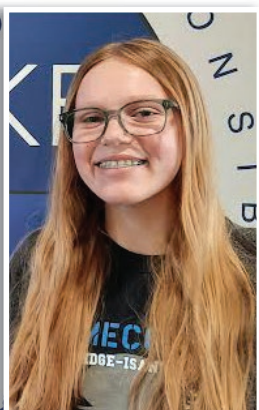

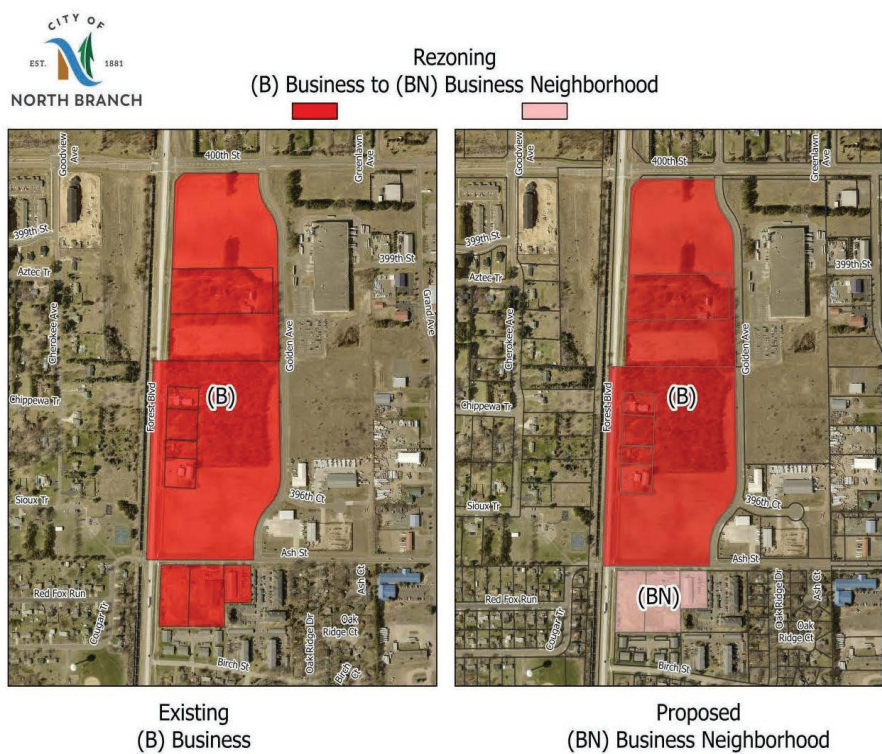
