From the editor:

The *Isanti-Chisago County Star* understands how important election guides are to voters in helping them make an educated decision on who they want to represent them.

All local candidates appearing in contested races on the General election ballot were sent a questionnaire and given a deadline of 5 p.m. on Friday, Sept. 16, to submit their answers. Any candidates not making that deadline were emailed a reminder and given an extended, final deadline of noon on Monday, Sept. 19. Candidates who were part of the primary election were given two additional questions from those asked for our Primary Election Guide. Please refer to our Primary Election Guide published in the July 28 edition for their answers to those questions. You can also directly access our Primary Election Guide by scanning the QR code to the right of this intro.

Out of the 43 candidates, all but four candidates — Dan Collison and Daniel Hinnenkamp for Isanti City Council, and Jesse LaValla and Shane O'Connor for North Branch School Board, returned answers.




Voters face major changes in county commissioner districts

Oftentimes it is confusing enough remembering the choices of who voters are able to vote for. Between precinct borders to official city limits and school district borders, voters can't be blamed for scratching their heads trying to figure out the names behind the ovals on the ballot. This year, however, that confusion has been magnified as both the state senate and representative districts, plus the county commissioner districts have all been adjusted to compensate for changes in population. This redistricting takes place every ten years following the census being updated.

For the state legislature redistricting, this area saw minimal changes, aside from the changing of the district numbers. Almost all voters in the Star's circulation area are still in the same State Senate district, which is currently held by Mark Koran. However, the number of the district has changed to District 28.

There were a couple changes for the area's State Representatives. The district currently held by Brian Johnson was expanded by approximately a



half-mile to the east in North Branch, with the border shifting from Interstate 35 to County Road 30. That district is now labeled as District 28A. Because of that change, voters in North Branch between I35 and County Road 30 were moved from Precinct C or Precinct B to Precinct A. The other area district, which is currently served by Anne Neu Brindley, is now District 28B. The other significant change has voters in Rush City moving to District 11B.

The county commissioner redistricting, however, turned out to be much more complicated, with both Isanti and Chisago Counties making significant changes to their boundaries. The easiest change to explain is in Chisago County, where the entire city of North Branch is now in a district of its own. For all other changes, however, its best to simply take a look at the above maps.

How to early and absentee vote in Isanti and Chisago County

The Nov. 8, 2022 elections are fast approaching, but you don't need to wait until election day to vote. You can vote early with an absentee ballot. The process is less complicated than you might think.

There are two ways to cast your early vote in person and by mail. Both are available for voters from Sept. 23 to Nov. 7, 2022, and both require you to apply to have an absentee ballot mailed to you. You do not need to be registered to apply.

To vote early in person you would need to go to your local election office, complete an absentee ballot application and then cast your vote.

For Chisago County you would go to the Chisago County Government Center at 313 N Main Street, hours, to get your absentee ballot application. For more information or to have an application for an absentee ballot sent to you contact Bridgitte Konrad at 651-213-8500 or elections@chisagocountymn.gov.

For Isanti County you would go to the Isanti County Auditor's Office, 555 18th Avenue SW, Cambridge, MN, during business hours, to get your absentee ballot application. For more information or to have an application for an absentee ballot sent to you contact Chad Struss at 763-689-1644 or elections@co.isanti. mn.us.

For both locations, if you're registered to vote in that county, you do not need to bring identification. If you're not yet registered to vote you can do so when requesting your ballot application by bringing a photo ID with your current address, or if your photo ID doesn't have your current address on it you would a part to bring your D along with our thou part of angle dence such as a bank statement, utility bill, etc. What constitutes a valid proof of residence can be found on the Secretary of State's website www.sos.state.mn.us/ elections-voting/register-to-vote/.

Alternatively, you can request an absentee ballot for the 2022 elections, using the Secretary of State's online absentee application or by downloading a mailin application. Both are available on the Secretary of State's website at www.sos.state.mn.us/elections-voting/other-ways-to-vote/vote-early-by-mail/.

All absentee ballots must be witnessed by either a registered Minnesota voter or a notary. The witness must sign the signature envelope and list their address.

The most important thing to remember when filling out the ballot application is to read the instructions carefully. If you do not complete all the forms correctby your ballot will not be counted

What is your reason for running?

I realized with three council seats and the mayor seat open for the election that this year will be pivotal for North Branch and shape the city's future. I wanted to ensure that there was a voice that could speak up for preserving our history while guiding its growth and ensure the residents feel welcome to attend council meetings and voice their opinion.

What is your top priority and how do you plan on addressing it if elected?

My top priority is to reduce the amount of traffic on 95 and increase safety for pedestrians. The major road for North Branch residents, industry traffic, police, fire, and EMS is 95. I'll work with the city, county, and state officials to get an interchange at 400th Street. The highway interchange will result in industrial traffic having better access to the industrial park and quicker access to I-35 for EMS crews. I will also work to get crosswalks painted on the corners of Central Park and better lighting at the intersection of 95 and 7th Avenue.

How would you balance residents' requests for providing services/amenities with lowering or keeping taxes as low as possible?

Serving as a chair of a 220-unit homeowner's association, I have the experience of reviewing the request and determining if it is a necessity or a "nice to have." If the item is necessary, the next question is, do we currently have the reserves? If we don't have resources for it, can it wait for next year's budget? If it's nice to have, we have to ask what the effect is on all the residents. For example, a group of residents might make an amenity request. But to pay for it, property taxes would need to increase. That group might support a higher property tax for the amenity, but we must consider other residents that a significant tax increase may negatively impact. We should ask, will the "nice to have" pay for itself? To limit impacts on taxes for necessities and "nice to have," we also need to pursue available federal and state grants.

I first became interested in assisting my local municipal government about 12 years ago and despite opposition by some, I prevailed in the legal process, and was appointed to serve upon our city's North Branch Municipal Water and Light commission in early 2018.

What is your top priority and how do you plan on addressing it if elected?

As your trusted water & light commissioner I have been able to coordinate support on the commission for initiatives and efficiencies in order to reorganize and improve the operational management of the water and light's business plan. Soon after my appointment it was clear to understand that something dynamic had to be accomplished in order to preserve a new form of our utility enterprise. In late 2019 we moved the commission meetings to the city hall in order to provide greater transparency and oversight for the citizens of North Branch. In 2020

our initiative to increase the size of our commission from 3 to 5 commissioners was advanced by the North Branch city council to the Minnesota legislature and soon after our request was approved by the legislature, the city council appointed 3 additional citizens to serve on our new 5 member commission, the work of this commission has resulted in a reduction of water rates by over 26%. In 2021 our new commission of 5 advanced some strategic changes in the utility business plan that resulted in structuring a sale of electric utility assets to our neighboring electric utility provider East Central Energy. This transaction is in review by the Minnesota Public Utilities Commission and the commission anticipates closing this transaction in December 2022.

The sale of our electric utility assets will allow the commission to pay off its electric revenue bond debt sooner than scheduled, and provide additional capital for continuing the work of infrastructure and maintenance upgrades currently being addressed within the city's aging water system.

If I am elected to serve you on the city council, I will be a steadfast advocate for continuing to improve and grow the city's water delivery system at an affordable cost.

Fellow citizens you deserve proven competent coordinated leadership. Together our team reorganized the citizen owned North Branch Municipal Water & Light utility enterprise and reduced your water rates by over 26%, I can and will contribute more.

How would you balance residents' requests for providing services/amenities with lowering or keeping taxes as low as possible?


As a Director on the Board of East Central Energy, I have been

How would you balance residents' requests for providing services/amenities with lowering or keeping taxes as low as possible?

Budgeting is one of the challenges facing any governing board. Just as you and I struggle to maintain a budget at home or your business, the County has the same problems of rising costs due to inflation. One major step we took in the past year was to undergo a major reorganization of the County Services division. We went from 13 plus department heads to 4 division leaders. Our goal is to provide better customer service while trying to maintain a reasonable levy. We are in the initial stages of this reorganization and our County Treasurer/Auditor has determined that the county will achieve a savings of \$765,000 over a 3-year period. We used our Federal COVID aid to provide over \$1.8 Million in Small Business aid, mental health support and aid to the schools. The 30-year historic County tax levy is around 6%. During that time as your Commissioner, we have managed to stay under that percentage.

customers would have to go to three different Departments to do property transactions. They now need to visit just one.

We also have to look for outside funding sources. For example, our Division Director has secured \$750,000 in Legacy funds for the next build out of Anderson Park, and has a grant for \$350,000 in the works for Springvale Park. Grants are also very important for bringing down the cost to local taxpayers.

What would you do to accelerate providing residents with

high-speed internet?

My family lives this every day, my husband is a Software Engineer and our daughter is a school teacher who both have worked from home.

We have to work with our partners to fix this. Isanti County is currently looking at opportunities with both East Central Electric and Midco. Midco is currently expanding their fiber network in Isanti county; East Central Electric is exploring similar opportunities. In order to leverage these developments, Isanti county has committed our America Rescue Plan (ARPA) funds to get fiber to every home. When I found out about the ARPA funds, I lobbied Congressman Stauber and both Senators Smith and Klobuchar to make upgrading Broadband an allowable use for these funds. I work hard at every level of government to get you better service.






What is your top priority and how do you plan on addressing it if elected?

These cuts were so difficult as our students deserve the best educational experiences possible.

How do you plan on maintaining the district's budget considering the continued lack of state funding?


