## Local author's mystery novel sheds light on trauma recovery through equine therapy

For Isanti author Pat Arneson, writing a mystery novel wasn't just a creative pursuit, it became a vessel for delivering healing and hope.

A licensed clinical therapist, Arneson spent much of her career working in high trauma settings. After sustaining a traumatic brain injury, she was forced into early retirement and an unfamiliar stage of life. That journey eventually led her to horses, and to writing her debut novel, "Simply Dead," a traditional mystery infused with deeper therapeutic purpose.

#### FROM BARN STALLS TO PLOT TWISTS

Arneson didn't grow up around horses and had never ridden one before her injury. But in search of something to lift her spirits during recovery, she told her husband she wanted to try horseback riding. That led her to a ranch near Wild River State Park, where she saw a sign advertising equine therapy, something she'd never heard of, even after decades in the mental

"I was terrified," Arneson said of her first encounter with horses. "I thought they were going to trample me to death."

Instead Arneson met BG Sky the horse that helped her learn about equine therapy and eventually became the inspiration for Rosie the horse in "Simply Dead." What started as merely a curiosity evolved into

Arneson became certified in equine therapy. She now serves as both board president and lead clinical therapist at the ranch near Brook Park, where she helps clients navigate trauma with the help of

Unlike traditional therapies like talk or group therapy, equine-assisted therapy relies on the horse's acute sensitivity to

human emotion. Horses, as prey animals, are attuned to subtle changes in energy, heartbeat and body language, often alerting therapists to a client's inner turmoil before the person is even aware of it.

'Horses respond to people in real time," Arneson said. "If someone is emotionally shut down, the horse might resist, withdraw or act unusually. That opens the door to conversations you might never have in an office."

Sessions can be as simple as brushing a horse while talking or as structured as navigating obstacles that symbolize personal challenges. "People reenact their lives in the arena," Arneson said. "You

# County's first marijuana store set to open in Isanti

Isanti County's first legalized marijuana dispensary will open in downtown Isanti.

Matthew VanHeel of Zimmerman, doing business as Northern Crown, LLC, is looking at opening a store at 108 Main Street, Suite 400. According to VanHeel, the store will be selling prepackaged products purchased from licensed growers.

"The store isn't big enough to be growing," he said. "It's just a small

He said the store itself will include a waiting area where customers must supply an ID to a security guard before being able to enter the main showroom area.

The council, on a 4-0 vote with interim Mayor Luke Merrill abstaining, begrudgingly approved the cannabis sales registration, although it wasn't due to any grievances with the owner. Specifically, Merrill and Council member George Hemen objected to the state's handling of legalizing marijuana sales.

Merrill in particular was upset over the state legislature recently not only increasing the amount of sales tax collected but at the same time taking away the small percentage of that sales tax that was supposed to go to cities.

"The city will not receive a cent of tax

money," Merrill said. "From the very beginning, I think they've botched this.

It was bad legislation from the start." 'Part of the decision in the initial discussion about this, that (the city receiving some tax money) played a factor," Hemen said. "And for that (taking away the tax money) to happen in the middle of all this, that's disappointing. The state has just been horrible at rolling

can't make this stuff up. The horses show you what's going on."

#### A NOVEL APPROACH TO HEALING

That transformative experience formed the foundation of "Simply Dead." A mystery novel with a twist, it's also a meditation on trauma, grief and the quiet strength of recovery.

Arneson decided to set "Simply Dead" in a fictional small town in Minnesota.

"I didn't want to have to get every single detail right in a way that would distract me from what I was trying to

"Simply Dead" follows Abby Mc-Guire, a therapist and reluctant sleuth who finds herself at a horse ranch, afraid of horses and emotionally raw from years working in trauma care. Though fictional, Abby's journey draws heavily from Arneson's own but when asked if the character is based on herself, Arneson gives an emphatic no.

"In terms that she's a therapist and she knows nothing about horses and her experience on the ranch is autobiographical, but she herself is not."

Arneson describes "Simply Dead" as a fun summer read with a little something more.

"I wanted to write a mystery with depth, where the therapy isn't front and center but becomes a powerful undercurrent," Arneson said. "The subplot of PTSD and anxiety is embedded, not talked about directly, but it's there, showing readers what healing can look like."

Described as a "light traditional" mystery, "Simply Dead" steers clear of graphic violence and leans on character development and emotional nuance. Readers can enjoy the story on multiple levels, as a page-turner, a character-driven drama, or an unexpected exploration of mental health through fiction.

"People will talk about books when they won't talk about therapy," Arneson said. "So the mystery becomes a carrier, of hope, of healing, of things people might not otherwise be ready to say out loud."


Arneson independently published "Simply Dead" after a yearlong dive into publishing options. She wanted to retain control over tone and content, specifically avoiding the trend toward darker, more graphic fiction that dominates bestseller lists.

"I'm about the opposite of that," she said. "I'm about walking out of dark-

A second book in the series is slated for release this October, with a launch planned at Dana's Bookstore in Isanti. In it, Abby returns to unravel a new mystery. And while Arneson isn't sure how long the series will run, she sees potential for more stories that shine a light on different types of emotional healing.

Arneson's work has already drawn attention from readers and book clubs across the region, including in the Twin Cities. She welcomes invitations to speak and would love to connect with local groups, especially if they're curious about horses, mysteries, or the path to recovery.

"This is not a book about mental health," she said. "It's a story. A fun one. If someone finds meaning in it. Even better."

this whole thing out."

City Administrator Josi Wood informed the council that no matter what their objections were towards the state, this specific business followed all the rules so the council has no grounds to reject the registration application.

"Our hands are tied," Hemen said as he seconded the motion to approve the application. Initially, Merrill voted against approving

the application as a statement against the state's handling of the entire process. However, after Wood reminded him the only reason the city could deny the application was due to it not meeting one of the city's ordinances, he changed his nay vote to abstaining.

"It's not fair to the taxpayers, to bear the brunt of police work and staff time," Merrill said. "That was a flop by the state and not by you (VanHeel) by any means."

think someone is trying to tell me I shouldn't leave away track meets early.

Due to the heavy, persistent rain, I decided to depart the recent Class AAA State Meet even though there were still a couple of Cambridge-Isan-

ti athletes yet to compete. Normally, I am a staunch "100% coverage" of things like state. However, the two remaining events consisted of Jackson Ziebarth in the 200 finals and Jay Ziebarth in the discus. I already had quality shots of Jackson from his 100 preliminary race two days earlier. So I figured that would suffice.

With Jay, discus is a very tough event to get quality photos, even under ideal weather conditions. For safety reasons, photographers are positioned a considerable distance away. And with the dark, rainy conditions at this

year's state meet, I wasn't able to use my largest zoom lens. In my old age, I just couldn't face getting soaking wet for very substandard photos.

So, with that rationale, I pulled out of the St. Michael-Albertville parking lot to make my way home. As I crossed the county line back into Isanti County, I came across a stretch that was being patched up using a loose gravel/tar mixture. Sure enough, the car in front of me kicked up a larger piece of gravel (I assume), which smacked my windshield leaving a circular crack.



# Post Offices of Isanti County

Historically, one of the earliest signs of a budding settlement in any area is a post office. The need for correspondence in even the wildest frontier was deemed a crucial service. In Isanti County, the

earliest post office was founded in Spencer Brook on June 29, 1857. This doesn't come as much of a surprise, seeing as that area of the county witnessed settlement activities as early as 1854. Coming in at a close second was the post office at Cambridge on October 26, 1857. \*That post office was located in the early platted village of Cambridge, just west of Florence (Paul's) Lake, where mail was circulated from a tiny

log cabin situated on the early Isanti County frontier.

As the county increased in population, other post offices sprang up as towns began to establish themselves. Operated out of a private home or general store, the county's rural post offices became a vital connection to Isanti County's residents and beyond. Isanti opened its first office at the home of Peter Norelius in 1865 near the highly traveled intersection of the Princeton-Sunrise Road and the Manomin Trail. It was at that location that many travelers, early businessmen, and settlers traversed the county and beyond. Other early post offices were Oxford (1864), Springvale & Stanchfield (1870), and Athens (1883), to name a few. As the county's population continued to grow, the growing need for postal service witnessed a total of 37 post offices come into service. This closely reflected the number of crossroad communities that dotted Isanti County's 13 townships. Unlike neighboring communities of North Branch, Harris, Princeton, and Anoka, the mail in Isanti County didn't have the benefit of coming by way of rail. That's not to say the above-mentioned communities didn't have to transport mail by wagon, it just meant letters, packages, and supplies arrived much quicker with the added efficiency of the rail system. Early in Isanti County's history, bulk mail was brought up from Anoka by wagon once per week to be dispatched by local offices.

As the 19th Century drew to a close, a Nationwide effort was implemented, and a new concept called Rural Free Delivery (RFD) quickly became the preferred method of how mail was picked up and delivered. Rural Free Delivery was to include Isanti County's 12,000 mostly rural residents. With the help of the railroad in 1899, the time had come for a more efficient method of mail handling and delivery six days a week.

The RFD was equipped with stamps, money orders, and shipping supplies. In short, they were traveling post offices with just about everything a person would need to successfully send and receive mail. As the RFD evolved, so did delivery zones or rural routes. Each carrier was assigned certain zones in Isanti County. For example, residents living in Spencer Brook Township were broken up into four zones: Princeton, Cambridge, Isanti, and St. Francis. For the most part, rural delivery zones have remained unchanged since the inception of the RFD. Early methods of delivery consisted of a single horse-drawn wagon. As the RFD evolved, a fully en-

closed cab complete with carrier name and route number pulled by a two-horse team was a common configuration. Not unlike today, the routes witnessed deliveries in all types of weather. In the early days of horse-drawn deliveries, a special cutter-type sleigh would've been used to navigate snow and ice-covered

By the early 1900s, just a fraction of the 37 offices continued to operate after the implementation of the RFD program. In fact, only seven remained open after 1908 and all but one do so to this day: Braham, Cambridge, Dalbo, Grandy, Isanti, and Stanchfield. Springvale held on until its closure in 1937. Gone were the small post offices, also known as star routes. As the horse and buggy gave way to the automobile in the early teens, mail delivery became that much faster as multiple carriers, stacked high with packages, rumbled down dusty county and township roads.

Standardized weatherproof mailboxes with names and route designations quickly replaced crude boxes, milk pails, and other less dignified receptacles. As the RFD continued to evolve, an interesting development resulted in its service to rural areas of the county. A benefit not often considered was the "improvement" of the road systems. The network of roads had to be a step above passable to ensure timely and dependable service.

Along with the road improvements, better signage delineating the county's road system was an additional benefit. With the continued aid of the railroad's prompt delivery, rural residents received a dependable service without having to travel to town. Since its introduction, rural mail service has remained essentially the same in concept. One change, however, marked an end to an era in 1968 when the final delivery by rail was dropped off in Cambridge on October 10. Advancements in bulk delivery centered on large trucks being dispatched from metro offices as they brought heaping loads of important packages, letters, and other correspon-

In recent times, technology like email, online banking, and certain cost-saving consolidation measures have forced a handful of the smaller offices in Isanti County to fight off the notion of closure due to the overall Nationwide decline in physical mail. Regardless of the looming threat of changes in the postal service, one can't argue with the feeling of entering through the doors of a post office. The idea that a simple letter or gift can be delivered anywhere in the world with a stamp is undeniably nostalgic. Generations of people, for hundreds of years, have reached out to families, soldiers, elected officials, and even Santa Claus through the post office. Weathering the storm and proposed changes, postmasters and carriers remain in steadfast service to their communities in Isanti County and across America. For now, residents can continue to count on the postal service's early promise: "Neither snow nor rain nor heat nor gloom of night stays these couriers from the swift completion of their appointed rounds.'

#### **DID YOU KNOW?**

- The Cambridge Post Office is the longest-operating business in Isanti County. Octoper 2025 will mark its 168th year.
- Athens was the shortest operating post office, lasting only four months in 1883 before mail was sent to Bethel.
- Grandy is the smallest post office in the county, measuring roughly 24x18 feet.
- The longest service held by a postmaster was Stanchfield's Claire Peterson, 1915-1963. Both his father and grandfather had been postmasters at Stanchfield starting in 1870. Claire's niece Jeanette (Peterson) Lindeman was the postmaster from 1963
- The Cambridge post office is home to a unique mural commissioned during the New Deal and Works Progress Administration. Seymour Fogel's People of the Soil was completed in 1940.

#### **Dixon Skjod**

Dixon Skjod of St. Francis passed away Tuesday, June 10, 2025, at VA Health Care in St. Cloud at the age of 94.

Dixon Darrell Skjod was born November 5, 1930, to Christ and Nancy (Nyman) Skjod in Braham,



MN. Dixon had two brothers, Dean and Layne, which have preceded him in death. Dixon attended a one-room school, District 29, for eight years then transferred to Braham High School. After schooling he did custom wood/log sawing and farmed the family farm. In 1952 he was drafted into the United States Army to serve his country during the Korean War.

He was released after the war was over in 1954. On his

first trip back to MN after being released from the Army he met his wife-to-be Betty Peterson. They were married February 12, 1955 in Harris, MN. They have three children: Dennis, Gary and Sharon. Their first house was in Medicine Lake, MN then to Crystal, MN and in 1976 they bought a small hobby farm in Corcoran, MN. Here Dixon could get back to doing the things he loved--farming. He raised beef cattle, pigs, chickens, ducks and geese. He also planted corn and made hay for his animals. He loved to garden so planted apple trees, strawberries, raspberries and grapes. They joined St. Paul's Lutheran Church in Hanover, MN. He loved to fish and hunt. You knew if you agreed to go fishing with him that would be an all-day affair or until you caught your limit. As a family you knew not to plan anything like a wedding or funeral at the opening of fishing, archery or rifle deer season. Those were sacred" holidays and not to be messed with. He still brags about the over 100 deer he has shot with the bow during his many hunting trips in MN, WI and SD. He also made an elk hunting trip to Colorado (but got no elk).

After several years of working for other contractors he started his own business, Dick's Water and Sewer, which he operated until his retirement in

Dixon's first trip after retiring was a "drive to Alaska" pulling a pop-up camper with a boat on top of it. Therefore, every night when we stopped first you unloaded the boat then set up the camper. Not exactly the best way to start your retirement we found out. We spent 3-4 weeks traveling the state of Alaska. We took a great trip to Sweden, Norway and Denmark (remember Dixon is Danish and proud of it). Shortly thereafter, we started spending our winters in Apache Junction, AZ and continued to for the next 22 years. When it took us three nights in motels to drive from AZ back to MN in the spring, we decided it was time to stay in MN. We sold the farm and moved to East Bethel, MN where we joined Our Saviour's Lutheran Church. It did not take Dixon long before he started tilling a plot for a garden and planting apple trees. We also joined the East Bethel Senior Center.

In 2020-21 Dixon started slowing down and in a couple of years we knew we had to move to a one-level house with no steps or stairs so we ended up at our present house in St. Francis, MN. Dixon was transferred to the VA facilities in St. Cloud in January 2024 where he resided until his passing

June 10, 2025.

# How long should kids ride in the backseat?

Question: I heard something about kids needing to ride in the back seat if possible. What is the age on that?

Answer: Back on August 1, 2024 there were new car seat guidelines put in place along with

> this. The back seat is the safest place in most vehicles. Children under 13 must ride in the back if it is available.

> Children under 2 years of age must ride in a rear-facing car seat until they reach the weight or height limit of the car seat. If they are too heavy or too tall for the car seat, they must switch to a front-facing car seat. Once they turn 2 years old, if they are under both the height and weight limits, they must stay in the rear-facing car seat until they are too tall or heavy for the

· Children older than 2 who exceed the rear-facing neight or weight limit of the car seat must sit in a forward-facing car seat until they reach the height or weight limit (typically 40-60 pounds, depending on the manufacturer).

· A child from 4 to 9 years old must use a booster seat and be secured with a safety belt if they are too tall or too heavy for the car seat.

· When a child is 9 years old, or they exceed the weight or height limit of the booster seat, they must sit without the booster and be secured with a seat belt.

# Minnesota starwatch for **July 2025**

During July the morning sky hosts three bright planets, each following its own path.

As the month begins, Venus is a beacon low in the southeast. Our sister planet stays low, but moves steadily northward as the winter stars stream past it. Try looking just before dawn on the 10th, when bright Aldebaran, the eye of Taurus, the bull, will be below Venus. The Pleiades star cluster will be above Venus, and no moon will interfere.

Also at dawn, Saturn stays fairly high as it drifts from southeast to south. In mid-month, Jupiter climbs over the northeastern horizon: on the 23rd, an old moon sits to the left of the giant planet as dawn starts to break. Watch Jupiter and Venus approach each other in the last week of the month. The pair will make a close pass in August.

In the southwest, the Summer Triangle of bright stars also graces the

morning sky. Two of those stars-Vega and Altair—line up with the moon between the 12th and 13th.

At nightfall, the Teapot of Sagittarius almost scrapes the horizon as it glides from southeast to south during July. Just west of the Teapot, bright Antares marks the heart of Scorpius. The moon visits Antares on the 6th and 7th and rises in the Teapot on the 9th. The next night, July's full moon rises in evening twilight and follows the Teapot across the night sky.

Also at nightfall, brilliant Arcturus, in kite-shaped Bootes, the herdsman, shines high in the southwest, while the Summer Triangle ornaments the eastern sky. Between the Triangle and Bootes are upside-down Hercules and Ophiuchus, the snake handler. If you have a star chart, these two lesser-known constellations can be fun to find.

Earth reaches aphelion, its farthest point from the sun, at 2:54 p.m. on July 3. At that moment we'll be 94.5 million miles from our parent star.

# Talking primary care with U of M

Q: What is primary care?

Dr. Loerzel: Primary care is comprehensive, patient-centered healthcare delivered by physicians and care teams that manage most health needs. It includes treatment for new and rapidly developing symptoms, chronic illness management, disease prevention and promoting healthy lifestyles through education and counseling.

Primary care is ideally positioned in healthcare delivery to coordinate complex medical care and to be the "healthcare home" for an individual and their

Q: What are the different types of primary care physicians?

Dr. Loerzel: Primary care physicians include OB-GYNs, internists, pediatricians, family medicine doctors, geriatricians and Med-Peds specialists. OB-GYNs focus on women's healthcare. encompassing reproductive health, prenatal care, operative and non-operative delivery and gynecological care. Internists treat adults, often managing chronic and complex conditions. Pediatricians care for infants, children and teens. Family medicine physicians treat all ages and may offer obstetric care. There are also primary care geriatricians who focus on the care of older individuals and addressing conditions related to aging. Med-Peds doctors are trained in both internal medicine and pediatrics, caring for patients of all ages. Unlike family physicians, they do not provide obstetric care.

Q: Why is it important to have a primary care doctor?

Dr. Loerzel: Having a primary care doctor ensures you have a dedicated physician and healthcare team to contact when needs arise. They know your medical, family and social history – lowing for personalized, comprehensive

care and better management of chronic conditions. Primary care doctors also guide preventive health screenings, follow up on care from other providers and coordinate referrals to specialists with the necessary background and testing. Primary care doctors help you navigate a complex healthcare system effectively. Everyone deserves a trusted primary care team to support their health across all stages of life.

Q: How often should I see my primary care doctor?

Dr. Loerzel: It depends on your age and health needs. Infants are seen frequently in the first year, then annually through early adolescence, and every two years through age 18. Adults are generally seen annually for wellness visits. If you have stable chronic conditions, visits every 3-6 months may be recommended. For acute issues or when working toward a specific goal, visits may be more frequent. It's important to establish care with a primary doctor to determine the best schedule for your specific health needs. If you're experiencing non-life-threatening changes in your health or a concerning symptom, you should reach out to your primary care physician. Seek emergency care for life-threatening issues.

Q: How does your work at the University of Minnesota advance health in Minnesota?

Dr. Loerzel: My work with the University of Minnesota helps advance health in Minnesota by training future physicians, especially through the new rural family medicine residency program in Willmar. I've taught medical, nursing and allied health students in my rural community for over a decade. Training physicians in rural settings is vital in growing the future workforce that will care for patients in our rural communities. The University of Minnesota's partnership with CentraCare will provide new opportunities and resources to strengthen the healthcare system statewide.

Dr. Maria Loerzel is an adjunct assistant professor at the University of Minnesota Medical School and a family medicine physician with CentraCare. She provides full-spectrum family medicine with a special interest in obstetrics, women's health and
