BACKGROUND: June 20, 2019 unless otherwise stated

- Walker County Judge Danny Pierce received a petition for the creation of an Emergency Services District. Health and Safety Code Sec. 775.011(a)
- The petition must be signed by at least 100 qualified voters who own taxable real property in the proposed district. *Health and Safety Code Sec.* 775.011(a)
- The petition contents/requirements must comply with both the Election Code Sec. 277.002 and the Health and Safety Code Sec. 775.013.
- Receipt of petition by Voter Registrar for signature verification

**RESULTS** of the petition verification stated below:



## PETITION TO CREATE WALKER COUNTY EMERGENCY SERVICES DISTRICT NO. 3

#### SERVICES:

The proposed District is to be created and operated under the provisions of Article iii, Section 48-e, Texas Constitution, and the statutory legislation, as amended, and to provide the following services, in such extent and manner as may be determined from time to time by the commissioners of such District: fire prevention, suppression and extinguishment, hazardous material incident responses, EMS first responder and rescue services.

#### **EXHIBIT "A"**

## That the boundaries of the proposed Walker County Emergency Services District No. 3 are;

Commencing at the intersection of the south right-of way line of State Highway 30 West with the Walker County - Grimes County line;

Thence, the line follows in a northerly direction along the Walker County - Grimes County line, being the centerline of North Bedias Creek, to the Walker County - Madison County line junction on the Jones, K (A-301) Tract 1;

Thence, the line follows the Walker County - Madison County line being the center line of Bedias Creek, to the Walker County - Houston County line where they intersect in the Trinity River, north-east of Holcomb, JJ (A-239) Tract 2;

Thence, the line follows the Walker County - Houston County line to the Walker County - Trinity County line where they intersect on the Millsaps, M (A-338) Tract 1;

Thence, the line follows the Walker County - Trinity County line south to the north bank of the Trinity River where it intersects at the south-east corner of the Ortega, J (A-34) Tract 6;

Thence, the line will continue west along the north shore of the Trinity River to the junction of the Trinity River and Nelson Creek, (North-west boundary line of the current ESD 1);

Thence, the line will follow Nelson Creek to its junction with Baldwin Creek on the Grooms, WM (A-215) Tract 1, (West boundary line of current ESD 1);

Thence, the line will follow Baldwin Creek to its intersection at Farm to Market 2628 on the Woodland Hills Lake, Lot 27 Reserve A, (South-west boundary line of the current ESD 1);

Thence, the line will follow Farm to Market 2628 to the east to its intersection with Farm to Market 980, (South boundary line of the current ESD 1);

Thence, at the intersection of Farm to Market 2628 and Farm to Market 980 the line will turn north and follow Farm to Market 980 to Lake Falls Road, (East boundary line of the current ESD 1);

Thence, at the intersection of Farm to Market 980 and Lake Falls Road the line will turn east following Lake Falls Road to the southern property line of the Edinburgh, C (A-19) Tract 30.1 to its junction with Harmon Creek, (South boundary line of the current ESD 1);


Thence, the line will follow south on Harmon Creek's west bank to its junction on State Highway 19, on the Huntwood-Section 1, Block 4, Lot Reserve C, (West side boundary line of the current ESD 1);

Thence, the line will follow south on the western right-of-way of State Highway 19 to where it intersects with the current ETJ line of the City of Huntsville, Texas on the Parker, J (A-36) Tract 1;

Thence, the line will follow the north side of the current City of Huntsville ETJ line to its junction of the south right-of-way line on State Highway 30 West, on the Lamb, GA (A-326) Tract 12.3;

Thence in a westerly direction along the south right-of-way line of State Highway 30 West to its intersection with the Walker County - Grimes County line; hence being the place of the beginning point;

There is saved and excepted from this boundary description any part of the extra-territorial jurisdiction or corporate area of the City of Huntsville, Texas.
