I was just informed by my staff that Decatur has delayed the start of school until Feb. 8, because Alltown Bus was unable to perform, saw this in an email from Decatur sent by my staff. That is unfortunate because this isn't true, we told Henry and Randy that we could make it work and we stand by that.

Alltown understands that we are asking for help that you may not be able to give, to be clear, our Chicago agreement gives us 40% since the start of school in September through January 31, 2021, this did not involve paying the driver's, aids. We just started school for Chicago running approximately 65 routes four days a week. The CPS agreement is back paying us for our overhead costs from September 8, 2020 through Jan. 31, 2021. Your offer of 40% on the three days the district doesn't run each week doesn't cover our costs of drivers & aides pay (with taxes) insurance, bus notes, rent, etc.. We would accept 40% of our daily rate from the start of school August 14, 2020 until Jan 31, 2021, that would allow us to pay our drivers and aids for all five days each week going forward until school starts, when they are only driving two day, three or four days a week. Another option would be to pay us 75% on the days the drivers aren't driving starting January 4 until the drivers have a full schedule. And pay us 100% on the days that the drivers are working. Knowing now that we have lost another 14 days of transportation, we still would like to start paying the drivers that we do have now, have a route pick, conduct our safety classes and get them ready for February. We ask that you present these options to the board so that we can let our drivers know that relief is in sight.

Henry Walker asked me to send you a list of people and districts that we currently have an agreement with to help us pay our drivers/ overhead (or both) during this Covid 19 Pandemic. As you know your district is starting school in a few weeks and we will be ready to provide the buses and drivers. You should know that we are concerned about our drivers coming back to work for only two days (pay) a week when they can make more from unemployment with the new stimulus package paying them \$300.00 per week plus there current unemployment benefits. I know that Henry has requested that we give you the agreements that we have in writing but I can only give you the names of the districts and the contact people to talk to. They will **confirm that we have agreements** in place to help us with our overhead/driver pay until school starts, agreements that pay us to pay our drivers on the days that they are not working and agreements in place to pay us 80% to 100% of our daily rate during E- learning. Kimmy informed me that Alltown will be short drivers due to the pandemic. This shortage will cause many routes to not be covered. We reduced our routes to about 86. Contractually we should have 95 drivers plus sub drivers. I was told so far Alltown is expecting around 73-75 drivers, and possibly fewer after official bid day tomorrow.

In the Agreement between the Decatur Public Schools and Alltown, it states "in the event Contractor cannot provide services for reasons stated herein, Contractor shall provide written notice to District by fax or email within 24 hours of the time Contractor is aware it services cannot be performed as required herein."

Based on the information we received, it appears you will default on your obligations for route coverage. This email serves as a written notice describing the nature of the default.

Dr. Fergau,

Henry Walker asked me to send you a list of people and districts that we currently have an agreement with to help us pay our drivers/ overhead (or both) during this Covid 19 Pandemic. As you know your district is starting school in a few weeks and we will be ready to provide the buses and drivers. You should know that we are concerned about our drivers coming back to work for only two days (pay) a week when they can make more from unemployment with the new stimulus package paying them \$300.00 per week plus there current unemployment benefits. I know that Henry has requested that we give you the agreements that we have in writing but I can only give you the names of the districts and the contact people to talk to. They will **confirm that we have agreements** in place to help us with our overhead/driver pay until school starts, agreements that pay us to pay our drivers on the days that they are not working and agreements in place to pay us 80% to100% of our daily rate during E- learning. All of the districts listed below have been informed that your office will be calling them, and since we have different agreements (some written and some not) with each district we felt it would be best to let them tell you what we do have.
