RELIGIOUS PROPERTY

For the past eighteen years, the Nebraska Department of Correctional Services (NDCS) has allowed individuals to purchase personal religious property based on their accommodated religion. As religious traditions have changed, the practice of religion has changed. In this present society, one finds individuals now seek to worship within their religion by using various accourtements which are found within the traditions of other religions. As an example, many practitioners of Native American Practices hold fast to the traditions of their heritage, yet also are active practitioners of Catholicism. For this reason an incarcerated Native American practitioner may request a Native American Bandanna and a Rosary. Under the current table of personal religious property a Native American is forced to declare a religion (Native American or Catholic) and then adhere to the property listed for that accommodated religion.

Beginning November 1, 2017 NDCS roligious property will be limited to those items listed on the new Personal Religious Property list in Attachment E of AR 208.01 (Attachment E is attached to this memo). To receive property on this list an individual must declare a religion or affirm that they are an individual who is spiritual but has no religious tradition (this individual is known as an Individual Religious Practitioner [IRP]). In order for an individual to receive IRP status he/she must follow the procedure as outlined in Administrative Regulation 208.01, Section VI, paragraph B.

To possess personal religious property, inmates must purchase a 6 Qt., 13.75 X 8.625 X 4.875 plastic storage container in which they must store their personal religious property. Only personal religious property listed on the personal religious property section of Attachment E may be stored in the box. The box which is listed in the personal religious property section of Attachment E must be purchased through the canteen. The cost for this box is \$1.65. Inmates are limited to 1 religious box in their possession.

Property control will engrave on the container "Religious Property" along with the inmate's name and number. Oversized items not to be stored in this container are indicated as such on the Personal Religious

Property list located in Attachment E of AR 208.01. Each immate will be responsible for providing the container to Property Control in order for his/her name, number, and the words "Religious Property" to be engraved on it.

Misuse of this container will result in a misconduct report and may result in the loss of the container and the property therein. If a misconduct report results in the loss of the box, the immate will be required to purchase another box along with any religious items from Attachment E. This storage container will be included in the inmates allowed storage area of four cubic feet.

FUNDING ACCOMMODATED RELIGIONS

Current Nebraska Department of Correctional Services (NDCS) practice is to fund accommodated religions by providing each accommodated religion \$50.00 a year however, finances used by NDCS accommodated Religions may not be acquired through the utilization of Department monies.

The State of Nebraska will cease the utilization of Department monies to fund accommodated religious on July 1, 2017.

NDCS Administrative Regulation (AR) 113.01 (Fiscal Management) provides a legal alternative for accommodated religions to obtain funds. AR 113.01, Section XVII (Donations), Paragraphs A and B state "Donations of cash or materials to NDCS may be accepted by the Warden/Program Administrator, if under \$500. Donations \$500 up to and including \$10,000 require acceptance by the Director. Donations over \$10,000 or real property require acceptance by the Governor...Donations to clubs or recognized religious faith groups may be accepted as long as they do not violate NDCS policy and shall be placed in the appropriate club or religious faith group account in a trust fund."

STATE PURCHASE OF ROCK AND/OR WOOD

Current Nebraska Department of Correctional Services (NDCS) practice is to provide rock and wood for accommodated religions. Rock and wood used by NDCS accommodated religions may not be acquired through the dispersion of Department monies.

The State of Nebraska will cease the practice of providing rock and wood for accommodated religions on July 1, 2017. NDCS Administrative Regulation (AR) 113.01 (Fiscal Management) provides a legal alternative for accommodated religions to obtain rock and wood, or the funds by which to do so. Existing supplies of rock and wood will be allowed to be expended.

AR 113.01, Section XVII (Donations), Paragraphs A and B state "Donations of cash or materials to NDCS may be accepted by the Warden/Program Administrator, if under \$500. Donations \$500 up to and including \$10,000 require acceptance by the Director. Donations over \$10,000 or real property require acceptance by the Governor...Donations to clubs or recognized religious faith groups may be accepted as long as they do not violate NDCS policy and shall be placed in the appropriate club or religious faith group account in a trust fund."
