

Just have these bums print out the FBI crime records and you'll see where the real trouble is, and I guarantee; it's not on any football field in AMERICA.



Disrespectful football player behavior





Mr. Daub,

I am a 2011 graduate of the University of Nebraska College of Law, the same institution where you earned your JD. Today I reside in Las Vegas. I write with regard to the following article:

It's possible that you were misrepresented or misquoted in this article. I know that happens sometimes. If that's the case, you deserve to have your position corrected and clarified.

However, if this article does accurately represent your position, I find it quite troublesome. Personally, I find it offensive when people do not stand and put their hands on their hearts during the national anthem prior to ball games or when the flag goes by in a parade. When I have my kids at those events, they understand that standing for the flag is a way we show respect for what the flag represents: equality under the law, the patriots who died establishing and defending our nation, the suffragettes who expanded the franchise, the civil rights protesters, immigrants, etc. I also explain to them that the flag represents our civil liberties, our freedom to practice our religion (which is especially important to us as member of a historically persecuted minority religion) and our right to free speech.

"If there is a bedrock principle underlying the First Amendment, it is that the government may not prohibit the expression of an idea simply because society finds the idea itself offensive or disagreeable." <u>Tex. v. Johnson</u>, 491 U.S. 397, 414 (U.S. 1989).

I see that you are an accomplished attorney. Surely you understand that the First Amendment protects an individuals right to free speech even when you or I may find that speech to be offensive, as is the case here ("one man's vulgarity is another's lyric." Cohen v. Cal., 403 U.S. 15, 25 (U.S. 1971)). Even so, the cause for which this speech is made has my support and sympathies. Our institutions do treat minorities differently than they treat white people like you and I. That is not just, and that is not consistent with our core values as a nation.

That said, I do not think these players intend disrespect. I believe they are intending to appeal to the core values that make our country great. While I wouldn't choose the same method of protest, I am deeply disturbed that you, as a state actor, seem to be threatening to take action against them in clear violation of the First Amendment. To the extend that kneeling is inappropriate and disrespectful, "the remedy to be applied is more speech, not enforced silence" or, in this case, dismissal from the football team. Whitney v. Cal., 274 U.S. 357, 377 (U.S. 1927). Make your case through persuasion and reason, not through the threat of state action, explicit or implied.

I hope you will reconsider your position. Thank you for your service to the University of Nebraska.

I have served on 6 of 7 continents. I've carried flag draped transfer cases filled with the remains of our fallen Soldiers, Marines, Sailors & Airmen. I have delivered men to and from war. I have taken wounded men to the hospital who I didn't know whether to wish them life or death because their injuries were so bad. I have had the privilege to serve amongst heroes.

In my mind, these men fought, lived, and died, to protect the founding principles of our nation. It is those enlightenment principles that inform my passion for unfettered expression in the academic environment. Offensive speech is the most important speech to protect. If men like Michael Rose-Ivey, Daishon Neal, & Mohammed Barry had their rights taken from them, it would be cheating. It would be cheating those of us who have paid with our time, our physical and mental health, our innocence, our limbs in some cases, and in the most serious cases our lives. Those payments were made in full, with the understanding that they were protecting the constitutional rights of the citizens of our country.

As importantly, I believe in the enlightenment in and of itself. Regardless of the constitution, an academic institution should never wish to muzzle people. Offensive speech is the speech that needs to be protected the most. It is ideas that offend our world view, that hold the potential to improve all of our lives by challenging our assumptions. I assume that America is a good place for all of us, Michael Rose-Ivey has challenged that idea for me, and I applaud him for it. While offensive ideas should be conveyed in a manner that is not intended to simply insult, the insult must sometimes still sting for the gravity of the idea to be fully realized. I congratulate Michael Rose-Ivey, Daishon Neal, and Mohammed Barry for accomplishing exactly that, and by cogently and intelligently relaying their experiences which led them to express themselves in this way. I would relate to them this quote from Ralph Waldo Emerson:

"Whoso would be a man must be a nonconformist. He who would gather immortal palms must not be hindered by the name goodness; but must discover if it be goodness. Nothing is at last sacred but the integrity of our own mind. Absolve you to yourself, and you shall have the suffrage of the world."

I also had the opportunity to watch an F-22 demo flight with Coach Riley and his wife Dee at the Nebraska National Guard's Guardians of Freedom Air Show this year. Mike and his wife are an absolute pleasure to be around obviously, but I told him what impresses me most about him is the way he carries himself and represents this university and this state. I want to reaffirm that now. His response, and the response of the leadership of the University has been perfect. Yes, this is America Coach Riley, and thank you for standing up for an American principle over an American symbol. It makes me proud to be an American, it makes me proud that I've fought for people who understand what American freedom is all about, and I'm proud to be a season ticket holder and annual donor to Nebraska football.

Lastly, thank you President Bounds for speaking truth to power by standing up to the regents and the governor himself on this issue, and letting them know that this university will not do the wrong but maybe popular thing. I love it, you pointed out to regents Pillen and Daub that their own regulations, and the Constitution of the United States protected our athletes rights. I applaud you for that! Please keep up the fantastic work.

To the University of Nebraska Community:

Over the past few days, our university has been at the center of a statewide conversation about free speech and the rights of student-athletes to peacefully protest. Many Nebraskans, including some of you, have expressed their opinions about the decision by three NU football players to kneel during the national anthem before Saturday's game. Some have been supportive. Others have disagreed, in some cases passionately so.

That all are free to share their view is the privilege of living in the greatest country in the world.

I have served in the military. I understand love of country and love of the flag and I know that freedom is not free. I recognize that some are upset by what they saw on Saturday night. But let me be clear. The University of Nebraska will not restrict the First Amendment rights of any student or employee.

Our position on this issue is abundantly clear. As stated in Board of Regents policy, which has been in place for almost a half-century: "Members of the academic community have the right to extensive latitude in making their opinions known... The public exploration and resolution of differing views can be successful only when groups and individuals discuss the issues in forums where the right to disagree, speak freely and be heard is preserved."

The same freedoms that protect the speech of those who have joined the conversation in recent days also protect our students' speech – whether they're kneeling during the national anthem, holding the American flag on the field, praying after a game or expressing their opinion during class or on campus. All of that speech falls under the same category. All of it is protected.

Our nation is dealing with difficult issues today, as we have for virtually our entire history. Each of us will react differently. College campuses, as much as any space, must be places where robust, even uncomfortable, debate is welcomed and encouraged. I want every student, faculty and staff member to know that I am unwavering in my support of your right to participate in these dialogues in the manner you choose under the First Amendment and University of Nebraska policy.

Thank you for all that you do for the University of Nebraska. I am honored and humbled to serve with you.

I respectfully want to voice an opposing view. I do not think that any player "had better be kicked off the team" for not standing during the national anthem.

Did some research and found Title 36 (Section 171) of the United States Code. I found that the words "must" or "shall" are not included in the language of Title 36. The key word in the Code is "should". There was no language that indicated any type of punishment would be issued for non-compliance.

I grew up in Lincoln in the 1970's and 1980's so I am aware of your background in Omaha politics and of your service to this country. So I find it curious that you are advocating the positions taken by both Russia and North Korea on this matter.

Russia fines its citizens for mocking its national anthem and has also proposed criminal charges of one year in prison or hard labor. In North Korea a citizen can be jailed for mocking the national anthem.

A kid wants to speak out in a non-violent manner for a cause that he believes in and you want to take away his scholarship and kick him off the team?

Did you listen to the thoughtful and intelligent statement made by the player on Monday? I do not think it was a "publicity seeking athlete". But rather a young man that wants to open a dialogue on how we as people can better treat each other.

I have not read my Bible lately but I do believe the message preached by Jesus was always about trying to treat other people in a loving and caring manner. Do not remember Jesus telling Paul that unless he complied with 100% of his teachings that he "had better be kicked off the team".

The flag, national anthem, or national bird are nothing more than symbols meant to promote patriotism. Those symbols do not grant or give the rights and freedoms you fought for in the Korean War.

"If there is any fixed star in our constitutional constellation, it is that no official, high or petty, can prescribe what shall be orthodox in politics, nationalism, religion, or other matters of opinion, or force citizens to confess by word or act their faith therein."

I appreciate your time and would conclude by relaying a report from the Congressional Research Service in 2008:

"The Flag Code is a codification of customs and rules established for the use of certain civilians and civilian groups, No penalty or punishment is specified in the Flag Code for display of the flag of the United States in a manner other than as suggested. Cases ... have concluded that the Flag Code does not proscribe conduct, but is merely declaratory and advisory".

Dear Mr. Bounds,

I just read your letter regarding the right for University of Nebraska athletes to express their protest by taking a knee during the playing of the National Anthem at a football game. I understand that you are in a tight spot here and that your official position needs to reflect the University policy. But I contend that your application of the policy is flawed and does not apply to a football game. Your letter stated in part, "As stated in Board of Regents policy, which has been in place for almost a half-century: "Members of the academic community have the right to extensive latitude in making their opinions known... The public exploration and resolution of differing views can be successful only when groups and individuals discuss the issues in forums where the right to disagree, speak freely and be heard is preserved."

I agree with freedom of speech Mr. Bounds. What I disagree with is the forum. These student athletes are under contract, are they not? Their contract no doubt has a conduct clause, and also spells out the requirements and expectations of them remaining part of the team. So let me ask you this, how is it that a football game is now a forum for political protest? It's not. And that is the point where the policy fails to apply.

If a player protested by not showing up for practice, would they be allowed to play? No, because there is an expectation that each player will participate in team events. Would players be allowed to protest by wearing clothing of their choice for a game or is there a uniform requirement? Like a "Black lives matter" or "make weed legal" t-shirt on the field? No, certainly not, they are expected to dress in the issued uniform. Can they express their protest on the field by sitting during play, no they cannot. And not because their right to wear clothing or perform a 'sit in' are being violated. But because there are rules of the game and they agreed to the rules. They are not allowed to bring in signage or grab a microphone and chant a protest, the expectation is that a football game is not the forum for that speech. Taking a knee during the anthem when the expectation is that everyone stand is the same thing and should be a violation of the rules of conduct. Just as there is an expectation of military personnel to behave in a certain matter while in uniform, so should there be an expectation of the athletes while in uniform representing the University of Nebraska.

This is not the East Coast and the people of Nebraska are not going to tolerate this type of behavior. My advice is to get some strict guidelines in place for student conduct immediately because if you let this get out of hand your job is probably going to be on the line sooner than later.

I am writing to you today to express concern and dismay regarding the actions of a member of the University of Nebraska's Board of Regents, Hal Daub. First of all, I want to thank you for your strong comments supporting the athletes after Daub's comments became public.

As you're aware, in an interview the Journal Star newspaper, Mr. Daub made a number of disparaging comments about a stance taken by football student-athletes with which Mr. Daub did not agree.





I'm surprised that as an educated professional with a law degree, you would suggest that 3 students are punished for exercising their right to free speech. As an alumni of UNL, I am greatly disappointed that you are associated with my university and my home state. To degrade our constitution that you have swore to uphold is a disgrace. As an attorney, I am sure you are aware of Tinker v. Des Moines Independent Community School District, 393 U.S. 503 (1969): "It can hardly be argued that either students or teachers shed their constitutional rights to freedom of speech or expression at the schoolhouse gate... Schools may not be enclaves of totalitarianism. School officials do not possess absolute authority over their students. Students... are possess of fundamental rights which the state must respect[.]"

For a university that prides itself on its inclusivity and diversity, I'm unsure how your actions as Regent represent those values. A university should be an enlightened environment where students feel welcome, safe, and supported while they peacefully protest, while they initiate meaningful dialogue, and while they push for positive social change. We task our younger generation with making the world a better place, yet when they take a peaceful stand to raise awareness of an issue they feel close to, you disparage and berate them. And I hope you feel ashamed. Because I'm ashamed for you. 


