Thirteen Ways the 2020 Election Was Rigged in Wisconsin

1. Mail in voting coupled with numerous Dem Lawsuits to change Election Laws.
2. Eric Movers List of 230,000 – 93% accurate – Kept on Voter Registration Rolls through Nov 2020 Election. WEC took off 70,000 in May of 2021.
3. WEC Sent 2.7M Absentee Ballot Applications – 230,000/8.3% returned; 30,000, w/no such address” voted.
4. WEC and SC knocked Green Party off the Ballot – Green Party - 31,000 votes in 2016
- 14 seconds knocked Kanye West off the Ballot – WEC had front doors locked!
5. Dems kept all liberal political parties off the ballot / conservative parties on Ballot received 50,000+ votes.
6. WEC prohibited Special Voting Deputies in nursing homes & assisted living facilities turning the AB process over to nursing home staff. Racine Deputy found fraud in nursing home with confession.
7. Indefinitely confined expanded from 70,000 to 250,000 statewide – City of Milwaukee from 6,000 to 60,000 - as suggest by Milw and Dane County Clerks to avoid Voter ID.
8. WEC (since 2016) directed clerks to fill in missing AB Witness Address. Emerg Adm Rule Scope by WEC.
9. Ballot Harvesting legal in Wisconsin for 20 years per WESB, GAB, WEC. Currently stopped by CT Order!
10. 500 drop boxes and “Democracy in the Park” – no statutes prohibiting. Currently stopped by Ct Order!
11. Some Voting Machine’s tested - verified flaws – technically substandard!
12. Unresolved questions regarding WEC Data Base? Should be full audit by o/s non-partisan, major firm!
13. Zuckerberg’s dollars allowed his group to run elections in major Dem cities – Gave \$31 per vote cast Racine, \$18 – Kenosha, \$37 - Green Bay, 44 Cents – Brookfield, \$12 - Milwaukee.

WISCONSIN ELECTION COMMISSION HISTORY:

- **WEC was setup in 2015** to take the place of the Government Accountability Board (2007 – 2015) Was set up to take the place of the WI State Elections Board (1974 – 2007).

“**E- Six Commissioners** appointed for 5 year terms – (1 by Sen. Majority Leader, 1 By Sen. Minority Leader, 1 By Speaker, 1 By Assembly Minority 78;/4=====Ω§¶

- **Administrator** – Appointed & at pleasure of 2/3 vote of the Commissioners (4) with the Sen. Confirmation – 4 y term. The Administrator appoints / hires all staff. Administrator, Attorneys & Staff suppose to be Non-Partisan??? DOJ Represents WEC – Remember, DOJ represents “the People” not necessarily WEC.

- **All past WI St Board, GAB & WEC decisions / motions, etc., carry forward** until 4 votes are obtained for approved. Therefore, Ballot Harvesting, Curing of Absentee Ballot Envelopes, etc. would be still in effect until such time of a final Court Declaratory Judgments.

- **WEC Agreement of 23-26 (78-86%) of 2021 LAB’s - 30 Audit Recommendations.**

- **Today, February 16 = WEC did right thing!** By following court order to withdraw all the guidance allowing drop boxes & ballot harvesting for WI April & all future elections since Ct declared this guidance invalid – pending a Wis. Sup Ct Ruling!
