I, L.D. Broddle #2492, of lawful age, being first duly sworn on oath, depose and state:

Your Affiant is a Police Detective with the Wichita Police Department (WPD). In that capacity, your Affiant was assigned to assist in the follow-up investigation of WPD case number 25C202244 which occurred on October 31, 2025, in Wichita, Sedgwick County, Kansas. During this investigation, Affiant learned the following information:

On October 31, 2025, at approximately 0751 hours, Officer Avila #2842, Officer Taylor #2719, Officer Zimmerman #2467, Officer McCrea #2801, Officer Martinez #2690, and Sgt. Shourbaji #1896, responded to a cutting at 1514 E. Crowley, Wichita, Sedgwick County, Kansas. The initial caller told Sedgwick County 911 Dispatchers her mother tried to kill her, so she stabbed her in return. The caller identified herself as Angelynn Mock and she was at the residence with her mother. Upon arrival, Officers Martinez and McCrea located a white female standing outside, bleeding, holding a towel. The female standing outside was later identified as **Angelynn Mock** (47, W/F). She indicated her mother was inside, injured, and was named Anita. Officers McCrea and Martinez entered the residence and located a white female, later identified as **Anita L. Avers** (80, W/F), lying on the bed, with multiple stab wounds to her face and torso. Anita was transported to Ascencion Via Christi St. Francis Hospital, via Sedgwick County Emergency Medical Services Medic 31, code blue and a GCS of 3. Anita was later pronounced deceased at 0826 hours on October 31, 2025, by Dr. Ronald Nold with Ascencion Via Christi St. Francis Hospital.

When she entered the residence to locate and render aid to Anita, Officer McCrea observed a bloody cell phone on the kitchen sink and a clean, kitchen knife on the kitchen floor. Additionally, Officer McCrea located a large butcher style knife with blood on it and a cell phone on a coffee table in the living room. Anita was found in the northeast bedroom in a bed, lying on

her back, with blankets covering up to her waist. She did not have any clothes on but was wearing undergarments consisting of underwear and a bra. Anita had multiple stab wounds on her body including her head, face, and torso and was unresponsive. Next to Anita on the bed, Officer McCrea located multiple kitchen style knives and a cheese grater, laid out on a pillow. There were blood droplets throughout the residence, but the main pooling of blood was on the bed where Anita was laying.

Officer Ramon Avila #2842 arrived on scene and observed a white female wearing a black shirt, red pajama pants, no shoes, with a large amount of blood on her body and clothing. She was identified as Angelynn Mock and Officer Avila asked her where her mother was hurt. She said, "Her face, eyes," and gestured to her torso area. Officer Avila asked if her mother's injuries were from stab wounds and she said, "yes." Officer Avila asked what happened and Angelynn said she went to her mother's room to talk and saw her sharpening knives. Her mother came after her with a knife and fought her. Angelynn was stronger so she pushed her back. Her mother then said, "I know you're fucking Jesus Christ," so she backed away. Her mother followed her, so she went around her, grabbed a knife, and got on top of her. Angelynn said her mother, "started spewing venom at me out of her fucking mouth," so she had to stab her to save herself.

Angelynn later said she went into the bedroom to talk to her mother about an upcoming job interview with KSN because she was a news anchor. Her mother was sharpening knives with bigger knives and told her she was jealous and did not want her to get the job. Angelynn said she ran around the house being chased by Anita and believed Anita was going to kill her. She said, "I had to kill her, she wasn't going to stop." Angelynn first said she stabbed first but later said her mother stabbed first. Officer Avila advised Angelynn of her Miranda Rights at 0808 hours on October 31, 2025, and she said she understood her rights but did not want to speak further. Officer Avila discontinued all further questions. When asked about the incident by EMS personnel, Angelynn said she wanted an attorney. Angelynn was transported to Ascension Via Christ St. Francis Hospital, by Sedwick County Emergency Medical Services Medic 32, code yellow, GCS 15. Angelynn was treated for six lacerations to her left hand, two lacerations to her right hand, and one laceration of her inner right arm.

Detective Johnson also spoke with Alyssa who said Javier came back into the residence and said a lady was outside and she needed to talk to her. Javier and Alyssa went outside and approached the female, who was sitting in the passenger side of Javier's truck. Alyssa could see the female was covered in blood and was out of breath. She was on the phone but said, "I'll talk to you guys," but then walked away. Both Alyssa and Javier knew an older couple who lived across the street at 1514 E. Crowley but had never seen the female before. Javier later retrieved his phone from the female, who was identified as Angelynn Mock, while she was talking to officers.

Oswvaldo Valverde (31, W/M) also lived at and was contacted by Det. Johnson and Off. Pena. Oswvaldo provided access to video footage from the residence's doorbell camera. The camera was motion activated and only recorded when activated by someone walking between the sidewalk and the house. A video recorded at 0637 hours, on October 31, 2025, showed Oswvaldo walking out the front door and getting into his car. In the background, the front yard and driveway of 1514 E. Crowley was visible. The same red car was parked in the street as seen when officers first arrived and contacted Angelynn. Another car was visible in the driveway, which was not present when officers arrived. A video from 0726 hours, when a juvenile walked by on the sidewalk, showed the vehicle in the street was still there, but the vehicle from the driveway was now gone. A video from 0748 hours, showed Javier leaving the residence and walking to his truck, which was parked on the street. A video from 0751 hours, showed Angelynn standing by the passenger side of the truck as Javier ran inside.

Officer Zimmerman was able to contact the only other resident listed for 1514 E. Crowley; Barry Avers (74, W/M), who was Anita's husband. Barry said he was currently at work in

Wellington, Kansas, but would return to his home immediately. Upon his arrival, Barry was notified of Anita's death and agreed to an interview at the Wichita Police Department Investigations Division. Your Affiant and Detective K. Kurtz #2278 spoke with Barry who said Angelynn was his stepdaughter and Anita's biological daughter. Angelynn was previously a news anchor in St. Louis, Missouri, before being laid off after an explosive situation involving alcohol. He could not recall the precise date, but she moved in with Barry and Anita approximately four or five years ago. At that time, Anita encouraged Angelynn to seek treatment with a psychologist or psychiatrist. Barry remembered Angelynn was originally diagnosed with bi-polar disorder but was later revised to be schizoaffective disorder. He knew her to have bouts of delusions mixed with periods of depression. To his knowledge, Angelynn was on medication, but he did not know what type and only assumed she took it as prescribed. She also had angry outbursts, but he never felt she was violent or felt threatened.

Barry said Anita and Angelynn had a back-and-forth relationship as most mothers and daughters but were close. Several years ago, she had an explosive outburst where police were called which resulted with Angelynn being held at the hospital for psychiatric reasons for approximately two weeks. The last outburst Barry could remember Angelynn having was three or four weeks ago when she yelled at the family during a card game. She accused the family of hating her and she said she hated everyone. Barry also recalled multiple times when Angelynn would be in a delusional state. She would say, "They're all robots," and "They're not real people." He also knew her to claim to be spiritual and talk to God, also claiming to be the Anti-Christ. Angelynn would get angry saying, "People don't understand. These things are real. They don't like me and don't want me." On one occasion, Barry recalled Angelynn saying, "I could blow everyone up if I needed to." Usually, these statements were made while Angelynn was on her stationary exercise bicycle.

Last night, October 30, 2025, as was his usual routine, Barry said he went to bed a little before eleven and Anita followed a short time later. Barry recalled hearing Anita and Angelynn have a conversation before he went to bed, but he thought it sounded like a normal, cordial conversation. The morning of October 31, 2025, Barry woke up around 0630 hours and felt Anita "cuddle up" next to him. He stayed in bed for another ten minutes before getting up. He got around for the day and left the house for work around 0710 hours. Barry drove to his employment at

Sumner Mental Health in Wellington, Kansas, in his Honda Fit (the same vehicle he would later return in). He had his first client at 0800 hours, and upon completion of the session, he was notified by officers of the incident. Barry advised both he and Anita sleep in the nude, though she frequently wore underwear and a bra to bed. When asked about the presence of knives in the home, Barry said he and Anita had several sharp kitchen knives. These were kept on a magnetic strip affixed to the outside of the pantry cabinet in the kitchen. To his knowledge, all the knives should have been on the magnetic strip. When asked about a cheese grater or fruit zester, Barry said they did own one and it should have been in a drawer in the kitchen, directly under where the knives were kept. Barry identified the front/southeast bedroom as belonging to Angelynn. He and Anita slept in the back/north bedroom which had an on-suite bathroom. A third bedroom was converted into an office. The bathroom off the main hallway/dining area was primarily used by Angelynn, but also by guests. Barry said when he left the house, Anita was still sleeping in their bedroom. He heard Angelynn awake in her bedroom, and she was talking and laughing.

Upon being taken to Ascencion Via Christi St. Francis, Anita had multiple stab wounds to her face, neck, torso, and arms. Angelynn had lacerations to her right and left hands and her upper right arm. An autopsy was performed by Dr. Gorrill with the Sedgwick County Regional Forensic Science Center. Dr. Gorrill listed the manner of death as a Homicide and the cause of death was multiple stab wounds. Dr. Gorrill noted multiple stab wounds with injuries to the pericardium, left ventricle, left lung, thyroid cartilage, right internal jugular vein, and left carotid artery. Anita also had stab wounds on both arms. No injuries were present below her waist.

Upon discharge from the hospital, Angelynn was transported to the Wichita Police Department Investigation Section to be afforded the opportunity to contact her lawyer. While inside the interview room, Angelynn made multiple statements, talking to herself, where she believed her mother was the devil. She said, "I'd kill that bitch to have my mom back any day. I don't even know who she is anymore. I know, I believe she's the devil."

A search warrant was obtained for the residence of 1514 E. Crowley. Wichita Police Department Crime Scene Investigators noted blood droplets outside the residence on the driveway, on the sidewalk leading up to the house, and leading back to the detached garage. Blood droplets were located inside the detached garage. Inside the residence, there were blood droplets in the front

living (on the south side of the house) and in the southeast bedroom, which was identified by both Barry and through indicia as belonging to Angelynn. Blood droplets were also visible leading into the kitchen. Blood was on the sink along with a black Apple iPhone, later identified as belonging to Anita. The phone was covered in blood but had wipe marks across the screen. Blood droplets continued into the kitchen and blood was visible on the pantry cabinet which had a magnetic strip for knives. One knife was still on the strip, and another was on the floor.

Blood droplets continued through the dining room and secondary/northern living area into the master bedroom where Anita was found. A large kitchen knife, covered in blood, was seen on the coffee table in the living room, along with a white Apple iPhone in a pink case (later identified as belonging to Angelynn). In the bedroom, there was a large blood pool in the bed where Anita had been laying, with blood spatter on the walls, curtains, and floor. On the opposite side of the bed from where Anita was found, four kitchen knives and a cheese grater were lying on a pillow. All the utensils had blood on them. While examining the bedding, the top sheet had at least twelve holes in the top half of the sheet, consistent with those caused by a knife.
