and feloniously possess any visual depiction, to wit: a photograph, whether made or produced by electronic, mechanical, or other means, of a child who was under 18 years of age, shown or heard engaging in sexually explicit conduct, to wit: actual or simulated exhibition in the nude, with the intent to arouse or satisfy the sexual desires or appeal to the prurient interest of the offender or any other person, to wit: image 4130 showing a prepubescent female engaged in a sexual masturbation
