I, Michael K. Brown #1580, of lawful age, being first duly sworn on oath, depose and state:

Your Affiant is a Police Detective with the Wichita Police Department (WPD). In that capacity, Affiant was assigned to assist in the follow-up investigation of WPD case number 25C165215. This incident occurred on September 7, 2025, in Wichita, Sedgwick County, Kansas. During this investigation, Affiant learned the following information:

On September 7, 2025, at approximately 2158 hours, Officer William Schoelwer #2765, Officer Logan Fria #2705, Officer Alexander Coker #2849, Officer Brycent Ashley #2990, Officer Sean Urban #2950, Officer Brennan Harris #2423, Officer James Hockett #2919, Officer Jose Arellano #2841, Officer Madison Lara #2954, and Sgt. Daniel Harty #1887 were dispatched to 1214 N. Grove on a shooting call. The calling party advised that her friend got shot in the stomach, and the shooter ran off on foot.

Upon arrival, officers observed a black male sitting in the front passenger seat of a red Kia Forte with KS tag He was identified as Trasaul Jones (B/M, 25), and he had a single gunshot wound to the right side of his abdomen with no apparent exit wound. Trasaul advised that he was shot once by his cousin, Jordan Jones (B/M, 27). Medic 23 arrived on scene, triaged Trasaul code red with a GCS of 15, and transported him to Wesley Hospital.

Officer Schoelwer went to the hospital and contacted Trasaul in the ER. He said he and his friend, Victoria Stewart-Calvin (B/F, 25), went to the house (1214 N. Grove) to check on the dogs. When they arrived, Jordan exited the house and confronted him (Trasaul) about his dog urinating and defecating in his bedroom. Trasaul said they both took a fighting stance, and Jones

struck him in the face with his right hand, causing two minor lacerations under his left eye. Then they started wrestling on the ground, and he placed Jordan in a "choke hold". Trasaul said he released his grasp, and Jones said they were going to have a rematch. Then Jones went into the house, and Trasaul and Victoria would follow a little after that.

Once inside, Trasaul began to clean up after his dog, then Jones stood by the entertainment center, waving a gun around. He described the gun as a black revolver with a snub nose and a brown handle. Trasaul said Jones was intoxicated, and he complained about the dogs. He said Jones lowered the gun and pointed it at the floor, and then he fired it into the floor. To prevent Jones from shooting again, Trasaul lunged toward the gun, and as he grabbed for the gun, Jones fired the gun twice, shooting him. Trasaul fell, and Jones grabbed his clothes and left the scene running to the south.

Officer Schoelwer showed Trasaul a mug shot photograph of Jones from Sedgwick County taken on March 3, 2025, and he positively identified him as his cousin Jordan, who had shot him.

Officer Hockett #2919 contacted Victoria. She advised that the person who shot her friend was named Jordan Jones. He was wearing dark shorts and a dark hoodie. She said he ran south on Grove after he shot Trasaul, and he was armed with a black short-barreled revolver. She said they were in the living room when this occurred, and he shot Trasaul twice from approximately two feet away, and Jones told Trasaul, before he fired, "If you step forward, imma shoot you". Victoria said she was standing next to Trasaul.

Victoria said she and Trasaul had come over to 1214 N. Grove around 2100 hours to take care of Trasaul's German Shepherd, who had puppies and was living in the residence. An argument occurred between Trasaul and Jones because the German Shepherd named Lola had defecated on the floor in Jones' bedroom and he was upset about it.

Victoria said Trasaul and Jones went out into the front yard and started fighting. She described the fight as wrestling; she didn't see them punching or hitting. Trasaul ended up getting Jones in a headlock on the ground, then Jones said he was done fighting, so Trasaul let him go. Then Jones commented, "We gonna have to have another one next week," meaning they were going to have a rematch of the fight.

After the fight, they all went inside and Jones told Trasaul, "You'll see in the morning, bet she won't shit in my room anymore". Victoria said she and Trasaul thought Jones meant he was going to kill the dog, and this upset Trasaul. Then Jones stepped up to Trasaul and shot Trasaul. Victoria showed Officer Hockett where this occurred in the living room and said Trasaul was in the south part of the room, and Jones was to the north, and he fired to the south.

While Officer Hockett was speaking with Victoria in the driveway, an SUV pulled up and the driver was identified as Saul Jones (B/M, 56). He is the owner of the residence. After Officer Hockett explained to him what happened, he agreed to sign a Waiver to Search for the residence. He said the only room he didn't have access to was the north upstairs bedroom, which was his son Jones' room. Saul advised that Trasaul was his nephew, and the German Shepherd was Trasaul's dog. He said he did not know where his son may have run off and had no idea of any ongoing disputes between his son and Trasaul.

Officer Hockett also spoke with Tiffany Stewart (B/F, 43). She is Victoria's mother and the registered owner of the red Kia. She gave Officer Hockett verbal consent to take photos of the outside and inside of her vehicle. He photographed the vehicle and advised her she could take her car and leave when she was ready. Lab 33 CSI Colton Goodon #V1466 arrived and processed the scene.

Later in the night on September 7, 2025, at 2350 hours, Officer Joshua Mercado #2942. Officer Alexander Coker #2849, Officer Logan Tibbitts #2987, and Officer Zachary Sykes #2685 were dispatched to 1200 S. Apache Dr. to contact a citizen who had information about this case. Upon arrival, Officer Mercado contacted Cyrus Jones (B/M, 35). Cyrus advised that Jones is his cousin, and at approximately 2323 hours on September 7, 2025, Jones contacted him via Facebook Messenger, saying he was going to call him. Cyrus advised that Jones uses Facebook Messenger to text people before phone calls because he only has Wi-Fi service. Cyrus said Jones then called him at 2357 hours from which is Jones' girlfriend's phone number. Cyrus said he is not familiar with her and did not know her name.

Cyrus said he recorded the second part of the conversation on his other phone. He said that during the initial part of the call, Jones told him that he shot Cyrus Jordan's brother, Trasaul. Jones said, "I had to shoot your brother," because one of the dogs peed on his (Jones) bed. Jones also

said, "I still got that, do some stupid shit, and I'll come step on you too. I still got this Motherfucker." Cyrus said he knew Jones was referring to a firearm because Jones showed him a firearm on September 5, 2025, during a family BBQ at Cyrus' residence. Cyrus described the gun as a Black 38 Special with a brown handle that originally belonged to his grandfather and was left at Trasaul's residence when his grandfather passed away. Cyrus said he recognized Jones' voice over the phone. He said they have talked on the phone many times and grew up together.

Officer Hockett provided the phone number to Officer Schoelwer. He ran the number and learned that it came back to Vanity Norwood (B/F, 41). Her last known address was 1675 S. Edgemoor.

Officer Schoelwer, Officer Logan Tibbitts #2987, Officer Urban, Officer Brennan Harris #2423, and Sgt. Harty went to 1675 S. Edgemoor and knocked on the door, but no one answered. Officer Schoelwer called the number, and a male answered. It sounded like he had just woken up. Officer Schoelwer identified himself as an officer and advised the male that he knew he was Jones and that he needed to open the front door. A few minutes later, Vanity opened the front door and advised that Jones was inside. The officers called for Jones to exit the residence, and he was eventually taken into custody at 0145 hours on September 8, 2025. As Jones was walked to a patrol vehicle, he stated, "It was really self-defense."

Sgt. Harty spoke with Vanity and asked for verbal permission to search inside her residence to make sure Jones had not left the gun inside. Vanity agreed, and the house was searched. The gun was not found, but Sgt. Harty found a white, bloody washcloth wrapped around a cold icepack in the clothes hamper in the bedroom.

Vanity told Sgt. Harty that Jones had just arrived. He knocked on the door, she let him in and noticed that his face was messed up and bleeding. He told her his cousin had done it, but he provided no additional details. She said she gave him an icepack, and she was not aware of him bringing any other property into the house.

Officer Schoelwer transported Jones to Patrol East and read him his Miranda Rights at 0246 hours. Jones agreed to speak about this incident. He said he and his cousin, Trasaul, live in the same house, and Trasaul's dog urinated and defecated in his (Jones) bedroom, which made him

upset. Jones said as he spoke to Trasaul about the dog, Trasaul "fired on" him. Meaning he hit him in the face causing two minor lacerations below his left eye. Jones said he and Trasaul began to wrestle, and Trasaul put him (Jones) in a chokehold. Jones said Trasaul eventually let go of him when Victoria stepped in to break up the fight, and he advised Trasaul that they were going to have a rematch because he (Jones) was bleeding.

Jones said immediately after the fight, he went into the house and grabbed his .38 Special revolver from a bucket on a shelf in the living room. He said he held it in his right hand and pointed the barrel of the gun down. Then Trasaul and Victoria came into the house and went to where the dogs were being held. Jones said he told Trasaul he had a gun, and they began to talk about the dogs and the ongoing family issues. Jones then turned to look at Victoria and asked who she was on the phone with, but Trasaul told him not to look at Victoria. Jones said he told Trasaul, "I'm armed, I have a firearm, please do not charge me," and Trasaul continued to yell at him. Jones said Trasaul then moved towards him to either take the gun or tackle him, so he fired the gun five times and then left the residence, leaving the gun there. He said he walked for a few blocks and then got a ride from a friend who dropped him off at the house on Edgemoor.

Jones had a previous felony conviction for aggravated battery DV in 2019 and a misdemeanor conviction for battery DV in 2024.

On September 9, 2025, your Affiant contacted Trasaul at Wesley Hospital. He signed a release for his medical records. Your Affiant asked him about the incident. He said he and Victoria went to the residence to check on his dog, and when they arrived, Jones was upset about his (Trasaul's) dog defecating in his room. Trasaul said they argued, and Jones asked him if he wanted to fight. He (Trasaul) agreed and said "sure," and he took off his hoodie and emptied his pockets. Then Jones came up to him like he was a fighter and extended his arm out as if he was ready to hit him, so he (Trasaul) punched Jones once in the face, causing a cut near his eye. Jones stumbled back, but then came toward him, so he took Jones to the ground and put him in a chokehold. Trasaul said he was going to hold Jones until he passed out or until Jones decided he was done, then Victoria got out of the car, told him to let Jones go, so he released him. Trasaul said they got up, and Jones talked about fighting in a week.

Trasaul then went into the house and cleaned up the mess that his dog made, and as he did this, Jones followed him and threatened to fuck him up, shoot him, and fuck his dog up. Trasaul told Jones to leave him alone so he could clean. When he was finished, he left and went to the car, and as he and Victoria were driving away, Jones told him, "You going to see in the morning". Trasaul said he felt Jones was threatening to hurt/kill his dog, and this pissed him off, so they pulled back into the driveway. Jones had gone inside, so he went in the house to confront him, and Jones had a revolver in his hand and was talked about "blow" you down (meaning fighting).

Trasaul said they were in the living room arguing, yelling, and Jones had the gun pointed down, but then he raised it. Trasaul said my "instincts took over" and he dove right in to try to get the gun. As he did this, he heard the first shot, then the second shot, then a third shot, and he felt the pain in his stomach, and fell to the floor. He said Victoria tried to help him, and Jones went into his room, changed his clothes, and left without rendering aid or checking on him.

Trasaul thinks that when he lunged at Jones, he grabbed Jones hand with the gun in it, but he never got control of the weapon. He felt that Jones intentionally shot him. Trasaul said he was not afraid when Jones threatened him or shot him.

Trasaul said the next day Victoria came to visit him at the hospital and told him that she thought her thigh was grazed by the second bullet, leaving a minor mark on her leg.

Trasaul said he believed he had broken ribs and some issues with his liver from being shot.

The bullet was still in Trasual and visible bulging on his side.

On September 10, 2025, your Affiant contacted Victoria. She said as she left the scene, she realized that her right leg had been grazed by a bullet. She was wearing shorts and noticed a swollen red mark on her upper right thigh. She did not tell any officers about this. She said there was no damage or marks on her clothing. She said the swelling had gone down and she agreed to send your Affiant a photo of her injury.

On September 10, 2025, your Affiant contacted Cyrus Jones. He agreed to send the recording of the phone call between him and Jones. Your Affiant sent him an Axon link, and Cyrus sent it in. The recording was a video showing the screen of his phone from Your Affiant listened to the call, and the male voice that Cyrus identified as Jones said, "You listening, alright. Look, I only, I only grazed that nigger. He all right. He gonna be all right. Cyrus replied, "Do you know that's attempted murder?" and Jones said. "Nope, it's below the hip."

Jones was convicted of Domestic Battery -bodily harm on March 31, 2025, in the Municipal Court of the City of Wichita Jones was also convicted of Criminal Threat, Intentional, a level 9 person felony, contrary to K.S.A. 21-5415(a)(1)(c)(1), on June 17, 2021, in the 18th Judicial District Court, Sedgwick County, Kansas, in case number 21CR358.
