#### **COUNT I**

# **SEXUAL EXPLOITATION OF A CHILD**

K.S.A.: 21-5510(a)(1) & (b)(1)(B) Felony; a severity Level 3 Felony

That on or between January 1 and March 24, 2025, in Reno County, Kansas, **RYAN JAMES STOECKLEIN** promoted a performance that included sexually explicit conduct of a child under 18 years of age, to wit: JMFG, DOB (xx/xx/2007), **a severity level 3 person felony.** 

#### **COUNT II**

### ATTEMPTED UNLAWFUL SEXUAL RELATIONS

K.S.A.: 21-5512(a)(9) & (b)(2) and 21-5504

Felony; a severity Level 7 Felony

That on or between January 1 and March 24, 2025, in Reno County, Kansas, **RYAN JAMES STOECKLEIN** did unlawfully and feloniously attempt to engage in consensual sexual intercourse and lewd fondling or touching with a person who was a student enrolled at the school where the offender was employed, to wit: Nickerson High School, who was 16 or more years of age, to-wit: JMFG (DOB: xx/xx/2007), and who was not married to the offender, while the offender was a teacher or other person in a position of authority, by completing an overt act towards the perpetration of the crime, done by a person who intended to commit such crime but failed in the perpetration thereof or was prevented or intercepted in executing such crime, a severity level 7 person felony.
