I, Skyler Boatright #2340 of lawful age, being first duly sworn on oath, depose and state:

Your Affiant is a detective with the Wichita Police Department, and in that capacity assisted in the follow-up investigation of Wichita Police Department case 25C090950. This incident occurred on May 25, 2025, in Wichita, Sedgwick County, Kansas. Your Affiant has learned the following information:

On May 25, 2025, at 0428 hours, Officer Kinder #2883 and Sgt. Thatcher #2070 were dispatched to a shooting call located at S. Laura. The calling party, Thomas Criscenzo (W/M, 57), told Sedgwick County Emergency Communications there was a female shot in the head. He said the female was Naomi Oglesby (W/F, 20), and she was the girlfriend of his son, Matthew Criscenzo (W/M, 19).

Sgt. Thatcher arrived on scene and entered the front door of the residence. He observed Naomi lying on the ground in the living room. Naomi was in a pool of blood and suffering from a gunshot wound to the head. Matthew was on the ground next to Naomi and was attempting to give Naomi mouth to mouth resuscitation. Sgt. Thatcher pulled Matthew away from Naomi and walked him to Officer Kinder. Matthew made a spontaneous statement, "I can't believe I did this, just fucking kill me." He continued talking and said, "I didn't want to, I didn't mean to, I just didn't want her to go and I thought she was gonna leave me." Officer Kinder walked Matthew to a police vehicle and Matthew continued making spontaneous statements including, "it all went to shit because I got drunk and she just wanted me to stop and I didn't want her to go" and "she loved me and I killed her". As Officer Kinder was trying to place Matthew in the back of the police vehicle he said, "I didn't think I really shot her and then my dad took the gun from me." Officer Kinder continued to monitor Matthew who made the unsolicited statement, "I shot her. I shot her. I didn't want her to go. I didn't think my finger was on the trigger and then she pushed me away and it went off and it shot her in the head."

Naomi was transported to Wesley Medical Center by Sedgwick County Medic 33. Naomi was approximately 37 weeks pregnant. The baby, a female, was delivered by medical staff via an emergency c-section at 0502 hours and was alive. The baby started having seizures and was intubated. Subsequent testing showed that the baby had severe brain trauma due to a lack of oxygen. Naomi was pronounced deceased by Dr. Christina Nicholas at 0504 hours.

Sgt. Thatcher observed a Glock 22 .40 caliber semi-auto handgun with serial number CBGE208 on the front porch of the residence. He also observed an extended firearm magazine on a couch in the living room, two gun boxes in a bedroom, and a holster in a bedroom.

Officer Kinder sat with Matthew in his patrol vehicle. Matthew continued to make multiple spontaneous statements including: "I can't believe I shot her", "I can't believe I pulled the trigger", and "she wanted to leave, I should have let her leave".

Officer Myles #2752 interviewed Thomas on scene. Thomas said he returned home from work at around 0315 hours. When he arrived home, he did not believe Matthew and Naomi were there. He explained that Matthew and Naomi did not live with him all the time but came over and stayed the night frequently. He said he was baking a cheesecake and went to his bedroom after putting it in the oven. A few minutes after getting into his bedroom he heard a gunshot right outside his bedroom. He opened his bedroom door and saw Naomi lying on the ground. He said Matthew was standing over Naomi and Matthew had a gun in his hand. He took the gun from Matthew and heard Matthew say, "what did I do". Thomas put the gun on the front porch and called 911.

Detective Vandermolen #2230 conducted a secondary interview with Thomas at the city building. He said when he returned home from work Matthew and Naomi were not there. He said Matthew has another child with a different woman. When Matthew has that child, he and Naomi will typically stay with him. Thomas texted Matthew around 0247 hours to let him know he was home. He thought he heard the front door open around 0250 hours. Matthew came inside and Naomi followed shortly after. Matthew and Naomi went into their bedroom and Thomas went into the kitchen. He said Naomi came into the kitchen and started making food for Matthew in the air fryer. Thomas went outside to smoke and could hear Matthew and Naomi talking, but did not believe they were arguing.

Thomas said after he was done smoking, he returned to his bedroom. After a few minutes, he heard a loud "pop". He opened his bedroom door and saw Naomi lying on the ground. Matthew was standing near Naomi and Thomas asked him what happened. He said Matthew was whimpering and said something to the effect of "I killed my baby". Thomas said he wasn't sure if Matthew had the gun in his hand when he opened the door, and it was possibly on the ground. At some point he saw the gun in Matthew's hand, and he knew he needed to get it away from him. He took the gun and put it on the front porch. Thomas called 911 and went back inside. He said there was so much blood, and he tried to get towels to clean it up.

Matthew was placed into an interview room at the city building. While sitting in the room by himself he continued to make spontaneous statements out loud. He said, "This is not real. I just shot her. I told her to go. She didn't want to go. I forced her to go and then I changed my mind and I shot her on accident and she pushed the gun away. Why did I do that though? Why did I even have my finger on the trigger? I know finger discipline." Another statement he said was, "why did I even have my finger on the trigger? Why would I do that? Why, why, why? Why would it go off? Why would I pull the trigger?" He continued to talk out loud and said "I really shot her. This isn't a bad dream I'm gonna wake up from."

Matthew was still in the room by himself and made the following statement out loud, "I don't even know what all happened, bro. I'm trying to think why did I do that? She grabbed the PS5 controller and turned it off and told me that she was going. So I got all of her shit ready for

her. And then, and then she walked out and all her stuff was right there, all of her clothes and everything. And I told her to stop. And then, and then I pointed my gun at her and she swatted it and it went off. And I didn't even think it shot her, I thought that it like grazed her. Oh my god, I know I shot her."

Your Affiant and Detective Vandermolen attempted to interview Matthew, but he declined to make a post Miranda statement. While Matthew was sitting in the interview room after the detectives walked out, he said, "I wanna go home with Naenae and I killed her. I killed her."

Detective Toman #2265 obtained a search warrant for S. Laura. CSI Chitwood V1319 processed the residence. Inside the residence she located a spent .40 caliber cartridge casing in the living room, two live .40 caliber rounds, an extended firearm magazine on the couch, and three gun cases in Matthew's bedroom.

On May 25, 2025, your Affiant received the provisional anatomic diagnoses from the Sedgwick County Regional Forensic Science Center, which had been composed by Dr. Timothy Gorrill. After completing a full post-mortem examination, Dr. Gorrill listed the cause of death as "gunshot wound to the head", the manner of death as "pending investigation", and listed the following preliminary findings:

- Gunshot wound to the head
- · Entrance-Right front-temporal scalp
- Path- Right parietal bone, right cerebrum, and left parietal bone
- · Exit- left front parietal scalp
- Range- close/near contact
- · Direction- left and up

Your Affiant observed the scene at S. Laura. There was blood splatter located along the living room wall near where Naomi was located. The blood splatter was low to the ground indicating that Naomi's head was near the ground when she was shot. The fired round exited the top of Naomi's head and struck a cat food bowl on the ground in the kitchen. The round struck the bowl approximately one inch above the floor.

On May 25, 2025, your Affiant contacted Ashley Stewart (W/F, 27), a sister of Naomi's. Ashley said she knew this was going to happen because Matthew was violent towards Naomi in the past. She said on September 22, 2024, Naomi sent her a picture of her face with bruises. Ashley called Naomi and asked her what happened. Naomi told her Matthew was violent towards her and the bruises were not a big deal.

On May 26, 2025, your Affiant contacted Mallory Baima (W/F, 36), one of Naomi's friends. Mallory said approximately one week ago there was an incident between Naomi and Matthew at Matthew's dad's house on Laura. Naomi told Mallory the following: Matthew was drunk and high. He wanted her to cuddle with him. Naomi didn't want to be around him while he was intoxicated so she said she was going to leave. Matthew grabbed Naomi and bit her on the hand. Then he pulled out a gun and told Naomi he was going to "fucking" kill her. Naomi said

Matthew pulled the trigger on the gun, but it was not loaded. Naomi said she thought her life was over and she was dead right there.

After Naomi told Mallory that account, Mallory told her that she needed to leave Matthew or he was going to kill her. She said Naomi has told her about multiple times when Matthew bit Naomi during arguments and that he had pulled a gun on her more times in the past. She estimated there were ten to fifteen incidents that Naomi told her about. Mallory said Matthew was "unstable" but more so when he was drunk or high.

Mallory said the on May 25, 2025 at 0419 hours she received a text message from Naomi asking if she could come over to her house. Mallory didn't see the message immediately and text her back several minutes later. When Naomi didn't respond to Mallory's reply, Mallory text again and said something to the effect of "you guys must be fighting again, I'm coming to get you."

On May 27, 2025, you Affiant contacted Marquez Keeve (B/M 20), a friend of Naomi's. Marquez said he had known Naomi since 6th grade and she was basically his "sister". He knew Matthew through Naomi. He said there were "a lot of physical incidents between Matthew and Naomi". He said Naomi told him that Matthew had bitten her and waved a gun in her face in the past. He told me about an incident when Marquez and Naomi were hanging out in her apartment and Matthew "barged" in and waved a gun around saying he was going to shoot Marquez and Naomi. Marquez said they did not make a police report about the incident. He believed the incident took place around the time Naomi had their first child.

On May 27, 2025, Detective Halls #2180 conducted a test fire and function test of the Make: Glock; Model: 22; Caliber: .40, serial number: CBGE208, to obtain two shell casings to be submitted through the N.I.B.I.N. system. Detective Halls advised the firearm fired and functioned as an operational firearm.
