INFORMATION

DARRIN C. DEVINNEY, a duly elected or appointed, qualified and acting County Attorney or Assistant of said County, and for and on behalf of the said State, being first duly sworn on oath, gives the court to understand and be informed:

COUNT ONE

On or about the 5th day of June, 2023 in Butler County, Kansas, **Joseph Shane Schroer** did recklessly cause or permit a child under the age of eighteen (18) years, to wit: V.B.S., YOB: 2016, to be placed in a situation in which the child's life, body or health is endangered; in violation of **K.S.A. 21-5601(b)(1);(c)(2)(A) ~ Aggravated Endangering a Child, a Level 9 Person Felony.**

COUNT TWO

On or about the 14th day of June, 2023 in Butler County, Kansas, **Joseph Shane Schroer** did recklessly cause or permit a child under the age of eighteen (18) years, to wit: V.B.S., YOB: 2016, to be placed in a situation in which the child's life, body or health is endangered; in violation of **K.S.A. 21-5601(b)(1);(c)(2)(A) ~ Aggravated Endangering a Child, a Level 9 Person Felony.**

COUNT THREE

On or about the 1st day of December, 2020 through the 20th day of September, 2024 in Butler County, Kansas, **Joseph Shane Schroer** did unlawfully make, generate, distribute or draw, or cause to be made, generated, distributed or drawn, a written instrument, electronic data, or entry in a book of accounts, with knowledge that such information falsely states or represents some material matter or is not what it purports to be with the intent to defraud, induce official action or obstruct the detection of a theft or felony offense; in violation of **K.S.A. 21-5824(a) ~ Making False Information, a Level 8 Non-Person Felony.**

COUNT FOUR

On or about the 1st day of December, 2020 through the 20th day of September, 2024 in Butler County, Kansas, **Joseph Shane Schroer** did with intent to defraud, make, present, submit, offer or cause to be made, presented, submitted or offered, any false or fraudulent claim for payment for any goods, service, item, facility, or accommodation for which payment may be made, in whole or in part, under the medicaid program, whether or not the claim is allowed or allowable, where the aggregate amount of payments illegally claimed is at least \$1,000 but less than \$25,000; in violation of **K.S.A. 21-5927(a)(1);(b)(1)(D) ~ Medicaid Fraud, a Level 9 Non-Person Felony.**

COUNT FIVE

On or about the 13th day of September, 2021 in Butler County, Kansas, **Joseph Shane Schroer** did conceal, destroy or materially alter evidence with the intent to prevent or hinder the apprehension or prosecution of any person; in violation of **K.S.A. 21-5904(a)(2);(b)(4)(B) ~ Interference With Law Enforcement, a Level 8 Non-Person Felony.**
