11:57 a.m.

Board and an acquaintance were seen leaving the apartment.

12:04 p.m.

Both individuals began traveling southbound on Cypress from Mt. Vernon

12:04:35 p.m.

SWAT officers pulled alongside Board near Cherry Creek Drive and Linden. Board increased speed on the scooter.

12:04:42 p.m.

After falling, Board reaches to his waistband with his right hand, pulling a loaded, .380 caliber handgun pointing it at the officer.

12:11 p.m.

Sedgwick County EMS and Wichita Fire arrive and assume patient care.

9:00 a.m.

Follow up begins on information that Benjamin David Board is located a SE Wichita apartment.

12:03 p.m.

Officers located Board and the other individual near Mount Vernon and Cypress.

12:04:11 p.m.

The two individuals separated. Board continued on the electric scooter along Cypress.

12:04:38 p.m.

SWAT officer announced "police, police, police, stop, stop, you're under arrest" as Board continued into a front yard. Board then abandoned the scooter and ran on foot a short distance where he appeared to stumble and fall to the ground.

12:04:43 p.m.

The officer fired his handgun, striking Board multiple times.

Aid rendered.

12:25 p.m.

Board is pronounced dead on scene.
