## A Bill to Propose the Required Student Fees for Fiscal Year 2026

**Summary:** Propose Required Student Fees of \$531.65 for fiscal year 2026 (academic year 2025–26).

**WHEREAS,** Title Two, Article VII, Section 4 of the Student Senate Constitution orders the Required Student Fee Review Committee to review the Required Student Fees for the Lawrence Campus and Edwards Campus annually by conducting hearings and collecting information thereon.

**WHEREAS,** The Required Student Fee Review Committee conducted these hearings on February 3–7, 2025, and completed its deliberations on February 7, 2025.

**AND WHEREAS**, This bill reflects the Required Student Fee Review Committee's proposal for the rates of each of the Required Student Fees.

**NOW, THEREFORE, BE IT ENACTED,** That the Student Senate proposes that the Required Student Fees be apportioned as follows:

**BE IT RESOLVED,** That the Student Senate —

- 1) Requests that University administration continue contributing funds to the operations of campus transit (relating to the Campus Transportation Fee Operations) to ensure that the service can operate at its pre-pandemic capacity.
- 2) Requests that the School of Journalism contribute funds to the University Daily Kansan to reflect the value that the UDK provides to its students.
- 3) Requests that University administration transfer responsibility for maintaining pool services on the Lawrence Campus away from KU Recreation Services, so the office may instead focus its funds on existing operations.
- 4) Requests that Lawrence Transit and KU Transportation Services reallocate their resources from SafeRide to bus operations, in accordance with the rates here proposed.
- 5) Requests that Lawrence Transit and KU Transportation Services study and implement programs to reduce SafeRide cancellation, which may include action on users who frequently request SafeRide service and then cancel the service or do not show up to the pickup location.

**BE IT ORDERED,** That the Chair of the Finance Council will transmit copies of this bill to University administration for review of the proposal.
