Dear Chairman Kenney, President Carter, and Chancellor Green,

I am writing to you today to express my concern over Regent Pillen's proposed resolution concerning Critical Race Theory. Attempting to limit for political reasons what material faculty can or cannot teach is a gross violation of the principles of academic freedom and a violation of the Board of Regent Bylaws.

You will also narrow our capacity for NU to recruit faculty, graduate students, post-doctoral researchers and undergraduates who want to include CRT among the frameworks they use to understand history, law and political policy, society, religion, economy, literatures, art and many other disciplines. This violates our land grant mission to serve all Nebraskans (and those we recruit from outside of the state).

For Regent Pillen and Governor Ricketts to identify one theory to be banned because of their vague claims of "Marxism" and "divisiveness" smacks up against academic rigor, as well as academic freedom. Both of their interpretations of CRT theory(ies) would garner a poor grade in my classes for undergraduates and would be a failing effort for any masters or Ph.D. level candidate. CRT theories and their precursors are tools that students and faculty have a right to examine, assess and include or exclude from their studies.

An elected Regent at NU or an appointed Chancellor or President requires having a more expansive and nuanced understanding of the role of competing ideas in higher education. That is how you protect the mission and reputation of the University of Nebraska as a land grant institution for all Nebraskans. Regent Pillen is espousing a political position that undermines NUs autonomy and academic reputation. I urge you and the Board to dismiss this resolution from the Board's consideration entirely.
