one of at least 17 victims of Dahmer. A published report says the first to die may have been a 19-year-old man and that he may have been buried at the former Dahmer home in Ohio.

Police Chief Philip Arreola said three policemen would be suspended with pay during an investigation into witnesses' reports that officers could have saved the boy and halted the series of killings in May.

"There is no doubt I am taken aback by this information," Arreola said. "This is matter of grave concern to me and the entire department."

Dahmer, 31, a convicted child molester on probation, admitted drugging, strangling and dismembering victims in his apartment, court records said.

The Milwaukee Sentinel reported in a copyright story that authorities from Summit County, Ohio, investigating the 1978 disappearance of a 19-year-old man, were told by Dahmer that he killed the man and buried the remains in the back yard of what was then the Dahmer family's home.

John Gardner, a police captain in Bath, Ohio, said a search of the 1.7-acre piece of former Dahmer property is scheduled Sunday.

"Potentially we have a crime," Gardner remarked after talking with Ohio investigators who interviewed Dahmer in Milwaukee, the newspaper said.

Two Milwaukee women said they called police after confronting Dahmer May 27 and seeing a bloody, nude Asian boy running from the Dahmer apartment house. Two officers dismissed the incident as a spat between homosexual lovers, the women said.

"This could have all been prevented. If they had listened that night, that little boy would still

be alive and all the others wouldn't be dead," said Nicole Childress, 18, one of the women who called police.

Arreola said he had confirmed the officers "had contact with the accused Jeffrey Dahmer and the victim" and will take "whatever action is warranted as soon as I have all the details" from the internal affairs probe.

The chief said there was a third officer suspended in addition to the two who the women remembered. He didn't specify the officers' roles in the incident.

Arreola also released names of two more victims — Erroll Lindsey, 19, and Curtis Straughter, 18, both of Milwaukee — found among the 11 victims in Dahmer's apartment.

The chief also said another victim from an out-of-state killing was also identified. Neither his name nor the site of the killing was released.

"At this point I would defer making any comment on that pending notification and the efforts of that jurisdiction," he said.

With the two names released Friday, police have identified nine males among the 11 mutilated bodies found in Dahmer's apartment Monday. Six were black and the others were Asian, Hispanic and white.

According to the criminal complaint, Dahmer said he boiled some victims' skulls for keeping and kept one heart in a freezer to eat later.

The former candy factor worker and soldier has been formally charged with four murders and more charges are pending, authorities said.

Probation reports and other records released Friday indicate that in the midst of his confessed killing spree, Dahmer talked about committing suicide because he had lost his job, was in debt, and faced eviction from the apartment where the bodies eventually were found.

"The client has dirty clothes, is unshaven and during the interviews was yawning as if having problems staying awake," a probation agent's report obtained by The Milwaukee Journal said.

"The client is in severe financial difficulty. He will lose his apartment the 1st of August. He talks again of suicide," the agent wrote after the July 18 meeting with Dahmer.

The bodies were found four days later.

One of Dahmer's victims, 14-year-old Konerak Sinthasomphone, the son of Laotian immigrants, disappeared May 26 on his way to soccer practice.
