On Tuesday, November 19, 2024, I was contacted by the Louisiana, Missouri Police Department Chief of Police Joshua Baker advising that one of his employee's, Detective Dayton L. Green had been issued a department service rifle, a Daniel Defense Inc., Model DDM4 and had then sold the weapon without the permission of the city for \$1,000.00 to an individual located in Bowling Green, Missouri. Chief Baker further stated that he now has the weapon in his

possession after speaking with the person who bought it. Through the investigation, it is believed that the weapon was sold on October 24, 2024 for \$1,000.00

Daylon Lawrence Greene committed the offense of Stealing, a Class D Felony by selling a Daniel Defense INC., model DDM4, serial number DDM4339314, owned by the City of Louisiana, Missouri Police Department with the purpose to deprive the City of Louisiana, Missouri Police Department either without their consent or by means of deceit or coercion and for the purpose of depriving the owner of the lawful interest therein, receives, retains, or disposes of property of another knowing that it has been stolen, or believing that it has been stolen. The weapon is valued at \$2,400.00.

Daylon Lawrence Greene committed the offense of Possession, Manufacture, Transport, Repair, or Sale of Certain Weapons Prohibited by knowingly possess, manufactures, transports, repairs, or sells: in violation of federal law: a machine gun. The Daniel Defense INC., model DDM4 is a rifle capable of firing more than one shot automatically, without manual reloading, by a single function of the trigger.

3. The probable cause is as follows:

It was reported to the Pike County Sheriff's Office that (then) Louisiana, Missouri Police Detective Daylon L. Greene's city issued patrol vehicle; Registration LAPD 3, VIN: 2C3CDXKT9JH197933; was stolen and then located approximately 2-3 blocks up the road after striking multiple city traffic signs. The Missouri State Highway Patrol responded to investigate the traffic crash portion of the incident and Deputy C. Halback of the Pike County Sheriff's Office responded for the investigation of the stolen vehicle portion.

During the course of the investigation, Louisiana Police Chief Josh Baker was informed by Witness 1 that he had observed Daylon L. Greene operating the vehicle at the time and observing him striking the stop sign, exiting the vehicle, walking around and then re-entering the vehicle and making a U-Turn and parking on the side of the road.

Daylon L. Greene made the comment that while at a residence located at 600 North Carolina Street Louisiana, Missouri, when he returned approximately 30 minutes later the patrol vehicle was gone. Daylon L. Greene said when he looked west on South Carolina Street, he observed the patrol vehicle parked at 8th and North Carolina Street.

Witness 1 stated that he drove up to Daylon L. Greene who told Witness 1 that someone had stolen his patrol vehicle. Witness 1 provided a voluntary statement to Deputy Halbach.

The investigation was in the hands of the Pike County Sheriff's Office while Daylon Greene interviewed multiple juveniles who state that they heard from other juveniles that Juvenile 1 had admitted to stealing the vehicle. Daylon Greene performed an interview with Juvenile 1 in the presence of Juvenile 1 parents and the Juvenile Office who denies that accusations and further denies stealing the vehicle.

Daylon L. Greene committed the offense of Property Damage in the First Degree by knowingly damaging a black 2018 Dodge Charger, Bearing city Louisiana Police plates: LAPD3, VIN: 2C3CDXKT9JH197933, by striking multiple city traffic signs and exceeding \$750.00 in damages to the patrol vehicle.

Daylon L. Greene committed the offense of property damage in the 2nd Degree by knowingly damaging city of Louisiana traffic signs: Stop sign and 25 MPH Speed Zone sign, estimating approximately \$273.00

Daylon L. Greene committed the offense of Leaving the scene of a Property Damage Crash by being the operator of a vehicle involved in an accident resulting in damage to property belonging to the city of Louisiana, Missouri. Knowingly damage has been
