INFORMATION

On behalf of the People of the State of Illinois, Adams County State's Attorney Todd R. Eyler charges:

COUNT 1: That from on or about the 31st day of August, 2025 through the 31st day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of AGGRAVATED BATTERY, in that he, in committing a battery, in violation of Illinois Compiled Statutes, Chapter 720, Act 5, Section 123, without legal justification and while he was in the Quincy University Gymnasium located at Quincy University, a sports venue open to the public on the date and time of the incident, located at 1800 College Avenue, Quincy, Adams County, Illinois, made physical contact of an insulting and provoking nature with [REDACTED] in that CODY L. PACK would strike [REDACTED] with his elbows and punch him in the ribs as well has to place him in a neck lock / chokehold impeding the ability of [REDACTED] to breathe, in violation of

Chapter 720, Act 5, Section 12-3.05(c) of the Illinois Compiled Statutes. (F-3) (0016104)

COINT 2: That on or about the 5th day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of INTIMIDATION in that he, with the intent to prevent [REDACTED] from reporting his acts of misconduct as a coach at Quincy University, directed a threat to [REDACTED], in that CODY L. PACK said to [REDACTED], "If I ever lose my job because of you, I will have nothing to lose and I will kill you", in violation of Illinois Compiled Statutes, Chapter 720, Act 5, Section 12-6(a)(1). (F-3/2-10 years)

COI-NT 3: That from on or about the 31st day of August, 2025 through the 31st day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of INTIMIDATION in that he, with the intent to prevent [REDACTED] from reporting his acts of misconduct as a coach at Quincy University, directed a threat to [REDACTED], in that CODY L. PACK said to [REDACTED] that if he lost his job and he couldn't provide for his kids that he would kill [REDACTED] and his family, in violation of Illinois Compiled Statutes, Chapter 720, Act 5, Section 12-6(a)(1). (F-3/2-10 years)

COUNT 4: That from on or about the 31st day of August, 2025 through the 31st day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of HATE CRIME, in that he, by reason of race or color, while committing a disorderly conduct, in violation of Illinois Compiled Statutes, Chapter 720, Act 5, Section 26-1 (a)(1), without legal justification, said to [REDACTED] "nigger you're too lazy

to be an outside slave so he would have to be an inside slave" and that "you can't be black and dumb, that's two negatives and they don't make a positive", while he was on real property owned by Quincy University, that being the Quincy University Gymnasium located at Quincy University, located at 1800 College Avenue, Quincy, Adams County, Illinois, in violation of Chapter 720, Act 5, Section 12-7.1 (b-5)(5) of the Illinois Compiled Statutes. (F-3)

COUNT 5: That from on or about the 31st day of August, 2025 through the 31st day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of HATE CRIME, in that he, by reason of race or color, while committing a disorderly conduct, in violation of Illinois Compiled Statutes, Chapter 720, Act 5, Section 26-1 without legal justification, stated to [REDACTED] "Do what your people do best, steal", in violation of Chapter 720, Act 5, Section 12-7.1 of the Illinois Compiled Statutes.

COUNT 6: That from on or about the 1st day of November, 2025 through the 31st day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of UNLAWFUL POSSESSION OF CONTROLLED SUBSTANCE, in that he knowingly had in his possession Adderall, a Schedule 11 controlled substance, other than as authorized in the Controlled Substances Act, in violation of Chapter 720, Act 570, Section 402(c) of the Illinois Compiled Statutes. (F-4/\$25,000) (5101110)

COUNT 7: That on or about the 5th day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of AGGRAVATED ASSAULT, in that he, in committing an assault, in violation of Illinois Compiled Statutes, Chapter 720, Act 5, Section 12-1(1), in that he, without lawful authority, knowingly shined a laser gun sight attached to a firearm towards and on [REDACTED], thereby placing [REDACTED] in reasonable apprehension of receiving a battery, in violation of Chapter 720, Act 5, Section 12-2(c)(5) of the Illinois Compiled Statutes. (F-4)

COUNT 8: That on or about the 5th day of December, 2025, at and within Adams County, Illinois, CODY L.

PACK committed the offense of POSSESSION OF FIREARM WITHOUT REQUISITE FIREARM OWNER'S I.D. CARD, in that he, knowingly possessed a handgun, that being a 1911 Kimber .45 caliber pistol, within this State, without having in his possession a Firearm Owner's identification card previously issued in his name by the Department of State Police under the provisions of the Firearms and Ammunition Act, in violation of Chapter 430, Act 65, Section 2(a)(2) of the Illinois Compiled Statutes. (M-A).

COUNT 9: That from on or about the 31st day of August, 2025 through the 31st day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of DISORDERLY CONDUCT, in that he, knowingly said to [REDACTED] "nigger you're too lazy to be an outside slave so he would have to be an inside slave" and that "you can't be black and dumb, that's two negatives and they don't make a positive", in such an unreasonable manner as to alarm or disturb [REDACTED] and to provoke a breach of the peace, in violation of Chapter 720, Act 5, Section 26-1(a)(1) of the Illinois Compiled Statutes. (M-C) (1255000) (mandatory 2 days in jail or 30 hours public service)

COUNT 10: That from on or about the 31st day of August, 2025 through the 31st day of December, 2025, at and within Adams County, Illinois, CODY L. PACK committed the offense of DISORDERLY CONDUCT, in that he, knowingly said to [REDACTED] "Do what your people do best, steal", in such an unreasonable manner as to alarm or disturb [REDACTED] and to provoke a breach of the peace, in violation of Chapter 720, Act 5, Section 26-1 (a)(1) of the Illinois Compiled Statutes. (M-C) (1255000) (mandatory 2 days in jail or 30 hours public service)




