ACKNOWLEDGMENT OF RIGHTS AND PETITION TO ENTER FELONY PLEA OF GUILTY

1. My name is Daylon L. Greene, and I am 29 years old. I completed the 12th grade in school, and I can read and write the English language.

2. I understand I am charged with the following: I. Stealing - Firearm - D Felony,

II. Unlawful possession, + transport, Manufacture, Repair or Sale of illegal weapon - D Fel.

3. These charges carry a range of punishment of:

- Class A: 10 to 30 years, or life imprisonment
- Class B: 5 to 15 years imprisonment
- Class C: 3 to 10 years imprisonment & fines up to \$10,000
- Class D: Up to 7 years imprisonment & fines up to \$10,000
- Class E: Up to 4 years & fines up to \$10,000.00

4. I have received a copy of the Information. I have read the Information and discussed it with my lawyer. My lawyer has counseled and advised me on the charge, on all lesser-included charges, if any, and on all possible defenses that I might have. I know that I may plead not guilty to any offense charged against me.

5. If I plead not guilty, I have the right to a speedy and public trial by jury, the right to see, hear, and cross examine all witnesses called to testify against me, the right to use subpoenas to compel the production of evidence or witnesses, the right to have the assistance of a lawyer at all stages of the proceedings, and the right to take the witness stand at my sole option. If I do not take the witness stand, no inference of guilt may be drawn from that decision. I know that as a part of my right to trial by jury, the State must prove my guilt beyond a reasonable doubt and the jury must be unanimous. If I plead guilty, I understand I am giving up all of these rights.

6. If I plead guilty the prosecutor has agreed to recommend the following:

1/2 Ses, 5 years MDOC, 5 years P.P., Complete Counseling & testing as required, No possession of illegal narcotics, alcohol or marijuana,

Search of home / car / person, Submit to B1B10/11 at request of p.o / LCO.
Restitution \$1000 + \$75.00 fee, 120 day HA, \$300 LefF, Pay all Court costs and fees.

7. No other officer or agent of any branch of government promised or suggested that I will receive a lighter sentence, or probation, or any other form of leniency if I plead guilty. I know that any such offer has no legal effect. I know that the Court can sentence me at its discretion within the range of punishment.

8. If I am on probation or parole, I know that by pleading guilty here my probation or parole may be revoked, and I may be required to serve time in that case, which may be consecutive to any sentence imposed upon me in this case.

9. Neither I, nor any of my friends or loved ones, has been, threatened, coerced, or forced in any manner to get me to plead guilty.

10. I am a United States citizen. If not, I understand that a plea of guilty to the crime charged may result in deportation, exclusion from admission to the United States, or denial of naturalization as a United States citizen.

11. I understand that I will be subject to lifetime supervision by probation and parole as a result of my plea of guilty to the charge(s). (Cross out if not applicable).

12. My mind is clear. I am not mentally ill, not under the influence of alcohol or drugs, and I am not under a doctor's care, except N/A.

13. The only drugs, medicines, or pills that I have taken today are N/A.

14. I understand that if my sentence includes restitution ordered by the Court that the balance shall bear interest at the rate provided by Section 408.040 of the Revised Statutes of Missouri, which is currently 9% per annum. In addition, the prosecuting attorney's office will collect an administrative handling fee in accordance with Section 559.100.3 of the Revised Statutes of Missouri which cannot exceed seventy five dollars.

15. If there is no plea agreement, I know that the sentence I will receive is solely a matter within the control of the judge. I hope to receive leniency, but I am prepared to accept any punishment permitted by law which the Court sees fit to impose. I understand that my plea of guilty cannot be withdrawn just because I do not like the sentence this Court imposes.

16. I know the Court must be satisfied there is a factual basis for the plea. I admit that the allegations in the State's Information are true. Further, I am pleading guilty because I am guilty, and I do not believe I could be found innocent by a jury. I respectfully request this Court to accept my plea.
