Affidavit Of Probable Cause For An Arrest Warrant

Indiana State Police Detective Ryan Winters, states that he believes and has good cause to believe that Trevor W. Singer committed the crimes of IC 35-42-21, Battery, a Class (B) Misdemeanor, two (2) counts, and IC 35-45-5-1.5, Public Nudity, a level (C) Misdemeanor. The belief is based on the follow:

- 1. This Affiant is a law enforcement officer with the Indiana State Police Department and has served in this capacity for eighteen (19) years. The Affiant is currently a Master Trooper Detective assigned to the Criminal Investigations Division.
- 2. The Affiant has been involved in numerous investigations to included but not limited to Police Action Shootings, Attempted Murder and Murder, Child Pornography, Child Solicitation, Child Molestation, Stalking, Intimidation and Harassment.
- 3. On July 30, 2022 The Terre Haute Police Department was dispatched to the Popular Pub. The 911 caller reported that an off-duty Terre Haute Police officer groped a female, exposed his genitals and forced a kiss on two females. The incident(s) were determined to have taken place at or near the parking lot of the Copper Bar and at or near the parking lot of Popular Pub. Both locations are in Terre Haute, Vigo County, Indiana.
- 4. The Affiant has reviewed body worn camera footage and incident reports generated by the Terre Haute Police Department. The affiant in addition conducted separate witness and victim interviews.
- 5. The suspect has been identified as Trevor Wiley Singer. Trevor Wiley Singer is a patrolman with the Terre Haute Police Department and was off-duty at the time of the incident, however he identified himself as a Police Officer to Person #1.
- 6. The Affiant learned that Trevor Wiley Singer entered the front passenger seat of Person #1's vehicle in the parking lot of the Copper Bar during the early morning hours on July 30, 2022.Person #1 was the driver, Trevor Wiley Singer was the sole passenger.

- 7. Person #1 stated that while driving from the Copper Bar to the Popular Pub, Trevor Wiley Singer placed his hand on her thigh and made stroking movements back and forth. Person #1 was wearing a skirt and the bare skin of her thigh was exposed.
- 8. Person #1 pushed Trevor Wiley Singer's hand away from her body numerous times while giving him directives to stop. Person #1 held her arm out to block Trevor Wiley Singer from touching her thigh.
- 9. Person #1 stated that while driving from the Copper Bar to the Popular Pub, Trevor Wiley Singer forcefully grabbed her face, turned her head and placed his mouth onto her face. Person #1 directed Trevor Wiley Singer to stop.
- 10. Person #1 stated that while still driving from the Copper Bar to the Popular Bar, Trevor Wiley Singer again forcefully grabbed her face, turned her head, and placed his mouth onto her face a second time. Person #1 again directed Trevor Wiley Singer to stop.
- 11. Upon arriving at the Popular Bar, Person #1 made a combination of what is estimated to be eleven (11) rapid Facetime, Voice Calls and text messages to Person #2 seeking assistance. Person #2 was inside the Popular Pub and had planned on meeting Person #1 in the parking lot outside the Popular Pub.
- 12. Person #1 stated that Trevor Wiley Singer while still seated in the front seat of her vehicle, in the parking lot of the Popular Pub, pulled down his pants and exposed his genitals. Person #1 observed his pubic hair and flaccid penis. Person #1 exited her vehicle and ran into the Popular Pub where a telephone call was made to 911.
- 13. Person #2 has been identified as working at the Popular Pub on the night of the incident.
- 14. Person #2 told the Affiant that she received approximately "15-16" rapid missed Facetime, Voice Calls and text messages from Person #1 that she deemed were urgent in nature.
- 15. Person #2 went to the parking lot of the Popular Pub to locate Person #1.
- 16. In the parking lot Person #2 approached Trevor Wiley Singer who was seated in the front passenger seat of Person #1's vehicle.

17. Person #2 confronted Trevor Wiley Singer. Trevor Wiley Singer grabbed Person #2 by the wrist and asked if could kiss her. She stated "no" and provided a reason, and attempted to pull away.

- 18. Trevor Wiley Singer pulled Person #2 towards him and forced his mouth onto her face.
- 19. Person #2 again attempted to pull away. Trevor Wiley Singer grabbed her body pulling her toward him and forced his mouth onto her face a second time.
- 20. The affiant interviewed Tyeson Mundy. Tyeson Mundy is a Patrolman with the Terre Haute Police Department and was in off-duty status as the time of the incident.
- 21. Tyeson Mundy reported that upon his arrival, he witnessed Trevor Wiley Singer "kissing" Person #2 outside Person #1's vehicle located in the parking lot of Popular Pub in Terre Haute, Vigo County, Indiana on the night of the described incident.

Affiant believes the aforementioned persons spoke from personal knowledge and observation. Wherefore, affiant requests a warrant for the arrest of **Trevor Wiley Singer** W/W/25 DOB: 5/1/1997 SSN: XXX-XX-4660 HEIGHT: 6-3 WEIGHT: 180 HAIR: Brown EYES: Blue.
