AFFIDAVIT FOR SEARCH WARRANT

THE UNDERSIGNED PERSON, BEING DULY SWORN UPON HIS OATH,
DEPOSES AND STATES AS FOLLOWS:

THAT, he has probable cause to believe that on the premises known as:

or within the curtilage thereof and the appurtenances thereunto belonging, including
outbuildings and vehicles, all within the County of Pontotoc, State of Oklahoma, there is
now being concealed certain evidence, property or items, namely:

1. Any cellular device belonging to or in the possession of CALVIN PRINCE.
2. Any desktop computer, laptop computer, or tablet belonging to or in the
possession of CALVIN PRINCE.

All of which is subject to being lawfully seized for the following criminal act (s), to wit:

1. Bribery – Title 21, Chapter 10, Section 382.

FURTHER, YOUR AFFIANT STATES, IN SUPPORT OF THIS APPLICATION AND FOR SHOWING THAT THERE IS PROBABLE CAUSE FOR THE ISSUANCE OF A SEARCH WARRANT, AS FOLLOWS:

That your affiant [REDACTED] is a duly authorized and qualified peace officer for the Oklahoma State Bureau of Investigation and has been so since February of 2013. I have been a Council on Law Enforcement Education and Training (C.L.E.E.T.) certified officer in the State of Oklahoma since December 5th, 2005. I was the supervisory investigator for the District 22 Drug & Violent Crime Task Force for 6 ½ years and previously worked as a patrol officer for the City of Ada Police Department, for 1 ½ year. In July 2008 I completed the 120-hour C.L.E.E.T Criminal Investigation Academy in Ada, Oklahoma. In July of 2014, I graduated from the OSBI 6-week Advanced Criminal Investigation Course. I have over 1600 C.L.E.E.T. continuing education hours and have obtained my Advanced Law Enforcement Certification.

PROBABLE CAUSE

I

The statements in this affidavit are based on information obtained during your Affiant's investigation. Since this affidavit is being submitted for the limited purpose of securing a search warrant, your Affiant did not include each and every fact known concerning this investigation. Your Affiant has set forth only the facts believed that are necessary to establish probable cause.

II

On November 19, 2024, [REDACTED] met with PETER BENES in reference to allegations of misconduct between the Pontotoc County Specialty Courts Administrator CALVIN PRINCE and females he supervised and/or counseled. BENES stated PRINCE had sent emails and text messages to [REDACTED] who PRINCE had counseled following a court ordered Divorcing Well Seminar she attended. The emails and text were explicit in nature and outside the professional boundaries of a counselor. BENES provided [REDACTED] with a thumb drive containing copies of those emails and text messages.

III

On November 19, 2024, [REDACTED] reviewed those text messages and emails and discovered the following:

- On January 22, 2020, PRINCE sent an email from his [REDACTED] account to [REDACTED] at [REDACTED] PRINCE emailed [REDACTED] about her participation in the Divorcing Well Seminar and welcomed her feedback.
- On November 5, 2023, [REDACTED] responded to the email with her thoughts on the seminar and her prior meetings with PRINCE through his involvement with drug court reviewing her previous felony charges. From there, PRINCE asked [REDACTED] numerous questions about her past and present situations. PRINCE told [REDACTED] he used to be on the Department of Corrections board of directors and

currently on the Pardon and Parole Board. Through these communications, [REDACTED] relayed to PRINCE that she was trying to get into counseling with [REDACTED] but she was booked up until 2024.

- On November 6, 2023, at 2021 hours, PRINCE stated "Would you be interested in letting me be your counselor until [REDACTED] is available?"
- On November 6, 2023, at 2049 [REDACTED] responded, "Would love that! You sure you're up to it?"
- On November 6, 2023, at 2054, PRINCE replied "Yes I am but you have to be COMPLETELY OPEN with me. I gotta know everything about you. Are you up for that?"
- On November 6, 2023, at 2049 hours, [REDACTED] replied, "That's fine, I am a very open person."

IV

[REDACTED] and PRINCE continued a daily dialogue through text and email about topics such as their daily work, [REDACTED] personal relationship with her ex-husband, and her mental health issues. (NOTE: PRINCE utilized phone number [REDACTED] to communicate with [REDACTED]. A records check confirmed this phone number was registered to PRINCE. It is known through the investigation; this number is the same number PRINCE uses as his personal cell phone number.) On November 8, 2023, at 1826 hours, PRINCE emailed [REDACTED] and stated "So give me a list of things you would change & how about your appearance." [REDACTED] sent PRINCE a list of eight things about herself to include her hair, teeth, skin, weight, and clothes that she would like to change. [REDACTED] number 3 on the list stated "I like all of my private parts so nothing to change there." This began a conversation about [REDACTED] private areas (breast, vagina, and buttocks) which prompted PRINCE to ask [REDACTED] to describe those areas and what she like about them. PRINCE relayed to [REDACTED] it was important to discuss her body in order to learn more about herself and her own beauty.

V

On November 9, 2023, at 1332 hours, PRINCE text [REDACTED] and stated he had availability on November 15, 2023, at 1730, at the Pontotoc County Drug Court Office, if [REDACTED] wanted to come in for a session. [REDACTED] agreed. (NOTE: On November 26 and 27, 2024, DEAN interviewed [REDACTED] about the emails and text messages between her and PRINCE. During this interview, [REDACTED] stated she had attended the session at PRINCE'S office. When she arrived at the office, the front door was locked, all the lights were off, except for PRINCE'S office. PRINCE came to the front door, unlocked it, and let [REDACTED] in. [REDACTED] and PRINCE went to PRINCE'S office where they discussed issues [REDACTED] was having with her mental health and problems with her ex-husband. [REDACTED] thought it was odd that PRINCE was not taking any notes about the session. At the end of the session, PRINCE stated he had a different approach and out of the box ideas. PRINCE asked [REDACTED] to get undressed so that he could point out areas of her body that he liked in order to build [REDACTED] confidence. [REDACTED] declined and stated she was not ready or comfortable enough yet to do so. This concluded the counseling session for that night.)

VI

On November 21, 2023, at 0039 hours, PRINCE sent [REDACTED] an email that included the statement "I wouldn't mind seeing your entire natural face & natural body." At 0059 hours, [REDACTED] emailed PRINCE a photo of her face. PRINCE replied, "Yea natural look is good on you as well [REDACTED] Natural body?" At 0118 hours, [REDACTED] emailed PRINCE three nude images of herself. At 1029 hours, PRINCE emailed [REDACTED] back and commented on the nude images which included the statement, "I couldn't tell if you were shaved or trimmed or what your [REDACTED] looked like. Maybe you didn't want me to see that part." At about 1059 hours, PRINCE and [REDACTED] began communicating through text messages. The topic of the messages was [REDACTED] potential career possibilities such as being a welder, firefighter, and nursing. [REDACTED] discussed the need for a pardon in order to obtain any of these career options. Along with the discussion of [REDACTED] career path, [REDACTED] and PRINCE also discussed [REDACTED] pubic hair.

VII

On November 22, 2023, at 1359 hours, [REDACTED] asked PRINCE if he thought a pardon was even a realistic expectation. [REDACTED] then told PRINCE her pubic hair was black and how often she shaves. PRINCE responded by saying, "Black?? Really? Not what I expected. I would like to see it [REDACTED]. Dark hair on white girls is gorgeous." "A pardon is absolutely possible for you!!! I'm looking up your record now. I'm here at my office alone you should stop by." [REDACTED] provided PRINCE with her legal name and the charges she had been convicted of. [REDACTED] made up an excuse of not being able to stop by PRINCE'S office because she knew if she did, he would have expected to see her naked or have sex with her. (NOTE: PRINCE'S office is in the Pontotoc County Drug Court building located at 310 S. Townsend, Ada, Pontotoc County, Oklahoma.)

NOTE: Please see attached exhibit, ATTACHMENT A, for complete context of the pardon conversation.

VIII

During the course of reviewing the emails and text messages between [REDACTED] and PRINCE, PRINCE speaks about communicating through email after hours when he is at his house. Specifically on November 21, 2023, at 2314 hours, [REDACTED] text PRINCE to see if he made it home. PRINCE replies "10 minutes out." PRINCE instructs [REDACTED] to keep chatting on email until bed.

A records check indicated PRINCE'S home address is [REDACTED], Pontotoc County, Oklahoma.

CONCLUSION:

It is the belief of your affiant, that PRINCE'S position on the Oklahoma Pardon and Parole Board qualifies as being a public officer as it pertains to the Bribery statute. I believe in [REDACTED] talking about getting a pardon on her crimes followed by PRINCE asking to see her pubic hair as well as stopping by his office after hours while he is alone insinuates a sexual request in return for assistance with a pardon. [REDACTED] had

previously visited PRINCE in his office, alone, after hours for a counseling session in which PRINCE requested [REDACTED] to remove her clothes, this time it was asked during the same message in which PRINCE states, "A pardon is absolutely possible for you!!!"

Based on your Affiant's investigation and experience it is the opinion of your affiant that the aforesaid evidence, items, or property conceals evidence of Bribery, Title 21, Ch. 10, Sec. 382 on the above-mentioned cellular device(s) and/or computer(s) and is located at the above-described residence.
