High School, engage in sexual intercourse with DW, hereafter styled the complainant, a person who was enrolled in Rockport-Fulton High School.

COUNT THREE

The duly organized Grand Jury of Aransas County, Texas, presents in the District Court of Aransas County, Texas, that hereinafter referred to as Defendant, on or about the 5th day of May 2025, in said County and State and anterior to the presentment of this Indictment, did then and there, while the defendant was an employee of a public school, namely Rockport-Fulton High School, engage in sexual contact with DW, hereafter styled the complainant, a person who was enrolled in Rockport-Fulton High School by touching the genitals of the complainant with his hand and with the intent to arouse or gratify the sexual desire of the defendant or complainant.

COUNT FOUR

The duly organized Grand Jury of Aransas County, Texas, presents in the District Court of Aransas County, Texas, that hereinafter referred to as Defendant, on or about the 10th day of September 2025, in said County and State and anterior to the presentment of this Indictment, did then and there, while the defendant was an employee of a public school, namely Rockport-Fulton High School, engage in sexual contact with DW, hereafter styled the complainant, a person who was enrolled in Rockport-Fulton High School by touching the breast of the complainant and with the intent to arouse or gratify the sexual desire of the defendant or complainant.
