

CLIP 2 – 911 CALLER TO MOBILE PD DISPATCH

- 1 MPD recording begins:
- 2 MPD Dispatch: Mobile Police dispatch operator 21
- 3 MC Dispatch: This is 911 transferring a caller at 5413 Carol Plantation Rd., apar - Lot 33.
- 4 MPD Dispatch: Okay, yes sir.
- 5 911 Caller: Yes ma'am, I had somebody uh, in the yard, trying to get into my yard and stuff and I come
6 outside and caught him and uh he went up the road, uh hollering and cussing and I told him you know I
7 told him how it was. Come on back and uh, and I'm not putting up with it here.
- 8 MPD Dispatch: Right, so he is no longer there?
- 9 911 Caller: No, he walked up the road up there, to it looked like trailer 27, but uh, ma'am he, that's a
10 mistake he made coming in this yard.
- 11 MPD Dispatch: Right. (long pause) Did he take anything?
- 12 911 Caller: (talking to someone in the background and then answers dispatch) uh, no ma'am. Not that I
13 can tell. Uh the dogs alerted me, uh, the one in the bedroom uh started bar...well the one in the living
14 room started barking and the one in the bedroom told me someone was outside. So, I uh got my
15 flashlight well I didn't have my flashlight at the moment. I opened up the door and there he was in front
16 of me and I said hey, what you doing? It's that skinny black dude, a thin one, yeah. He's homeless, they
17 squattin over here on some property, it's a mess over here ma'am. I'm not going to live over here much
18 longer, these people over here.
- 19 MPD Dispatch: Yes, sir, I'll let the officers know.
- 20 911 Caller: Yes, ma'am.
- 21 MPD Dispatch: We'll get them out there as soon as possible, okay?
- 22 911 Caller: Ma'am?
- 23 MPD Dispatch: I will get them out there as soon as possible, okay?
- 24 911 Caller: Alright, thank you.

26 (MPD Dispatch to officer dispatch)

27 MPD Dispatch: I need any Precinct 2 units to clear for a possible in progress 54R at Plantation mobile

28 home park. 2SAM5 do you copy the call? 205? **(54R= Residential Burglary) (2S5 – On-duty Sergeant)**

29 205: 205, I copy **(205 - On-duty Lieutenant)**

30 MPD Dispatch: 10-4. 2139 hours.

31 322: 322

32 MPD Dispatch: 322

33 322: It going to be a civil matter. You can show us 10-8-3 **(10-8-3 – Back in service, no report on previous**

34 **call)**

35 MPD Dispatch: 10-4 so far

36 322: So far. **(322 – Responding Officer)**

37 MPD Dispatch: Starting in route to signal 54 in progress at the Plantation Road Mobile Home Park 5413

38 Carol Planation Rd, 5413 Carol Plantation Road Lot 33. Complainant advised that a homeless male that

39 frequents the area, possibly attempted to break in his trailer. Will be a black male, wearing a hat, red

40 shirt, possible red pants. Subject last seen near trailer 27.

41 322: 10-4. Previous location

42 MPD Dispatch: 10-4 2146 hours.

43 322: 322, 10-23.
