- 1 MC Dispatch: Mobile County dispatch what is your location?
- 2 911 Caller: 5413 Carol Plantation Rd. Lot 33
- 3 MC Dispatch: 5413 Carol Plantation Rd. Lot 33
- 4 911 Caller: Yes ma'am
- 5 MC Dispatch: Did you need police, fire, or medical assistance for you, sir?
- 6 911 Caller: Yes, I sure need police, absolutely.
- 7 MC Dispatch: What's going on?
- 8 911 Caller: I've got uh, someone trying to get in the uh, trailer. Busted in on us, me and my girlfriend.
- 9 MC Dispatch: Somebody tried breaking into your trailer?
- 10 911 Caller: Yes, me and my girlfriend.
- 11 MC Dispatch: Do you know who this person is or is it a stranger?
- 12 911 Caller: He's a homeless guy that hangs around over here in the trailer park. He don't need to be
- 13 hanging around in my yard. My dogs alerted me and he's going to act all crazy and shit, walking down the
- 14 road. I told him to just come on back, God dammit. They not running over me in here. (unrecognizable
- 15 speech)
- 16 MC Dispatch: Give me a description is he a white male, black male, Hispanic?
- 17 911 Caller: Ma'am, he's a black male.
- 18 MC Dispatch: Do you know what color shirt he has on tonight?
- 19 911 Caller: I think it's red, a reddish shirt or his pants might be red I'm not sure. Uh, he's got a hat on.
- 20 He's going up the road.
- 21 MC Dispatch: Do you know what color hat?
- 22 911 Caller: I don't know. I can't see, it's dark.
- 23 MC Dispatch: Okay
- 24 911 Caller: Even though there's a street light right there

25 MC Dispatch: Do you know if he has any weapons on him, sir?

26 911 Caller: No ma'am, I don't know all that.

27 MC Dispatch: Okay

28 911 Caller: I just need some officers out here.

29 MC Dispatch: Okay, I'm putting the request in right now sir. What is your name?

30 911 Caller: [REDACTED] I'm a tenant here.

31 MC Dispatch: Is the last four of your phone number [REDACTED]?

32 911 Caller: Yes, ma'am.

33 MC Dispatch: I'm getting you on the line direct with the police department. Keep them updated with

34 what's happening while they are on the way, okay.

35 911 Caller: Yes, ma'am. You're not the police department?

36 MC Dispatch: I'm 911. I've given all this information to the police. I'm going to get you on the line direct

37 with their dispatch.

38 911 Caller: Alright, thank you.

39 MC Dispatch: What part of your house was he trying to break into?

40 911 Caller: Uh, he was coming in to the yard, up over the fence and the dogs uh, alerted us. I have two

41 dogs here. We have two. (He starts conversation with someone in the background) Beside the trailer

42 here.

44 MPD Dispatch: Mobile Police dispatch operator 21

45 MC Dispatch: This is 911 transferring a caller at 5413 Carol Plantation Rd., apar - Lot 33.

46 MPD Dispatch: Okay, yes sir.

47 911 Caller: Yes ma'am, I had somebody uh, in the yard, trying to get into my yard. (Mobile County
