I, Detective Sergeant Brian Salerno, an Investigator with the Osage Beach Police Department, knowing that false statements on this form are punishable by law, state that the facts contained herein are true.

- 1. I, Brian Salerno have probable cause to believe that Fernando Zell Hutchinson of Osage Beach, MO 65065 committed the following criminal offense(s).
  - 2. The facts supporting this belief are as follows;
- On 03-31-24, at approximately 2032 hours, Osage Beach Police were called to the parking lot of for a shooting victim in the parking lot.
- 4. On arrival, Officers found a subject shot in the chest who was later identified as Medical assistance began and Officers asked who shot asid didn't know. Was shot in the chest. Was able to say that was at the scene with someone named "Mike" who was later identified as said in an interview that and were at the parking lot "hanging out". Said a male subject came up to their vehicle, reached in, grabbed something, and ran away. Said and and ran after the male, North, towards apartments. Said stayed on the South side of running East, while went to the North side of chasing the male. Who was bleeding walking up from behind Southbound and told "He shot me".
- 5. The investigation identified that the scene extended from the Northwest part of their property towards the units of 12 through 16. Several shots ring out on the video. Then another male, wearing a light-colored hoodie, and dark pants, runs from the field North of the property and heads towards the units of 12 through 16. The subject falls and a distinct sound of a metallic object scraping against the cement can be heard on the tape. The subject goes into room 12. The subject leaves room 12 and goes into room 15.
  - 6. Dispatch received a phone call from the of Fernando Hutchinson, who said was involved in a shooting, asking if he was in custody.
- The 3 subjects from unit 12 were interviewed post-Miranda. The first interview was who said Fernando Hutchinson, and juvenile Official Cour were smoking when Fernando Hutchinson said he was going to get some weed. said they watched as Fernando Hutchinson ran from the other subjects. said they all three went to partment, which is unit 12. heard gunshots and then saw Fernando Hutchinson bursting through their door and said Fernando Hutchinson dropped a Glock-type pistol on falling down. the ground when fell. sald Fernando Hutchinson stated, got too said that made think Fernando Hutchinson shot the close to me". kicked Hutchinson and juvenile out of apartment at other that time. believed Hutchinson and went to Hutchinson's apartment, number 15.

- 15. Hutchinson has a criminal history of Burglary and Stealing a motor vehicle, on or about 03-20-23 In Camden County, but no convictions at this time. Hutchinson attempted to flee and later turned himself in on that case of Burglary and stealing MV.
