

attracted to Murawski. ██████ stated she was not. I asked ██████ what was the reason she had sex with Murawski. ██████ stated she was "Obligated" because Murawski had spent \$800 on her bond and loaded her jail account with \$250 for the last five months. I asked ██████ if Murawski ever implied or said that the sex was "Payback" for the money he had spent on her. ██████ stated every time Murawski would send her money, he told her "You're going to take care of me when you get home, right?"

9. ██████ spoke of how she and Murawski were once driving to Eldon to meet someone and she asked Murawski if ██████ would be mad if she knew he bonded her out so he could have sex with her. ██████ said Murawski responded, saying "Yeah, of course, we're never going to tell her." I repeated to ██████ what Murawski told her and asked if he acknowledged that he bonded her out for that reason. ██████ stated he admitted that was the reason. ██████ spoke of how she believed Murawski knew that she wasn't attracted to him and how he would try to make her feel guilty. ██████ said Murawski would try to get her drunk because of it. ██████ said that Murawski would try to kiss her and it was "Weird".

10. ██████ stated that she was at Murawski's condo on October 7th or 8th of 2016, and a couple police officers came by with a binder of police officer pay amounts and "Quotas". ██████ stated Murawski showed her the documents and boasted about how he could help her with criminal matters. I asked what she felt Murawski meant when he said that. ██████ stated she believed he wanted to show her how much "Power" he had in his position. ██████ indicated that Murawski was implying that if she had sex with him he could use his position in Lake Ozark government to help her in the areas of law enforcement and legal matters.

11. I asked ██████ about other girls that Murawski may have had around while she was with him. ██████ spoke of a black girl named ██████ that lived with him for a short time. ██████ said that Murawski told her he did "Pretty much the same thing with her that he did with me". It should be noted that Murawski was likely speaking of a 16-year-old Columbia prostitute by the name of ██████, who was named in a 2016 interview the FBI had with Murawski. In this interview, Murawski admits to having contacted ██████ on Craigslist and paying for sex with her in August or September of 2015. Murawski admitted his contact and the sexual meeting with ██████ was an appointment for prostitution. ██████ said she spoke with ██████ on the phone after learning that Murawski had kicked her out of his condo so he could move ██████ in after she was released from jail ██████. It should be noted ██████ was provided a phone paid for and on the phone plan of Murawski at the time of his 2016 interview with the FBI. ██████ said ██████ was living in St. Louis and was homeless, needing money. ██████ stated she and Murawski sent some money through the post office to ██████. I asked ██████ what Murawski meant when he said that he had done the same thing with ██████ as he had with her. ██████ explained Murawski provided money and items to ██████ in exchange for sexual favors.
