<small>On the people of the state of Missouri to amend Article VIII of the Missouri Constitution as passed by the general assembly in 2017, which article as a condition of enactment be forth hereinafter in a 2018 proposition submitted at general elections of June 11 or as provided herein, vote any act which violates employee rights legal and collective, also legal remedies for anyone injured as a result of another person violating or intending to violate employee rights, and which shall not apply to union agreements entered into before the effective date of Senate Bill 107</small>
