*On this 17th day December, 2019, the Grand Jury of the Parish of Livingston, State of Louisiana,
charges that in the Parish, District, and State aforesaid:*

DENNIS WALLACE PERKINS
COMMITTED THE FOLLOWING OFFENSES:

COUNT 1

On or about April 5, 2019, the defendant committed **FIRST DEGREE RAPE**, in violation of Louisiana Revised Statute Title 14:42(A)(4) and (A)(5), in that he engaged in oral sexual intercourse with Juvenile Victim 1, a child under the age of thirteen, by forcing the mouth of the victim onto the genitals of the offender, with the assistance of **CYNTHIA THOMPSON PERKINS**, without lawful consent of the victim, and whereby two or more offenders participated in the act.

COUNT 2

Between May 20, 2019 and May 21, 2019, the defendant committed **FIRST DEGREE RAPE**, in violation of Louisiana Revised Statute Title 14:42(A)(4) and (A)(5), in that he engaged in vaginal sexual intercourse with Juvenile Victim 1, a child under the age of thirteen, with the assistance of **CYNTHIA THOMPSON PERKINS**, without lawful consent of the victim, and whereby two or more offenders participated in the act.

COUNT 3

On or about June 20, 2019, the defendant committed **ATTEMPTED FIRST DEGREE RAPE**, in violation of Louisiana Revised Statute Title 14:27 and 14:42(A)(4) and (A)(5), in that, having the specific intent to commit the crime of First Degree Rape, with the assistance of **CYNTHIA THOMPSON PERKINS**, by means of vaginal sexual intercourse with Juvenile Victim 1, a child under the age of thirteen, without lawful consent of the victim, and where two or more perpetrators participated in the act, he performed an act for the purpose of, and tending directly toward the accomplishing of his object.

COUNT 4

On or about April 3, 2019, the defendant committed **FIRST DEGREE RAPE**, in violation of Louisiana Revised Statute Title 14:42(A)(4), in that he engaged in oral sexual intercourse with Juvenile Victim 1, a child under the age of thirteen, by touching the genitals of the offender upon the mouth or tongue of the victim and without the lawful consent of the victim.

COUNT 5

On or about May 21, 2019, the defendant committed **SEXUAL BATTERY OF A CHILD UNDER 13**, in violation of Louisiana Revised Statute Title 14:43.1(C)(2), in that he engaged in the intentional touching of the genitals of the offender by the victim whereby the defendant, with the assistance of **CYNTHIA THOMPSON PERKINS**, forced the hand of Juvenile Victim 1, a child under the age of thirteen, to touch the defendant's penis while he engaged in vaginal intercourse with **CYNTHIA THOMPSON PERKINS**, when both offenders are seventeen years of age or older.

COUNT 6

On or about May 21, 2019, the defendant committed **SEXUAL BATTERY OF A CHILD UNDER 13**, in violation of Louisiana Revised Statute Title 14:43.1(C)(2), in that he engaged in the intentional touching of the genitals of Juvenile Victim 1, a child under the age of thirteen, whereby the defendant, with the assistance of **CYNTHIA THOMPSON PERKINS**, inserted his fingers into the genitals of Juvenile Victim 1, when both offenders are seventeen years of age or older.

COUNT 7

On or about June 20, 2019, the defendant committed **SEXUAL BATTERY OF A CHILD UNDER 13**, in violation of Louisiana Revised Statute Title 14:43.1(C)(2), in that he engaged in the intentional touching of the genitals of the offender by the victim whereby the defendant, with the

assistance of **CYNTHIA THOMPSON PERKINS**, forced the hand of Juvenile Victim 1, a child under the age of thirteen, to hold the defendant's penis when both offenders are seventeen years of age or older.

COUNT 8

On or about June 20, 2019, the defendant committed **VIDEO VOYEURISM**, in violation of Louisiana Revised Statute Title 14:283(A)(1)(a) and (B)(4), in that he used a camera, videotape, photo-optical, photo-electric, or any other image recording device, for the purpose of observing, viewing, photographing, filming, or videotaping a person, Juvenile Victim 1, a child under the age of thirteen, without the consent of the victim to the specific instance of observing, viewing, photographing, filming, or videotaping, for a lewd and lascivious purpose, and with the intention of arousing or gratifying the sexual desires of the offender.

COUNT 9

On or about April 23, 2019, the defendant committed **VIDEO VOYEURISM**, in violation of Louisiana Revised Statute Title 14:283(A)(1)(a) and (B)(4), in that he used a camera, videotape, photo-optical, photo-electric, or any other image recording device, for the purpose of observing, viewing, photographing, filming, or videotaping a person, Juvenile Victim 1, a child under the age of thirteen, without the consent of the victim to the specific instance of observing, viewing, photographing, filming, or videotaping, for a lewd and lascivious purpose, and with the intention of arousing or gratifying the sexual desires of the offender.

COUNT 10

On or about May 25, 2019, the defendant committed **FIRST DEGREE RAPE**, in violation of Louisiana Revised Statute Title 14:42(A)(5), in that he engaged in vaginal sexual intercourse with Adult Victim 1 with the assistance of **CYNTHIA THOMPSON PERKINS**, without the lawful consent of the victim, and whereby two or more offenders participated in the act.

COUNT 11

On or about May 25, 2019, the defendant committed **VIDEO VOYEURISM**, in violation of Louisiana Revised Statute Title 14:283(A)(1)(a), in that he used a camera, videotape, photo-optical, photo-electric, or any other image recording device, for the purpose of observing, viewing, photographing, filming, or videotaping a person, Adult Victim 1, without the consent of the victim to the specific instance of observing, viewing, photographing, filming, or videotaping, and for a lewd and lascivious purpose.

COUNT 12

On or about November 8, 2014, the defendant committed **FIRST DEGREE RAPE**, in violation of Louisiana Revised Statute Title 14:42(A)(5), in that he engaged in vaginal sexual intercourse with Adult Victim 2 with the assistance of an as yet unidentified adult female perpetrator, without the lawful consent of the victim, and whereby two or more offenders participated in the act.

COUNT 13

On or about November 8, 2014, the defendant committed **VIDEO VOYEURISM**, in violation of Louisiana Revised Statutes Title 14:283(A)(1)(a), in that he used a camera, videotape, photo-optical, photo-electric, or any other image recording device, for the purpose of observing, viewing, photographing, filming, or videotaping a person, Adult Victim 2, without the consent of the victim, to the specific instance of observing, viewing, photographing, filming, or videotaping, and for a lewd and lascivious purpose.

COUNT 14

Between June 1, 2019 and June 18, 2019, the defendant committed **SEXUAL ABUSE OF AN ANIMAL**, in violation of Louisiana Revised Statute Title 14:89.3(A)(1) and (A)(7), in that he knowingly and intentionally engaged in sexual contact with an animal, to wit: a dog, and filmed, distributed, or possessed pornographic images of his sexual contact with said animal.

COUNT 15

Between May 1, 2018 and February 28, 2019, the defendant committed **MINGLING OF HARMFUL SUBSTANCES**, in violation of Louisiana Revised Statute Title 14:38.1, in that he intentionally mingled a harmful substance or matter with any food or drink with the intent that the same should be taken by any human being to his or her injury by ejaculating on various pastries and into bottles of energy drinks which were subsequently ingested by unsuspecting victims.

COUNT 16

Between May 1, 2018 and March 31, 2019, the defendant committed **OBSCENITY**, in violation of Louisiana Revised Statute Title 14:106(A)(1), in that he exposed his genitals while in a vehicle, in places open to the public view, with the intent of arousing sexual desire or which appeals to prurient interest or is patently offensive.

COUNT 17

On or about May 9, 2019, and while acting in Livingston Parish, the defendant committed **PRODUCTION OF PORNOGRAPHY INVOLVING JUVENILES**, in violation of Louisiana Revised Statute Title 14:81.1(A)(1) and (E)(4)(a), in that the defendant, who is over the age of seventeen, intentionally produced an electronic visual representation of pornography involving juveniles depicting a sexual performance involving Juvenile Victim 2, a child under the age of seventeen at the time that the visual representation was created. The electronic visual representation referenced in this Count is mutually exclusive of any other visual representation charged in any other Count of this Indictment.

COUNT 18

COMMITTED THE FOLLOWING OFFENSES:


