This notice shall satisfy two separate but related procedural requirements for activities to be undertaken by the Housing Authority of the County of San Joaquin and its non-profit subsidiary Delta Community Developers Corp. First being the Notice of Intent (NOI) to Request Release of Funds (RROF), and then the Findings of No Significant Impact (FONSI).

REQUEST FOR RELEASE OF FUNDS
The City of Stockton will submit a NOI for the RROF 15-days after the public notice, or the next working day (August 7, 2020) to the HUD Field Office for the release of Community Development Block Grant (CDBG) and Project-based Vouchers (PBVs) under Title 1 of the Housing and Community Development Act of 1974, as amended, and public housing program funds under the Housing Act of 1937, to fund local community development activities with the stated goal of providing affordable housing, anti-poverty programs and infrastructure development, to undertake a project located at 2000 Sutter Street, for the purpose of constructing one (1) 3-bedroom residential detached unit and one (1) 1-bedroom residential Accessory Dwelling Unit (ADU). Funding for this project will be provided utilizing (1) CDBG funds provided by the City, (2) Housing Choice Vouchers Program, Project-Based Vouchers, provided by HUD and (3) Rental Assistance provided through the Central Valley Low-income Housing Corporation (CVLIHC). Funding will also include the use of Homeless Emergency Aid Program (HEAP) funds provided through San Joaquin County. The available funding is estimated to provide approximately \$1.6 million over twenty (20) years.

The City of Stockton certifies that Janice Miller in her capacity as Assistant Director consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the Housing Authority of the County of San Joaquin to use Project-based Vouchers (PBVs).

OBJECTIONS TO RELEASE OF FUNDS
HUD will accept objections to its release of funds and the City of Stockton certification for a period of fifteen (15) days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Stockton; (b) the City of Stockton has omitted a step or failed to make a decision or finding required by HUD regulations of 24 CFR Part 58; (c) the Housing Authority of the County of San Joaquin has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality.
