The undersigned law enforcement officer being first duly sworn, states that:

Count 1: ELECTION FRAUD - VOTING BY DISQUALIFIED PERSON

The above-named defendant on or about Tuesday, April 4, 2023, in the City of Mequon, Ozaukee County, Wisconsin, did intentionally vote at an election when she did not have the necessary elector qualifications, contrary to sec. 12.13(1)(a), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

PROBABLE CAUSE:

Complainant alleges that the Mequon Police Department received an email from the Mequon Clerk indicating that Olha Voinovych had voted at the school board election on April 6, 2023 in the City of Mequon, Ozaukee County, Wisconsin. The City Clerk ran the subject through Wisconsin Department of Transportation and received information that the subject was a "temporary visitor." Detective Wegner looked at the voter registration form provided by the clerk for the last name of VOINOVYCH, OLHA, Driver License #V_____. In reviewing the voter registration application he noticed the four boxes at the top were all checked, including "Are you a citizen of the United States," the next box had "Have resided at the address provided below for at least 28 consecutive days prior to the election and do not currently intend to move," the next box stated "Will be at least 18 years old on or before Election Day," and the final box said "Are not currently serving a sentence including incarceration, parole, probation, or extended supervision for a felony conviction." The voter registration form was completed on April 4, 2023, and proof of residence, a Wisconsin Drivers License was provided showing an address in Mequon. Detective Wegner learned from Homeland Security that Voinovych is not a US citizen and is currently a citizen of the Ukraine, was illegally present in the US and has been here illegally since 2017. Voinovych is currently seeking asylum with the US government and her case is currently going through the asylum process in the Chicago Asylum Office.

Detective Wegner spoke with Voinovych together with the assistance of her daughter in law as her English as limited. When told that she may have voted illegally, the daughter in law

explained that she had filled out the voter registration form, checking the various boxes. The daughter in law is a US citizen. Voinovych admitted to voting at the election.

Complainant further alleges that all of the above state events occurred in the County of Ozaukee, State of Wisconsin.

Based on the foregoing, the complainant believes this complaint to be true and correct.
