I heard from Lynda, then my County Administrator, then my LCC chair, and finally my board chair (this morning). I think perhaps one of the middle two shared my concerns with the board chair. He said it's not meant to criticize how we handled things but to try to control "leaks" (of which I said there wasn't one, especially in August when we didn't send LCCs any info ahead of time) and to try to control the messaging. I said we could control who we send a press release to, but we can't control how journalists write their stories or who picks it up once one paper publishes something. He seemed to agree that a press release is good to avoid an open records request that might result in even worse data interpretation. He also said he didn't like that some people are trying to use our study for political gain. I think it's more that our study adds to the overall information about water quality in our state, about which, yes, some politicians and journalists definitely have an agenda.

He said our corporate counsel is working on language, so I'm guessing the draft resolution that went around will be changed quite a bit. I also asked that he keep the County Cons in the loop and allow us to provide input on the language. We'll see if that happens. I'd rather lowa County stay out of it but I guess that's up to the supervisors.

I didn't expect any issues around this study to come up until the next round of data is released! But I guess with budget time it is very much on the minds of board members, especially in Lafayette County. Any news on the SWIGG funding in your budget Terry?

Terry and all-

Here are my initial thoughts on this Resolution by the Lafayette County LCC. I have been asked by a reporter to respond, but so far have not. Below is what I'd propose to say; if any of you have other opinions please let me know ASAP. I'll address them point by point.

1. The dissemination of future test results will be limited to the Lafayette County Conservationist, the Lafayette County Land Conservation Committee Chair, and the Lafayette County Health Department. Known hereafter as the "Review Board of the Water Quality Study." They will review the tentative results, discuss issues

surrounding interpretation of the tentative results, and issue press releases when appropriate.

This point isn't workable. Because this is a multi-county study, any results we choose to release will be shared simultaneously with all three counties as well as with the press and others as appropriate. Speaking for WGNHS, we are public employees and our work is public work. We cannot choose to release some data to some parties and not to others. Our only contractual obligation at this point is to Grant County, and that obligation is to eventually release the data to Grant County. The most common practice in University research is not to release any data until after the completion of a project and the publication of a report or journal article. Such reports would be public documents not subject to any local review.

Lafayette County Land Conservation Committee members, as well as other members of the Lafayette County Board, will be informed of the study results when the public is informed.

This is exactly what we have done, and will continue to do.

 When information is made public, all Board members, committee members, county officials and county employees shall encourage members of the public including, without limitation, members of the press, to review and disseminate complete and accurate information concerning the information and the water study.

This is reasonable, and hopefully no different than current practice.

4. In the event that a conference is held to distribute results, invitations will be extended to local TV stations, radio and news outlets. The conference will do a complete review of the whole test process and the expectations for the release before any further information is given. The press will be given an official press release provided by the Review Board following any conferences that are held, which will include information from the study in its entirety.

If Lafayette county itself sponsors a conference then it is appropriate for the county to establish the game plan for that conference. However, the research team may present and/or discuss results at other conferences or meetings that Lafayette County does not control or sponsor.

5. No board member, committee member, county official or county employee is authorized to make any public statement regarding the water study without the authorization of the Review Board. Any board member, committee member, county official or county employee violating this process may be subject to discipline.

Hi Katherine,

In the past, including the Kewaunee County project, we have provided the funding entity with a table of all of the specific well results – in a list, with no identifying location data and no identifying owner information. That is what we did in Kewaunee and it is what the WGNHS has done for previous projects that involved sampling domestic wells. For the WGNHS projects we have sometimes provided a generalized map of the sampling locations, but at a scale that it is not possible to tie a specific result to a specific home.

I have been working on the proposals and budgets for the supplemental funding from DNR and also on the year 3 contract for the counties. I put one round of microbial sampling in the DNR proposal/budget. The DNR is asking for more detailed locations and we are currently negotiating on that topic.

Thanks for doing this. I am merely defending the good work of the SWIGG Committee and the joint efforts of Grant Lafayette and lowa Counties. These people deserve a chance to explain the study and the status of the study which is far from complete. It's too bad when people draw conclusions that are contrary from a well written press release- please see the press release attached. Please use this as a resource. The Dubuque Telegraph Herald was the only member of the media present at the press release. They did a very accurate report on the study. Bob Middendorf, WGLR radio also did an accurate report. There has been some good reporting done outside Milwaukee and Madison.

County Administrator Larry Bierke, County Conservationist Kathryn Abbott, or I will be more than happy to steer you in the right direction in order to get to the people who are directly involved in this ongoing study. You will be able to track the progress of the study. You might note that approximately 25 years Iowa County did a similar study and the results were very close identical to the recent phase 1 of the study. The conclusion is while the wells have not gotten worse, they have not gotten better either. Phase 3 may more closely pinpoint the reasons for the contamination.

The AP conclusions were selected from Phase 2, a narrow sampling of wells which were already identified as contaminated in phase 1. It really no surprise when wells that tested positive for contamination in phase 1 were confirmed in 32 out of the 35 wells. The wells that tested negative for contamination did not move on into phase 2 because that would be pointless to move wells clean of contamination into phase 2 of the test. Right now we are concentrating on contaminated wells only.

Someone is feeding bad information to the Journal Sentinel and the AP. This is tragic that this was sent nationwide. The AP report is 100% contaminated. Our reputation has been tarnished forever. I saw the bad article in the Chicago Tribune!

We look to you as an investigative reporter to shed the light of the truth on this matter. How we clear our reputation from this bad publicity is an unknown.

I have cc'ed Lafayette and Grant Counties and the Iowa County Land Conservation Chair, David Gollon in along with County Administrator Larry Bierke and County Conservationist Kathryn Abbott
