NARRATIVE

On August 28, 2018 at approximately 22:11, I, Officer Renner was dispatched to 211 East Walworth Street, in the City of Elkhorn, Walworth County, Wisconsin for a female that was out with her niece and she could not get her to respond.

I arrived at 211 E Walworth St and made contact at the residence and I asked the female who answered the door if she had called 911. She told me that she did not. At this time Officer Finster located the caller who was at the municipal parking lot on the 10 block of S Lincoln St. I arrived on scene at approximately 22:18. When I arrived on scene I could see Officer Finster out talking with a older female who was identified as [REDACTED] [REDACTED] [REDACTED] [REDACTED] [REDACTED] was the individual who called. Officer Finster advised me to check on the female that was located in the back seat of the vehicle parked in the lot.

I observed a vehicle parked on the south side of the lot bearing WI registration [REDACTED] The vehicle was parked on the south side of the parking lot and it was facing south. When I walked up to the drivers side of the vehicle I observed a female sitting in the back seat. The female was later identified as [REDACTED] [REDACTED] [REDACTED] She was sitting upright and her face was covered in blood. I could see a [REDACTED] above her right eye and I could also see [REDACTED]. [REDACTED] face was severely swollen. She was awake but she did not say anything. I attempted to ask her questions and she did not respond to anything that I was saying. [REDACTED] did not have any pants, socks or shoes on. She was wearing a sweatshirt that was covered in blood and vomit.

At this time Elkhorn Rescue arrived and began to prepare [REDACTED] to be transported. When rescue members were getting [REDACTED] ready to remove her from the car they attempted to open the rest of the car doors. All of the other doors to the car were locked forcing a rescue member to reach across [REDACTED] to open the rear passenger door. I went to the rear passenger side of the vehicle and was going to help rescue remover her from the car. Rescue was then able to remove her without my assistance. [REDACTED] was removed from the back seat of the car and put onto the cot and was then transported to the ambulance.

While [REDACTED] was being prepared to be transported to the hospital I called Chief Christensen and informed him of the incident. He advised me to have the vehicle towed for the collection of evidence. I then advised Officer Finster that the vehicle was going to be towed.

I arrived at [REDACTED] Medical Center where [REDACTED] was transported to. [REDACTED] was already being treated by emergency room staff. I was able to obtain a few pictures of [REDACTED] injuries while she was being treated. I also advised hospital staff to place paper bags over [REDACTED] hand to preserve any evidence. They were also asked to place any of [REDACTED] clothes into paper bags to

preserve any evidence that were on them. I asked hospital staff to contact a [REDACTED] to collect evidence from [REDACTED] body. I was told that she was going to be transported to [REDACTED] [REDACTED] for trauma treatment. They said that once she gets there they will make sure a [REDACTED] exam is conducted. I was then told that the family of [REDACTED] was in the waiting room.

I made contact with [REDACTED] family in the waiting room and I brought them into the family room that would be more private. Once they were in the family room I started asking them questions about [REDACTED] past. I mainly spoke with [REDACTED] Aunt [REDACTED]. I was told that [REDACTED] was from [REDACTED] and that she has only lived in the United States for five years. She stated that [REDACTED] works at [REDACTED] and that she went into work around 11:00 am on August 28, 2018 and that she worked until 9:00 pm on the same date. [REDACTED] stated that [REDACTED] just got a new car approximately 2 weeks prior and that last week she started driving it after she got insurance on it. [REDACTED] stated that after [REDACTED] did not come home she went to go look for her. She stated that she drove past [REDACTED] that is located on the [REDACTED] [REDACTED] [REDACTED] of the intersection of [REDACTED] [REDACTED] and [REDACTED] [REDACTED] said that as she drove past she saw a beige colored van parked in the lot that she was not familiar with seeing there. She then continued to drive to the municipal lot located less than a block north of [REDACTED] on the east side of the street.

[REDACTED] stated that she pulled into the lot and when she did she saw movement on the drives side rear door of the vehicle. She said that she saw a male then take off on foot and run away from the vehicle in a direction that would be east by the way she described it. [REDACTED] stated that it looked like the male was wearing a dark colored jacket that may be either dark blue or black. She described the male as being average height. She also described him as being thin. I asked her if that meant the he was around my height and she stated that she thinks so. I am 5'10" tall. I was also in the room with [REDACTED] uncle [REDACTED] [REDACTED] who was in the car with [REDACTED] when they found [REDACTED] [REDACTED] who did not speak English stated to [REDACTED] that he believed the man was wearing a dark t shirt with blue jeans. He also stated that he believed the man to be of darker complexion. [REDACTED] then stated she went up to [REDACTED] car and that is where she located her in the back seat. [REDACTED] did say that all the doors on the car were closed when they found her.

I asked [REDACTED] if [REDACTED] had any boyfriends or romantic relationships. She said that she did not. I asked her if [REDACTED] has ever said anything to her about employees she works with. [REDACTED] did say that [REDACTED] once said that a family member of the owner of [REDACTED] was kind of a creep. She said that [REDACTED] said he was one that "likes to look at girls butts." I asked [REDACTED] and the rest of the family if they had anything else they though I should know and they did not.

I then spoke with Mike Jessen from Elkhorn Rescue. Mike advised me that when they were treating her in the back of the ambulance that he observed what looked to be

defensive wounds on [REDACTED] hands. I asked Mike if he could write up a statement about the wounds he observed on [REDACTED] so I could attach it to my report. He stated he would.

I then collected the clothing that was removed from [REDACTED] in the emergency room and brought it back to the police department. Once I arrived back at the police department I was asked by Detective Bushey if I could go walk the area that the suspect ran through. I went back to the area and was not able to locate anything or see any foot prints in the dirt in the area where the suspect was described to have went. I did observe a house on S Jackson St that had cameras on the residence. I saw a camera on the south side of the house that was facing the area where the suspect was described to have traveled through.

I returned to the police department and advised Detective Bushey of my findings. He said that he will have someone the following day go to the residence to see if anything was captured on the camera footage.

I then went to the City of Elkhorn Department of Public Works where the car was towed to for safe keeping. I arrived there with Detective Bushey and Sergeant Croak. Detective Bushey examined the car to see if there was anything else that stood out about the car. He then popped the trunk of the vehicle and we all observed what looked to be blood in the trunk of the car. After they were done examining the car I sat with the vehicle to ensure it was not tampered with.

Sergeant Croak came to relieve me for a short time so I could go back to the police department and place the victim's clothes into the evidence dryer. I arrived back at the police department and placed the clothing that was removed from [REDACTED] into the evidence dryer in the evidence room at the police department. I first placed craft paper in the base of the unit to collect any debris that falls off the clothes. After I was done I returned to the DPW to continue to sit with the car.

Officer Termaat came to the DPW and relieved me for a short time so I could return to the police department and package and enter the evidence into our records management system. All the clothing items were placed into brown paper bags and they were sealed with evidence tape. The craft paper that was placed at the bottom of the dryer was also collected and packaged in a brown paper bag. All items were then turned over to Officer Termaat to be taken to the crime lab.

I returned to the DPW again to continue to sit with the vehicle until Officer Termaat arrived to have the vehicle transferred to the crime lab for processing.

NARRATIVE

On Tuesday, August 28, 2018 at approximately 11:20 pm I, Sergeant Croak, met with Officer Finster regarding this case. I was informed [REDACTED] was found bloody and unresponsive in her car in the municipal parking lot in the 10 blk. S. Lincoln St. Officer Finster had [REDACTED] vehicle towed by Elkhorn Collision to the DPW garage. I looked inside the vehicle and observed a pile of vomit on the rear passenger seat. There was a purse or bag next to the vomit on the seat.

I spoke with Officer Renner at LMC. Officer Renner had been talking with [REDACTED] family. I learned [REDACTED] closed at [REDACTED] at 9:00 pm and always comes straight home. I was advised [REDACTED] didn't return and her aunt came to look for her. I was advised the aunt found [REDACTED] in the car and called 911. Officer Renner advised family stated [REDACTED] wasn't dating anyone or involved romantically. Officer Renner stated the aunt saw a person running east from the car when they arrived.

I called Det. Bushey and advised of the incident. Det. Bushey stated he would come to the police department. I called the owner of [REDACTED] [REDACTED] A. [REDACTED] [REDACTED], several times but no answer. Awhile later dispatch advised [REDACTED] was calling the police department. I called [REDACTED] back and asked if [REDACTED] closed the business with anyone tonight. [REDACTED] said yes a woman named [REDACTED] I asked for a better spelling and last name. [REDACTED] stated he didn't know a last name as he was at home and the woman had only worked a couple shifts. I asked if [REDACTED] ever talked about dating anyone. [REDACTED] said no. I asked if [REDACTED] ever talked about anyone bothering her while at work. [REDACTED] said no she was very easy to get along with. I asked [REDACTED] if he had surveillance cameras at the store. [REDACTED] said yes and I asked if we could see them. [REDACTED] said he would be to the store at 7:00 am 08-30-18. [REDACTED] stated [REDACTED] is a great employee and my questions were making him nervous. I advised something happened to [REDACTED] and we are trying to gather information. [REDACTED] sounding worried, stated he hoped [REDACTED] was alright and he would be happy to help with his store video.

Det. Bushey arrived and officers briefed him on the incident. Det. Bushey and I went to the vehicle at DPW. Det. Bushey looked inside and noted blood on the interior of the rear passenger side door. Det. Bushey popped open the trunk and officers observed blood in several locations. Blood was observed on the area where the trunk lid shuts down to. Blood was also in the crease area where the trunk folds down and up. Officer Renner contacted dispatch and asked that [REDACTED] cell phone be pinged.

At approximately 3:30 am I learned from dispatch it was pinging to within 25 meters of lat/long 42.4015910,-88.3224342. According to Google maps this point on a map is on a farm off Barnard Mill Rd., Ringwood, IL. I contacted McHenry County Sheriff's Office and advised them of this incident and the phone ping. I asked that a deputy make contact at the farm and ask to search the area the phone was mapping. At approximately 4:15 am I received a call from McHenry dispatch and was advised a deputy went to the farmhouse and the elderly gentleman didn't know [REDACTED] by name. I asked if permission was given to search the area and was advised the deputy didn't try. I asked that they try again.

I spoke with McHenry County several times and learned there are three cell towers on the property. They also advised that three separate residences are on the farm property. McHenry County stated deputies checked the area and ditch lines but could not find the phone even while calling it to hear a ring.

NARRATIVE

On Tuesday, 8/28/18, at approximately 11:55 PM., I, Detective Bushey, received a call at home from Sgt. Croak. Sgt. Croak advised me of this incident. I was told the victim had been taken to [REDACTED] Hospital and was being transported from there to [REDACTED] Hospital in [REDACTED] WI. I told Sgt. Croak I would be right in. I arrived at the police department on 8/29/18 at approximately 12:15 AM. I met with Sgt. Croak and Officer Finster at the police department. Officer Renner arrived later. I was told about the injuries to the victim in the case, [REDACTED] I was told she worked at [REDACTED] located at the corner of [REDACTED] and [REDACTED] Streets in Elkhorn. I was told that she usually closes at 9:00 PM. and when she hadn't come home and didn't answer her phone her aunt, [REDACTED] went looking for [REDACTED] told officers that she saw [REDACTED] car in the city parking lot located just north of [REDACTED] told officers that when she pulled into this lot she observed a person running away from [REDACTED] car. [REDACTED] then went to look in [REDACTED] car and found her in the back seat unconscious and bleeding. [REDACTED] was [REDACTED] from the waste down. I was told [REDACTED] hands had bags placed over them to help save any possible evidence. Officer Renner advised me that he had collected [REDACTED] clothes from [REDACTED] Hospital. Officer Renner showed me some pictures. I told the officers that I knew the Harknesses who live in the ten block on S. Jackson Street, the direction the suspect ran, have a camera outside their residence. I was told [REDACTED] vehicle was towed to the city garage on N. Washington Street. I asked Officer Renner to go back to the city lot where [REDACTED] vehicle was and walk the lot and through Harkness' back yard to see if anything was dropped along the way. I then returned a call to Kathy the [REDACTED] nurse with [REDACTED]

I asked Kathy if she would be doing the [REDACTED] on [REDACTED] Kathy told me that she was allowed to only go to [REDACTED] Hospital and [REDACTED] Kathy stated she has called and left a message with her supervisor to see if she can go to [REDACTED] which is an [REDACTED] Hospital. Kathy told me that [REDACTED] doesn't have a [REDACTED] nurse or any [REDACTED] [REDACTED] I told Kathy I would pick one up from [REDACTED] Hospital and take it to [REDACTED] and meet her there. Kathy stated she would call her supervisor again and call me back. We ended the call. I then drove to the city garage with Sgt. Croak arriving there at approximately 1:25 AM. I looked at [REDACTED] black [REDACTED] It was surrounded by police tape. I had been told when the officers first arrived at the city parking for the rescue call for [REDACTED] that the only door on the vehicle that was unlocked was the back door on the drivers side which is where [REDACTED] was located. I was told the first responders unlocked the other doors. The keys to [REDACTED] car had not been located. Neither was her cell phone. As I looked at [REDACTED] car I observed it was wet from the rain. I could see on a window of the car where the sales slip used to be for the car. I had been told [REDACTED] had just recently bought this car. I opened the back door on the passengers side. I could see blood splattered on this door and the seat. I could see what looked like vomit on the seat. There

was what looked like soiled blankets on the floor on the drivers side back. Officer Finster told me those blankets were probably from the rescue squad. I did not notice any blood in the front seat area. I did press the button to open the trunk. As I opened the trunk I could see what appeared to be fresh blotter drippings on the carpeted floor of the trunk and on the black lower rubber gasket or seal. There was nothing else in the trunk. I closed the trunk. I returned another call to Kathy. Kathy stated she still hadn't heard back from her supervisor. Kathy stated she talked with Jen, a ER nurse at [REDACTED] and she advised they did have a nurse there tonight who was certified in [REDACTED] tonight but they didn't have any [REDACTED] [REDACTED] [REDACTED]. I told Kathy I would get one from [REDACTED] and start heading up there. Officer Renner stayed with [REDACTED] car. I asked Sgt. Croak to have the sheriff's office try to ping [REDACTED] phone. I then drove to the police department to pick up some equipment and then drove to [REDACTED] Hospital arriving there at approximately 2:38 AM. I received a [REDACTED] [REDACTED] [REDACTED] from security. I briefly talked with ER staff. I found out that [REDACTED] had been sedated and that she had a [REDACTED] [REDACTED] I cleared from [REDACTED] Hospital at approximately 2:43 AM. and began driving to [REDACTED] Hospital. While in route I received a call from Kathy again. Kathy advised that the nurse who was certified in [REDACTED] had a [REDACTED] [REDACTED] now but Kathy was certain that the nurse would be able to gather the evidence right away because they were taking [REDACTED] into surgery. I continued to [REDACTED] hospital arriving at approximately 3:27 AM. I met with the ER nurse Jennifer Butler and the [REDACTED] Butzine. [REDACTED] the victim, was in surgery.

Butzine advised me that she had collected evidence from the victim before she was taken into surgery. I was told [REDACTED] had a [REDACTED] and her [REDACTED] was [REDACTED] They did not know if there was any brain damage yet and [REDACTED] was not conscious. Butzine stated she collected a lot of scrapings from under [REDACTED] fingernails. Butzine stated she also observed damage inside [REDACTED] and [REDACTED] Butzine was currently drying the swabs she had used. Butzine also had blood samples which were collected from [REDACTED] I was told family members of [REDACTED] were in the family waiting room off the ER. I went and spoke with them.

[REDACTED] told me that [REDACTED] has been working at [REDACTED] for about two years. She told me she, [REDACTED] used to drive [REDACTED] to work and pick her up from work but [REDACTED] recently bought a car and now was driving herself. [REDACTED] stated [REDACTED] liked working at [REDACTED] [REDACTED] stated that the last time she talked with [REDACTED] was about a day ago. [REDACTED] did text [REDACTED] today at around 3:00 PM. when she was at work. [REDACTED] stated [REDACTED] closes [REDACTED] at 9:00 PM. [REDACTED] stated [REDACTED] is normally home from [REDACTED] about 9:15 PM. to 9:20 PM. [REDACTED] stated when she didn't arrive home last night [REDACTED] called her 11 times in a row. [REDACTED] stated she was worried and she and her older brother drove down to [REDACTED] [REDACTED] stated as they drove by [REDACTED] she saw a beige colored van parked in [REDACTED] lot which [REDACTED] stated seemed suspicious because usually there is no

[REDACTED] stated they then saw [REDACTED] car in the parking lot next to [REDACTED]. [REDACTED] stated as they pulled in she observed a person run from [REDACTED] car. I drew a rough sketch of the city parking where [REDACTED] car had been parked. I asked [REDACTED] to show me where she saw this person first that ran from [REDACTED] car and where he ran to. [REDACTED] showed me on the sketch that it appeared to her the person got out of [REDACTED] back drivers side door and ran east towards the southeast corner of the city parking lot. I thanked Butzine for all of her help. I cleared from [REDACTED] Hospital at approximately 6:22 AM. I drove back to Elkhorn. As I was driving back Sgt. Croak advised me that [REDACTED] phone had pinged to a location in Wonder lake, IL. I asked Sgt. Croak to have the dispatcher call Wonder lake and check on the location of the phone. I drove to [REDACTED] in Elkhorn on E. Geneva Street arriving at approximately 7:20AM.

I observed parked in the parking lot a beige or pearl colored Toyota Sienna van with Illinois plates. This van belonged to the owner of [REDACTED] who was now at work, [REDACTED] [REDACTED] I looked in this van from the passengers side front door window. I observed in the cup holder of this van an open plastic bottle that once contained water. The bottle was half full of an orange colored liquid substance. I observed on the drivers seat the lower right side a red color that appeared to be blood. I also observed on the cloth parts of the side of the front seat some red looking material. I had Officer Dixon join me at [REDACTED] and we went in to talk to [REDACTED] [REDACTED] was preparing food for the day. [REDACTED] had no marks on his hands or face. The Walworth County Fair had just started on Wednesday, 8/29/18, and carnival workers mostly from out of state had been arriving in Elkhorn the last few days. I called Tom Reichert, who was in charge of the security at the fair grounds. I told Reichert about the assault last night and asked him to ask his employees if anyone came in to the grounds after 10:00 PM. that was all scratched up. I also asked him to check with the boss of amusement people to see if any employee that was supposed to be there today, didn't show up for work. Reichert stated he would and we ended the call.

As of 12:30 PM. [REDACTED] had not called me back. Detective Bass and I drove out to [REDACTED] residence located at [REDACTED], just west of Elkhorn arriving there at approximately 12:37 PM. We knocked at the door and an older female came out of the residence. I asked if [REDACTED] was here. The female whom we verbally identified as Kimberly Talarek, stated no she went to work at [REDACTED] Kimberly stated [REDACTED] is her son, Taylor Talarek's girlfriend. Kimberly stated Taylor picked up [REDACTED] from work at [REDACTED] last night in his white Dodge pickup truck. Taylor was working in Illinois at this time. Kimberly gave us Taylor number. We thanked Kimberly and cleared from this residence at approximately 12:42 PM. I then drove to [REDACTED] and we met with [REDACTED] again. [REDACTED] was also there working.

[REDACTED] stated he had some information for us. One of the men portable radio in his hand. [REDACTED] confirmed it was the two men she was talking about. I asked [REDACTED] about closing last night. [REDACTED] stated she left before [REDACTED] [REDACTED] stated she asked [REDACTED] if she wanted her to wait and walk out together. [REDACTED] stated [REDACTED] told her no she could go. [REDACTED] stated she got in her boyfriend's white truck and drove out the south driveway. [REDACTED] stated because of the way her boyfriend's truck was parked by the back door when they left she could not see by it to say if there was anyone or any vehicle in the parking lot at [REDACTED] I took photographs of the two men [REDACTED] had pointed out in the video surveillance. Detective Bass and I then cleared from [REDACTED] at approximately 2:22 PM. I drove to the municipal lot located about 100 feet north of [REDACTED] Chief Christensen and Officer Kirkpatrick were there.

Chief Christensen stated they found the cell phone belonging to [REDACTED] Chief Christensen showed me where the phone was laying in the grass in the southeast corner of this parking lot. I was told that the county put in the wrong GPS coordinates last night and the phone was not in Wonder Lake like I was first told. We began in the sunlight checking for more evidence. In the parking stall directly east of where [REDACTED] car had been parked last night I located two hair ties and a black zip tie. The hair ties had black and blue beads. I photographed and collected these. I photographed and collected the cell phone. Next to the cell phone was a pink shoe string which had been tied in a knot. I also collected this. Chief Christensen located in some brush on the grass a large hammer. This hammer was located about six feet south of the parking stall that [REDACTED] car had been parked in. I photographed and collected this hammer. I noticed that the grass was green under this hammer indicating it hadn't been there long. I also photographed the parking lot. Detective Bass and I returned to the police department arriving at approximately 3:04 PM. I brought the evidence collected at the city lot into the detective office and placed each piece of evidence on a clean sheet of paper. Hernandezs stated they were home in Lake Geneva last night around 5:00 PM. and stayed home all night. This was checked by calling Hernandez Jr.'s mother and she confirmed her son was home all night. Hernandez Jr. did admit to have a disagreement with one of the workers at [REDACTED] a couple days ago but he would not harm anyone. Detective Bass and I cleared from the fair grounds at approximately 6:04 PM.

On Thursday, 8/30/18, in the afternoon hours, I sat down with [REDACTED] [REDACTED] looking at the surveillance video from the night of 8/28/18. I wanted to see if there were any photos of a van leaving that parking lot at [REDACTED] One witness,

Taylor Talarek, stated there was a maroon Chevy van with the broken window which he observed when he was there picking up [REDACTED] [REDACTED] [REDACTED] stated she saw a beige colored van in [REDACTED] lot when she was looking for [REDACTED] I viewed the video. The video cameras are only located inside the building at [REDACTED] so some things can be seen through the windows. I observed a vehicle, later to be determined to be a marked Walworth County Sheriff's Department squad, pull in the south entrance off of Geneva Street at 10:30 PM. according to the time on the camera. At 10:32 PM. I observed a full size Chevy or GMC van similar to a 2002 Chevy Express van exit this same driveway the squad had just pulled in. This van to me seemed to be beige or tan in color. As I forwarded and backed up the video you can see what looked like plastic over the back side door window on the passengers side. This van turned east on E. Geneva Street and continued east out of range of the camera.

On Friday, 8/31/18, at approximately 7:40 AM. I arrived for work and checked my emails. There was one that was forwarded to me from Chief Christensen about a crime tip that was sent in in response to a press released which was sent out yesterday which included a possible van which is of interest in this case. The release showed a picture of a maroon Chevy van with a center passengers side window broken out covered in plastic like was reported by Taylor Talarek. The crime tip had a maroon and silver 1997 Chevy Gulfstream conversion van which had a back side passengers side window covered in plastic. This van was found on facebook by the tip stir. The van was listed for sale and gave a plate of 770GVA WI. This plate comes back to a Rosa and Lewis Shults of Genoa City. These two were both born in 1938. I called Taylor Talarek and asked him to come in a look at the photo. Taylor stated the photo looked very similar to the van he saw. I asked Taylor how certain he was of the color of the van. Taylor stated pretty certain. Taylor told me that Tuesday he pulled into [REDACTED] to pick up [REDACTED] just before 9:00 PM. Taylor stated he hadn't been there to pick [REDACTED] up before so he drove south along the east entrance to the customer entrance door. Taylor stated he was blocking the door so he backed his white Dodge truck up looking in his mirrors. Taylor stated he knew there was a van behind him to he was watching to make sure he didn't back into it. Taylor stated looking in his mirror he could see the van and it looked maroon. told the desk person [REDACTED] was in intensive care and that I was there with her early Wednesday morning the day she was brought in. The desk person again stated there was no one here with that name. The desk person called security. I then met with Lee in security. I told Lee what I needed. I told Lee I know [REDACTED] is here. Lee cited HIPPA concerns. I told Lee I didn't believe that applied to law enforcement investigating a case. Lee and I went up to the second floor and I waited in a waiting area near intensive care. Lee told me he would go in and talk to a nurse in intensive care. Lee came back about ten minutes later and told me again HIPPA did not allow the hospital to give me any information. I gave Lee my card and asked him to give it to the nurse taking care of [REDACTED] I then cleared from [REDACTED] hospital at approximately 11:42 AM. I returned to the police department. Later in the day I received a call from [REDACTED] a cousin of [REDACTED]

[REDACTED] told me she was in to see [REDACTED] today at [REDACTED] Hospital. [REDACTED] stated [REDACTED] is awake and able to write. [REDACTED] stated [REDACTED] wants to know why she is in the hospital and wants to go home. [REDACTED] stated the family told [REDACTED] she was in a car accident. [REDACTED] stated the doctor was going to remove the tube out of [REDACTED] throat tomorrow. I told [REDACTED] I was at the hospital today also but was not allowed to see [REDACTED] [REDACTED] stated she was calling to let me know she worked at [REDACTED] in Elkhorn at one time with [REDACTED] [REDACTED] stated [REDACTED] never had a boyfriend either here or in [REDACTED] [REDACTED] stated there was a 22 or 23 year old white man that used to work at [REDACTED] by the name of [REDACTED] [REDACTED] who was constantly asking [REDACTED] out and she kept telling him no. This man spoke with an accent. Kyle stated this man stated he was done working with the carnies and needed to get a ride back to Texas right away. Kyle stated the man was wearing a long sleeved jacket and stated he did have a ride coming. Kyle stated the man was in his 20's, bought some coffee, and left. Kyle didn't notice any scratches on the man's face. I thanked Kyle and we ended the call.

Shortly after 7:00 PM. I received a face time call from Sgt. Croak. Sgt. Croak advised they have a van stopped to matched the one we were looking for from [REDACTED] Sgt. Croak showed my the van. It did match. Sgt. Croak stated the 18 year old female driving the van did not admit to being at [REDACTED] Tuesday night. I told Sgt. Croak I would be right in to the police department. Detective Bass was

beginning an interview with the 18 year old female. Sgt. Croak advised me that the female did admit to being at [REDACTED] Tuesday night with a man she met on Tinder. This man's first name was Gavin and he worked at the fair. Gavin had been identified as Gavin D. Hendriks from South Africa. I drove to the fairgrounds arriving there at approximately 9:05 PM. I met with one of the North American Midway (NAM) managers, Pat Repp. He had Gavin come to the NAM office. I met with Gavin, age 22. I interviewed Gavin in the office area of this trailer. Also present was Officer Person.

I told Gavin he was not under arrest. Gavin admitted to meeting a girl on Tinder. Gavin admitted to riding his bike and meeting this girl at [REDACTED] Tuesday around 6:30 PM. Gavin stated they ate there and were there 45 minutes to an hour. Gavin stated they walked across the street to the gas station. Gavin stated they bought soda and cigarettes. Gavin stated this was the first time they had met. Gavin stated they walked back to [REDACTED] and sat in her van talking for about two to three hours. Gavin stated when a squad car pulled in the girl stated they should probably leave. Gavin stated because it was raining the girl drove him back to the fair grounds. Gavin described getting dropped off at the high school gate. Gavin stated he and the girl did not kiss or have any sexual contact. I asked Gavin if he saw the employees leave [REDACTED] Gavin stated no. I asked Gavin if he heard anyone screaming or yelling while he was at [REDACTED] Gavin stated no. Gavin had no marks on his arms or face. I asked Gavin if he and the girl smoked marijuana. Gavin stated no. I told Gavin the girl admitted they had and a marijuana pipe was found in the girl's van. Gavin again repeated they had not used marijuana. Gavin stated he knows he can't use drugs or he would be sent back to south Africa. I told Gavin about a girl being assaulted just north of where he was parked with this girl. I asked Gavin if he would look around at the fair grounds amongst the fellow employees to see if any have scratches on their face or arms. Gavin stated he would. Gavin then left the trailer. I then spoke with Mark Cockerham, the Division manager of NAM.

Mark stated he wanted to know what was going on because he was in charge. I told him we were investigating a severe assault that occurred to a young woman. Mark inquired why we were talking to his employees and wondered if we were concentrating on "his" South Africans. I told Mark we were checking all leads. I told Mark we located a hammer next to the victim and this hammer is just like ones used by his employees to set up their rides. I asked Mark if he was able to determine if he was missing any of his hammers. Mark stated no employee has come to him and asked for another one. I described the hammer to Mark and he stated they have about 50 of those. Mark stated he could do an inventory and let me know if he is missing any. I asked Mark if any of his employees did not show up for work on Wednesday, opening day of the fair. Mark stated one didn't. I asked who. Mark stated John Davis. I asked where Davis is. Mark stated Davis came to the fair with three others. The other three are still working this fair so John, Mark was told, was staying at a motel. I asked Mark which hotel. Mark stated he didn't know but he would find out for me. I asked Mark for information on this John Davis. Mark went to the office where the records are kept and gave me the

information he had. I told Mark there was a black male employee that according to an off duty officer thought he was covering his arms and face while operating a ride. The off duty officer also stated this black male had a bunch of sabs on his face like he may have been covering something up on his face. Mark stated that is Jeff Tolson who has been working with him for some time. Jeff stated Tolson always covers his face with Vicks vapor rub because he has sinus issues. Mark told me that every morning they do a roll call for all of the employees in front of the office. The employees then are sent out to their work areas. Mark stated the employees start arriving at 9:30 AM. and are sent out before 10:30 AM. I thanked Mark for his information and I cleared from the NAM office trailer. I returned to the police department and placed the recorded interview I had with Gavin on the L-drive. I then had dispatch run Tolson and Davis.

Tolson had a short criminal history with a conviction for theft. Davis had a very long criminal history including arrest for theft, battery, disorderly conduct, aggravated assault, criminal trespass, burglary to a vehicle for felony theft sex motivated crime, aggravated domestic battery choke in a rude manner, and other charges. Davis also has warrants for his arrest including two from Marion County, Kansas for aggravated assault, interference with law enforcement, attempted vehicle burglary, disorderly conduct and domestic battery. These two warrants have a bond of \$20000 each however they are not entered as extraditable.

Detective Bass and I went out and checked the Thomas Motel, Hampton Inn, Crossroads Hotel, and the AMeric Inn and did not locate a John Davis registered at any of these hotels.

On Saturday, 9/1/18, at approximately 9:45 AM. I met with Pat Repp on the fair grounds. I asked Repp where Mark Cockerham was. Repp stated probably in his trailer which he directed me to. We knocked on the door and Mark came out of the trailer. I asked Mark if the employee check in had been changed to another location because it was raining. Mark stated no that it was at 11:00 AM. like it always is in front of the office trailer. I asked Mark if he found out what motel Davis was staying at. Mark called someone and then told me he is staying in Beloit at a motel. I asked why he would drive 45 minutes one to a motel when there was one in Elkhorn. Mark stated because the motel was cheaper. Mark then told me that all of his hammers are accounted for. It seemed very amazing to me that an inventory of all of the 50 hammers that Mark stated he owns were found between 9:00 PM. last night and 9:30 AM. this morning. Mark stated they would cooperate with the police. I then asked Mark if right after the do their employee roll call tomorrow at 11:00 AM. if he could ask his employees to go to a location next to the office trailer where I would have five or six officers asked his employees some brief questions and take a DNA sample from them. Mark hesitated and then stated he better talk to corporate to check on that. I told Mark we would ask for consent for the DNA sample. Mark stated he didn't want to get in trouble and would call his boss and talk with their attorneys. I gave Mark my cell phone number and asked him to call me as soon as he heard back. I then cleared from the outside area of Mark's trailer. I then met with Jim Hansen who is one of the people in charge of security at the fair grounds.

We looked at surveillance footage from the cameras at the gates to the fair grounds for the night of 8/28/18. After about an hour and a half Hansen had to leave to perform some security duties. I was not able to look at the entire time frame to see if anyone came walking into the fair grounds after 10:00 PM. on 8/28/18. Officer Rayfield was later assigned to follow up on this. I received a call from Mark Cockerham who advised me that the corporate attorneys advised that we would have to get a warrant for each employee if I wanted DNA samples for them. I thanked Mark and ended the call. I returned to the police department and called the Marion County Sheriff's office in Marion, Kansas. I asked to speak to the officer who was in charges at this time. The dispatcher stated she only had one deputy on and she would have him call me. A short time later I believe he said his name was Deputy Wilson called.

Deputy Wilson advised they do have warrants for Davis but they are entered as non-extraditable because they are a poor county. I asked Deputy Wilson to check with his sheriff to see if they want to make it extraditable as I believe we may be having contact with Davis. I also asked for a copy of the arrest report pertaining to this warrant. I gave Deputy Wilson my email address to send it to. We then ended the call. Chief Christensen and I discussed this case and updated the press release.

On Sunday, 9/2/18, at approximately 9:00 AM. I called the Marion County Sheriff's Office and spoke with Deputy Wilson again. I asked if he could send me a booking photo from their jail of John Davis. Deputy Wilson stated he would have it done. I asked if he determined which department arrested Davis so I could get their reports. Deputy Wilson stated it was the Hillsboro Police Department in Hillsboro, Kansas. I was given the number for Hillsboro Police of 620-947-3440. I called this number and eventually spoke with an Officer Huebert. I asked for the reports of the arrest for Davis. Officer Huebert did send me those reports. I read them. Davis was arrested because he was caught trying to break into someone's vehicle at their residence and when Davis was confronted by the homeowner Davis pulled a knife on the homeowner and threatened him. The other charge Davis was facing was for a domestic battery where it is reported he choked his girlfriend, Sabrina Hessel, who Davis has a child with. I later also received the booking photo of Davis. At approximately 10:55 AM. Detective Bass and I stopping in at the fair grounds.

We watched the roll call for the fair employees by the NAM office trailer. I saw about 35 to 40 employees get their assignments and leave. I did not notice any with unusual scratches. Some employees were wearing long sleeve shirts and I was not able to check their arms. I then called Mark Cockerham and he agreed to meet me at the NAM office. A short time later Detective Bass and I met with Cockerham.

I asked Cockerham what the names and information was on the three other guys that were working with and riding with Davis. Cockerham, Detective Bass and I

went in the office trailer. I was given the names of Jerid Schafers, Anthony Steinle, and Cody Simpson. Cockerham stated John Davis was on the fairgrounds today. Cockerham called someone to bring Davis to the office. A short time later Davis arrived at the office. We stepped outside at the request of Cockerham.

Davis told me that he, his wife and child were staying at Tollway Hotel in South Beloit. Davis stated on Tuesday night, they stayed at the Skylodge Hotel in Delavan. I asked why he didn't stay there which is much closer to Elkhorn than South Beloit. Davis stated they raised their rates for the weekend. Davis stated his wife's name was Sabrina L. Hessel, DOB [REDACTED]. Davis allowed me to look at his arms, face and neck. Davis had no fresh marks. Davis stated they arrived Tuesday, 8/28/18, stayed at the Skylodge until Thursday and then moved to the Tollway Hotel. Davis stated he did help set up the fair. Davis stated he had nothing to do with the assault. I did ask Davis about the warrants for he and Hessel. Davis was aware of them but stated he felt the charges would be dropped. Davis allowed me to collect his DNA using a buccal swab I swabbed the inside of Davis' mouth. I let the swab dry, placed it in an envelope and later secured it in evidence. Davis then left from the area of the office trailer. I was told that the others that work with Davis work by the Speed Pitch and bottle stand up games. Detective Bass and I went to that location and met with Cody Simpson, Anthony Steinle, and Jerid Schafers. All three told us they arrived Tuesday, helped set up and got drunk and had problems remembering anything after that. They knew as almost every other NAM employee, that we were looking into an assault that had occurred. They also stated they stayed at the Skylodge Motel and are now staying at the Tollway Hotel in South Beloit. When I asked Steinle if I could look at his hands, arms and chest. Steinle stated he got drunk in Marshfield, WI., where he was working at the fair there, and then he got beat up by the cops and put in jail. I observed several small red cuts on Steinle's knuckles of his right hand. I did not see any on his arms. Steinle's chest was slightly red just below his neck. When I asked Anthony Steinle for a DNA sample, he refused to give me one. Steinle stated his DNA was on file in Ohio from an arrest there. Detective Bass was talking with Jerid Schafers. Detective Bass stated Jerid was willing to provide a DNA sample. I collected one from Jerid. Just as I did Cockerham walked up and scolded me for doing this to the employees in front of their games. I told Cockerham I tried to collect it from Steinle behind his game but he refused. I told Cockerham that Jerid walked out to the front of the game with Detective Bass and that's why I collected it there. Cockerham asked why we were not collecting DNA from all of the employees at the Home Depot Store. I told Cockerham that even if the employees at the Home Depot Store were related to this case, they were not leaving town on Tuesday like his employees were. Cockerham then passed on to all of his employees that they were not supposed to talk to the police unless he or one of the other supervisors were present. Cockerham then left our location. We then spoke with Cody Simpson. He provided the information the others did about their arrival times, being drunk and not remembering anything. Detective Bass and I then walked away from the Speed Ball and bottle set up stands. We watched Anthony Steinle from a distance.

We observed that Steinle was drinking a bottle of Dansani water. We watched for about 40 minutes. We observed Steinle set his bottle down on I believed a speaker in front of the stand. noticed the water in the bottle was about an inch high from the bottom. I observed that Steinle had taken his NAM uniform shirt off and he and another employee walked away from the stand to the south. The bottle was left abandoned in front of the stand. With a gloved hand Detective Bass picked up this bottle and she and I left the fairgrounds and returned to the police department. I later placed the bottle in a brown paper bag, and sealed the bag and placed it in evidence. I also placed in evidence the buccal swabs from Davis, Schafers, and Mitchel Delabarre. I also called the Wood County Sheriff's Office where Marshfield is, and got a booking photo of Steinle. Marshfield Police case #18-138909, arrested on 8/26/18. Steinle bailed out on a \$100.00 cash bond.

On Monday, 9/3/18, at approximately 6:00 AM. I got a call from Officer Worland. Officer Worland advised dispatch called him and asked him to call [REDACTED] because [REDACTED] had now remembered who attacked her and a police officer may be involved. Officer Worland stated he called [REDACTED] to find out what was said. Officer Worland advised me that [REDACTED] was asking for an update on the investigation. I told Officer Worland if he found out more to let me know. At approximately 9:20 AM. I got a call from Chief Christensen who advised that [REDACTED] was now talking and was able to describe her attacker. I said I would be right in. I arrived at the police department at approximately 10:00 AM. A short time later I met with Heidi from APFV. Heidi advised she would be assisting with helping with [REDACTED]. I had to wait for Detective Bass to finish an interview. Heidi stated she would head up to [REDACTED] Hospital to be there for comfort with the family. I told Heidi we would meet her there as soon as we could. Detective Bass and I arrived at [REDACTED] Hospital at approximately 12:00 PM. We first met with the family including [REDACTED] and [REDACTED].

[REDACTED] who does most of the speaking for the family stated [REDACTED] stated it was a black guy who attacked her. [REDACTED] and [REDACTED] stated [REDACTED] told them about this younger white male who had a uniform that was giving her a hassle at work about the price of a sub and the other employee paid for his sub. I told [REDACTED] and the rest of the family who thought that might have been a police officer that we had identified that young man who has learning disabilities. I told them he wants to be a fireman and sometimes carries a hand held radio. [REDACTED] and [REDACTED] stated [REDACTED] still did not know she had been [REDACTED] [REDACTED] and they asked that we not tell her as this would upset her too much. I told them I wouldn't tell her. Detective Bass, Heidi, [REDACTED] and [REDACTED] mother, went into [REDACTED] room. We sat down next to [REDACTED] and I introduced ourselves. The interview with [REDACTED] was recorded on Detective Bass' hand held digital recorder, however the intubation tube had just been taken out of [REDACTED] I believe the day before and she had great difficulty talking with any volume.

[REDACTED] stated she has been working at [REDACTED] for about a year. [REDACTED] stated on Tuesday she worked from 4:00 PM. until then close at 9:00 PM. [REDACTED] stated she worked with [REDACTED] [REDACTED] stated she closed a little after 9:00 PM

and walked out to the parking lot behind [REDACTED] [REDACTED] stated she saw a silver van parked in the lot. [REDACTED] stated she crossed [REDACTED] parking lot to the store behind. (There is a business condo located just to the north of [REDACTED] containing an attorney's office and an insurance office) [REDACTED] stated sitting on the sidewalk between the two business was a black man. [REDACTED] advised he was a skinny black man with darker skin. [REDACTED] stated this black man was wearing a white t-shirt, black pants, and black shoes. [REDACTED] stated this black man was in his twenties. [REDACTED] stated this black man said "Hi" to her. [REDACTED] stated she didn't say anything and continued walking fast towards the parking lot where her car was parked. [REDACTED] stated this black man said hi again and she began running to her car. I drew a picture and [REDACTED] showed she ran along a path on the east side of the business condo. [REDACTED] stated she was scared and felt this black man was chasing her. [REDACTED] stated she got back to her car and got in it. [REDACTED] stated the next thing she remembers was waking up here in the hospital. I asked [REDACTED] if she had ever seen this black man before. [REDACTED] stated she didn't know him. She also didn't know if he ever came in [REDACTED] or not. I could see that the section of [REDACTED] [REDACTED] [REDACTED] been placed [REDACTED] on her [REDACTED] and was held on by [REDACTED] [REDACTED] The hair on that side of her head had been cut off. We ended the recorded interview with [REDACTED] I asked [REDACTED] through her aunt [REDACTED] if she would recognize the black man who attacked her if she saw him again. [REDACTED] stated yes. Detective Bass and I then cleared from the hospital at approximately 1:05 PM. We drove back to Elkhorn arriving at the police department at approximately 2:05 PM. At approximately 2:37 PM. Detective Bass and I arrived back on the fair grounds. A short time later we met with Mark Cockerham.

We told Mark the description of our suspect given by [REDACTED] I asked what employees he had that may match that description. Mark thought for a few minutes and gave us the names of Terrence (Leflore), Trent (Mitchell), and Oqwandre Wiltz. We first talked with Leflore.

Leflore told us that he helped set of the rides Tuesday. Leflore talked about setting up a kids bubble bee ride. I asked Leflore if he left the fairgrounds after setting up the rides. Leflore first stated that he was going to go to the laundry mat (He described the location of the Cleaning Machine in the ten block of N. Lincoln Street) Leflore stated he was going to ride with some other carnival workers. Leflore then stated he walked down to the laundry mat going west on Fair Ave. and then west on Court Street and then south on Lincoln St. I had drawn a diagram and this is the route Leflore stated he went. Leflore did not know the street names. Leflore stated he was back at the fairgrounds around 5:00 PM. I asked Leflore what time he was at the laundry mat. Leflore stated he didn't remember. I asked Leflore if it was light out or dark. Leflore stated it was dark. I told Leflore it doesn't get dark until about 8:00 PM. I asked Leflore if he was at the laundry mat at 8:00 PM. what time he got back. Leflore stated right after 8:00 PM. I asked Leflore if he walked down to [REDACTED] from the laundry mat. Leflore stated no. I asked Leflore if he knew where [REDACTED] was. Leflore stated yes across from Burger King. I asked Leflore if he had ever

gone in the [REDACTED] in Elkhorn. Leflore stated no. I asked Leflore what he was wearing that night. Leflore stated a green NAM shirt and black pants. Leflore stated when he left the laundry mat he headed back to the fairgrounds along the same route. According to Leflore's statement he never went any further south than the laundry mat. It should be noted that when I was talking with Leflore he was wearing a red NAM sweatshirt over a white t-shirt and black pants and black tennis shoes. LeFlore stated he was on probation for burglary out of Jackson, MS. I asked Leflore what his probation agent's name was. LeFlore stated he didn't remember. I asked Leflore if it was alright if we took his picture. Leflore stated no and looked at Mark Cockerham asking if he had too and Mark told him no. I then asked Leflore if he would submit to a DNA swab. I explained it was just me putting a cotton swab in his mouth. Leflore stated no. I asked Leflore why. Leflore stated he didn't want to. Again Mark told Leflore he didn't have to. I asked Leflore who could confirm he was at the laundry mat and then back at the fairgrounds by a little after 8:00 PM. Leflore stated Angelique and Dale could confirm he was at the laundry mat and should be able to confirm when he got back to the fairgrounds. Leflore then started walking back to his ride he was running in Kittie Land. I had a criminal history run on Leflore and he did have a conviction for burglary in MS. but it did not confirm he was on probation. Mark then brought Trent Mitchell to talk with us.

We then talked with Trent. Trent stated on Tuesday night he never left the fairgrounds. Trent stated back home in Martinsville, LA., he had been arrested for battery and had to pay a fine. We asked Trent if we could take his picture and collect his DNA. He also refused and Mark also told him he didn't have to. Mark did say that he remembered giving Trent a ride back to bunk houses around 5:30 PM. and dropping him off. I then asked to speak with Angelique. Mark walked us over to a ride that Angelique was operating in Kittie Land. I noticed as we were walking over Leflore approached Trent who just walked away from us and appeared to be asking him questions. We met with Angelique Bardnard, who is from South Africa. Angelique stated she Dale and another carnival worker went to the laundry mat. Angelique described the location of the cleaning machine. Angelique stated she did remember seeing Terrence (Leflore) walking on the sidewalk by the laundry mat. Angelique stated she never saw Terrence in the laundry mat and never saw him come back to the fairgrounds. I thanked Angelique. We then asked to speak with Dale. Mark walked us up to the rescue squad/security office area and Mark brought Dale to us.

Dale's stated his real name is Charles A.D. Snow and he was from Eubank, KY. Dale told us that on Tuesday evening he had driven Angelique and another carnival worker to the laundry mat. Dale described the Cleaning machine location. Dale stated it was almost 9:00 PM. and he and Angelique had to run to Speedway to use the ATM machine to get money for the laundry before the laundry mat closed which Dale thought was 10:00 PM. . Dale stated as he was driving to Speedway south on S. Lincoln Street and looked over at the sidewalk to his left (east side) and in the mid 10 block of S. Lincoln Street just north of [REDACTED] he saw Terrence walking towards [REDACTED] on the sidewalk in the rain. Dale stated he remembered making a

comment to Angelique saying "What is Terrence doing walking in the rain." The parking lot that [REDACTED] was attacked in is located at this spot. I thanked Dale for his information and Dale went back to work. Mark who heard this interview made a comment, "that's interesting". I told Mark I was going to take Terrence into the police department for further questioning. Mark asked that we not handcuff Terrence in front of people on the fair grounds. I agreed to allow Mark to have one of his other carnival supervisors bring Terrence to a carnival vehicle on the grounds and we would escort him to the police department. I asked Officer Rayfield to follow Mark from a short distance and watch Terrence being brought in. Eventually Terrence was brought to the carnival vehicle and that vehicle driven by the carnival supervisor followed my unmarked squad while Officer Termaat trailed behind. We left the fairgrounds at approximately 4:19 PM. We arrived at the police department at 4:21 PM. I escorted Terrence into the booking room. Officer Termaat sat with him while I prepared for the interview. I gave Terrence a bottle of water.

At approximately 5:02 PM. I sat down in an interview room in intake with Terrence. I read Terrence his rights from my Miranda card. Terrence stated he understood his rights and agreed to talk to me. Terrence stated on Tuesday (8/28/18) he helped set up the rocking boat ride. Terrence stated he walked to the laundry mat and got there about 7:00 PM. Terrence stated he was going to do his laundry but it was raining so he decided not to. Terrence stated he used the bathroom at the laundry mat and then walked back to the fairgrounds going the same route he came. I drew a map for Terrence and Terrence described coming out of the fairgrounds going down Court Street and south on Lincoln Street and then going back the same way he came. Terrence again stated he never went towards [REDACTED] from the laundry mat. Terrence stated since the fair was here he had never went in [REDACTED] but he did go in Burger King and Speedway. Terrence stated he left the laundry between 7:30 PM. and 8:00 PM and was back at the fairgrounds around 8:00 PM. Terrence stated he ran back to the fairgrounds. Terrence stated Angelique and Dale saw him at the laundry and maybe at the bunk house. Terrence stated he was wearing a bluish colored shirt and pants or shorts I told Terrence that Angelique stated she saw him wearing a white shirt and black pants Tuesday. Terrence stated that is what he usually wears at work. Terrence stated he could have been wearing that. Terrence stated the black pants he was wearing is the only pair he has. Terrence stated he had a couple of white shirts. I told Terrence that after we talked with him and then talked with Trent I saw him approach Trent and appeared to ask him what he talked about with the police. I asked Terrence what they talked about. Terrence stated Trent was just asking what's going on and he didn't like talking to the police. Terrence stated Gina who works in the ticket booth took them to Walmart last Thursday and he bought the pants and the shoes he is wearing now. Terrence stated his other shoes were Nike's and they were grey and black but they got all wet. I asked Terrence how they set up their rides. Terrence told me about putting pins in the bracing for the rides. I asked what tools they use. Terrence mentioned some tools but did not say a hammer. I asked Terrence if he uses hammers. Terrence stated no. I told Terrence I was told hand held hammers are used to help pound the pins in.

Terrence stated the pins just go in and clip. Terrence stated the only thing he knew about the assault was what people said at work so he didn't know much about it. Terrence told me about the burglary he did years ago. He stated he saw an open window on a house and crawled inside and later turned himself in. Terrence repeated he had nothing to do with the assault in Elkhorn. I again asked Terrence if I could get a DNA sample from him. Terrence still refused. This interview ended at approximately 5:38 PM. I told Terrence he was being arrested for obstructing an officer, lying to the police and would be going to jail. I left the intake area and Officer Termaat sat with Terrence. At approximately 6:05 PM. Officer Termaat called me with a question from Terrence. Terrence asked if he gave a DNA sample if he could go. I told Officer Termaat no. Later Officer Termaat did tell me Terrence gave him a DNA sample.

At approximately 6:10 PM. Officer Termaat stated Terrence wanted to talk with me again. At approximately 6:22 PM. I met with Terrence again in intake. I reminded Terrence that he agreed to an interview earlier and he still had his rights. Terrence understood . Terrence stated he wasn't truthful with me the first time. Terrence now wanted to tell me he was wearing a green and black beanie, black shirt, blue jeans or shorts. Terrence stated he didn't have black pants before he went shopping at Walmart. Terrence stated there should be a Walmart receipt at the bunk house some where. Terrence stated he had a white bag with dirty wet clothes just outside his bunk house and a pink book bag (backpack) with dry clothes in it. I asked Terrence if I could have permission to go through his phone to check out what was in it. Terrence stated he only had the phone for about a month. Terrene stated I could go through his phone. Terrence apologized for lying to me earlier. Terrence asked if he could not go to jail now. I told him no. Terrence stated he would need his wallet and his black rapid card. I believe this is where his pay is direct deposited into. I asked Terrence for permission to go into the bunk house and get his stuff and pick up those bags outside. Terrence stated yes. Terrence described where his bunk house was. I ended this interview with Terrence at approximately 6:36 PM. The interviews at the police department were recorded on my hand held digital recorder and the in house video recording system. Officer Termaat transported Terrence to the Walworth County jail and confined him on obstructing charges.

At approximately 7:40 PM. I transferred the cell phone belonging to Terrence, a I-phone model A1661, to Detective Craig from the Walworth County Sheriff's Office. Detective Craig stated he was going to take the phone to have it analyzed. Detective Craig left with the cell phone. Officer Rayfield brought in Terrence's clothes, wallet, ID, and the Rapid card. In the wallet was also a social security card with Terrence's name on it and a credit card with his name on it. The two bags of clothes contained what Terrence had described to me. Officer Rayfield stated he met with Mark Cockerham at Terrence's bunk and he stated this was all Terrence's property. Officer Rayfield stated he looked in one of the bags and it contained a wet [REDACTED] shirt. I asked Officer Termaat, who is trained as an evidence technician to go through these bags. Officer Termaat showed me the black in color size small [REDACTED] shirt. Later he showed me a white t-shirt that had the

words Biloxi Beach written on it. This t-shirt had what looked like blood stains on it. A Deputy David Deauchine had been contacted by this department because he is a sketch artist working with the Dane County Sheriff's Office. Deputy Deauchine had spoke with Detective Bass and agreed to go to [REDACTED] Hospital to attempt to get information from [REDACTED] to make a sketch of the suspect. I knew he and Heidi from APFV was with the family. I texted Heidi and asked her to call me. Heidi did call me. I asked to speak with Deputy Deauchine which I did. I knew the press release did not mention [REDACTED]

On 9/4/18 at approximately 1:20 AM. I stopped in at the Walworth County jail. I met with Terrence LeFlore again. I read LeFlore his rights again from my Miranda card. LeFlore again waived his rights and agreed to talk to me. I showed LeFlore his wallet and ID cards. LeFlore confirmed they were his. I again asked LeFlore what he knew about the assault in Elkhorn. LeFlore stated not much. I confirmed with LeFlore that he only knew what others had said at the fairgrounds. I showed LeFlore a picture of the white t-shirt with the Biloxi Beach on it. LeFlore stated that was his t-shirt. I asked LeFlore how the blood got on that t-shirt. LeFlore stated he didn't know. I told LeFlore that we had his phone analyzed and found that he searched for a [REDACTED] in Elkhorn, Grey Hound buses, fingerprints in blood, and other things. I told LeFlore that we found a black [REDACTED] t-shirt in with his belongings that I already confirmed belonged to the girl that was assaulted. I told LeFlore we had enough to arrest him already. I told LeFlore he had been lying to me several times. I told LeFlore that I believe he would be getting charged. I told LeFlore that I needed him to be honest now so I could go to the district attorney and tell him he was being honest. I told LeFlore maybe he planned this and things went wrong. I told LeFlore maybe he didn't intend to harm this girl and it went to far. I told LeFlore this was the last time I would be talking to him so he could explain this to me. I asked LeFlore to tell me the truth. LeFlore looked at me and looked at the picture of the [REDACTED] shirt and asked if I found that in his clothes. I told LeFlore that one of our officers did and I saw the shirt. I told LeFlore tell me why he did this. LeFlore sat silent for a while. I again asked LeFlore to be honest this time. I again asked LeFlore why he did this. LeFlore sat quiet again and then stated quietly he wanted the money. LeFlore stated he looked up what time [REDACTED] closed. LeFlore stated he planned on taking money from her and going back in [REDACTED] LeFlore stated when the woman came out he followed her to the parking lot. LeFlore stated he didn't know she had a car in the parking lot. LeFlore

stated when the woman got to her car he hit her with the hammer once to get her to drop her purse. Leflore stated when he hit her she fell to the ground. Leflore stated he did not have sex with her. Leflore stated he wanted to make it look like a [REDACTED]. Leflore stated he used the hammer handle to [REDACTED] her [REDACTED] and [REDACTED]. Leflore stated no. I asked if everything he told me now was the truth. Leflore stated yes. At approximately 1:40 AM. I ended the statement. This interview was recorded on my hand held digital recorder. Leflore went back to his cell. I gave the wallet and contents to the jail staff to put in Leflore's property. I then cleared from the jail. When I returned to the police department I placed the recorded interview from my hand held digital recorder on the L-drive.

At approximately 1:30 PM. I met with [REDACTED] her mother, [REDACTED] and Carmen from APFV in the intensive care unit at [REDACTED] hospital. I returned [REDACTED] driver's license to her. I asked [REDACTED] if she would sign the medical release forms for [REDACTED] and [REDACTED] hospital. [REDACTED] agreed and did sign the two forms. [REDACTED] also allowed me to take current photos of her which I later downloaded to the S-drive at the police department. I then told [REDACTED] and her family members who were present that the person who harmed her had been locked up in jail and that he admitted to harming her. I told [REDACTED] and her family that I did not believe the person who was arrested for harming her knew who she was. [REDACTED] and her family were very relieved that the person who harmed her was in jail. I cleared from [REDACTED] hospital at approximately 1:53 PM.

On Wednesday, August 29, 2018 at approximately 5:45 A.M. I, Officer Dixon, arrived for my duty shift at the Elkhorn Police Department. I was advised by Sgt. Croak that on 8-28-18 sometime between the hours of 9:04 P.M. and 10:00 P.M. a female employee from [REDACTED] located at [REDACTED] in the City of Elkhorn, County of Walworth, Wisconsin had been battered and possibly [REDACTED] after she left the business. Sgt. Croak asked me if I would go to [REDACTED] and try and look at the video and see if there might be anything that would help us determine what happened.

As I was getting ready to leave the police department to go to [REDACTED] Det. Bushey arrived at the police department and stated that he would go with me to [REDACTED]. We arrived at [REDACTED] at approximately 7:17 A.M. and entered the business that was open. When we arrived we were met by the owner, [REDACTED] Det. Bushey advised [REDACTED] that we were there to look at the video from 8:00 P.M. to closing on Tuesday, August 28, 2018. [REDACTED] stated that [REDACTED] and [REDACTED] were working at that time.

[REDACTED] had us follow him into the office where he then went to the computer and pulled up the security video onto the screen. He then was able to pull up video of 8-28-18 from 8:00 P.M to approximately 10:00 P.M.. Det. Bushey talked to [REDACTED] and then stated that he needed to leave to talk with someone. I then watched the video from approximately 8:45 P.M. and noticed some customers in the building. There was a family known to me and then a male and female couple and then a single male. After that I observed [REDACTED] and [REDACTED] cleaning the store and locking up.

I observed [REDACTED] several times check her phone and then put it down and go back to work. At approximately 9:02 P.M. [REDACTED] exits the building through the rear door on the east side of the building. I then saw what looked like a white truck drive through the east side of the parking lot and then turn west onto E. Geneva St.. That was at approximately 9:03 P.M.. I continued to watch the video and [REDACTED] puts on a white hoodie and then leaves the building by herself at approximately 9:04 P.M.. I continue to watch the video until approximately 10:00 P.M. and did not see anyone enter the building and did not see any vehicle drive out the east drive leading to E. Geneva St.. All the cameras show video inside the building and there are no cameras outside.

Det. Bushey returned and I advised him what I had observed on the video and we then asked [REDACTED] if he knows how to retrieve the video on a thumb drive and he stated he did not but stated I could try and figure out how to retrieve the video. I was not able to do this and [REDACTED] stated that he has an employee that comes in later that should be able to do that. We left a thumb drive with [REDACTED] and asked him to call if he was able to retrieve the video.

I then went to 12 S. Jackson St. the Harkness residence to see if they had any video as I had been advised by Sgt. Croak that the possible suspect had ran east in the municipal parking lot and might have ran through their property and they had outside cameras at their house. I talked to Lynn Harkness and she advised me that they do have video outside and pulled up the cameras on her phone to show me what areas they cover. I advised her that it is possible that the person I was looking for might have ran through their yard last night and that if he did it might have been captured on their cameras. Lynn was trying to pull up the video but she was having trouble doing so at that time. She stated she would continue to try and let me know if she finds anything on the video.

I also asked her if they had heard anyone yelling last night between 9:05 P.M. and approximately 10:00 P.M.. Lynn advised me that they were watching a movie on TV from approximately 9:00 P.M. to 10:00 P.M.. Lynn stated that at approximately 9:30 P.M., or somewhere around that time, she thought she had heard a "shrieking noise" and asked her husband Derek if he heard it and he stated he did not. Lynn thought it might have been her daughter making the noise but she did not make it either. Lynn stated that she did not hear anymore noise and did not think anymore of it. Lynn stated she would let us know either way if they find anything or not on the video.

I then went to the First National Bank on the northwest corner of E. Geneva St. and S. Lincoln St.. I entered the bank and talked to the manager Stephanie Larson. I advised her that I was checking to see if their outside cameras capture any video of the parking lot by [REDACTED] I explained to Stephanie that our department was investigating an incident that happened to an employee at [REDACTED] and I wanted to see if the video had captured anything. Stephanie called her boss and asked if it was ok to allow me to see the video and she was advised that it was but if there was anything that we needed we would have to obtain a subpoena.

We looked at the video and due to the rain during the night it was very hard to see anything. The video did show vehicles traveling on the road as there was a white light and red light traveling on the road. The cameras are activated by motion and at approximately 8:45 P.M. there appeared to be headlights shining west from the [REDACTED] parking lot. The video continued and at approximately 8:54 P.M. a vehicle pulled into the parking lot/driveway at Nommensen Law Offices and also leads to the houses next to [REDACTED] There was another vehicle that appeared to pull into the same parking lot/driveway. At approximately 9:05 P.M. the lights to the vehicle shining west disappear and it is unknown if the vehicle pulled out of the parking lot or they just turn them off. The video is so distorted from the rain that it is hard to see the vehicles. I advised Stephanie if we needed anything else we would call. I thanked her for her time and then left the bank.

I then went to Lyles TV and Appliance which is located at 17 S. Washington St. but the rear of the building faces S. Lincoln St. and [REDACTED] parking lot. I entered the building and talked to Nicole Ritzert. I asked her if they had any

video cameras on the rear of the building that might capture the parking lot at [REDACTED] and she stated they do have cameras but did not know if they would capture the parking lot. I also advised her that I was trying to find video that would capture the parking lot on 8-28-18 between the hours of 8:00 P.M. and 10:00 P.M.. Nicole stated that she would have to check and see and then get back to me later. I later received a phone call from Nicole and she stated that the cameras do capture the parking lot but they only keep the video for 12 hours and then it starts to record over it.

I then went to Speedway located at 102 S. Lincoln St. and talked to the manager Sally Walsh. I advised her of what I was looking for and hoped her security video might have captured something. I asked her if we could look at the video for 8-28-18 from 8 P.M. to 10:30 P.M.. We quickly looked at the video and I did not see any vehicles that might have been coming or going from [REDACTED]. Sally did say that she would download a copy of the video on a disk and call when it is done in case someone wants to watch the video again.

I was unable to locate any video that shows anyone coming or going from [REDACTED] during the time that [REDACTED] left work and was then attacked in the parking lot either at [REDACTED] or the municipal lot just to the north where her vehicle was parked.

On Wednesday, 08/29/18, at approximately 2:15 PM, I, Chief Joel Christensen of the Elkhorn Police Department, was on-duty and arrived at the municipal parking lot located on the east side of the 10 block of S. Lincoln Street (tax parcel YRW 00026). Previously, Secretary Theresa Boeger provided me with an email from AT&T, that was received on 08/29/18 at 1:53 PM, indicating that the victim's phone was located at 088 32 24.497W (Longitude) and 42 40 15.988N (Latitude). I entered the coordinates into Google Maps and it indicated the phone was located at the very far southeast corner of the parking lot parcel.

PSLO Joseph Kirkpatrick also responded and I met with him in the parking lot. As I reached the location, I observed a cell phone laying on the grass just east of a telecommunications pedestal. I notified PSLO Kirkpatrick and dispatch that I had located what I believed was the victim's phone. I asked PSLO Kirkpatrick to obtain a camera to photograph the location before collecting the phone. I asked PSLO Kirkpatrick to remain with the phone while I entered the back yard of 14 S. Jackson Street, the Brad Wales residence, which I believe would have been the yard the suspect entered upon fleeing. I noticed that the Harkness residence did have a video camera on the south side of their residence, 12 S. Jackson Street, that did appear to be pointing in the direction of the opening to the Wales residence. I made contact with Lynn Harkness and she said she had checked her video cameras and was not able to capture anything due to the rain and lighting last night. I then made contact with Brad Wales at his residence and asked if he heard or saw anything suspicious last night and he said he had not.

Upon returning to the parking lot, Detectives Bushey and Bass had arrived and Det. Bushey said he located what he believed to be the victim's hair tie along with a zip tie on the south side of the parking lot in the parking stalls. I then checked the brush line on the south side of the parking lot and near the opening in the brush to the east end of the office building located at 15 S. Lincoln Street, I observed a short handle mallet, or sledgehammer, with what appeared to be a steel head. I alerted Det. Bushey to the item and he photographed the item and location before having it collected.

The female was unable to keep focus or answer some of my questions. I advised Officer Renner who arrived on scene to get his medical bag from his squad and tend to her, while I spoke with the caller.

I spoke with the caller later identified as [REDACTED] Ines [REDACTED] [REDACTED] [REDACTED]. I asked her what happened. She stated her niece did not arrive home after working at [REDACTED] like she normally does. She stated she worried and drove to the scene. She stated when she arrived she observed a thin male wearing a dark colored jacket or sweat shirt. She stated she did not get anymore details or even see his face. Officer Renner to go with the victim to the Hospital and I would stay with the vehicle.

I did not find anything of evidentiary value during the camera search.

On Friday, August 31, 2018 I, Officer Rayfield, was on duty in the City of Elkhorn County of Walworth State of Wisconsin assigned to bike patrol. At approximately 7:04pm I heard over the police radio that Sergeant Croak was advising a van, which matched the description of the van seen leaving [REDACTED] on August 28, 2018 at 10:32pm, was southbound from the area of Napa Auto Parts store on North Wisconsin Street. I responded to North Lincoln Street and East Court Street to look for this vehicle.

I then observed a tan GMC van with Wisconsin registration 680YLD northbound on North Lincoln Street. I observed that the third window had plastic covering the window. I followed the vehicle and observed that it had a driver's side brake light out. I caught up to the van as it pulled into the main parking lot of the Walworth County Fairgrounds. I knocked on the driver's window and ordered the driver to pull over. The driver pulled into a parking isle and stopped. I contacted the driver and sole occupant and explained the reason for the stop. The driver was identified by Wisconsin photo driver's license as Tirzah Elizabeth Lynn Layhew [REDACTED]. Tirzah did not know about the defective brake light. I asked her if she was the only person who drove the van. Tirzah explained that she was the driver of the van normally, however her parents also used the van. Tirzah also said that she had several siblings including two older brothers. At this point Sergeant Croak was on scene to assist in a marked patrol squad.

I checked Tirzah's driving status and then returned to speak with her further. I explained to her that the vehicle she was driving was seen near the scene of a violent crime. I told her that I wanted to make sure that she and her vehicle were not involved in that crime. I asked Tirzah if I could search her vehicle. Tirzah was very cooperative and advised that I could. During the search I located a pipe in Tirzah's purse that smelled strongly of marijuana. I also located a partially eaten Subway sandwich in the center console. I also found a receipt from the Williams Bay, WI Subway showing a purchase made on August 29, 2018. I asked Tirzah about the marijuana pipe. She admitted that the pipe was used for marijuana and stated that it belonged to her brother. She advised that she had never used the pipe to smoke out of. The pipe was secured in Sergeant Croak's squad car. Sergeant Croak then made several phone calls to Tirzah's family members who had access to the van. I took photographs of the van and then I questioned Tirzah about her whereabouts on Tuesday, August 28, 2018.

Tirzah stated that her vehicle could not have been in Elkhorn on the day in question because it had been in Illinois until August 30, 2018. Tirzah stated that her father drove the van from Illinois to Wisconsin on that day. I asked Tirzah specifically if the van was in Illinois on August 28, 2018. Tirzah stated

that it was not and that it had been at her home in Williams Bay, Wisconsin. I asked Tirzah if she or anyone else in the house had driven the van on Tuesday. Tirzah told me that she and her parents were at home the entire day. She said that she had no knowledge of anyone driving the van. I also asked how long the window on the van had been broken. Tirzah stated that it had been broken for at least a year. I advised Sgt. Croak of this information. He then told me that he had just hung up with Tirzah's mother. Tirzah's mother advised that Tirzah had left the house on that Tuesday and she, in fact, went to [REDACTED] in Elkhorn. I confronted Tirzah with this information. Tirzah then admitted that she was at [REDACTED] in Elkhorn on Tuesday.

Tirzah said that she was at [REDACTED] meeting a friend. She said that she was there in the evening, after dark. Tirzah provided a name of the friend to be Gavin. She said that she met Gavin that night on a dating app called Tinder. Tirzah advised that she did not know Gavin's last name however she did communicate with him via text message. I obtained Gavin's phone number and physical description. Tirzah stated that she did enter [REDACTED] and eat there. She also admitted that she was there for at least an hour after the restaurant had closed. I asked Tirzah which way she left when she exited the parking lot. Tirzah told me that she exited out the "back" entrance and turned towards the hospital.

At this point Detective Bass was on scene. She was briefed on the information that I had gained up until that point. Detective Bass asked Tirzah if she was willing to come to the Elkhorn Police Department for a recorded statement. I heard Tirzah state that she would go voluntarily. Detective Bass asked that someone remain with the vehicle. I moved the van, with Tirzah's permission, into a parking stall. Sergeant Croak advised he would remain with the van and I cleared the scene.

Frank indicated that Mikey is about 21 years old. I asked Frank if he said anything to Mikey. Frank said no. I asked Frank if he knows Mikey to be abusive in any way towards his sister and Frank said no. I asked Frank if he saw Mikey come home Tuesday night. Frank indicated that he (Frank) worked from 6 PM on Tuesday until 6 AM on Wednesday so he doesn't know if he came back or not. Frank indicated that he has seen Mikey since but doesn't pay attention to what day or the time of day he sees him. Frank was unable to download the video from his phone due to lack of WiFi. I gave Frank my email address and asked that he send the video to me.

On Friday, August 31, 2018 at approximately 6:50 pm, I, Sergeant Croak, was advised by dispatch of a suspicious van that matched the suspect vehicle leaving NAPA and traveling south on N. Wisconsin St. in the City of Elkhorn, Walworth County, Wisconsin.

I advised CSO Rodriguez to look for the van because she was directing fair traffic at N. Lincoln St. and E. Court St. In a marked squad I left the police department north on N. Wisconsin St. I made it to N. Lincoln St. and didn't locate the van so I turned south. I heard Bike Patrol Officer Rayfield advise he located a similar suspect van in the main parking lot at the fairgrounds. I turned east on E. First Ave. and proceeded to the fair parking lot.

On arrival I observed a tan GMC Savana van with a broken third window on the passenger side. I spoke briefly with Officer Rayfield and Deputy Frami. I advised I would check the surveillance video from [REDACTED] in the squad. I watched it several times and then more with Deputy Frami. We agreed the vehicle was extremely similar down to the molding stripe that runs on the lower side of the van from front to back.

I spoke with Officer Rayfield and learned the driver, Tirzah, is the primary driver and advised she was home with her parents 08-28-18. I asked about any siblings who may drive the car. Tirzah stated she had two older brothers and younger siblings who don't have licenses. I obtained information for the older brothers and for Tirzah's mom. I called Terrance and left a message. Terrance called back quickly. I advised Tirzah's van was seen near a crime in Elkhorn earlier this week and asked his whereabouts. Terrance stated he lives and works in Illinois. I asked when he was last in Wisconsin or the Elkhorn area. Terrance stated Monday he came in the morning and left for Illinois in the evening. Terrance stated that could be confirmed with his vehicle's Ipass records. I asked Terrance if he had driven the van recently and Terrance said no. I thanked Terrance for his time. Next I called Tirzah's mom, Liane. I advised the same details as with Terrance. I asked about the van and if anyone drove it Tuesday. Liane said no she and Tirzah were home. I explained a little more about the incident and mentioned it was near [REDACTED] in Elkhorn. Liane said excitedly that Tirzah did eat at [REDACTED] in Elkhorn with a friend on Tuesday. I asked if she was sure because Tirzah was not explaining that. Liane stated officers just needed to "jog her memory."

I advised Officer Rayfield and he was able to learn from Tirzah that she did eat at [REDACTED] with Gavin during a date. Tirzah stated the two left before the store closed and then they talked in the van for more than an hour. Det. Bass arrived to speak with Tirzah. Det. Bass transported Tirzah to the police department for a taped statement. I remained with the vehicle until it was determined we didn't

On Monday, September 3, 2018 at approximately 6:45pm I, Officer Rayfield, was asked to respond to the area of the water tower at the Walworth County Fairgrounds, 411 East Court Street, in the City of Elkhorn County of Walworth State of Wisconsin to obtain property. I spoke with Detective Bushey who advised I was going to pick up property which belongs to Terrance D. Leflore [REDACTED]. I was further advised that the division manager, Mark Cockerham, was going to meet me to assist.

I located Mark at a trailer and he showed me to an unlocked door on the trailer. Mark stated that this bunk room belongs to Terrance. He also pointed to two backpacks under the steps to the bunk. He stated that those belonged to Terrance as well. I began collecting the property from the water first. I drained as much water as I could from a black backpack. I removed clothes from the main compartment of the bag and placed them into a large plastic garbage bag. I then checked another compartment of the bag. Inside I located a black polo shirt with a [REDACTED] logo on it. I emptied the water from the backpack, replaced the polo shirt, and put the entire bag into the garbage bag. I then obtained a pink backpack from the water. I was able to drain most of the water from the bag without removing anything inside. That backpack was then placed into the garbage bag.

I then entered the bunk house. I gathered all clothes, shoes, and toiletries. I gathered as much loose change as I could gather. I obtained his television and Playstation as well. I also located a wallet, phone, and money card. All the dry items were placed into a separate garbage bag. All of the property was loaded into my squad car. On August 29, 2018, I, Detective Bass, was advised to come into work early due to this incident. I arrived at work at 12:00 P.M. Detective Bushey briefed me on this incident. Detective Bushey advised that the victim, [REDACTED] R. [REDACTED] worked at [REDACTED] located on [REDACTED] Detective Bushey advised that left work last night around 9:00 P.M. and was found beaten and [REDACTED] in her vehicle around 10:15 P.M.

At approximately 12:35 P.M., Detective Bushey and I went to [REDACTED] residence located at [REDACTED] Detective Bushey advised that [REDACTED] was an employee of [REDACTED] and closed with [REDACTED] last night. Once at the residence we spoke with Kimberly Talarek. Kimberly stated that she is [REDACTED] boyfriend's mother. Kimberly stated that her son's name is Taylor Talarek. Kimberly stated that [REDACTED] was at work at [REDACTED] and was not home. Kimberly stated that Taylor picked [REDACTED] up from work last night. We cleared from the residence and went to [REDACTED]

Once at [REDACTED] we spoke with [REDACTED] [REDACTED] stated that she had only worked at [REDACTED] for 8 days. [REDACTED] stated that she closed last night with [REDACTED] [REDACTED] did not appear to know that [REDACTED] was injured after leaving work last night. [REDACTED] stated that she did not have any problem's with [REDACTED] other than she pronounced her name wrong. [REDACTED] stated that she and [REDACTED] do not talk much when they work. [REDACTED] stated that [REDACTED] did not say that she was supposed to meet anyone after work. [REDACTED] stated that last night before leaving she asked [REDACTED] if she wanted her to wait for her so they could walk out together because it was raining. [REDACTED] stated that the subject came back the next day on August 28, 2018 with a another male subject with a pony tail. [REDACTED] stated that on August 27, 2018, the subject came in with only \$8.00 and did not have enough money to pay for his meal. [REDACTED] stated that the subject was 50 something cents short. [REDACTED] stated that she covered the remainder of the subject's bill with her own money. [REDACTED] stated that [REDACTED] told the subject that he cannot do that in the future and won't be able to buy the food if he does not have enough money. [REDACTED] stated that the subject got mad and stated that the prices were "retarded" anyway and way too high. [REDACTED] stated that the subject eventually left. [REDACTED] stated that the subject then called on the phone a short time later and yelled at [REDACTED] [REDACTED]

provided me with the number the subject called from. Detective Bushey and I watched the video from the 27th and 28th until we were able to locate the subject [REDACTED] had described. On the 28th we located the subject and the older, skinny subject with the pony tail the subject was with. [REDACTED] confirmed that we were looking at the right people. [REDACTED] another [REDACTED] employee, stated that the large male subject comes in every 3 or 4 days and orders a ham sandwich. [REDACTED] stated that he believed the older subject was the younger subject's father. [REDACTED] stated that the larger younger subject told [REDACTED] that he works for the fire department and he is stationed at Sunset park or the Library.

Detective Bushey and I took photos of the subjects and cleared from [REDACTED]. Detective Bushey and I then drove to the municipal parking lot where the assault occurred. Chief Christensen was there and advised that he had located [REDACTED] cell phone near the tree line to the South East corner of the lot. Detective Bushey and I looked around the area. Detective Bushey located some hair ties with blue and black beads and a black zip tie located in the area of where [REDACTED] vehicle was parked. Chief Christensen also located a hammer with a steel head and faded red or pink handle in the bushes to the South of where [REDACTED] vehicle was parked. I took photos of the items and we collected them. [REDACTED] cell phone was also collected.

Detective Bushey and I returned to the Elkhorn Police Department. I checked in house for the phone number that [REDACTED] had given me for the angry customer at [REDACTED]. In house showed the number belonged to Toribio Hernandez, DOB [REDACTED]. I checked our history with Toribio and recalled that an officer had told me that Toribio had some anger issues and had gone to Lakeland School. I saw that the subject had an address in Lake Geneva. I contacted the Lake Geneva Police Department for information on the subject. Lake Geneva advised that the subject had a recent sexual offense charge with them, but the dispatcher could not see the details on the case. The dispatch advised that the subject's mother, was Linda Hernandez. After digging around in the in-house and social media, I was able to identify the older subject as Toribio's father, Toribio Hernandez Blanco. I printed out the photos of the subjects I had taken from the [REDACTED] video surveillance. Detective Bushey and I brought the photos to the fairgrounds to share with security, as we wanted to speak with the subjects if they were located there. Shortly after entering the fair, Detective Bushey and I located Toribio and his father.

Detective Bushey and I made contact with both subjects. Neither subject had any injuries on their face, chest or arms. I contacted Linda Hernandez, Toribio's mother. Linda stated that Toribio was home all night from 6:00 P.M. on. Linda stated that Toribio has emotion issues and his feelings were hurt when [REDACTED] yelled at him. Linda stated that Toribio would not hurt anyone. I advised Detective Bushey that Linda confirmed that Toribio was home from 6:00 P.M. on after being dropped off by his father. Detective Bushey and I cleared from the fairgrounds.

I contacted Taylor Talarek. I asked him what he saw when he went to pick up [REDACTED] from work last night. Taylor stated that he arrived at [REDACTED] at 8:58 P.M.

and pulled out at 9:02 P.M. Taylor stated that it was raining a lot so he pulled in right next to the door [REDACTED] comes out. Taylor stated that there was a van in the lot that he believed belonged to the other person working with [REDACTED] Taylor described the van as being a older Chevy van maroon or dark red in color. Taylor stated that [REDACTED] told him about what happened so he looked up a similar model to the van he saw in the lot. Taylor stated that he would email me the photo. Taylor stated that the unique thing about the van was that the rear most passenger side window was covered in plastic. Taylor stated that he did not see anything else. Taylor emailed me a photo of the van he believed he had seen parked at [REDACTED] I shared the photo with the department.

I then went to the fairgrounds and spoke with one of the managers of North American Midway Entertainment, Pat Repp. I asked Pat for a list of all the places his company had been this past year and for a current list of all the employees he had working for him. Pat had a female get me the lists. I then showed Pat a picture of the hammer located at the crime scene. Pat stated that there would be a "couple dozen" of those laying around here. Pat stated that every ride has a hammer. Pat stated that he did not recognize that particular hammer. I thanked Pat for the information and left his office.

Officer Termaat asked that I meet him in the main gate parking lot. I located Officer Termaat in the lot with a Maroon van similar to the van that Taylor had sent me a picture of. This van had a broken driver side window. Officer Termaat pointed out the vehicle had black zip ties on the gear shift and a name tag for a Mitchell Delabarre in window indicating that he worked for the carnival. Officer Termaat also pointed out that there was a [REDACTED] bag inside the vehicle. As I walked around the vehicle, I smelled a strong odor of marijuana emitting from it. Officer Termaat had a K9 run around the vehicle and advised me that the K9 did hit on the vehicle.

I parked across from the vehicle and waited for the driver to come out to the vehicle. At approximately 8:30 P.M., I observed a male subject walk to the back passenger door of the vehicle and get in. I advised Officer Termaat, who was waiting in the area. Officer Termaat arrived on scene and we made contact with the subject. The subject stated that he was Mitchel J. Delabarre, DOB [REDACTED]. Mitchel stated that he was working at the carnival and came out to change his shoes. Mitchel stated that there was marijuana in the vehicle. Officer Termaat had previously advised me that Mitchel had prior marijuana arrests. We placed Mitchel in the back of Officer Termaat's squad car. Sgt. Croak waited with Mitchel while we searched the vehicle. Due to the weather conditions and lighting issues, it was determined to seize the vehicle and search it at the police department. Mitchel gave Officer Termaat permission to drive his vehicle to the police department. I transported Mitchel in Officer Termaat's squad.

Once back at the police department, I placed Mitchel in interview room 116, located in the detective office. At 10:25 P.M., I interviewed Mitchel. Mitchel stated that he has worked for Tyson Parks, an independent contractor of carnivals,

for 2 years. Mitchel stated that this is his 3rd time here in Elkhorn. Mitchel stated that they got into town on Monday morning at 5:00 A.M. Mitchel stated that on Tuesday the 28th he was setting up for the fair. Mitchel stated that they got done at approximately 9:00 P.M. Mitchel stated that he drove back home to Beloit after he was done. Mitchel stated that he was in Beloit around 10:00 P.M. Mitchel stated that he was not driving his vehicle that night because it was in the shop getting new shocks on it. Mitchel stated that he was driving an old red Ford Ranger on Tuesday. Mitchel stated that he picked up his van at 11:00 P.M. on Tuesday night at an auto body shop named D and M Auto Repair in Beloit. Mitchel stated he did not know anything about a crime that occurred in Elkhorn. Mitchel did not have any injuries on his arms or face. Mitchel stated that he has black zip ties because they use them all the time at the fair. Mitchel stated that carnival workers buy zip ties by big tubs. Mitchel stated that most carnival workers use black zip ties. Mitchel stated that the only time he went to [REDACTED] was this morning for breakfast. The receipt found in the [REDACTED] bag in Mitchel's vehicle verified that he was there this morning. Mitchel provided me with a DNA sample.

I contacted Mitchel's mother and spoke to her. Mitchel's mother, Monica Delabarre, stated that Mitchel got home around 10:00 P.M. on Tuesday. Monica stated that Mitchel was driving his sister's old Ford Ranger because his vehicle was getting new shocks on it. Monica stated that Mitchel and his sister picked up his vehicle that night after they got home. Monica stated that they got something to eat afterwards and came home. I thanked Monica for the information and ended the call.

I advised Mitchel that his mother confirmed what he told. Mitchel was arrested for other charges from our department, but was released after paperwork was completed. Mitchel was advised to let me know if he heard or saw anything suspicious amongst his coworkers.

On August 30, 2018, I went to the Milwaukee Crime Lab to drop off [REDACTED] cellphone, the hammer, and the pink shoe string that was also located next to [REDACTED] phone. I arrived at the crime lab at 1:02 P.M. and cleared at approximately 1:35 P.M.

Once back at the department, I was advised by Detective Bushey that a vehicle can be seen pulling into to [REDACTED] South entrance at 10:30 P.M. and the van can be seen pulling out the same entrance at 10:32 P.M. I advised that I would go to [REDACTED] and try to get video of these vehicles.

At 5:11 P.M. I went to [REDACTED] residence. I spoke with [REDACTED] [REDACTED] stated that everyone else was at the hospital. I left a crime victim form and a pamphlet for both APFV and [REDACTED] [REDACTED] with [REDACTED] I asked [REDACTED] if I could search [REDACTED] room for anything that might be helpful to the investigation. [REDACTED] stated that I could. I looked through [REDACTED] items. She did not have a lot of belongings. I located a laptop, which [REDACTED] stated that I could look at. There was nothing on the laptop. I located an email address and password which I tried to enter into Outlook and Facebook and it did not work

for either. I did not locate a diary, journal, notes, or anything else that would be helpful to figure out who would have done this to [REDACTED]. In a basket in [REDACTED] room, I located a black rubber band with beads on it just like the rubber bands located at the crime scene. I did not locate anything else helpful to the investigation.

At approximately 6:00 P.M., I went to [REDACTED] to review the video. At 10:30 P.M. on August 28, 2018, I observed a marked Walworth County Sheriff's Vehicle pull into the south entrance of the lot. At 10:32 P.M., a van that appears to be lighter in color pulls out of the same south entrance. The van was large and had high taillights with the license plate on the back passenger side. The vehicle looked to be similar to a Chevy Express van with a darker colored molding strip across the bottom of the vehicle. The second to last window on the passenger side was covered with something, like plastic. I took video and pictures of the van. I sent the video and pictures to the police department to help with locating the vehicle and identifying make and model.

I observed [REDACTED] leave work at approximately 9:02 P.M. At 9:04 P.M. [REDACTED] walks out the rear employee door on the east side of the building wearing dark colored sweatpants, tennis shoes, a pink hooded sweatshirt, and carrying a pink purse with two [REDACTED] visors clipped on the straps. [REDACTED] had her hair down when she left.

At approximately 8:15 P.M. I went to the fairgrounds. I spoke to Pat Repp again. I brought Pat a list of the employee's from his company that had questionable criminal history's. I asked Pat where those 7 subjects: Russell Bassett, Roydell Batiste, Robert Golsby, Gabriel Wiltz, Oqwandre Wiltz, Trent Mitchell, and Howard Sneed, worked. Pat advised that all of those employees worked in Kiddie land. Pat stated that they all work rides and told me who was supposed to work each ride. Pat and the female employee did not know exactly which ride everyone was on at the moment because they jump around. I walked around Kiddie land and looked at the rides I was advised these employees should be on. I did not see any injuries on any of the subjects I looked at. Kiddie land was busy at this time and therefore I did not speak to each employee. I cleared from the fairgrounds.

[REDACTED] called and spoke to me. I gave [REDACTED] an update on what we had done so far. I asked [REDACTED] how [REDACTED] was. [REDACTED] stated that [REDACTED] wrote a few things like where am I, why am I here, and I want to go home. [REDACTED] stated that [REDACTED] doesn't remember anything. [REDACTED] stated that the doctor stated the important thing was for [REDACTED] to rest and let her brain heal. [REDACTED] stated that [REDACTED] gets worked up easily and she needs time to relax. [REDACTED] stated that she did not want officers to talk to [REDACTED] before she spoke with a psychologist. I thanked [REDACTED] for letting me know how she is and sharing her concerns. I told [REDACTED] to contact me if anything changed.

On August 31, 2018, I arrived at work at 1:15 P.M. I met with Detective Robert Craig from the Walworth County Sheriff's Office. Detective Craig and I went to

Detective Craig assisted with getting a photo of the van and began downloading █████ phone which he had gotten from Detective Bushey. After getting the video and photos together, Detective Craig and I began looking at █████ phone download. Everything in █████ phone was in Spanish. Detective Craig and I translated some of the stuff but did not see anything of concern. At approximately 7:30 P.M., I was asked to respond to the main gate parking lot to assist officers with a vehicle that believed was the van from █████ I cleared from the sheirff's office and responded to the fairgrounds.

Once at the fairgrounds, I observed a beige van with dark molding and plastic covered second to last passenger side window. Officer Person advised that the female driver was an 18 year old girl from William's Bay. Officer Person advised that the female, Tirzah E.L. Layhew, DOB █████, stated that she was not at █████ I was then advised by Sergeant Croak that Tirzah did admit to being at █████ with a male subject named Gavin that she met on Tinder. I asked Tirzah if she would be willing to come back to the police department for an interview. I explained to Tirzah that she was not under arrest. I explained that her vehicle was seen leaving the scene of a crime and wanted to ask her what she knew about it. Tirzah agreed to come back for an interview.

At approximately 8:24 P.M, I began an interview with Tirzah in interview room number 116 located in the detective office. Tirzah advised that she lives in William's Bay. Tirzah stated that she met a guy named Gavin on Tinder. Tirzah stated that Gavin works for the carnival. Tirzah stated that Gavin and her arranged to meet at █████ in Elkhorn on Geneva Street at 6:30 P.M. on Tuesday the 28th. Tirzah stated that she was a little late getting to █████ Tirzah stated that Gavin rode his bicycle to the restaurant. Tirzah stated that she did not know Gavin's last name. Tirzah stated that she and Gavin ate at █████ Tirzah stated that after they ate they talked in the vehicle for a bit. Tirzah stated that they walked to Speedway and got some drinks. Tirzah stated that they sat in the vehicle and talked about things like religion for the next couple of hours. Tirzah stated that a vehicle pulled in behind them and flashed their lights. Tirzah stated that she wasn't sure if it was a police officer, but stated that it made her realize that █████ was closed and they should leave. Tirzah stated that she pulled out of the south entrance and went east on Geneva Street. Tirzah stated that she dropped Gavin and his bike back off at the fairgrounds. Tirzah stated that she did not see anyone walking or hear anything. Tirzah stated that she knew nothing about any crimes or why I even wanted to talk to her. Tirzah let me look through her phone at the conversation between her and Gavin, who told her his last name was Hendriks in their conversation. Everything Tirzah told me appeared to be accurate with their conversation. I had Detective Bushey go speak with Gavin at the fairgrounds before I released Tirzah to ensure their stories were similar. I ended my interview with Tirzah. I had Tirzah sit in a chair in my office while Detective Bushey spoke to Gavin. While waiting to hear from Detective

Bushey, I reviewed the [REDACTED] footage I had. I saw Gavin sitting at a table alone waiting for Tirzah, who was about 10 minutes late. After eating the two left the store.

Detective Bushey advised that Gavin's story with the same and Tirzah could be released. I drove Tirzah back to her vehicle at the fairgrounds.

I returned to the police department. I asked CSO Rodriguez to translate [REDACTED] phone information. CSO Rodriguez was able to tell me that nothing seemed suspicious on her phone. There was conversation between [REDACTED] and her Mama about her uncle's health. There were very few other conversations on the phone. Nothing on the phone helped to determine who did this to [REDACTED] or what happened.

At approximately 11:15 P.M., Detective Bushey and I drove around to the motels in the city looking for a John Davis, a possible suspect as he decided not to show up for work on Wednesday, or his vehicle. We did not locate John or a vehicle that would belong to him.

On September 1, 2018, I arrived at work at 11:45 A.M., I went to [REDACTED] and burned video of August 27, 2018, before it would be erased. While I was at [REDACTED] I got [REDACTED] work schedule from the past week. On August 23rd and 24th [REDACTED] worked from 11:30 A.M. to 9:00 P.M. On August 25th [REDACTED] worked 9:00 A.M. to 3:00 P.M. On August 26th [REDACTED] was off. On August 27th [REDACTED] worked 4:00 P.M. to 9:00 P.M. On August 28th [REDACTED] worked 11:00 A.M. to 9:00 P.M.

I also contacted [REDACTED] and asked her how [REDACTED] was doing. [REDACTED] stated that [REDACTED] was basically the same. I told [REDACTED] to let us know if anything new came up.

I put out an updated press release on the department's Facebook page.

On September 2, 2018, at 10:45 A.M., Detective Bushey and I went to the fairgrounds. Detective Bushey and I watched the roll call for the employees. No one in particular stuck out as suspicious. Detective Bushey interviewed John Davis. After speaking to John, Detective Bushey and I went to speak to the co-workers John was sharing a hotel room with. Detective Bushey spoke to Anthony, while I spoke to Jarid. Jarid stated that he could not keep his days straight because he drinks a lot. Jarid stated that he knew nothing about the assault except that he heard we were asking around about it. Jarid was very cooperative. Jarid agreed to give a DNA sample. Jarid showed me that he did not have any injuries. Jarid stated that if he had to guess that someone from the fair did something it would be one of the ride attendants. Jarid stated that the ride workers are "shady" and he has heard of things like this happening other places with them. Jarid did not know who or where specifically anything occurred, just stated that he heard about it.

Detective Bushey advised that Anthony had some cuts on his knuckles. Detective Bushey stated that Anthony said that he was in a fight in Marshfield, WI, where their last carnival was. Anthony stated that he was drunk and tried to fight the police. Anthony stated that he went to jail. Anthony refused to give a DNA sample to Detective Bushey. Detective Bushey and I went around and spoke to a few other carnival workers in the area. I observed Anthony drinking water from a Dasani Water bottle. Anthony set the water bottle down on the clock timer for the Speedball game he was working. Detective Bushey and I stayed in the area and watch Anthony. After awhile Anthony's water bottle was almost empty. Anthony took off his work shirt, met up with another employee and walked away. Anthony was completely out of sight and no where in the area when I walked passed his game and looked around for a few minutes. Anthony had abandoned his water bottle. I collected the water bottle with a gloved hand. Detective Bushey and I left the fairgrounds. I turned the bottle over to Detective Bushey and he put it into evidence.

Once at the police department, I called [REDACTED] to check on [REDACTED] [REDACTED] stated that [REDACTED] was the same. [REDACTED] stated that the [REDACTED] had been removed. [REDACTED] stated that [REDACTED] doesn't remember anything. [REDACTED] stated that [REDACTED] was talking a very little bit. [REDACTED] stated that [REDACTED] has only said a few words about the pain and medication. Detective Bushey and I spoke with [REDACTED] family for a few moments. [REDACTED] was concerned about the man that had given [REDACTED] a hard time at work the day before. We explained to [REDACTED] that we identified that subject and ruled him out. [REDACTED] stated that the subject was a firefighter or police officer. We explained to [REDACTED] that the subject has disabilities and believes that he is a firefighter and sometimes wears a uniform and carries a radio. We assured [REDACTED] that the subject was not an actual firefighter or police officer. [REDACTED] also told Detective Bushey and I that [REDACTED] does not know that she was [REDACTED] yet. [REDACTED] asked that we not tell her this yet. We assured [REDACTED] that we would not tell [REDACTED] this information when we spoke to her. After answering all of the families questions, we put on gowns and gloves to entered [REDACTED] room.

[REDACTED] stated that the subject had dark black skin, short black hair, and was skinny. [REDACTED] stated that the male was wearing a white t-shirt, black pants, and black shoes. [REDACTED] stated that the subject was in his mid twenties. [REDACTED] stated that the subject said hi to her. [REDACTED] stated that she got scared and ran to her car. [REDACTED] stated that she got into her car and the next thing she remembers is waking up in the hospital. [REDACTED] stated that she did not know the male subject but stated that he could have been into [REDACTED] and she wouldn't know because she sees so many people through out her day. [REDACTED] stated that she thought she would recognize the subject if she saw him again. We ended the interview with [REDACTED] at approximately 12:52 P.M. Detective Bushey and I cleared from the hospital at approximately 1:05 P.M.

After returning the Elkhorn Police Department, Detective Bushey and I went to the Fairgrounds at approximately 2:37 P.M. Detective Bushey and I met with Mark Cockerham. We described the description [REDACTED] gave us to Mark. Mark advised that he had three employees fitting that description. Mark stated that the three

employees he had in mind were Terrence Leflore, Trent Mitchell, and Oqwandre Wiltz. Mark stated that all of the subjects worked rides in Kiddie Land. Mark stated that he would bring each of the employees to our location individually so we could speak to them.

The first subject Mark brought to us was Terrance D. Leflore, DOB [REDACTED] Terrance was wearing black pants, black shoes, a white t-shirt and a red sweatshirt over the t-shirt. Terrence was tall and thin. Terrence provided us with his current information. Terrance stated that he heard about what we were questioning people about. Terrance stated that on Tuesday, August 28, 2018, he was in Elkhorn. Detective Bushey asked Terrance where he was from 5:00 P.M. to 10:00 P.M.

Terrance stated that he was doing laundry at the laundry mat. Terrence initially stated that he was back around 5:00 P.M. Detective Bushey asked if it was dark out when he got back and he stated that it was. Detective Bushey told Terrence that it would still be light out around that time and asked him if he knew what time he really got back. Terrance stated that he was back to the bunk house around 8:00 P.M. or shortly after. Terrence stated that he walked to the laundry mat. When Detective Bushey asked Terrence which way he walked, he pointed towards the armory gate. Terrence told Detective Bushey that he knew where [REDACTED] was and knew it was across the street from Burger King. Terrence stated that he did not walk down to [REDACTED] Terrence also stated that he had never been to [REDACTED] Terrance stated that Angelique and Dale could verify that story. Terrence stated that he had been charged with burglary once. Terrence stated that he had a probation agent, but did not know his name. Terrance would not give us DNA or let us take a photo of him. When we asked Terrence for both he looked at Mark, who was also standing with us and stated, "Mark, I don't feel comfortable with this. Mark?" Terrence asked if he had to let us take photos and we stated that he did not have to. Terrence stated again that he did not feel comfortable. Detective Bushey and I ended the conversation with Terrence.

Mark then went and got Trent. Trent stated that on Tuesday after setting up rides, he went straight back to the bunk house to shower. Trent stated that he went right to bed after he showered. Trent stated that he never left the fairgrounds that night. Mark, who again was standing in on the conversation, stated that he could confirm that Trent was in the bunk house, because he gave Trent and another subject a ride back to the bunk house on the golf cart. Trent stated that he had been arrested for battery before. Trent stated that he did not want to give a DNA sample or have us take pictures of him. We ended the conversation with Trent.

Detective Bushey and I went to speak to Angelique Barnard, DOB [REDACTED] Angelique is from South Africa. Detective Bushey asked Angelique what she did not Tuesday night. Angelique stated that she got done setting up rides at about 5:00 P.M. Angelique stated that she and Casper went to do laundry at the laundry mat. Angelique stated that they did not want to wait for the laundry so they came back to the fairgrounds. Angelique stated that Dale was available to give her and

Casper a ride back to the laundry mat to get their laundry a little later. Angelique listed some other employee's she saw at the laundry mat, but never mentioned Terrence as being at the laundry mat. Angelique stated that she did see Terrence walking around near the laundry mat, but she was not with him and did not see him in the laundry mat. Angelique stated that she never saw Terrence get back to the bunk house. Angelique stated that she believed Terraece was wearing a white t-shirt that night.

Detective Bushey and I went and spoke to Dale, who was identified as Charles "Dale" Snow, DOB [REDACTED]. Dale stated that he gave Angelique and Casper a ride to the laundry mat. Dale stated that at around 8:45 or 9:00 P.M., they drove to Speedway so Angelique could get some money from the ATM. Dale stated that on the way they passed Terrence walking on the left side of the sidewalk in the area of the old Elkhorn Garage. Dale stated that he did not see what Terrence was wearing but knew for 100 percent it was him because he made a comment to Angelique about why Terrance was out walking in the rain and wondered what he was doing. Dale stated that they went back to the laundry mat and left there at about ten minutes to 10:00 P.M. Dale stated that they probably got back to the bunk at 10:00 P.M. Dale stated that he never saw Terrence at the bunk house.

After speaking with Dale, Mark stated that there was a little suspicion about Terrence's story. I asked Mark about the bunk houses. Mark stated that every person has there own space. Mark stated that the rooms are very tiny and they don't have closet space. Mark stated that he regularly checks the bunks and does inspections. Mark stated that Terrence usually has a very clean room. Mark stated that Terrence had a girlfriend that worked for them up until about two weeks ago. Mark stated that the girlfriend, who was later identified as Jessica M. Spicer from Ridgedland, MS, DOB [REDACTED] was a miserable person, so they let her go.

Detective Bushey and I agreed to have one of the supervisors of North American Midway, Luis Gerardo Gomez, DOB [REDACTED], bring Terrance to the police department for a formal interview and an obstructing charge. Luis followed Detective Bushey and I back to the police department and a marked squad followed behind Luis. We arrived at the police department at approximately 4:21 P.M.

Once back at the police department, I attempted to locate who Terrence was on probation with. I contacted Jackson Mississippi Police Department. Mississippi Police stated that I needed to contact Hintz County Sheriff's Office. I contacted Hintz County. Hintz County told me to contact court services and gave me a phone number. I called the booking sgt. back and she stated that Terrence showed clear in there system. I asked the booking sgt for a phone number for probation and parole. The booking Sgt. gave me the number of 601-576-3520. I tried this number and did not receive an answer. I then went and asked Terrence who he was on probation with. Terrence stated that he did not know his agent's

name. Terrence stated that he was on probation in Canton, Mississippi. I also took photos of Terrence while I was speaking to him.

At approximately 6:15 P.M. spoke to sketch artist Deputy David Deauchine, from Dane County. Deputy Deauchine stated that he would be able to travel to [REDACTED] Hospital tonight and complete a sketch if the victim was up to it. I contacted [REDACTED] nurse, Jen, and asked her to speak with [REDACTED] and let me know if she felt up to working with a sketch artist. Jen called me back and stated that [REDACTED] wanted to do the sketch and felt like she could. Jen stated that [REDACTED] wanted Heidi present while doing this. I contacted Heidi and advised her of this. Heidi stated that she would go to the hospital. Oqwandre stated that he was busy and was not willing to answer my questions. Other carnival workers started yelling at me and telling me that they weren't going to talk to us. I cleared from the fairgrounds.

I returned to the police department. I was told by Officer Termaat that a black [REDACTED] Shirt had been located in Terrence's belongings.

On September 4, 2018, I put out an updated press release on the department's Facebook page.

I located a photo on Terrence social media of him with facial hair. I scanned and attached the photo to the call.

On, 09/03/18, at approximately 4:10pm, I, Officer Termaat responded to the north gate of the Walworth County Fairgrounds at the request of Detective Bushey. Upon arrival he explained that a person of interest related to this crime was going to be transported to the police department by his boss. Bushey explained they would be following him to the police department and he requested that I follow behind to make sure they make it to the police department. I did the same arriving at the police department at approximately 4:25pm.

Upon arrival Detective Bushey asked that I stay with the subject in the booking area while he prepared to interview him. I did the same and while doing so I learned the subjects name was Terrence D. Leflore M/B DOB

██████████ After Detective Bushey completed an intial interview he asked that stay with the subject while he prepared a notice of arrest. He explained that the subject was going to be confined for obstructing. While waiting Leflore began asking me questions about DNA and asked if there was DNA in fingerprints. I explained there was not and explained to him potential sources of DNA. He then began talking about how his boss told him he did not have to provide a sample of his DNA if he did not want to. I explained to him that without a warrant we could not force him to provide a DNA sample. He began talking about not doing the crime and explaining that he was at the laundry mat which is down the road from the crime scene. He asked why we were asking for samples of everyone's DNA. I explained that we request the sample to attempt to locate suspects and also rule out people. I explained that if there is DNA found it would be compared to a database and also compared against the samples we obtained during our investigation. Leflore then asked if he would still be going to jail if he provided a sample of his DNA. I explained that I was certain he would be but I would ask Detective Bushey. I called Detective Bushey and confirmed that he would be going to jail regardless of whether he provided the sample. He then said he might as well not provide a sample then. A short time later he changed his mind and said he wanted to provide a sample. At 6:05pm I collected the buccal swab from Leflore, let it air dry, and then placed it in a envelope and sealed it with evidence tape. I kept the swab in my possession until later in the evening when I secured it in secure evidence storage.

At approximately 6:57pm, I transported Leflore to the Walworth County Jail and confined him on a State charge of Obstructing. Upon arrival I seized the pants, t-shirt, and shoes he was wearing as evidence. I placed each item in a separate plastic bag and transported them to the police department where I secured them in the evidence drying cabinet as they were damp from his time working at the fair. I later packaged each item in separate paper bags,

sealed them, and secured them in secure evidence storage. I also learned that Officer Rayfield had gone to the fairgrounds and collected Leflore's belongings from the bunk house he was staying in. This included two garbage bags containing clothing, back packs, and other personal property. Along with a small television and Playstation. I was also informed that there was a black [REDACTED] shirt in one of the backpacks

I brought the bags of evidence to the evidence processing room and began going through them. The following items of evidentiary value were located collected, packaged, sealed, and secured in secure evidence storage.

- Black backpack that had a black size small [REDACTED] polo style shirt in the front pocket
- Blue draw string back pack that contained a black t-shirt and white t-shirt that were together as if they were worn at the same time, a pair of black athletic shorts, and a grey wash cloth. The white t-shirt and the black t-shirt were separated and on the lower front of the white t-shirt there appeared to be a potential blood stain. On the black shirt a small green leaf that appeared to have blood on it was found. All items were packaged separately.
- A pair of black dress pants was found and collected

On Tuesday, 9/11/18, in the morning hours, I, Detective Bushey, received an email from Sgt. Illingworth with the Walworth County Sheriff's Department. Sgt. Illingworth advised that a Steven Pritchard, an inmate in the county jail, left a message that he wanted to speak with a detective about Leflore. At approximately 10:23 AM. I arrived at the Walworth County jail. A short time later I met with Pritchard.

Pritchard stated he is in the same cell block with Leflore. Pritchard stated when Leflore found out he, Pritchard, is a convicted sex offender, Leflore came to him asking questions. Pritchard stated Leflore is going around the jail talking about his case. Pritchard stated Leflore asked him if fingerprints could be found on a hammer after it had been rained on. I obtained this video from Sgt. Shannon Illingworth with the Walworth County Sheriff's Office. I knew that Niehus and Leflore met in the jail when Niehus was confined in the same section of the jail with Leflore. On this video Leflore talks about seeing himself on TV. Niehus warns Leflore about not saying anything on this video because they listen to these. Niehus tells Leflore about how preliminary hearings work and how the court system works in Wisconsin. Leflore tells Niehus that they gave him six charges. Niehus tells Leflore they will give him a plea and they will drop four of the charges. Leflore wonders how much time he will get for these charges. Niehus tells him five years in prison. Niehus then offers to put money on Leflore's books if Leflore gives him his money card he has in his property and passwords. Leflore does give Niehus the password and agrees to release his money card to him. Leflore tells Niehus that these guys are trying to put attempted homicide on me. Niehus responds saying that girl was pretty fucked up and in intensive care. Leflore answers; "ya". Leflore tells Niehus he is reading a book that tells him God forgives and it doesn't matter what you did God forgives. Leflore tells Niehus this is his first violent crime.

I then listened to a jail phone call that Leflore made to Niehus on 9/19/18 at 10:13 AM. In this call Leflore asks Niehus if he got a hold of the two people he asked him to get a hold of. Niehus stated he sent them a message but they haven't called back. Leflore asks if Niehus put any money on his account yet. Niehus stated he will be putting money on his commissary.

On 9/21/18 I listened to a jail call from Leflore to a Will Hawkins. The call was made on 9/21/18 at 1:15 PM to [REDACTED]. In this call Hawkins tells Leflore that he saw him on the news and this was all over. Leflore tells Hawkins he said he did it because they kept telling him he did it. Leflore tells Hawkins that they didn't say they found any DNA and if they don't find any they will have to let him go. Leflore tells Hawkins there was a van involved and other people.

On 9/24/18 I listened to a jail call from Leflore to Hawkins made on 9/22/18 at 1:22 PM. to [REDACTED]. In this call Leflore asks Hawkins to call Alan (Niehus) and Leflore gives Hawkins Niehus number. Leflore stated he gave Alan his card and his money and he hasn't heard anything from him since. Leflore tells Hawkins that his public defender says they are racist and she is going to fight it and if he gets convicted she is going to try to get him less time.

On Monday, January 28, 2019, I, Detective Bass, checked my email upon my arrival at work. I saw that I had an email from DA Wiedenfeld. The email contained an email from Attorney Larry Pruden. Part of the email went as follows:

Larry Pruden, here. I represent Juan Garnica who is currently in the Walworth County Jail. He tells me that he has received information from another defendant who has been charged with a [REDACTED] in which the victim was hit with a hammer. He told me the name was Laflores or Leflores, I am not sure the exact spelling.

It appears that the information my client has was derived from jail conversations with the accused. He is willing to share this information with investigators.

DA Wiedenfeld responded and stated that he would not be offering any deals or reductions to Juan's charges in exchange for his statement. DA Wiedenfeld advised that he would have Detective Bass follow up with him.

I emailed Attorney Pruden and asked if Juan would still be willing to speak to me even though DA Wiedenfeld would not be offering him anything in exchange for the information.

Attorney Pruden responded and advised that Juan did still want to speak and stated that he needed to be present when we met.

I arranged with Attorney Pruden to meet with he and Juan on February 6, 2019 at 11:30 P.M.

On February 6, 2019 at 11:30 P.M., I met with Attorney Pruden in the lobby of the Walworth County Sheriff's Office. We went and spoke with Juan. I recorded the conversation. I began my recorder at 11:45 P.M.

Juan stated that he spoke to a sergeant about what he was told first. Juan stated that he didn't even know what Leflore was here for. Juan stated that when he got moved to K pod, he met Leflore. Juan stated that he didn't know anything about Leflore's case. Juan stated that Leflore started asking him questions. Juan stated, "He was asking me how long it would take for his fingerprints to be washed off in the rain." Juan stated that he told Leflore it depends and wanted to know what he was talking about because he had no idea what he was referring to. Juan stated that Leflore then asked him under what

circumstances could DNA be left behind. Juan stated that he didn't understand what Leflore was talking about. He stated that he had just gotten to the pod and didn't even know Leflore's name at that time.

Juan stated that a guy he was in jail with named, Michael Rice, was sitting right behind him when Leflore was asking him these questions. Juan stated that he asked Michael if he heard what Leflore was asking and Michael stated that he did. Juan stated that Leflore stated that he left something out in the rain. Juan stated that he asked Leflore what he was talking about. Juan stated that Leflore told him that "there was a knife that they found." Juan stated that after that he started connecting the dots.

Juan stated that people started asking him what "Hammertime" was talking to him about. Juan stated that he asked who Hammertime was. Juan stated that someone told him that was what they call Leflore because he hit a girl with a hammer and [REDACTED] her. Juan stated that he was like, "What the fuck." Juan stated that recently Leflore was asking him how long it would take to get his charges dropped because they didn't have anything on him at the time.

Juan stated, "It kinda screwed with me because yeah I'm in jail, yeah there's a little bit of a criminal code, but I still have a moral compass." Juan stated that he didn't like the way that Terrence was asking him the questions. Juan stated that Terrence was asking him about "his" fingerprints not just fingerprints in general. Juan stated that recently Terrence was bugging him again because he has a court date coming up. Juan stated that he's not the jail house attorney and he doesn't want to hear this "shit." Juan stated that Terrence was asking him about video of him at [REDACTED]. Juan stated that Terrence also asked him about [REDACTED]. Juan stated that Terrence is smart enough to ask him these questions when he's alone in the day room by the TV or in the gym, but stated that he doesn't understand why Terrence asks him these things. Juan stated that he knows Terrence is "full of shit." Juan stated that he just told Terrence that he has an attorney for this "shit" and he's not his attorney.

Juan stated that he's been in jail since November 28, 2018. Juan stated that he didn't meet Terrence right away. Juan stated that he wrote about what Terrence told him. Juan stated that he wrote a poem about it called 'Confession' and put a date on it. Juan stated that the paper was in his cell. Juan stated that he would give a copy of it to his attorney to give to me.

Juan stated that he spoke to Sgt. Harold about what Terrence told him. Juan stated, "All I know is he's the strangest guy in there and the way he talks about this shit. He only does it with certain people. I asked Juan if the staff talked to Terrence and told him not to talk to him anymore. Juan stated, "No, people just kinda do their own thing. You can tell his cornbread ain't quite done all the way, if it's done at all. Everyone's kinda got their own little slice of crazy. I get it, but his is more than I'm willing to tolerate. This is

some serious shit." Juan stated that he even asked Harold what happened to the victim and if she was alright. Harold told him that she went to the hospital and was released. Juan stated, "My daughter is at the fair every year so this kind of shit doesn't sit well with me."

Juan stated that he talked to his attorney about this. Juan stated that talking to me wasn't about getting anything. He stated that this just doesn't sit well with him.

Juan stated that he doesn't know a lot about the case or what we have for information, but stated that Terrence is talking like he's going to walk out of here. Juan stated that on this past Sunday Terrence was asking his advice about a speedy trial and how that would help him. Juan stated Terrence was saying that we don't have anything on him and a speedy trial would rush anything we don't have. Juan stated that Terrence told him that he has court coming up on the 15th. Juan stated that he wouldn't know any of this stuff if Terrence wasn't telling him. Juan stated over and over again that this doesn't sit well with him. Juan stated that he doesn't believe Terrence at all when he says he didn't do it. Juan stated that this was "serious shit" and he doesn't want him to just walk out of here on a technicality.

Juan stated that he just can't understand why Terrence talks about this to people. Juan stated, "I don't know if he's just scared or not well in the head."

Juan stated that everything he told me was the truth. Juan stated that I didn't threaten him in anyway or make him any promises.

I ended the recorded conversation with Juan at 12:04 P.M.
