

INTRODUCTION

Every veteran can recall his or her first days in the military. Discarding your civilian clothes, your civilian hair, and your civilian mannerisms – trading them for a uniform and uniformity. From your first day to your last day, you are assigned a rank, whether it be Private or Chief Master Sergeant. You are indoctrinated in military precision – the precision of verbal commands, the precision of drill and ceremony, and the simple precision of the hand salute.

Over the years of military service, you accumulate insignias – higher rank and medals for war service, meritorious achievement, and valor. The insignias are visible: chevrons on your sleeve and ribbons on your chest – distinct symbols arranged with an exact precedence.



For a veteran, the penultimate memorial to his or her military service is the government-issued grave marker. Uniformly arranged on a green field of grass with the precision of a troops in formation, who have been mustered for a final parade ceremony. Like their former uniforms, the only distinguishing features are the individual inscriptions on each veteran's marker: name, rank, branch, war service, and medals. Unlike those worn on a daily uniform, these insignias are permanently carved in stone.

The Central Wisconsin Veterans Memorial Cemetery, and the headstones installed within it, should reflect and memorialize both the dedication to duty and the military precision demonstrated by each of these veterans while in uniform.

Anything less diminishes their service to our nation.

The first edition of *Vandalism of Neglect* was published on Memorial Day 2017. Only one copy was distributed: it was sent directly Secretary Daniel J. Zimmerman, of the Wisconsin Department of Veterans Affairs, under an executive summary that highlighted its major findings.

At the time of this writing, **nobody** at the WIDVA has contacted me about this book or the findings contained therein.

PREFACE TO THE FIRST EDITION

Burials at the Central Wisconsin Veterans Memorial Cemetery have been carried out for nearly 130 years.

In total, the installations of over 7,000 headstones were administered either by the Grand Army of the Republic (GAR) or subsequently by the Wisconsin Department of Veterans Affairs (WIDVA).

Hundreds and hundreds of these stones have erroneous inscriptions: wrong dates, wrong ranks, misspelled names, missing war service, missing valor awards, and incorrect military units.

Additionally, there are more serious errors in the placement of the headstones themselves – including misplaced headstones and duplicate headstones.

This publication documents a total of 858 headstones with inscribed errors or other serious indications of mismanagement. Ignoring, for a moment, the seriousness of this work; basic human error might allow for an error rate of perhaps 5% or less. Given the solemn nature of this work, the precision it requires, and the permanence – it is literally carved in stone – the goal should be an error rate of less than 1%.

The error rate described in this publication is more than 12%.

Not all of these stones need to be replaced, however, some of the errors clearly demand that individual stones be replaced.

Eventually, every stone – through normal wear – will need to be replaced. It will be important to have this corrective information available when a new stone is ordered.

Obviously, those errors of misplacement, duplication, etc – should be addressed immediately.

Limitations:

- I did not have access to CWVMC records, except for the limited information that has been transferred to the VA Nationwide Gravesite Locator database, which is known to be incomplete.¹
 Access to these records (and collaboration by the state of Wisconsin) was requested at the time my research began but was politely declined.
- While many requisitions/applications for veteran's headstones are quickly available online, records are not immediately available for the years 1903-1925 and 1963-to-date. Access to all applications could clarify some of the presumed errors.
- As exhausting as this work was, researching 100% of the headstones for any missing or incorrect information (medals, ranks, units, etc) – would be too time consuming as a personal research

project. So, I concentrated on the more obvious errors, apparent anomalies, and missing information. Undoubtedly, many dozens of additional errors remain unidentified.

• I am not privy to the requests and desires of the deceased veterans and their families. For example, a veteran may not have wanted the war or his valor awards to appear on his headstone. The family may have purposely limited a veteran's military information to preserve inscription space for sentimental messages.

I have no interest in placing blame for these errors, however, I am resolute in providing this information in the hopes of reducing or eliminating future errors.

My recommendations – for improving the accuracy and completeness of CWVMC headstone inscriptions – follow.

PREFACE TO THE REVISED EDITION

I thought my research project at the Central Wisconsin Veterans Memorial Cemetery (CWVMC) was finished. I had researched every burial for 125 years (1888 to 2013) and published four (4) books about the cemetery.

Last fall, in final effort to obtain better information about CWVMC burials, I submitted an "Open Records" request to the Wisconsin Department of Veterans Affairs (WIDVA). One day before Veterans Day, the WIDVA flooded my email inbox with very large PDF files.

The WIDVA disgorged 2,244 pages of burial records. It was as though my research had to be started over again – from scratch.

I could now compare my database of burial records to the "actual" burial records. Access to the actual records solved many mysteries, however, they also created many new mysteries. For example, I could finally resolve why some married couples were not buried in adjacent graves; but, with the actual records, I found additional couples buried apart from each other.

These new findings were significant enough to require a revised version of this book.

I have been researching the "Home Cemetery" for 8 years – off and on. Almost from the beginning, I have had one nagging question: "Are there unmarked burials in this cemetery?"

I finally have an answer: "YES"

• **Bernard William McBRARTY** was a Civil War combat veteran of both the Union Navy and Union Army. He is buried at the CWVMC, but he does **not** have a headstone.

McBRARTY and his military service have been "unknown" for over 95 years.

• **James Francis ARMSTRONG** was a Civil War veteran who had been at the Veterans Home for less than a week when he died – too brief a time to appear in some official records. His grave appears to have been marked with the name and military unit of another Civil War veteran.

ARMSTRONG and his military service have been "unknown" for over 110 years.

• CWVMC records confirm that the two (2) headstones inscribed as "UNKNOWN" do, in fact, mark the graves of two (2) individuals whose identities are not known. It is likely one of these graves is occupied by Bernard McBrarty. Despite my herculean research efforts, the identity of the second person – and his or her role during the Civil War – remains unknown.

Again, I have provided revised recommendations near the end of the book.

A Partial Explanation for Burial Anomalies

Current CWVMC burial records were not created contemporaneous to each burial, nor do they appear to have been transcribed from older records – older records, which would have been created contemporaneous to each burial.

CWVMC burial records appear to have been created by "walking the cemetery" and recording information from headstones.

In other words: NO HEADSTONE = NO BURIAL RECORD

How consistently were headstones installed at the CWVMC?

Eligible veterans buried at the CWVMC have always been authorized a government-issue headstone.

However, none of the Civil War wives and widows were eligible for a government-issue headstone. In some cases, the family furnished a private headstone. In other cases, members of the Veterans Home would take up a collection to purchase a headstone for a dear deceased friend.

Many of these women were buried in graves marked only with temporary markers, which were left in place for many years.

A total of 270 women were buried at CWVMC between 1911 and Feb 1926, which means many dozens of "temporary" markers were in place for 5, 10, or up to 15 years.

Many of the burial errors (or anomalies) relate to burials that occurred prior to 1926.

LETTERING OF MARBLE SLABS FOR WOMEN AT VETERANS' HOME

The lettering of marble slabs to be used for markers for the graves of deceased women inmates at Wisconsin Veterans' Home is now being done at the Waupaca Granite Works, A.W. Spindt, proprietor.

The federal government furnishes a stone for every soldier grave but makes no provision for permanent marking of the grave of a widow.

All women's graves since 1911 have been only temporarily marked at the Veterans' Home Cemetery.

The ninety-seven slabs that have been cut down from old slabs erected by relatives of soldiers will be sufficient to mark the graves of women buried during the years from 1911 to 1917 with three markers for graves made in 1917.

BURIAL ANOMALIES

Two Burials Marked as "UNKNOWN"

Anyone, who has attended the Tomb of the Unknowns at Arlington, knows it is the most solemn memorial associated with the United States Armed Forces. The memorial is dedicated to all US service members who have died in service without being identified – "known but to God".

Collectively, national military cemeteries across the country contain the remains of tens of thousands of "Unknown" soldiers, sailors, Marines, and airmen. But, the CWVMC is not a battlefield cemetery where you would expect to find "Unknown" burials.

Two (2) burials at CWVMC are marked with headstones inscribed with a single word: "UNKNOWN".

CWVMC inter-office memos confirm both that the burials were carried out at these gravesites and that the identities of the individuals were once known but have been "lost" over time.

ONE IDENTITY IS NOW KNOWN

Bernard William "Barney" McBRARTY was a Civil War combat veteran who served in both the Union Navy and the Union Army. His service included a hitch on the gunship USS General Thomas, service as a basic infantryman, and a lengthy assignment with a federal artillery regiment. In total, he served almost three (3) years. He was one of four (4) McBrarty brothers who answered the call to serve during the "war of the rebellion".

He applied for membership at the GAR Veteran Home in King on 21 Jun 1921. On his application, he stated he was: 78 years old, widowed with no living children, received an Army pension worth \$50 per month, and had lived in Wisconsin for the past eight (8) years. When asked, if he died, to whom should his property should be sent, he answered there was "no one to leave it to".

Bernard McBRARTY died at the GAR Home on 19 Feb 1923. The Waupaca County Post announced his death, but stated the funeral arrangements were pending — no further details were published. His Waupaca County death record shows that **McBRARTY** was buried at the Veterans Home Cemetery.

Based on a careful analysis of CWVMC burial records, it can be reasonably concluded that...

Bernard McBRARTY is buried in one of the two graves marked with an "UNKNOWN" headstone.

The unresolved questions:

- 1. In which, of the two "UNKNOWN" graves, is McBRARTY buried?
- 2. Who is buried in the other "UNKNOWN" grave?

MIS-MARKED BURIAL: JAMES ARMSTRONG

James Francis ARMSTRONG enlisted in the 3rd Iowa Infantry on 20 May 1861 – only five (5) weeks after the start of the Civil War. He served for 35 months during this enlistment. He also claimed service in the 156th Illinois Infantry, but his name is not found on its roster – suggesting he may have used an alias during this enlistment.

From his home in La Crosse, he applied for admission to the GAR Veterans Home on 15 Nov 1907. He gave these answers about himself: he was 79 years old, worked as a mason and had lived in La Crosse for the past eight (8) years. Asked if he was married, single, or a widower – he responded, "YES".

The application also documented his dire living condition: he had no pension, he had no money nor any personal property, and he was unable to support himself because he was sick with "dropsy".

His application was received at King on 19 Nov 1907. Applications were approved by the Board of Trustees during scheduled meetings. While applications were pending approval, it was not unusual for a Civil War veteran with immediate needs to be admitted to the Home on an unofficial basis.

James ARMSTRONG was a temporary resident of the GAR Home when he died of dropsy on 23 Nov 1907. **He had been living at the Home for only four (4) days at the time of his death**. Because his membership was unofficial, his name was never entered in the Veterans Home admissions ledger – this peculiarity of record-keeping would lead to the mis-marking of his grave.

His Waupaca County death record confirms he was a resident of the GAR Home when he died. It also confirms that James ARMSTRONG was buried at the Veterans Home Cemetery.

He was never assigned a burial number and he does not appear in any CWVMC burial record. It appears cemetery management failed to adequately document ARMSTRONG's burial — or, at least, failed to maintain any documentation of his burial. A review of CWVMC burial records shows that cemetery management often consulted the Home admissions ledger to resolve burial record-keeping deficiencies. It is therefore supposed:

While searching in the admissions ledger for a veteran (perhaps for "James A_____"), they found James ANGEVINE, who (not coincidentally?) was also from La Crosse. ANGEVINE's entry in the admissions ledger was annotated with "Died June 29, 1914". Normally, if a date of death was recorded it was followed by the burial location — but this was not true for ANGEVINE. CWVMC records show that ANGEVINE was buried at Sec 9, Lot 4 OOS, Grave 44; and a headstone with his name is installed there.

In their attempt to confirm the identity of the person buried in Lot 4 OOS, Grave 44; it appears that **James ARMSTRONG** was misidentified as **James ANGEVINE**. But, **ANGEVINE** is known to have died and been buried in La Crosse.

After a detailed analysis of CWVMC records and other documentation, it can be reasonably concluded that James ARMSTRONG is buried at Sec 9, Lot 4 OOS, Grave 44.

NEVER-BURIED-HERE BURIALS

Burials of two (2) Civil War veterans – thoroughly documented in CWVMC records – never happened. Probably not a coincidence, both non-burials involve a veteran who died in the month of June 1914.

1. **James ANGEVINE** was admitted to the Veterans Home on 6 May 1896.

CWVMC records and the NGL database show that he died on <u>29</u> Jun 1914 and was buried at Sec 9, Lot 4 OOS, Grave 44. He served in a New York regiment, and this lot was reserved for veterans who served in out-of-state units. A government-issued headstone was installed at this site, which was inscribed with his name.

He was visiting his hometown, when he died in La Crosse on <u>27</u> Jun 1914. He was a well-known resident of La Crosse and the news of his death and burial was recorded in local newspapers.

James ANGEVINE is buried at Oak Grove Cemetery in the city of La Crosse.

Research has concluded James ARMSTRONG is buried at Sec 9, Lot 4 OOS, Grave 44.

Peter STEINEBACH was a member of the Veterans Home when he died on 17 Jun 1914.

CWVMC records and the NGL database show that he was buried at Sec 8, Lot 3 OOS, Grave 83. A government-issued headstone was installed at that site – inscribed with his name and military unit. Strangely, the headstone is not a "Civil War style" headstone, which suggests it was ordered well after STEINEBACH had died.

His Waupaca County death record clearly states that his remains were removed to "Colby, WIS" for burial on the same day he died. A newspaper article published Colby announced his death; it also noted that his remains were escorted by his son on the "evening train" and they arrived in Colby on the same day he died.

Peter STEINEBACH is buried at Colby Cemetery in Colby, WI, next to his wife, Lydia.

The contents of Grave 83, if any, is an open question.

Not-A-Person Burials

Four (4) burials – documented in CWVMC records with varying levels of credulity – never happened; furthermore, the persons documented in each burial – never existed.

1. Marion LOSIR was assigned burial #166 and according to CWVMC records he is buried at Sec 7, Lot 2 OOS, Grave 7. Twenty-four (24) years after his death, Marvin LOSIE was assigned burial number 1031 and he is buried at Sec 8, Lot 3 OOS, 37. A government-issued headstone inscribed "Marvin LOSIE" is installed at BOTH gravesites.

Marion LOSIR never existed as a person. "Marion LOSIR" is a duplicate record for Marvin LOSIE, who did exist.

It can be reasonably concluded that Marvin LOSIE is buried at Sec 7, Lot 2 OOS, Grave 7.

The contents of Sec 8, Lot 3 OOS, Grave 37, if any, is an open question.

2. Both **Maria MAYNARD** and **Maria MOORE** were assigned burial #422. Each has a headstone installed in Lot 13 INF – at Grave 2 and Grave 5 respectively.

Detailed analysis of all available records concludes: Maria MOORE never existed as a person.

The contents of Grave 5 (and perhaps Grave 2), if any, is an open question.

3. **Unity RUSSELL** was assigned burial #641½. According to CWVMC records, she is buried at Sec 10, Lot 5 OOS, Grave 67. A headstone, with a very simple inscription, is installed at this site.

A review of CWVMC records finds that "**Unity RUSSELL**" was a duplicate identity formed by an erroneous transcription of "Emily RUSSELL" as "**Eunity** RUSSELL". At some point, "Eunity" morphed into "Unity", was assigned a burial number, and provided a headstone.

(The 1900 Census shows only ONE (1) person in the entire United States with the given name of "Unity" – she lived in Tennessee and had no connection whatsoever to the state of Wisconsin.)

Nelson and Emily RUSSELL, who are buried adjacent to the "Unity" headstone, did not have a family member named "Unity".

Unity RUSSELL never existed as a person. The contents of Grave 67, if any, is an open question.

4. Mana STANLEY was assigned burial #713 and according to CWVMC records she is buried at Sec 2, Lot 8 OOS, Grave 30. A headstone is installed at this site.

Detailed analysis of all available records concludes: Mana STANLEY never existed as a person.

The contents of Grave 30, if any, is an open question.

MISMANAGEMENT OF BURIAL RECORDS

Each burial at the CWVMC is assigned a "burial number" – a number assigned chronologically. According to CWVMC documentation, various anomalies within this numbering system allow for the real possibility that the records of additional burials may have been "lost"; and, therefore, the burials themselves would be "lost":

• Missing Burial Numbers:

In 1995, CWVMC staff compiled a list of "missing burial numbers" – burial numbers for which no burial had been assigned. Those burial numbers are:

Numbers that have been stricken-through have been resolved by the author; that is, a known burial can be assigned to these burial numbers.

<u>Unresolved Question:</u> Do any (or all) of these "missing burial numbers" represent unknown and unmarked burials?

Half-Number Burial Numbers:

Over time, CWVMC management failed to document some burials as they occurred. To document these burials after-the-fact, management created these "half-number" burial numbers, so that the burials could be "inserted" into the chronological numbering system:


<u>Unresolved Question:</u> Were there other burials at CWVMC that have gone undocumented and the graves unmarked?

² Missing burial number 684 was identified by the author – ironically, it was "missed" during the 1995 CWVMC analysis of "missing" burial numbers.

SPOUSES BURIED SEPARATELY

STIPULATIONS FOR THIS SECTION:

- 1. In the CWVMC, a husband and wife should be will be buried in adjacent graves.
- 2. All burial locations stated in this section are based on CWVMC records. Any <u>presumptions</u> about burial locations or headstone installations are deliberately phrased as such.
- 3. All CWVMC records regarding specific burial locations were propagated by an eyes-on survey of headstones taken in the 1950s. For burials before 1950, "Burial Location" was determined by the location of a headstone, and **NOT** from original, contemporaneous burial records.



Orson & Margaret HEATH

Orson HEATH died in 1911 and was buried at Lot 5 OOS, Grave 18. His wife, **Margaret**, was buried in Grave 21 of the same lot.

Between their graves, are buried **John and Maria BARTON**, in Graves 19 and 20 respectively.

Margaret HEATH died on 29 Jan 1922.

John BARTON died only six (6) weeks later on 16 Apr 1922.

John BARTON would not have been buried next to **Orson HEATH**, who had a living a spouse at the Veterans Home.

Presumably, Margaret HEATH's headstone was installed at John BARTON's grave, and John BARTON's headstone was installed at Margaret HEATH's grave.

Jerry & Hannah GIBSON

Jerry GIBSON died on 5 Jul 1905 and was buried at Lot 21 INF, Grave 67. This is a "corner" grave – the southeast corner of the lot.

Hannah GIBSON died in 1912 and was buried in the same lot, in Grave 2, which is immediately adjacent to the northwest corner grave (Grave 1). The occupant of Grave 1 is **John BROW**, who died on 22 May 1905. **Jerry GIBSON** and **John BROW** are buried in diagonally-opposite corners of the same lot and they died within 6 weeks of each other.

Presumably, **GIBSON**'s headstone was installed at **BROW**'s grave, and **BROW**'s headstone was installed at **GIBSON**'s grave.

John & Ellen HESSON

John and Ellen HESSON are both buried in Lot 7 OOS, but not in adjacent graves.

Ellen died 11 years after her husband, and she was buried three (3) rows away from his grave. The only grave immediately adjacent to **John**'s grave was <u>not</u> available at the time of **Ellen**'s death.

Edward & Mary BENSON

In 1905, **Edward BENSON** was buried in Lot 42 INF, which is the lot reserved for members of the 42nd Wisconsin Infantry regiment. There is only one grave adjacent to **BENSON**'s grave; and, it is occupied by **Charles SMITH**.

Charles SMITH did not serve in the 42nd Wisconsin.

Mary BENSON was buried in Lot 1 OOS, which is a lot reserved for Civil War veterans (and their spouses), who served in units not affiliated with the state of Wisconsin. Her husband served in the 42nd Wisconsin.

So, both **Charles SMITH** and **Mary BENSON** are buried in the wrong lot.

Charles SMITH died on 9 Feb 1909.

Mary BENSON died on 9 Feb 1909.

It would be reasonable to conclude that either:

- Mary BENSON and Charles SMITH were each buried in the grave intended for the other;
 OR,
- 2. The headstone for each was installed at the grave of the other.

Michael & Bridget HANLEY

Michael HANLEY died in 1905 and was buried in Lot 6 OOS.

Bridget HANLEY died in 1923 and was buried in Lot 8 OOS.

Michael was buried in Grave 2 of Lot 6 OOS. At the time of his burial, Grave 1 was already occupied, but Grave 3 was vacant. Grave 3 remained vacant for three (3) years <u>after</u> **Bridget**'s death.

Bridget was not assigned a burial number at the time of her death, which suggests her burial and burial location were not properly documented. There may have been additional confusion because **Bridget HANLEY** was admitted to the Veterans Home as **Bridget O'GRADY**.


James & Anna LYON

James died in 1907 and was buried at Lot 22 INF, Grave 6.

Anna died in 1919 and was buried in the same lot as her husband, but in Grave 22, which is at the end of the next row.

The two graves (Grave 5 and Grave 7), which are immediately-adjacent to **James**' grave, remained vacant until 1977.

Anton & Wilhelmina REITER



Wilhelmina died in 1901 and was buried in Lot 9 INF, Grave 25.


Anton died three (3) years later and was buried in Grave 29.

Grave 26 – immediately-adjacent to **Wilhelmina**'s grave – remained vacant until 1979.

James & Maria WATT

Maria WATT was buried at Lot 7 OOS, Grave 14. Her husband, **James WATT**, died only 42 days later. He is buried in Grave 25 of the same lot – but in a different row.

William SANDEL is buried next to Maria WATT in Grave 15.



All three (3) of them died within 42 days of each other:

Maria WATT 5 Feb 1900 William SANDEL 7 Mar 1900 James WATT 19 Mar 1900

Presumably, **SANDEL**'s headstone was installed at **James WATT**'s grave, and **James WATT**'s headstone was installed at **SANDEL**'s grave.

George & Elizabeth RICE

Elizabeth died in 1921 and was buried at Lot 8 OOS, Grave 2.

George died two (2) years later and was buried in Grave 25 of the same lot – one row and several gravesites away from his wife's grave.

Grave 3 – immediately-adjacent to Elizabeth's grave – remained vacant until 1946.

John & Annice RYAN Chauncey & Rebecca TIMMERMAN

Both couples are buried in Lot 4 CAV. **Annice** and **Rebecca** pre-deceased their respective husband.


At one end of the lot, **Chauncey TIMMERMAN** is buried next to **Annice RYAN**.

At the opposite end of the lot, John RYAN is buried next to Rebecca TIMMERMAN.

Both John RYAN and Chauncey TIMMERMAN died four (4) months apart in 1915.

It would be reasonable to conclude that either:

- John RYAN and Chauncey TIMMERMAN were each buried in the grave intended for the other;
 OR,
- 2. The headstone for each was installed at the grave of the other.



Elisha & Lucy WAGNER

Elisha died in 1921 and was buried at Lot 4 OOS, Grave 58.

Lucy died on 3 Aug 1923 and was buried in Grave 62 of the same lot.

Between the **WAGNER**s' graves, three people are buried: **LeGrand COLEMAN** and his two wives, **Helen and Emma**. All three **COLEMANs** share a single headstone.

Of this group, **Helen COLEMAN** was the second to die. Why would she be buried in the only vacant grave next to **Elisha WAGNER** – if both Elisha and Helen had surviving spouses at the Veterans Home?

Presumably, **Lucy WAGNER** is buried next to her husband, and her headstone was installed at the wrong grave (on the wrong side of the single **COLEMAN** family stone).

Herman & Wilhelmine SCHULZ

Wilhelmine died in 1919 and was buried in Lot 3 INF, which is the lot reserved for members of the 3rd Wisconsin Infantry and their spouses.

Herman had served in the 3rd Wisconsin Cavalry during the Civil War, so **Wilhelmine** should have been buried in Lot 3 CAV.

When **Herman** died in 1928, he was buried in Lot 3 CAV – more than a hundred yards away from his wife's grave.

Albert & Mary THORP

Albert died in 1910 and was buried at Lot 14 INF, Grave 5.

When **Mary** died in 1924, she was buried in Grave 22 of the same lot. Her grave is one (1) row and two (2) gravesites away from her husband's grave.

The grave immediately-adjacent to Albert's grave remained vacant until 1931.

Sarah VOUGHT & Gardner VOUGHT & David AMIDON

Sarah VOUGHT is buried at Lot 4 CAV, Grave 10.


Her two husbands are buried nearby. **David AMIDON** is buried in Grave 5 and **Gardner VOUGHT** is buried in Grave 7 of the same lot.

Therefore, **Sarah VOUGHT** is buried in a different row than both her husbands.

A large "family" stone was installed at Grave 6; the only inscription is "VOUGHT". A smaller stone (inscribed with **Sarah**'s full name and lifespan) is installed at Grave 7, but this stone is a footstone – marking the foot of her grave. Footstones are not authorized in the CWVMC, so the stone was installed in-line with the next row.

It is reasonable to conclude that **Sarah VOUGHT** is buried in Grave 6 – between her two husbands – and only her footstone is located at Grave 7.

John & Mary WALTON



John died in 1910 and was buried at Lot 16 INF, Grave 3. An adjacent grave, Grave 6, was vacant at that time.


A year later, in 1911, **Sarah CASE** was buried next to **John WALTON** in Grave 6. She was a Civil War widow whose husband was buried in a hometown cemetery. Described elsewhere in this work, **CASE**'s burial record was mismanaged, so her burial location will remain suspect.

Mary WALTON was buried in Grave 14 – located in a different row and several gravesites away from her husband's grave.

The two graves, on each side of **Mary WALTON**'s grave, are occupied by a married couple (see **James & Ellen WELSH** below).

Confusion about **Sarah CASE**'s burial leaves open the possibility that **Mary WALTON** is buried in Grave 6, and their headstones were installed at each other's grave.

James & Ellen WELSH



Ellen and James WELSH are buried in Lot 16 INF, in Grave 13 and Grave 15 respectively.

Between their graves, **Mary WALTON** is buried in Grave 14. **WALTON**, herself, is separated from her own husband's grave.

Of these three individuals, James WELSH died first in 1908. Ellen WELSH and Mary WALTON died about one (1) year apart.

Presumably, **Ellen WELSH**'s headstone was installed at **Mary WALTON**'s grave, and **Mary WALTON**'s headstone was installed at **Ellen WELSH**'s grave.

Charles & Lydia WELCH

Charles and Lydia WELCH are both buried in Lot 5 INF, in Grave 5 and Grave 6 respectively.

Although numbered consecutively, the graves are found in two different rows and two gravesites away from each other.

George & Louisa LAUX

Louisa's first husband, **John POWELL**, died of disease during the Civil War. She married a veteran of the war, **George LAUX**, before the war was over. They were both admitted to the Veterans Home in 1896. **George** died in 1900 and was buried in Sec 1, Lot 1 OOS, Grave 80.

After **George**'s death, **Louisa** married **Charles WEEKS**, another Civil War veteran and member of the Veterans Home. They were later divorced.

Louisa LAUX was buried next to **Charles WEEKS** (the husband she had divorced) at Sec 6, Lot 9-12 BTY, Grave 32. **George and Louisa**, who were married for 37 years, are buried on opposite sides of the cemetery.

INTERLOPING BURIALS BETWEEN SPOUSES

The following table lists 12 pairs of burials, where a husband and wife are buried "near" each other in the same row. And, where, at some time after their burials, an "interloping" burial was made between them:

OSTENSIBLY INELIGIBLE CIVILIAN BURIALS

Five civilians with no apparent military service are buried at CWVMC. By law, only military veterans – or their wives, widows, and certain dependent children – are authorized to be buried at the CWVMC.

In fact, CWVMC records support the fact that for the first 50+ years of the cemetery, only members of the GAR Veterans Home were authorized to be buried at the CWVMC. So, burials were restricted to those individuals eligible for membership at the Home. ³

The first civilian burial occurred at CWVMC in 1942. If a special dispensation (to the long-standing eligibility criteria) was established for this civilian or subsequent civilians, it is not publicly known. The most recent burial of a civilian was in 2007.

Under state law and federal funding regulations, current burials at the CWVMC are generally restricted to:

"veterans, their spouses, minor children, and unmarried children who were physically or mentally disabled and incapable of self-support"

None of the civilian burials can be found in the NGL database – the only CWVMC burial listing available to the public. Have these burials been purposely concealed from public scrutiny?

Civilian Burials:

- 1. **Reverend Ernest B. EARLE** died on 22 Aug 1942. He was the Veterans Home Chaplain from 1913 to 1939, but he was not an employee at the time of his death. An extensive obituary makes no reference to military service. His burial represents the first "exception" to the burial eligibility criteria. He is buried at Sec 1, Lot 15 INF, Grave 36.
- 2. **Daniel WALSH** died on 21 Mar 1943. He had been a Veterans Home employee from 1920 to 1936 but was not an employee at the time of his death. He is buried at Sec 6, Lot 9-12 BTY, Grave 50.
- 3. **Walter E. FREDRICKSON** died on 14 Jun 1944, while he was the Chief Engineer at the Veterans Home. He had worked at the Home for "nearly 40 years". He is buried at Sec 1, Lot 15 INF, Grave 33.
- 4. **Kate EARLE** died on 28 Aug 1946. She was Reverend Earle's widow. She is buried at Sec 1, Lot 15 INF, Grave 36.
- 5. **Florence FREDRICKSON** died on 16 Aug 2007. She was married to Walter FREDERICKSON, and she was also a Veteran Home employee for more than 30 years. She is buried at Sec 1, Lot 15 INF, Grave 34.


³ During this period, <u>former</u> members of the Veterans Home, whose pre-deceased spouse had been buried at CWVMC, were sometimes brought to CWVMC for burial next to their spouse.

ERRONEOUS AND/OR MIS-RECORDED BURIALS

STIPULATIONS FOR THIS SECTION:

- 1. All CWVMC records, the NGL database, and the <u>actual</u> burial location should be both consistent and accurate
- All CWVMC records regarding specific burial locations were propagated by an eyes-on survey of headstones taken in the 1950s. For burials before 1950, "Burial Location" was determined by the location of a headstone, and NOT from original, contemporaneous burial records.
- 3. All burial locations stated in this section are based on CWVMC records. Any <u>presumptions</u> about burial locations or headstone installations are deliberately phrased as such.





Lewis and Bessie WILSON are buried in Lot 44 INF. **Bessie** died in 1976; and, at the time, a reservation was probably made for Lewis to be buried next to her, when he died. **Lewis** died in 1988.

Lewis is buried in Grave 32, where his headstone is installed.

Bessie is buried in Grave 33, where her headstone is installed.

These burial locations are documented in three separate ways:

- 1. The individual cards for Lewis and Bessie filed in the set of "Burial Cards" labeled "GAH-150".
- 2. The lot map for Lot 44 INF, which shows individual gravesites, grave numbers, burial numbers, and full names of the deceased.
- 3. The location of the headstones.

The NGL database has the gravesite assignments reversed. In the NGL database, **Lewis** is incorrectly assigned to Grave 33 and **Bessie** is incorrectly assigned to Grave 32.

Arthur Harris

According to the NGL database, **Arthur HARRIS** is buried at Sec 3N, Lot 34, **Grave 30**. There is no headstone installed at this gravesite.

Arthur HARRIS' headstone is installed at Sec 3N, Lot 34, **Grave 29**.

Is **Arthur HARRIS** buried at Grave 29 or at Grave 30?

Paul HINDS

According to the NGL database, **Paul HINDS** is buried at Sec 4N, Lot 59, **Grave 14**. There is no headstone installed at this gravesite.

Paul HINDS' headstone is installed at Sec 4N, Lot 59, Grave 15.

Is Paul HINDS buried at Grave 14 or at Grave 15?

John BEASLEY

According to the NGL database, John BEASLEY is buried at Sec 2N, Lot 44, Grave 28S.

The reverse side of his headstone is inscribed with the location: "2N, 44, 28S".

Section 2N does not have a Lot 44.

John BEASLEY's headstone is installed at Sec 3N, Lot 44, 28S.

Robert SANDERFOOT

According to the NGL database, Robert SANDERFOOT is buried at Sec 3N, Lot 37, Grave 10.

The reverse side of his headstone is inscribed with the location: "3N, 37, 10".

Robert SANDERFOOT's headstone is installed at Sec 3N, Lot 37, Grave 10S.

The headstone installed at Sec 3N, Lot 37, Grave 10, is also inscribed with the location: "3N, 37, 10".

James CHOLEWINSKI

According to the NGL database, **James CHOLEWINSKI** is buried at Sec 3N, Lot 33, **Grave 4**. There is no headstone installed at this gravesite.

His headstone is installed at Sec 3N, Lot 33, Grave 3.

Is James CHOLEWINSKI buried at Grave 3 or at Grave 4?

HEADSTONE INSCRIPTION ERRORS

RECURRENT ERRORS

Names

All things considered, the most jolting errors are those in which a married couple's two side-by-side headstones are each inscribed with a different spelling for the same surname. A total of 20 married couples have disparate-surname inscriptions. Additional errors were made for given names. Examples:

<u>Husband</u> <u>Wife</u>

MOLLETT MOLLETT

WHITEMORE WHITMORE

KOZELEK KOSELEK

If not before, when the second stone was received, a basic comparison should have identified the error.

Rank/Rating

For use on a government issued headstone, all ranks and ratings must be reduced to an abbreviation. The official abbreviations for government headstones have been compiled and published, so the rank abbreviations should not be a matter of speculation when ordering a headstone.

Navy ratings are notoriously easy to get wrong. A single rating – Motor Machinists Mate – was inscribed incorrectly on five (5) separate headstones; one as recently as 2014.

Incorrect: MMM1 Correct: MOMM1

It is important to know that "MMM" does not exist. It is also important to know that the difference of a single letter can change a veteran's rating completely – inscribing onto a headstone a "job" she or he never held in the Navy.

GM3 = Gunners Mate 3rd Class

GMA3 = Gunners Mate Aviation 3rd Class

Recently, the abbreviation "PVT2" has been used. Presumably, the abbreviation was used for a Private in the E-2 paygrade. However, this rank should be abbreviated as "PV2".

How much difference does it make? One is right and the other is wrong. These abbreviations are carved in stone!

Only in modern times (post-Vietnam) has there been a distinction made between a Private E-1 and a Private E-2. Traditionally, a Private First Class was worthy of making a distinction; otherwise, all other variations of Private were just referred to as "Private" and abbreviated as "PVT". Utilizing PV1 or PV2, while correct, is making a distinction without a difference.

There are at least 38 headstones with no rank. For Civil War veterans, a stone with no rank was understood to be a "Private" – they are not part of the 38. These 38 stones are for veterans from all other eras, who held a higher rank – but no rank was inscribed on their headstone. In my experience, rank can always be obtained from the National Archives.

A recurrent error, that was not included in this list of inscription errors, is the use of "C" after a WWII Navy rating; where the "C" denotes "Class", as found in Gunners Mate 1st Class.

During WWII, ratings were written with the "C": GM1C. WWII-era military records provided by the family or a government agency will likely show the "C".

However, the Department of Veterans Affairs guidelines do not include the "C" when a rating is to be inscribed on a military headstone. Presumably, this was to save on the cost of the inscription, or to make the ratings consistent with the modern version: GM1.

War Service

There are 140 headstones with no war service or missing war service, when the veteran clearly served during wartime – and in many, many cases, saw active combat during these war(s).

One major explanation is that the Army's Office of the Quartermaster General (responsible for designing and issuing veteran's headstones) did not address "war service" for several decades.

Civil War veterans were issued headstones with a distinct design, which identified a Civil War veteran just by the design. This is also true for some Spanish-American War veterans. All "other" veterans were issued a more generic headstone, similar to those issued today.

However, many World War I and World War II veterans were issued headstones with no mention of their wartime service.

Additionally, 22 veterans served in two (even three) wars, but their headstone shows service during one war only.

Dates

A presumption could be made that some of the early dates of birth and death are incorrect because these dates were not always known or recorded. I included erroneous dates only when they conflict with an exact date that was known to the Veterans Home (in its own records).

For at least a decade, there was a pattern of inscribing the wrong date of death – off by only one or two days. Presumably, instead of recording the date of death, cemetery administrators recorded the date they became aware of the death or the date of the burial.

Combat/Valor Awards

Veterans who earned combat decorations should have these medals inscribed on their headstone. My research was not universal, but my targeted efforts revealed these awards were missing from headstones:

All military awards are prescribed in an established (ironclad) order of precedence and there is an established method of recording these awards. An incorrect inscription could diminish the honor associated with each award.

For example, one headstone has this inscription:

PURPLE HEART BRONZE STAR MDL

The Bronze Star has higher precedence, so it should always be displayed "above" medals of lower precedence – in this case, the Purple Heart.

This inscription shows another problem. "BRONZE STAR MDL" has been used on recent headstones, but this abbreviation is not approved. The only authorized <u>abbreviation</u> is "BSM".

Another example is a headstone that was improperly inscribed: "2 BRONZE STAR MEDALS". The correct abbreviated inscription is: "BSM & OLC".

Military headstone abbreviations should not be "guess work". The Department of Veterans Affairs has published lists of authorized abbreviations for use on government-issued headstones:

State of Enlistment

While not a current feature of a veteran's headstone, for many decades the veteran's state of enlistment was prominently included in each inscription.

A total of 38 stones are inscribed with the wrong state of enlistment. And, in every case, the stone was inscribed with "WISCONSIN" rather than the correct state of enlistment.

GLARING ERRORS

Military records confirm that Paul KRAUSE served as a "Saddler" (made and repaired leather gear) in the US Army during World War I. He served in the 54th Infantry, which deployed to France with the AEF.

Appallingly, his headstone reads "SADDLE".

This inscription is perhaps the best example of why quality control is so important for both the headstone application and for the headstone itself when it is received at the CWVMC.

Thomas DALMADY served in "Hugh Sterling's Independent Delaware Infantry" regiment. This is one of the few "named" units that was not re-designated at the time it was recognized by the federal War Department.

Apparently, when the headstone was ordered (or inscribed) there was confusion between the veteran's name and the name of his unit. "Thomas" in his name was replaced with "Hugh".

The headstone application clearly states "FRANK", so the inscription is in error and should have been noticed at delivery of the stone.

Edwin GRIMM enlisted in 1915 and deployed with the AEF to France during World War I. He served in the 348th Machine Gun Battalion and saw combat in the following battles: Meuse-Argonne, Ypres-Lys, and Aubreville-Lorraine.

He re-enlisted for World War II on 4 Nov 1942 at the age of 45.

His headstone shows no war service nor his combat unit(s).

According to the NGL, Elwood GUTHMAN served during three (3) wars: World War II, Korea, and Vietnam.

During WWII, he served in HQ Company, 133rd Infantry; which saw intense combat in North Africa and Italy. GUTHMAN earned the Combat Infantryman Badge and the Purple Heart with 2 Oak Leaf Clusters.

His headstone should include these inscriptions:

HQ CO, 133rd Infantry
WORLD WAR II
KOREA
VIETNAM
BRONZE STAR
PURPLE HEART & 2 OLC

While he was actively engaged in combat, his 25-year-old wife (whom he married only 3 months before embarking for war) passed away back home in Iowa. Asked by a war correspondent about this deeply personal loss, GUTHMAN responded, "It was a tough blow to get that message, but there was nothing I could do but carry on."

Alois MAND enlisted in 1940, before Pearl Harbor, and was assigned to the 17th Infantry. He fought in some of the major battles in the Pacific Theatre: Aleutian Islands and the Retaking of Attu, Kwajalein Atoll, Liberation of the Philippines, and the battle of Okinawa.

MAND received these combat decorations, which are not inscribed on his headstone:

- Distinguished Service Cross
- Bronze Star with Oak Leaf Cluster
- Purple Heart with Oak Leaf Cluster

Obvious or not, the abbreviation for Battalion Sergeant Major is: BN SGT MAJ.

Yes, he was Commandant of the Wisconsin Veterans Home from 1949 to 1960 – the main administrative building at the Veterans Home bears his name.

May SEIDEL was married to Richard T. SEIDEL Jr, but there is no evidence that he served in the military.

Her son, Richard H. SEIDEL, III, enlisted as a Private in 1942 and was eventually discharged as a 1st Lieutenant, US Army. He died in 1968. The VANGL confirms that May SEIDEL was the <u>mother</u> of 1Lt Richard SEIDEL. Additionally, Richard SEIDEL's surname is misspelled in the inscription.

Here is a headstone, which states that a woman was married to her son.

Annie SMITH arrived at the Wisconsin Veterans Home on 3 May 1909.

According to a note on her county death record:

"She was shipped here from Milwaukee with no record and died the next A.M. before anything could be learned."

The death record provided no information on her birth date, age, birth location, spouse, or parents. While it did state that she was married, this may have been a presumption, because she must have been married to a veteran to be eligible for membership in the Home.

The "Annie SMITH" who died on 4 May 1909 is the only person who died in Waupaca County with that name (or remotely similar name) between 1887-1938 <u>and</u> was buried at the Veterans Home Cemetery.

Only one of these statements can be true:

- "Armie SMITH" is "Annie SMITH" who died on 4 May 1909, and the headstone inscription is inaccurate for both her given name and year of death (and almost certainly for year of birth).
- "Armie SMITH" died in 1912 and her complete identity is currently unknown. And, the burial location of "Annie SMITH", who died on 4 May 1909, is both unrecorded and/or unmarked.

Inscription indicates that Martha LARSON served in the US Army. There is no evidence that she served in the military at any time.

The NGL database confirms that she was the "wife of Louis Larson, PVT, US Army".

Sarah (Van Wormer) CASE was a resident of the Veterans Home when she died on 2 Nov 1911.

Her exact identity was finally confirmed only by reviewing Veterans Home registration records for every female member registered prior to 1930.

Recent access to the CWVMC burial cards shows that her true surname (CASE) had been known for decades. On her burial card, "CHASE" is obliterated and replaced with "CASE" and a notation was made stating that her name – as recorded in the Veterans Home admissions ledger – was "Sarah CASE".

Sarah CASE was the widow of Simeon CASE, who served in the 16th Wisconsin Infantry during the Civil War. She was admitted to the Veterans Home from her residence in Wautoma on 14 Sep 1908. Her obituary noted that she "had not been able to lie down in bed for ten years and could only rest and sleep in a chair".

Inscription indicates that she served as a Corporal in the US Army during World War I. There were no female Corporals in the US Army during World War I and there is no evidence that she served in the military at any time.

Her husband, Adam B JOHNSON, was a Corporal in the US Army during World War I. The NGL database states that Anne JOHNSON was the "wife of AB Johnson, CPL, US Army".

Inscription indicates that Hazel FOREMAN served in the US Army. There is no evidence that she served in the military at any time.

The NGL database confirms that she was the "wife of Stanley I. Foreman, CPL, US Army".

FAITHFUL & HONORABLE

During much of the 19th century, US Army enlistments were recorded in large ledger books. The left page contained a soldier's enlistment information. The right page recorded his service and discharge details. At the end of each line, the character of the soldier's service was described. For many years, an acronym was used for most soldiers: "F & H". This was short-hand for "faithful & honorable" service.

Years ago, it appears federal policy denied a government headstone to an individual who had received a dishonorable discharge. He or she was either denied a marker outright, or, was issued a marker with a limited inscription: full name and date of death only. These outdated policies are not (easily) accessible today, but their impact can be found in the CWVMC.

Nine (9) headstones with limited inscriptions were identified in the CWVMC. Eight (8) of them were procured locally (likely after the federal government refused to issue a headstone) and one was issued by the War Department.

In each of two (2) cases, the individual had served only one enlistment and received a dishonorable discharge. In other words, these two headstones were appropriate for the character of their service.

However, in the remaining seven (7) cases, each veteran had <u>multiple</u> tours of service. And in each case, the veteran had disparate characters of discharge: **one less than honorable discharge and also one or more <u>honorable</u> discharges.**

Veterans who have received both an honorable and a dishonorable discharge (for separate periods of service) qualify for veterans' benefits based on their honorable service. If not at the time of their deaths, these seven (7) veterans now qualify for a "complete" inscription on a government-issued headstone.

These men should have a government-issued headstone with an "honorable" inscription.

It should be noted that all these men served faithfully and honorably (and most saw combat) during one or more of the nation's wars and none of the unfavorable discharges occurred during war service.

Non-Compliant Individual Memorials

By custom, tradition and (now) federal regulation, the only memorial allowed for an individual person at a national cemetery is the standard grave marker. Non-marker memorials are allowed for larger groups of veterans – those who fought in a specific war, or died in a nearby battle, or served in a particular branch or unit of the military, etc. For example, those national cemeteries that began as Civil War battlefield cemeteries often have group memorials for men who served from a single state and fought in the battle.

According to the National Cemetery Administration's guidelines⁴ for new memorials, a new monument's primary purpose should "honor military service in the United States Armed Forces by *groups or organizations* – as distinctive from individuals and civilian service, however notable and patriotic".

A National Cemetery may accept a monument <u>only</u> "from organizations whose purposes, objectives and teachings, as exemplified by their constitution, by-laws and activities are primarily patriotic in nature."

Further requirements:

"Commemorative works will not be accepted from individuals."

"The proposed commemorative work does not bear acknowledgement of individual or corporate contributors, nor any advertising."

In fact, the guidelines provide a sample disapproval letter to be used by a cemetery director to reject an offer for a new memorial that was intended to honor the service of an individual (in the example, the monument would have honored the military service of a former governor).

The underlying philosophy is to restrict individual monuments (i.e., grave markers) to a uniform size and shape, installed in a military and uniform manner – in which no individual marker is more or less important than the next.

For the CWVMC to accept grant funds from the National Cemetery Administration, the state of Wisconsin is required to certify that the CWVMC "will be operated and maintained in accordance with the operational standards and measures of the National Cemetery Administration".⁵

A state cemetery that accepts National Cemetery Administration funding must submit an annual report, "State Cemetery Data", which requires the CWVMC to "list memorials located at cemetery".

To summarize, the Central Wisconsin Veterans Memorial Cemetery cannot install commemorative monuments for individuals <u>and</u> accept funds from the National Cemetery Administration.

RECOMMENDATIONS

- 1. Implement efforts to:
 - a. Identify the remaining "UNKNOWN" burial and investigate "missing" burial numbers
 - b. Identify the actual burial location for Bernard McBRARTY and install a Civil War veteran's headstone. Recommended inscription for his headstone:

- 4. Consider removing these headstones:

- 5. Review cases of "separated spouses" and "interloping burials between spouses" and revaluate current policies regarding the reservation system with the goal of preventing subsequent dilemmas.
- 6. Review the eligibility of all civilian burials at the CWVMC. Take any corrective action as required under applicable laws and regulations. Establish a policy to prevent subsequent dilemmas.
- 7. Take corrective action on all headstones that have been installed at the wrong burial location and/or have been recorded as installed at the wrong burial location.
- 8. For all headstone applications, utilize the resource, "Headstone and Marker Inscription Abbreviations", which is available here:

- 9. Discontinue using these abbreviations:
 - a. "PVT1" and "PVT2"
 - b. "BRONZE STAR MDL"
 - c. Final "C" on Navy ratings
- 10. When ordering a headstone for a widowed spouse, consult the spouse's headstone to ensure both inscriptions will be (accurate, and) consistent with each other.
- 11. Visit a gravesite before and after a headstone is installed to ensure proper placement; also, make use of the photographs available on FindAGrave at:

12. (If not already being accomplished) When assisting the family in ordering a government-issued headstone, record their preferences – particularly if they decline to include standard military information in the inscription. For example, if they decide not to inscribe war service (perhaps because the veteran did not serve in the actual war zone), record that in the burial file.

⁶ Mary (Jenner) MILLARD died in July 1921 and was buried at CWVMC. In November 1921, her remains were disinterred and moved to Rienzi Cemetery in Fond du Lac, where her husband is buried. Ironically, she has no headstone in Fond du Lac. With the approval of family members and/or Rienzi Cemetery, her CWVMC headstone could be installed at her unmarked grave there.

- 13. Perform quality control when a headstone arrives at the cemetery; compare the inscription to the information submitted on the application form. Immediately return any headstone found to have inscription errors.
- 14. Discontinue the memorial bench program and remove the existing benches perhaps redistribute them to locations on the Veterans Home campus.
- 15. Requisition and install replacement headstones for the "faithful and honorable" veterans.
- 16. Review all "Burial Inscription Errors" and determine which errors justify immediate action the ordering of a replacement stone. Develop a plan to replace these headstones.
- 17. As routine replacement headstones are ordered (due to wear or damage, etc), ensure that information compiled in this work "Burial Inscription Errors" is utilized, to ensure corrections are made. Establish policy as needed.
- 18. Compile and modernize all CWVMC burial records:
 - a. Implement an in-house electronic database for all burials, past and future (consider purchasing state-of-the-art cemetery management software application)
 - b. Ensure the database is complete and that all burials are adequately documented ⁷
 - c. Make a limited version of the database accessible to the public on demand both online and at the cemetery
 - d. Draw new, digital, accurate maps for all burial locations, which show a "truer" layout of graves and headstones ⁸
 - e. After review of this work and all its findings, make all other necessary corrections to burial records.
- 19. Establish policy to ensure the accuracy of future headstone requisitions and reduce the rate of errors (demonstrated in this work to be as high as 12%) to as near zero as possible.

⁷ The current de facto CWVMC burial listing – the NGL database – does not include almost 200 burials (3% of all burials).
