Violated Special Condition: Have no contact of any kind with DESERAE CALBO. "Contact" includes, but is not limited to, contact in person, by phone, letter, email, text, through social networking websites, or any other means, or contact through a third person at defendant's direction or request. Defendant is further prohibited from knowingly going within sight of DESERAE CALBO and going to DESERAE CALBO'S residence, place of employment, or school. Defendant shall not have any contact with anyone with whom DESERAE CALBO resides. THIRD PARTY CONTACT BETWEEN CHRISTOPHER CALBO AND DESERAE IS PERMITTED THROUGH COUNSEL ONLY.

On 10/05/2023, Deputy Beulter started an investigation into Christopher Bradley Calbo breaking his court ordered no contact order with Deserae Calbo after Deputy Director O'Toole reviewed some messages Mr. Cablo was sending on the Inmate Turnkey Messaging system.

Below are the excerpts from Deputy Beulter's report:

"On October 5th 2023 I spoke with Parole and Probation Officer Susie O'Toole about AIC Christopher Calbo (JB#51409). PO O'Toole told me, in substance, that she suspected Mr. Calbo has been in communication with his wife, who he has been ordered to not have contact with as a condition of his

Probation, based on messages Mr. Calbo was sending on the Inmate Turnkey Messaging system. I looked into the matter further.

AIC Calbo was booked into the Lincoln County Jail on 08/14/2023. AIC Calbo was charged with Domestic Violence related charges. AIC Calbo was sentenced on 09/07/2023 on this case (See Case# 23CR26202). A Condition of this Order states:

"Have No Contact of any kind with DESERAE CALBO. "Contact" includes, but is not limited to , contact in person, by phone, letter, email, text, through social networking websites, or any other means, or contact through a third person at defendant's direction or request. Defendant is further prohibited from knowingly going within sight of DESERAE CALBO and going to DESERAE CALBO's residence, place of employment, or school. Defendant shall not have any contact with anyone with whom DESERAE CALBO resides. THIRD PARTY CONTACT BETWEEN CHRSTIOHER CALBO AND DESERAE IS PERMITTED THROUGH COUNSEL ONLY." Reviewing AIC Calbo's Turnkey Account I found the following:

An account was created by a "Margie Newman", phone number (541) 591-1249, Email: Margielnewman45@gmail.com. There are multiple messages on this account from 08/18/23 to present. I immediately noticed that there is only one message sent from Margie to AIC Calbo. The only messages is the first message sent on this account on 08/18/23 at 11:00 AM stating "Hi Honey it's mom. Are you getting this message?" All other messages on this account are sent by AIC Calbo to "Margie Newman".

I learned from PO O'Toole that Margie Newman is AIC Calbo's mother. Another account was created by "Deserae Calbo", phone number (208) 320-2383, Email: calbos112@gmail.com. The only messages sent on this account are from "Deserae Calbo" to AIC Calbo.

I printed all messages off for both accounts and reviewed them parallel to each other. Reviewing the messages, I believe there is reasonable suspicion that AIC Calbo is communicating with Deserae Calbo by relaying information through Margie Newman.

I have attached messages from both accounts to this case report.

The following are messages sent by Deserae Calbo, along with calls made by AIC Calbo to Margie Newman. These messages and calls show that Margie Newman is present during the calls.

CALL: CALBO, CHRSTOPHER 8/23/23 2:28 PM In substance, AIC Calbo asks Margie if she is "at the house" and if she is staying there for a while. She says "Yes". AIC Calbo asks if she is "starting tonight", Margie says "No". Margie tells AIC Calbo that she is unloading some stuff.

MESSAGE: [ Deserae Calbo | 8/23/23, 7:12 PM ] I get so sad when I hear your voice. I love it but hate it all at the same time. I'm so in love with you and can't wait to have our life back. I'm still sober and so happy with this new life. I'm so proud of you too!

MESSAGE: [ Deserae Calbo | 9/12/23, 7:07 PM ] I hope you got approved to work in the kitchen or do something to help you get out more. I made my hubby's left over frozen spaghetti sauce tonight. It was still delicious. I miss you so much and I defnatly miss your cooking. I don't eat much if anything anymore.

CALL: CALBO, CHRISTOPHER 9/13/23 10:15 AM Margie tells AIC Calbo about what they are eating. AIC Calbo says that it sounds good, "So does spaghetti and so does everything else I hear about". Approximately 07:45 into the call I could hear what sounded like a third party speak. During the call AIC Calbo expresses his frustrations and sadness with his situation, at times he sounds like he is crying.

CALL: CALBO, CHRISTOPHER 9/13/23 10:54 AM AIC Calbo tells Margie he is sorry for being so emotional. AIC Calbo tells Margie he meant to say to her he is proud of Deserae for standing up for her self. 01: 14 in the call AIC Calbo tells Margie "obviously you've seen her is she doing ok?" Margie states "Yep, I'm still here" and tells AIC Calbo she is going to freeze some squash and make it when he returns home. Approximately 1:50 into the call I can hear what sounds like a third party female voice. AIC Calbo states, "It sounds like you're busy". Margie tells AIC Calbo "We're in the middle of cooking". AIC Calbo tells Margie "I love". Margie states "We love you too sweet heart". Approximately 2:15 into the call a third party female voice gets on the phone and states "I love you". Margie speaks again and says "We decided that she has a right to say these things, you can't respond but". AIC Calbo states "No, I didn't even know, I didn't even know it was gonna happen".

MESSAGE: [ Deserae Calbo | 9/13/23, 11:16 AM ] It's nice hearing your voice it melts my heart but i don't like you being down and super negative about everything. I'm sorry I said anything about spaghetti or anything else that makes you sad. It's really to talk to you without upsetting you. And when I say I hope you've kept your promises and if you still feel the same way about me that you did when you went in. I need reassurance, too, you know. You can't text me, write me, call me or anything so it's really difficult to know how you're feeling about me. This is hard on everyone.

CALL: CALBO, CHRISTOPHER 10/4/23 6:48 PM Approximately 00:20 into the call AIC Calbo asks if Margie "went in by herself". Margie tells AIC Calbo that he is on "speaker". AIC Calbo says "Hi everyone". Margie states "Everybody said hi".

Approximately 05:13 into the call AIC Calbo says "I hope everybody's happy". Margie tells AIC Calbo "Everybody's happy". AIC Calbo tells Margie that this will have to be his "good night message". Margie tells AIC Calbo "Ok, well, at least you got to talk to her sitting here". AIC Calbo says tells Margie he misses "Everybody" and loves "everybody" and "cannot wait to put my arms around you, it's killing me". AIC Calbo sounds as if he is crying.

06:18 into the call Margie states "We love you so much". AIC Calbo says "I love you to, drive safe". Margie states "We will sweetheart". A third party female voice can be heard along with Margie's stating "I love you". AIC Calbo responds "I love you too very much".

THESE WERE THE LAST CALLS MADE TO THIS NUMBER ON 10/4/2023. MESSAGE: [ Deserae Calbo | 10/5/23, 6:41 AM ] Good morning baby. Another day is gone! I hope you have a good day. I loved hearing your voice but hate to hear you cry. I miss you so much. I love you."

#### **CONFORMANCE / EVALUATION:**

Mr. Calbo has been non-compliant with his supervision as he has violated his no contact order.
